Where are our loved ones?

Families of the victims of enforced disappearances first time speak freely, demand probe and justice

Ayesha Ali has been praying every day for over 10 years to see her son.

As several people emerged from secret detention centres known as Aynaghar after the fall of the Sheikh Hasina-led government early this month, Ayesha started hoping that her son Abdul Quader, who was 23 when he disappeared in December 2013, would knock on the door any moment.

"I touch his clothes everyday and I tell myself that he will come back. I keep looking out of the window, expecting to see him on the street," she said, breaking down in tears at a human chain at Central Shaheed Minar.

"Everyone says the country is now independent. Is the country not independent for my son?'

Other participants at the event then embraced Ayesha and tried to soothe her. Quader, a student of finance at Jagannath University, was picked up by men claiming to be Rab members from the capital's Bashundhara area, family members said. He was a supporter of

Many other family members of the victims of enforced disappearance were at the event, marking the International Day of the Victims of Enforced Disappearances.

Mayer Daak, a platform for the families, has been commemorating this day since 2013.

Speaking about her Mazharul Russel who has been missing since 2013, another participant named Nusrat Jahan also broke down.

"I want to touch my brother's hands. He used to take me to the school on his bicycle. I have nightmares of him being locked in a dark room alone. Find me, he says to me," Nusrat said.

She then urged Chief Adviser Prof Muhammad Yunus to take steps to investigate the secret prisons.

She said there must be Aynaghar at the facilities of law enforcers where "my brother and others are probably

"We want to know whether our loved ones are alive or dead," she added.

'I was forced to step down'

Ex-Islami Bank MD says he had to put signature on pad never used by the bank

Islami Bank's former managing director Abdul Mannan had not appeared or spoken publicly since S Alam Group took control of the bank in March

Breaking more than seven years of silence yesterday, he said the infamous conglomerate forced Mannan at gunpoint to

resign from his post at the Shariah-based bank after h was taken hostage by members of a security agency.

"I was forced to resign on a pad that the Islami Bank has never used since its inception in 1983 till date," Mannan said at a discussion vesterday where he recalled a few memories of his forced removal at that time.

The Forum for Bangladesh Studies organised the virtual event on "Elimination of Occupancy in the Banking Sector: Will the Plight End?".

Commemorating the deaths in the recent studentled movement that ousted the Awami League regime on August 5, he said: "Now I think I have freedom of expression. Earlier, I did not have the courage to speak even while staying abroad."

How UCB's Ronny acquired so much offshore assets

Ex-minister Javed, wife's bank accounts frozen, but his brother Anisuzzaman Ronny, wife Imrana remain unmarked

As Saifuzzaman Chowdhury Javed's grip over United Commercial Bank (UCB) created a trail of disguised loans with abuse of political influence after he became a minister in 2019 back home, his brother Anisuzzaman Chowdhury Ronny's assets saw a meteoric rise in the UK.

Last year, The Daily Star reported that Javed, the former land minister, and his wife Rukhmila Zaman co-own over 260 properties in the UK while Bloomberg News had put the figures at over 350 properties worth about £200 million, or over Tk 3,143 crore.

This newspaper has now tracked five UK companies owned by Ronny and his wife Imrana Zaman Chowdhury together or individually with their business partners. The firms hold properties worth £22.31 million, or over Tk 350 crore, acquired after Javed's entry to now-deposed Hasina's cabinet.

The firms are Bitcom Real Estate Ltd, Ronny 42 Ltd, AA Mandarin Ltd,

RIGHTS VIOLATIONS UN to dispatch fact-finding team to Bangladesh

The UN Human Rights Office will dispatch a fact-finding team to Bangladesh in the coming weeks to conduct an impartial and independent investigation into the human rights violations committed between July 1 and August 15.

The decision comes after Chief Adviser Muhammad Yunus requested the UN High Commissioner for Human Rights Volker Türk for such a mission, said Spokesperson for the UN rights office Ravina Shamdasani at a press briefing in Geneva yesterday.

The fact-finding mission will investigate violations and abuses perpetrated during the mass protest, analyse root causes, and make recommendations to advance justice, accountability and way out for long-term

An advance team visited the country from August 22 to 29, meeting people including student leaders of the recent

The team also met many advisers to the interim government, the chief justice, senior officers of the police and
