Extra burden on ADCs as interim govt vet to finalise list for appointing DCs

The government is yet to appoint deputy commissioners in 25 districts even though 13 days have gone by since the DCs from those districts

The DCs are the heads of civil administration in districts. They play a pivotal role in overseeing local governance and ensuring effective delivery of public services. The DCs now have additional workload as they are in charge of zilla parishads and municipalities.

Additional deputy commissioners are now filling in for the DCs withdrawn from 21 districts while four DCs, who have been transferred, had to stay at their previous stations as their districts were affected by

Sources said the public administration ministry cannot immediately appoint DCs to the districts as it needs time to make a list of officials fit for the job.

Preferring anonymity, a joint secretary at the Cabinet Division told The Daily Star that the interim government does not want to use the list of officials prepared by the previous government to appoint new DCs.

The official said the list made by the Hasina-led government is deemed full of officials close to the previous regime.

Usually, the government first appoints new DCs before transferring the existing ones. Sometimes, the two are done concurrently.

"However, the interim government has ordered the transfer of nearly half of the district DCs without preparing a list of replacements," the official said.

The government on August 20 withdrew the DCs from the districts, including Dhaka, Gazipur, Chattogram, Mymensingh and Cox's Bazar, and attached them to different ministries, directorates, and other

The DCs of Chandpur, Cumilla, Noakhali, and Moulvibazar stayed at their stations because of the floods.

Following the fall of Hasina's government on August 5, many DC and UNO offices were attacked. Some officials even had to flee their stations fearing for their lives.

Right after the interim government was formed, many DCs sought

Series sweep beckons Tigers

For the first time since 2009 an away Test series sweep beckons Bangladesh in Rawalpindi on Day 5 of the second Test against Pakistan, but chances of rain playing spoilsport -- as it had done on Monday to wipe out the third session -- can dampen the tourists' party, with Tigers needing 143 more runs to win.

It has been a remarkable tale of fightback from the Tigers this match. Having bowled Pakistan out for 274 in the first innings, Bangladesh were reduced to 26 for six in their first innings before Liton Das and Mehedi Hasan Miraz's rescue act saw them fall just 12 runs short. Then with the ball, Bangladesh completely dominated proceedings yesterday.

Pace sells and Bangladesh capitalised with the three pacers taking all 10 wickets in Pakistan's second innings, the first time that Bangladesh pacers have attained the feat in Test cricket. Mehedi had written his

BTRC's curious U-turn on Summit Comms

The telecom regulator has walked back on its decision just two months ago to allow Summit Communications to transfer its shares without any fee, in a development that raises questions about the extent of benefits the company received during the 15 years of the previous Awami League government.

Muhammad Farid Khan, chairman of Summit Communications, is the younger brother of AL presidium member Faruk Khan, also a five-time member of parliament from the Gopalganj-1. Farid is also a close friend of Sajeeb Wazed Joy, the

son and ICT affairs adviser of former prime minister Sheikh Hasina.

As per rules, when a company transfers shares, it has to furnish 5.5 percent of the selling price as a fee to the state coffer.

In April 2021, Kirtonkhola Tower Bangladesh had to pay Tk 5.7 crore to Bangladesh Telecommunication Regulatory Commission (BTRC) for share transfer to new companies through ssuing new shares.

However, for Summit Communications, which became the largest infrastructure company in the telecom and internet sector after debuting in 2009, the fee was SEE PAGE 2 COL 2

Shirin steps down as JS speaker

President accepts her resignation

Sharmin Shirin Chaudhury, the speaker of the recently dissolved 12th Jatiya Sangsad, resigned vesterday.

She sent her resignation President letter to Mohammed Shahabuddin, confirmed sources at the Bangabhaban.

The move came 27 days after former prime minister Sheikh Hasina on August 5 stepped down and fled to India in the face of a mass uprising.

Three state-run banks far exceeded their limits to salvage a coal-fired power plant project of an Orion Group subsidiary, which was stalled for six vears, with Tk 10.579 crore in loans thanks to policy relaxation by the Bangladesh Bank

under the now-ousted Sheikh Hasina government.

However, the loans, on top of Tk 6,244 crore liabilities of Orion companies with the banks, were

not disbursed and the conglomerate decided to turn the project into a solar power plant.

Orion Group companies have borrowed a total of Tk 8,457 crore from banks, including Tk 616 crore from Mercantile Bank, Tk 357 crore from Social Islami Bank and Tk 1,240 crore from AB Bank as of June this year.

The group looked to Agrani, Janata

and Rupali banks for the syndicated loan approved last year for the project at Moheshkhali in Cox's Bazar under Orion Power Dhaka-2 Limited (OPDL-2) after its bid for foreign funds had failed, officials of the banks and Orion said.

Awami League's pick Abdur Rouf Talukder was the governor when the

central bank had November 2022 relaxed section 26-kha (1) of the Bank Company Act-1991, which states loans given by a bank to a single borrower shall not exceed 25

percent of the bank's capital. The central bank relaxed the rule for coal-based power companies for the next five years. It gave the no-objection certificates (NOCs) for the OPDL-2 loans from August to October last year.

Bangladesh Bank spokesman Md Mezbaul Haque has recently told The Daily Star that the banks, not the

12kg LPG cylinder price hiked by Tk 44

The price of a standard 12kg LPG cylinder has been set at Tk 1,421 for the month of September, up Tk 44 from Tk 1,377 the previous month.

The new price of the essential fuel came into effect at 6:00pm yesterday, as announced by the Bangladesh Energy Regulatory Commission.

The price of LPG per kg will now be Tk 118.44, which was Tk 114.79.

Prices of other liquefied petroleum gas (LPG) cylinders – from 5.5 kg to 45 kg – will go up proportionately.

As per the BERC decision, the price of "auto gas" (LPG used for motor vehicles) also increased to Tk 65.26 per litre from Tk 63.21 per litre.

The price of LPG, marketed by state-owned LP Gas Company, will remain the same as it is locally produced with a market share of less than 5 percent, reports UNB.

Govt cancels Momen's contract as foreign secy

The government has cancelled the contractual appointment of Masud Bin Momen as the foreign

The Ministry of Public Administration issued a gazette notification to this effect yesterday.

On Sunday, a farewell reception was accorded to Masud Bin Momen at the Ministry of Foreign Affairs that was also attended by

Foreign Adviser Md Touhid Hossain.

Masud Bin Momen took over the helm of the foreign ministry in 2019, and in November 2022, the Awami League government extended his tenure on a contractual basis for two years until December 6 this year.

Prior to his appointment as the foreign secretary, he served as the Bangladesh Ambassador and Permanent Representative to the UN in New York since 2015.

Before that, he served as Bangladesh's Ambassador to Japan from 2012 to 2015.

Shirin steps down as JS speaker

A gazette issued yesterday said the president accepted Shirin's resignation and it already came into

Shahabuddin on August 6 dissolved the parliament formed through the January 7 national election.

On August 14, former deputy speaker Shamsul Hoque Tuku was arrested in the murder case of a rickshaw puller who was killed in the capital's Paltan during the quota reform protest.

Now the questions have come up whether the post of the Speaker has fallen vacant and who will administer the oath of office to the newly elected members of the next parliament.

According to the constitution, even after her resignation, Shirin will continue as Speaker until her successor takes over.

In other words, she will be considered as the Speaker until the next elected Speaker takes over.

Shirin will administer the oath of

office to the lawmakers of the new JS.

The Speaker of the Jatiya Sangsad is the third highest post of the state.

Article 74 of the constitution states how the posts of the Speaker and deputy speaker will become vacant.

It says that the Speaker's post will fall vacant due to five reasons.

The constitution stipulates that if the president's office becomes vacant or if the president is unable to perform his duties due to absence, illness or any other reason, the Speaker shall carry out the duties of the president until a new president is elected or the president resumes his duties, as the case may be.

On the other hand, Article 50 of the constitution says, "The president may resign with a signed letter addressed to the Speaker."

Article 74 of the constitution deals with the election of the Speaker and the deputy speaker.

According to the constitution, parliament shall elect a Speaker and a deputy speaker from among the MPs during the first sitting of the Jatiya

Sangsad after a general election. Nizam Uddin Ahmed, a former professor of public administration at Chittagong University and also a parliamentary affairs expert, yesterday said despite her resignation, Shirin will remain as the Speaker until the new Speaker is elected in the

next parliament. Shirin became the Speaker for the first time on April 30, 2013. She has

been holding the post since then. She was first elected an MP from Rangpur-6 in the 2014 national

election. After the fall of the Awami League government on August 5, many cases have been filed against AL leaders across the country. On August 27, a case was filed against Shirin over the death of Muslim Uddin, a jeweler, in Rangpur during the quota reform

Muslim Uddin's wife Dilruba Akter filed the case at Rangpur Metropolitan Magistrate's Court, accusing 17 people, including the Speaker.

Former commerce minister Tipu Munshi, now behind bars, was shown arrested in the same case.

Then on June 12, the BTRC allowed the company to do the share transfer without any charges.

Before doing so, the telecom regulator sought the legal opinion of the law firm, which said that since

shares, the 5.5 percent fee on the selling price was not applicable.

Summit also said the fee was not applicable as the company was raising its paid-up capital by issuing

However, the BTRC's legal and licensing division wanted to slap the charges from the onset as Summit was transferring and selling shares in the guise of issuing new shares, The Daily Star has learnt from officials involved with the proceedings.

It is because after issuing the shares, Farid's holdings in the company came down from 95 percent to 25 percent as he transferred the shares to new entities and Summit also submitted the sales agreement with these companies.

Of the new shares, about 9.44 crore shares worth Tk 113.38 crore were issued to the UAE-based company Global Energies -- enough to secure 49 percent stakes in Summit Communications.

One of the shareholders of Global Energies is Adeeba Aziz Khan, the middle daughterof Farid's older brother Muhammad Aziz Khan, also the chairman of Summit Group.

She nominated Farid's daughter

Summit was merely issuing new Fadiah Khan and Sanadina Khan, the daughter of her uncle Jafer Ummeed Khan, as directors of Summit Communications, according to BTRC documents that cited the Global Energies Holdings' board resolution.

Another 4.04 crore shares worth Tk 48.59 crore were given to Mauritiusbased Sequoia Infra Tech -- enough to secure 21 percent stakes in Summit Communications. Doorvesh Kumar Jugurnauth, who also serves as a director of Sequoia Infra Tech, will represent it on the board of Summit Communications.

remaining 71.04 lakh shares were issued to Summit Communications MD Md Arif Al Islam, whose stake remains unchanged at 5 percent.

"So, the charge is justified for we earlier charged Summit --Kirtonkhola Tower Bangladesh for the same process," said a top official of the commission on the condition of anonymity to speak candidly on the issue.

But, BTRC's immediate past president Md Mohiuddin Ahmed pursued to get legal opinion in this regard, according to the BTRC officials involved in the process.

Mohiuddin, who resigned as BTRC president on August 14, could not be reached for a comment despite repeated attempts.

After the fall of the Sheikh Hasina government on August 5, the BTRC wrote back to the law firm and said its legal opinion is only advisory and not binding.

On August 14, the BTRC sent a letter to Summit Communications directing it to pay 5.5 percent of the selling price of the share.

In its response to The Daily Star, Summit Communications said it has already furnished Tk 10.24 crore to the regulator after the BTRC letter.

"On the surface, you would see Summit has become a giant providing quality services and operating under law and rules. It's true," said a top official of a company that operates in the telecommunication industry.

But the government has provided all kinds of facilities enabling Summit to grow, issue directives and set policies directly in its favour, he said.

"In this context, we commend the recent decision to impose a revenue share on share transfers retrospectively, as it reflects a newfound autonomy," said telecom expert Abu Nazam M Tanveer it added.

However, this move suggests that similar instances may have occurred in the past.

To address these potential gaps, an independent investigation should be launched to enable the regulator to recover any lost revenue on behalf of the state, he added.

Communications Summit maintains it has done nothing wrong.

were exempted from the single borrower exposure limit to speed up electricity generation," said the BB spokesman.

Before joining the central bank as its governor following the Awami League's ouster and Rouf's resignation, economist Ahsan H Mansur had told The Daily Star that the exemption from the single borrower exposure limit for these types of power plants was avoidable. We do not need coal-based power plants, we need renewable energy."

Approving such projects on political grounds is "not good news" for governance in the banking sector, he had said. "The state-run banks have no accountability and governance. That is why they [coalbased power producers] took large amounts of loans from these lenders."

A senior Bangladesh Bank official who monitors the state-run banks told The Daily Star that the three lenders approved the loans at a time when a major portion of their credit was already concentrated with some large borrowers, which is "very risky".

A lender's risk increases when a single customer gets a large portion of loans, sometimes even more than the client's capital, he added.

For instance, seven borrowers, including AnonTex, Crescent, Ratanpur, and S Alam groups, account for 57 percent of the total defaulted loans at Janata Bank.

Even after this, scam-hit Janata Bank approved a Tk 5,078 crore loan for Orion Power, which is 219 percent of the lender's Tk 2,314 crore paid-up capital – far exceeding the 25 percent ceiling relaxed by BB. Orion Group was already one of the top borrowers of Janata, with Tk 2,875.85 crore loans taken until June this year.

Janata had the highest Tk 48,000 crore defaulted loans as of June this year, up from Tk 5,818 crore in 2017. It faced a Tk 2,750 crore capital shortfall until December last year, having been put in deep trouble by Anontex, Beximco and S Alam

Janata Bank has yet to disburse the loans, said Jabbar. "I'm trying to run this bank smoothly. I want to protect the bank from further deterioration of its health."

Agrani Bank approved a Tk 2,856 crore loan for OPDL-2, which is 138 ercent higher than the lender's Tk 2,072 crore paid-up capital. The state-run bank approved the new loan to the company despite Orion Group subsidiaries having a Tk 2,250.63 crore liabilities with the lender.

Rupali Bank last year approved Tk 2.645 crore for the company and the amount is 569 percent of the bank's paid-up capital of Tk 464.70 crore. Orion Group subsidiaries' outstanding loans at Rupali Bank stood at Tk 1,117.48 crore until June

Agrani Bank was the lead arranger for the loans, but Janata Bank approved the highest amount followed by Rupali Bank despite their worsening financial health, caused by high defaulted loans and capital shortfalls, showed the lenders' meeting minutes.

Defaulted loans at Agrani stood at Tk 20,864 crore or 28 percent of disbursed loans as of March this year, up from Tk 14,806 crore during the same period last year, BB data show. The bank also faced Tk 4,450 crore capital shortfall as of December last

Contacted, Md Murshedul Kabir, managing director and CEO of Agrani Bank, declined to comment.

Zaid Bakht, who recently resigned from the post of chairman of the bank, told this newspaper that the loan had been approved long ago by "maintaining due diligence" with the central bank's permission.

A senior official of the bank, seeking anonymity, said Agrani Bank approved the loans because the government had cleared Orion's plant and signed an agreement to purchase power from it.

Rupali Bank's defaulted loans stood at Tk 10,357 crore as of March this year, which is 21 percent of its disbursed loans, BB data show. It faced a Tk 2,193 crore capital shortfall last year.

The bank's Managing Director

Salman Obaidul Karim, managing

Daily Star on Thursday that they secured approval for a syndicated loan from Agrani, Janata, and Rupali Bank "based on the coal project's financial credibility without any undue influence". He explained that significant investments were made for the

coal project from Orion's equity, including for land procurement, land development, and basic and detailed engineering, in collaboration "internationally with reputed" engineering consultants.

However, recognising the longterm benefits for Bangladesh's economy and energy sustainability, the conglomerate decided to pivot to a solar project, he said, adding that this decision, made during the previous government's tenure, reflects the firm's "commitment to the country's well-being over shortterm profitability".

The Orion Group managing director said they requested the banks to cancel the loans approved for the coal project and to approve a new loan for the solar project. Rupali Bank cancelled its portion of the loan in April, effectively cancelling the entire syndicated credit, he said.

If disbursed, the tenure of the project loans would be 15 years, including a one-year grace period, while the project was expected to be completed in three years, industry insiders said.

Orion had initially planned to implement a 635 MW coal power plant at Gozaria in Munshiganj but it later moved the project to Moheshkhali in Cox's Bazar with hopes to supply electricity for 25 years from 2026.

The funds initially allocated for land development in the coal project have been reallocated to the solar project on the land given by the government, ensuring a smooth and responsible transition, Salman said. The company has also applied for

a new loan for developing a renewable power plant on the Munshiganj land where it had initially planned the coal project, he said.

"The cancellation during the previous government's tenure demonstrates that no special favours were sought or received."

Washington to work closely with Dhaka

US envoy tells Yunus

Washington will closely work with the interim government, especially regarding health, education, labour, governance, and the Rohingya issues, said US Embassy Charge D'Affaires in Dhaka Helen LaFave.

She made the remarks while paying a courtesy call to Chief Adviser Prof Muhammad Yunus at the State Guest House Jamuna in Dhaka.

"The US government is happy to congratulate the chief adviser and is looking forward to working closely together," according to a statement of the US charge d'affaires.

She said Washington will support the interim government of Bangladesh and strengthen ties with Dhaka on a range of

The US embassy in Dhaka will resume its consular service this week to expedite visa processing, she said, adding that thousands of Bangladeshi students now study in US universities.

The US has started resettling Rohingya to the US, and Helen LaFave hoped the process would be expedited.

The US is the largest contributor to the Rohingya humanitarian responses, SEE PAGE 4 COL 4

Stop the DAP implementation Demands IAB

The Institute of Architects Bangladesh yesterday called on the government to halt the implementation of the Detailed Area Plan (DAP) for 2022-2035, prepared by Rajdhani Unnayan Kartripakkha (Rajuk), citing violations of laws, lack of transparency, and potential environmental harm.

At a press briefing held at the Jatiya Press Club, the IAB alleged that the DAP threatens water bodies, floodplains, and agricultural land, while also fostering corruption in the design approval process.

"The implementation of the DAP has been ongoing for a year, but due to existing disparities and ambiguities in the plan, a certain Rajuk circle's dominance during the approval of new building designs has escalated," said Prof Muhammad Ali Naqi, vice president of IAB, while reading out a written statement.

Naqi said the plan has led to increased harassment of landowners and the public, resulting in delays, confusion, and corruption.

He called for the immediate suspension of the DAP's implementation and necessary reforms through active stakeholder engagement to address legal and other inconsistencies

The IAB reported that they have contacted Rajuk regarding the suspension and reform of the DAP, to which Rajuk responded that the matter would be placed before the chief adviser.

Video of man mercilessly beating women goes viral; rights activists condemn assault

Shahida, a 50-year-old former sex worker who now works as a field officer and the man posted the video on his for Ahsania Mission's HIV prevention Facebook account. and treatment project, was brutally attacked on August 29. The incident took place in the Shyamoli area of the capital.

"After distributing condoms to the floating sex workers, I was standing in front of a mobile recharge point when a man wearing a blue t-shirt and mask suddenly approached me with a green pipe and began beating me," Shahida

"He assumed I was soliciting clients, but I told him I'm a service holder and showed him my ID, asking him to stop," she added. "But he didn't listen and kept beating me, asking why I was talking to the sex workers."

The man struck her nine times before running off to attack other sex workers waiting for clients nearby.

Despite people being present, no one intervened to help.

The entire incident was filmed,

Nagorik Oikya, Gono Odhikar get EC registration

The Election Commission yesterday granted registration to two parties, Nagorik Oikya and Gono Odhikar Parishad, bringing the total number of registered parties to 47.

Nagorik Oikya, led by Mahmudur Rahman Manna and formed in 2012, will use the electoral symbol "kettle". Gono Odhikar Parishad, founded by 2018 quota reform movement activists under the leadership of Nurul Haque

Nur, will have the symbol "truck." EC Secretary Shafiul Azim confirmed to The Daily Star that the party met all the necessary criteria for registration. EC Additional Secretary Ashok Kumar Debnath also

confirmed the registration of Nagorik Oikya. Nur said the previous commission had withheld their registration based on reports from the then-government's intelligence agency. "Last time, the commission gave various excuses for not registering us. After the fall of the fascist government, everything is being reformed," he said

during a press conference at the EC. Meanwhile, a faction of Gono Odhikar Parishad, led by Reza Kibria, protested by blocking the EC secretary office for over an hour, demanding their party's registration.

Shafiul Azim responded, saying, "Some unruly individuals entered his office. There is a process for granting party registration, and we are adhering to it."

In May 2022, 93 parties applied for registration, with 12, including Gono Odhikar Parishad and Nagorik Oikya, being shortlisted.

However, ahead of the 12th parliamentary polls, the EC registered two of the 12 parties, excluding Gono Odhikar Parishad and Nagorik Oikya.

QUICK RENTAL LAW HC questions constitutionality of two sections

The High Court yesterday questioned the constitutionality of two sections of the quick rental law, which protect rental and quick rental power plants from legal challenges and give the energy minister sole authority to approve electricity purchase plans.

In a rule, the HC asked the authorities concerned of the government to explain why sections 9 and 6(2) of the Quick Enhancement of Electricity and Energy Supply (Special Provisions) Act 2010 should not be declared unconstitutional.

Section 9 states that no question about any action done or deemed to be done, and any order or direction given under this law, cannot be raised before

Section 6 (2) says that any planning or proposal related to the buying or investment decisions has to be approved by the energy minister and sent to the cabinet committee for approval after communicating and bargaining with one or more institutions following section 7 of the act.

The HC bench of Justice Farah Mahbub and Justice AKM Rabiul Hassan issued the rule following a writ petition filed

ENFORCED DISAPPEARANCE Victim's family calls for justice

The family of a victim of enforced disappearance from Pabna yesterday demanded that the authorities find his whereabouts and sought justice for him.

Abdul Gaffar Piyash, a student of Pabna Polytechnic Institute from the town's Library Bazar, went missing on December 4, 2016.

At a press conference at Pabna Press Club, Piyash's brother Abdul Hamid alleged plainclothes men on a white microbus had detained his brother that day.

"We went to Pabna Sadar Police Station to lodge a missing diary but police officials rejected to take our complaint. Since then, we have been searching for him," Hamid said.

"If my brother is guilty of any crime, he could have been punished according to legal procedure, but why would he be made a victim of disappearance? We want to know about his whereabout," he added.

"My son was not involved in politics. I demand justice," said Piyash's mother Saleha Khatun.

Contacted, the police station OC Md Rawshon Ali said he was not working with the station eight years back; so, he does not know what happened to Piyash.





Hasina sued in five more murder cases

Former prime minister Sheikh Hasina was sued in five more murder cases over the deaths of five people in the capital's Jatrabari and Dhanmondi areas between July 19 and August 14.

Hasina is now facing at least 90 cases, mostly for murders during the mass student protests that forced her to resign and flee the country on August 5.

In the cases, former ministers Obaidul Quader, Asaduzzaman Khan Kamal, Hasan Mahmud, Jahangir Kabir Nanak, and Dr Samanta Lal Sen, former lawmakers Shamim Osman, Nazrul Islam Babu, Ferdous Ahmed, and Mashiur Rahman Mollah Sajal, former IGP Chowdhury Abdullah Al-Mamun, and former DB additional commissioner Harun Or Rashid have also been made accused, among others.

Four of those cases were filed with the court of Dhaka Metropolitan Magistrate Saddam Hossain.

recording complainants' statements in the four cases, the magistrate asked the officer-in-charge of Jatrabari Police Sation to register the complainants as first information report, said court sources.

against Hasina and 57 otners over the death of his relative Obaidul Islam on August 4.

According to the case statement, leaders and activists of the AL-led 14-party alliance fired on thousands of people with illegal weapons in front of Kajla Petrol Pump in Jatrabari on August 4 during the anti-discrimination student movement, where Obaidul died of bullet injuries.

One Rubel filed a case against Hasina and 35 others over the death of his brother Rasel in the Kajla area on August 5.

One Mariam filed a case against Hasina and 93 others over the death of her son Saif Arafat Sharif, while Shilpi Akter filed another case against Hasina and 12 others over the death of his son Saidul Islam Yeasin.

In the cases' statements, the complainants said Sharif and Yeasin were killed in front of Jatrabari Police Station on August 14 by the accused, while they were managing traffic there. Meanwhile, one Renu filed a case with the court of Dhaka Metropolitan Magistrate Faraha Diba Chanda against Hasina and 137 others over the death of her son Shuvo during quota reform protests.

According to case statement, Shuvo suffered bullet injuries in Dhanmondi on July 19 and died One Mohammad Ali filed a case the next day while undergoing



Ad filmmakers thrive for reform, aiming to make industry 'PROFESSIONAL'

For years, we've heard countless stories of crew members struggling to receive their due payments after completing their work. These incidents often unfold quietly and are usually resolved through personal negotiations, with little attention given to the larger

issue.

In a bold move to end longstanding struggles, Bangladeshi ad filmmakers have stepped forward to claim their rightful dues. Determined to establish a professional and fair working environment in the advertisement and film production sector, the Bangladesh Association of AdFilm and Content Producers (BAAcP) announced an indefinite strike on September 1.

Despite ongoing negotiations, key issues remain unresolved, including the settlement of previous dues, timely work orders, 75% Advance Payment, and the remaining 25% Payment within 45 days of billing.

The strike comes in response to ongoing disputes with advertising agencies and clients who consistently fail to settle payments with production companies.

Md Habibur Rahman Tareq, the convener of BAAcP, told The Daily Star that their demands were first

> presented to the association of Bangladeshi ad agencies over a year ago. "Initially, we attempted to resolve the matter privately by meeting agencies," he explained. "However, they kept asking for

more time, and

despite our efforts, no one was truly willing to plaguing the ad film industry for

He further explained that the growing backlog of unpaid dues has taken a toll on the work culture. "We have laid out our demands clearly, and we believe these are rightful steps toward creating a professional environment in the industry," he asserted.

Tareq who is also the Executive Producer of Runout Films, pointed out the troubling trend of the market evolving into a monopoly, where unprofessional practices not only harm existing players but also discourage newcomers from entering the industry.

In the meantime, three agencies have agreed to meet the demands outlined in the protest. The BAAcP has announced that they will resume work only once their demands are fully addressed. Upon receiving confirmation, they will continue their collaborations and resume shooting with the agencies as planned.

Renowned director Adnan Al address the issues that have been Rajeev, owner of Runout Films, uprising on August 5," she said. noted that while the issue has

been raised repeatedly, a proper solution has yet to materialise. "There is no central association for the prominent agencies in Bangladesh, which complicates the process of lodging complaints and resolving issues," he said. "For young directors and producers just starting their careers, payment delays can make it incredibly challenging to continue working. Despite numerous attempts to address the problem through individual meetings and emails, no effective resolution has been reached."

He also shared that agencies are coming forward and having meetings with the advertising producers, which is a positive sign.

Raka Noshin Nower, who founded Studio Yellow Something two years ago, expressed the difficulties producers face when payments are delayed. "As Bangladesh undergoes significant reforms, it's time for our industry to follow suit. We've gained momentum from the recent mass "The demands we've outlined are entirely justified, and addressing them is essential for creating a professional environment within the industry. While there are other issues to tackle, this is the critical first step. By doing so, we can raise our standards to an international

Afzal Mahboob, CEO of Grev. emphasised that their terms and conditions with clients are in line with global standards. "When it comes to advance payments and work orders, we adhere strictly to international rules and regulations," he said. "We ensure that work orders are executed precisely according to Grey's established protocols."

One of the primary concerns is the settlement of previous dues, with producers calling for the immediate payment of outstanding balances that have accumulated over time. Additionally, the association has expressed frustration over the inconsistent issuance of work orders, which often results in production delays and last-minute rushes that place undue strain on resources.

The strike has garnered significant support from other key industry associations. Patients, especially those in critical condition, were put in serious trouble when healthcare workers and medical students called for strikes in public and private hospitals nationwide. However, services in most private and some public hospitals remained unaffected.

healthcare services Emergency resumed at DMCH yesterday as army and Border Guard Bangladesh personnel ensured doctors' security. However, outpatient, inpatient and routine medical services remained suspended, leading to an increased patient load at the emergency department.

The hospital's outpatient ticket counters were closed yesterday morning. Several patients and their relatives unaware of the ongoing strike - were seen waiting for medical attention. Many had travelled from around the city and surrounding areas, only to find that services were unavailable.

Sweden tells parents

Toddlers should not be allowed to watch screens at all, Sweden told parents

Children under the age of two should be kept away from digital media and television completely, the country's Public Health Agency said.

Kids between the ages of two and five should be limited to a maximum of one hour of screen time a day, it said in new recommendations, while those aged six to 12 should spend no more than an hour or two a day in front of a screen. Teenagers aged 13 to 18 should be limited to two to three hours per day, the agency said.

"For too long, smartphones and other screens have been allowed to enter every aspect of our children's lives," Public Health Minister Jakob Forssmed told reporters.

The minister said that Swedish teens aged 13 to 16 spend six and a half hours a day on average in front of their screens, outside of school hours.

The health agency also recommended that kids not use screens before going to bed and that phones and tablets be kept



I had 'every right' to interfere in last polls: Trump

Former US President Donald Trump, who faces federal and state charges for allegedly trying to overturn his 2020 election loss to President Joe Biden, insists he had "every right" to interfere in the election.

"Whoever heard you get indicted for interfering with a presidential election where you have every right to do it?" Trump said in a Fox News interview that aired on Sunday.

A federal indictment accuses Trump of defrauding the United States by preventing Congress from certifying Biden's victory and depriving voters of their right to a fair election. He faced a revised federal indictment last month accusing him of illegally trying to overturn his 2020 election loss.

Trump faces similar charges in Fulton County, Georgia, where he was also charged with racketeering, which is used to target members of organized crime groups and carries a penalty of up to 20 vears in prison.

Trump, who is the current Republican nominee for president, has not said whether he would unconditionally accept the results of the Nov 5 election if his Democratic rival, Kamala Harris, wins.

West should permit Ukraine to launch long-range attacks

Says Zelenskiy, urges them to supply weapons for that

President Volodymyr Zelenskiy yesterday said Ukraine's Western allies should not only allow their weapons to be used for strikes deep inside Russia, but also supply Kyiv with more of the arms themselves.

Ukraine has long urged partners to allow it to fire Western weapons at targets far into enemy territory, and those calls have grown louder as Russian airstrikes on Ukrainian energy installations, other infrastructure and residential buildings

After a meeting with Dutch Prime Minister Dick Schoof in the southeastern Ukrainian city of Zaporizhzhia on Monday, Zelenskiy said Kyiv was "more positive" about the prospects of getting such permission.

"For today, only to allow – is also not enough," he said, adding that allies should ensure deliveries of weapons to use for such attacks. "We didn't

get everything we would like to use," Zelenskiv added.

added that Zelenskiy agreements on supplies had not been fulfilled.

He said he discussed with Schoof strengthening Ukraine's air defences. He mentioned there were "some ideas" on how to increase the fleet of F-16 jets donated by allies, one of which was lost in a crash in Ukraine last week.

"We will keep providing defence equipment, and F-16s, and funding for munitions," Schoof said.

Schoof added that the Netherlands would provide Ukraine with around 200 million euros (\$221.4 million) in support to repair energy infrastructure and for humanitarian assistance.

"Workers at five industrial parks in four districts demonstrated, demanding a minimum salary of Tk 20,000 per month, and other facilities, including leave and holidays during festivals," said Kamruzzaman Kamal, marketing director of PRAN-RFL Group, a leading agro-processor and

He said protests broke out in Ashulia, Savar, Dhamrai and Gazipur yesterday after workers from different sectors took

Factory shutdown an ominous sign

Workers' grievances must be conveyed constructively, not by disrupting production

We are deeply concerned to see production come to a halt at a number of factories due to workers' protests over the past few days. Reportedly, production remained suspended at some 10 ready-made garment (RMG) and 20 pharmaceutical factories on Saturday and Sunday as factory workers staged demonstrations to press home various demands. Assurances of fulfilment of logical demands have thus far failed to dissuade them from demonstrating. This is a troubling turn of events, especially when the country is going through a critical phase of political and economic transition.

Workers have been demonstrating in Savar, Ashulia, Dhamrai and Gazipur areas with demands ranging from job regularisation, pay raise, and lunch allowance to two-day weekly holiday and attendance bonus. Several factory owners said that even though they had sat with the protesters and assured them of fulfilling their demands, the latter continued protests. A top official of a pharmaceutical company said that workers had given 24 hours to fulfil all their demands, even though doing so is not possible in such a short period of time. Several owners also said they shut down their facilities to avoid possible untoward incidents. Meanwhile, workers of an RMG factory said the authorities closed down the facility without clarifying whether their demands would be met.

On Monday, 30 RMG factories in Ashulia were shut down amid protests by job-seekers who demanded "proportional" recruitment of men and women at the factories. RMG industry insiders told The Business Standard that "outsiders" were trying to instigate the workers to create unrest in industrial hubs, taking advantage of the still fragile law and order situation in the country.

This is deeply distressing. We expect factory owners to address the genuine grievances of workers on a priority basis. but agitating workers, too, must understand the gravity of the situation. Suspension of production, especially of export products, has long-term consequences for our exportdriven economy. Supply chain disruptions may lead to loss of business, which will surely affect our export earnings. If this situation persists, Bangladesh's image will be further tarnished, and investors, both domestic and foreign, may further lose confidence. We simply cannot afford that right

We urge the interim government to send out a clear statement condemning the ongoing unrest, and take steps to ensure safety at the factories and restore the confidence of industrialists. Already, businesses have paid a heavy price, thanks to the politically motivated attacks on industrial units following the fall of the Sheikh Hasina government on August 5. We cannot have further disruptions. We also urge the workers to not force unrealistic demands upon factory owners, and pursue peaceful means to engage with the latter. If factories remain shut, their jobs will be jeopardised too. Instead of occupying the streets—which has been causing considerable public suffering—they must pursue dialogue through trade unions and workers' rights bodies. The factory owners, too, must fulfil their legitimate demands as soon as

A step in the right direction

Regular disclosure of assets by govt officials can check corruption

We commend the interim government for its instruction to all government employees to submit their wealth statements. A senior secretary at the Ministry of Public Administration has also said that those who will not do so will face punishment. Currently, public employees are required to declare their movable and immovable assets at the time of joining the service, and later to submit wealth statements every five years. However, in reality, they hardly comply with these rules. The lack of accountability has given rise to corruption in many forms. So, making asset disclosures mandatory is a welcome

It may be recalled that when the Government Servant Conduct Rules-1979 was formulated, government officials were required to submit wealth statements every year. But in 2002, the rules were amended to extend the period of disclosure to five years. On what justifications were the rules changed still remains a question. But then, as if to give public officials a further scope to get involved in corruption, the public administration ministry earlier this year pushed for a change that would have done away with the obligation to submit wealth statements, instead proposing that employees' asset records are collected from their annual tax returns given to the National Board of Revenue. Clearly, these amendments and proposals were made to grant special privileges to public employees, which is quite unacceptable.

Over the past few decades, we have seen how corruption has spread in every sector in the country, from banking to health to energy to transport to construction. Corruption in the public sector is primarily enabled by public officials, and it starts with their very recruitment process. We have recently come across many reports on how question paper leaks have become a regular phenomenon in the BCS exams. Although the Awami League government routinely insisted on "zero tolerance" against corruption, in reality, it did little to uproot it. We witnessed how money laundering and bad loans almost crippled our economy. We saw how investigations into corruption cases were obstructed by the government machinery. The Anti-Corruption Commission, meant to check corruption in public service, could hardly play its mandated role.

These trends must be changed. The time has come to reverse this scenario and build an administration based on accountability and transparency. The mandatory disclosure of assets by government officials can be the first step towards achieving that goal. All advisers of the interim government should also publish their asset details to express their solidarity with this move. People have high expectations from the interim government, and they must not fail them.

The need for a clear charter for the intelligence agencies

That the law enforcement officials including those in the intelligence agencies had dangerously overstepped their jurisdiction and went beyond their charter, if there is any, is a manifest reality. The heart-rending wailings of the victims of enforced disappearance sadly bring to light the arbitrary and predatory activities of a section of public servants. The compounding tragedy is that while the victims' families were complaining and seeking justice for a painfully long time, the government of the day was consistently in denial mode, thus making light a grave human rights violation.

The undeniable facts of enforced disappearance and torture in unauthorised custody like the Aynaghor, now in public view, surely dent our credentials as an orderly and law-bound society. How have we descended into such a deplorable state, and where are the fault lines? Also, what was the apportionment between political executives and the executers on the ground in the wrongdoers' culpability?

It is no secret that intelligence agencies play a leading role in providing political-analytical inputs to the ruling party and its government. However, there are tales of political skulduggery on behalf of successive political regimes. The agencies are known to have undertaken strategic exercises during elections and conduct election forecasts and analysis to oblige the party in power. In doing so, they have become an instrument of partisan politics. The accompanying politicisation or lack of impartiality and objectivity distorted the policy process and damaged the credibility and political legitimacy of the state.

There is credible suspicion that our intelligence agencies lack an acceptable legal framework and a well-honed charter of duties. Consequently, the allegation of its

functioning in a thoroughly political manner cannot be brushed aside. We do not have adequate safeguards and constant vigilance against likely misuse of the powers of intelligence personnel. This requirement assumes greater significance since intelligence

violent means should be matters of concern to the agency, issues like power, politics, factionalism within a political party, and defections must be kept outside the gambit of the tasks of intelligence agencies.

As such, the intelligence agencies should not be the judge of their own operations with regard to the necessity and propriety thereof, nor should they be allowed to operate as politicians' agency or instrument, or degenerate into an institution for controlling the opponents of the ruling party. The agencies must not be engaged in assessing the election prospects of the ruling party and be

disruption of public order through interest of the party in power must be guarded against. Besides, the ruling party must not be allowed to watch the activities of other political parties and even members of its own party.

> The catch-all definition of national security must not be used as a cloak to hide abuses. The definition has to exclude from its purview anything that smacks of denial of human rights and basic freedoms. There should be clear and firm guidelines on the limits to the agency's authority, the areas of coverage, the manner of functioning, and the methods they are permitted to use. The heads of agencies must be accountable to the executive and the legislature. They have to be subjected

Doctors, mob justice and the health sector

The recent assault on doctors at Dhaka Medical College and Hospital (DMCH) marks a deeply troubling moment in our society, highlighting a surge of mob mentality that threatens the sanctity of our most vital institutions. This incident not only demands immediate and unequivocal condemnation but also calls for a broader reflection on the implications of such actions for the future of our healthcare system and societal order.

Medicine is a profession steeped in responsibility, sacrifice, and dedication. The journey to becoming a doctor is arduous, requiring years of intense study, relentless discipline, and an unwavering commitment to the well-being of others. Having a "Dr" before one's name comes with immense expectations—of competence, compassion, resilience,

and integrity. DMCH has been a cornerstone of healthcare in Bangladesh. As one of the oldest and most prestigious medical institutions in the country, it has trained generations of doctors who have gone on to serve both at home and abroad. The hospital itself is a lifeline for thousands of patients daily, offering services that range from emergency care to specialised treatment for complex conditions. Its significance perhaps can never

often under the most challenging conditions.

The doctors at DMCH, many of whom are young and still in the early stages of their careers, are often overwhelmed, working in challenging conditions with limited resources. Despite these challenges, they continue to provide critical care to those who need it most. When such individuals are assaulted, it is akin to an attack on the entire system of care and compassion that they represent.

In a country where healthcare resources are already limited, the erosion of trust between doctors and patients could have catastrophic consequences. When doctors begin to fear for their safety, the quality of care inevitably declines. Fear breeds hesitation, and in medicine, hesitation can be fatal. The psychological toll on healthcare workers—who are already under immense pressure-can lead to burnout, decreased morale, and even a reduction in the number of professionals willing to serve in these high-stress environments. Over time, this could exacerbate the brain drain. with talented doctors choosing to leave the country for safer, more supportive environments abroad. Such a loss would be irreparable, further exacerbating the healthcare challenges we face.

I think that the attack on DMCH be overstated: it has consistently doctors is symptomatic of a broader provided care to the most vulnerable, issue plaguing our country: the rise

of mob mentality. When individuals or groups take justice into their hands, they undermine legal institutions and create an environment of fear and uncertainty. This is especially dangerous in the medical field, where decisions must often be made quickly and under immense pressure. that they are protected from unjust retribution. Without this assurance, the very essence of medical practice is compromised.

At the same time, it is also important to understand that the anger and frustration that lead to such incidents do not emerge in a vacuum. They are often rooted in deep-seated grievances, whether real or perceived, about the quality of care, the accessibility of services, or the conduct of medical professionals. While violence is never an acceptable response, these grievances must be acknowledged and addressed through transparent, accountable mechanisms. The interim government has a crucial role to play in this regard.

They must ensure that any allegations of medical negligence are investigated thoroughly and impartially, with clear communication to the public about the findings and any subsequent actions. Accountability, grounded in justice and not in vengeance, must be maintained on all sides

Owing to the instability we are currently experiencing, the interim government must take decisive action. They must ensure the safety of all medical professionals. This is already being done by increasing security at hospitals, particularly in high-risk areas like emergency rooms where tensions often run high. Legal frameworks must be strengthened to deter violence against healthcare workers, with swift and decisive action taken against those who violate these laws. There is also a need for broader public education on the realities of medical practice, including the inherent uncertainties and risks involved in medical treatment.

Furthermore, this incident should prompt a national conversation about the values we hold as a society. The respect we accord to those who dedicate their lives to public servicewhether in medicine, education, or other fields-reflects our collective commitment to the common good. When we allow violence to go unchecked, we signal that the rule of law is secondary to the rule of the mob. This is a dangerous path, one that leads not to justice, but to chaos. This is something we are yet to combat as a nation.

We cannot think of the DMCH incident as an isolated event as it is a stark reminder of the dangers of mob mentality and the urgent need to protect our healthcare professionals. The safety and dignity of our doctors are not just their concern; they are the concern of all who depend on them-indeed, the concern of the entire nation.

In 1849 French writer Jean-Baptiste of people living at home and abroad was Alphonse Karr wrote: "The more things change, the more they stay the same." This may be briefly interpreted to mean that despite drastic societal changes, certain fundamental aspects are so deeply rooted that they remain unchanged overtime, unless consciously and decisively addressed.

The criminal investigation for a serious offence in Bangladesh generally begins with a written complaint—General Diary (GD) or First Information Report (FIR) lodged at a police station usually by a victim or a relative, but sometimes by someone individuals. This complaint forms the basis on which those individuals may be arrested and remanded in police custody for up to 15 days and then in prison until trial, unless bail is granted at some stage. They spend months or years incarcerated while still innocent in the eye of the law. It may be months before the strength of the case is assessed by the court. The principle, formulated in the 19th century by the British rulers, is that arrest and incarceration first and investigation later. No regard for human liberty, no respect for the truth—it served the purpose of keeping a subject race down by instilling the fear of mass arrest and incarceration at will. Inheriting this legacy through the Pakistani rulers, the successive governments in Bangladesh found it expedient to keep the colonial concept

The impact of the injustice of the inherited system is less apparent when a government in power is relatively tolerant of the rule of law. But an authoritarian regime, such as the one which has just been overthrown, takes full advantage of the system—resulting in numerous false cases against innocent people, torture in police custody and imprisonment for months without charge. It is no wonder that Bangladesh's ranking in the World Justice Project Rule of Law Index has gradually fallen to 127 out of 142 countriessandwiched between Zimbabwe and Mozambique—in the last 15 years. The score is even worse when the criminal justice system is singled out within the rule of law context.

In "the 36 days of July 2024," Bangladesh was shaken to the core. The seismic transformation swept away an authoritarian and murderous regime. The sacrifice by the students and the efforts

not expected was that the same arbitrary method of arrest and investigation process. befitting only of the regime as brutal as the one overthrown, would be followed.

On August 21, 2024, the Ministry of Home Affairs issued a circular directing the police not to refuse GDs, FIRs or complaints and to process them speedily. Cases are now being filed on a daily basis in all parts of the country. It is not unusual for a murder allegation to name over 400 individuals as suspects. There have been incidents of arrests and remand of individuals, who may have been suspected of financial crimes or other misdemeanours, but there is not a shred of evidence connecting them with the murder offence in question.

This trend needs to be corrected urgently. This is because it brings the interim government into disrepute. Secondly, while the international community and the rights organisations at home and abroad have not spoken out yet, they are certainly observing the developments closely. Thirdly, the interim government would not be able to persuade any foreign government to return those suspects, who have managed to flee the country, when such arbitrary arrests and incarceration are prevalent in the country. Fourthly, as Barrister Sara Hossain has pointed out, the way these cases are being framed, they will not be able to pass the initial stage. Thus, many are likely to be discharged before the trial stage since no real efforts seem to have been made to collect independent and forensic evidence. Imagine the scenario, where these individuals walk out of prison with the hero's welcome from their followers.

In Bangladesh, wholesale reform of the criminal investigation and justice system is necessary for it to be compatible with the values associated with the rule of law. It is beyond the scope of this article to discuss such reform. However, the interim government could consider giving several directives to the police and court as a first

These directives can include ordering police to register complaints themselves in relation to as many cases of the killings as

possible, conduct the initial investigation as to the person who actually did the act. and then follow the chain of command upwards to where the order had initiated from. Police officers, who have actually committed the act of killing or injuring, must be interviewed as suspects, while bearing in mind that some of them may have acted in self-defence and others may invoke the defence of duress from their

Besides, only the victim, a relative of the victim or someone in some tangible way affected by the crime should be allowed to lodge a complaint, GD or FIR. The document must have a declaration of truth, with the warning that if it is later found that the complainant has knowingly provided false information, they may be prosecuted for an offence. Also, an arrest should only be made when the officer in charge is satisfied that there is a reasonable suspicion that the person has committed the crime in question. The basis of that suspicion must be recorded. The individual must be told the allegation for which they have been arrested. Moreover, the officer in charge must ensure the prisoner's total safety to and from the court. Where facilities are available, with the consent of the prisoner, interim hearings could take place via video link allowing the prisoner to appear from a

suitable room in prison. Regarding remand in police custody, it should be an exception rather than the rule. The police must strictly justify why they need further time in police custody. The magistrate or the judge must give sufficient reason for allowing police remand. Meanwhile, a suspect must be offered to have a lawyer of their choice, registered with the bar council, present during the police interview and interrogation. The suspect must be informed that they do not have to answer questions, but that in such circumstances, the court would be at liberty to draw adverse inferences from their refusal to answer questions. Where a suspect complains of physical assault in police custody, the magistrate or judge before whom they appear, unless found not to be credible, must order an examination of the person by an independent medical professional and submission of the medical report to the court.

As the interim government took charge, its declared mantra was reform, reform, reform—which resonated well with the people. In that spirit, the above steps would be a good start as the current government embarks on reforming the criminal investigation and justice system.

A case for democratic reforms in universities

The recent mass uprising, which began as the quota reform movement, had a unique characteristic. In many public universities, including Dhaka University, we witnessed the ruling party's student body being driven away from the residential halls.

After the chaos subsided, during my regular morning walk, I noticed many new changes on the Dhaka University campus. In front of Mohsin Hall, I saw various belongings of Chhatra League members in the dumpster. I also came across a PVC banner that read, "Politics is banned here from this day. From now on, no one can force a student to attend a political gathering or the guest room."

The banner indicated that the antidiscrimination movement had given students a platform to unite and express their solidarity.

Living in a university residential hall traditionally provides students with opportunities to improve their lives, both academically and non-academically. Therefore, students who experience economic hardship often prefer to live in these halls, hoping to achieve their long-cherished dreams.

Unfortunately, until now, the halls had been transformed into places where ordinary students faced heavy oppression.

The halls had operated without a proper seat allocation system for students. The student wing of the former ruling party essentially managed the halls with unofficial authority, allotting seats to themselves. As a result, students lost their dreams and hopes, facing nightmares in their residential halls. This is how many "shikharthi" students become "gundarthi" (hoodlums). And the university administration's teachers have served as enablers in the transformation of bright students into goons.

Universities should be proper educational institutions in every sense, and student halls should be places where residential students can learn how to be fair and just in their social and educational lives. Now that a platform of unity has emerged among the students, they are endeavouring to erase their memories of living in such nightmarish environments. For that reason, the hall administration must perform the responsibilities of maintaining these halls, which is supposed to be a routine institutional

The aforementioned PVC banner clearly exemplifies this. As discussed above, the two main demands were that no one should be forced to attend political programmes or be sent to guest rooms against their will. These are their biggest concerns, and they are trying to escape them. They are striving for a system where their dreams do not turn into nightmares and where the administrative system supports them in achieving their goals, completing their education, and doing something meaningful with their lives.

Autocracy, oligarchy, and dictatorship at the state level have enabled and even encouraged mismanagement in all forms of government and organisational structures. As such,

universities are not exempt from this. Whenever we talk about the 1973 Dhaka University Order that guides the university's operations, we take pride in it. We rightly appreciate that it ensures freedom of speech, expression, and the right to speak. However, it also inherently contains certain autocratic

elements.

For example, as per the order, the Vice Chancellor (VC), in some exceptional cases, can overturn any rule, suggestion, or decision already made by any administrative body. But these "exceptional cases" have become everyday practices. This is just one example. Even in selecting the VC, his or her academic or administrative qualifications do not matter. The chancellor appoints him or her based on their political identity. The same goes for the recruitment of teachers.

If we examine the list of past provosts, we see how different they were from the current ones in terms of their wisdom and personality. Some of the current provosts did not even have the required qualifications to become teachers, yet they became provosts. This practice is not limited to provosts or VCs only; it also applies more or less to many of the administrative

Partisan identity had become a deciding factor in their appointments. This does not mean that this factor was present only in the past 16 years. However, the former regime took this malpractice to an extreme and unparalleled level.

The same issues extend to the Dhaka University Teachers' Association.

As a bargaining agent, the Teachers' Association is supposed to negotiate with the university administration and the government for the best interests of teachers. There should be debates and negotiations from both sides. However, teachers who are already in administrative positions often contest elections for posts in the association with the advantage of easily getting votes from junior colleagues, which can lead to their election. Under these circumstances, it is difficult to discern who is making whom accountable and how.

After the fall of the Hasina-led autocratic regime, the opposition party is trying to reestablish its position. As a result, anarchy seems to be on the rise, with personal agendas and witch-hunting, targeting people who had associations with the ruling party in some cases. Without proper administration, it seems like students are preparing lists to decide which teachers will stay and who will not. The situation has become quite unruly in some places, with registrar's offices and other administrative buildings being targeted.

We are forgetting that this is an educational institution. Of course, teachers with allegations against them must be investigated, and justice must be served—there is no doubt about that. But all of this must go through

Anarchy is not the solution. It will destroy the integrity of the university. If this practice continues, it will not ensure a stable environment for the university or government. What we need is creative leadership in the administrative process that brings back the original structure and upholds the spirit of the people's uprising and sacrifices.

The leaders need to create a structure and a plan with the goal of state reform. They should reform higher educational institutions, including universities, to establish a studentfriendly, democratic administrative body that dismantles the autocratic structure. This will pave the way for a bright future for students and bring about a brighter tomorrow.

Addressing dual citizenship in public offices in Bangladesh

Recent developments, such as the apprehension of retired Justice AHM Shamsuddin Choudhury Manik, who admitted to holding both Bangladeshi and British citizenship, have sparked concerns regarding dual citizenship in high public offices. This issue is particularly significant given the constitutional and legal restrictions surrounding dual citizenship for officeholders in Bangladesh.

Reports suggest that several highranking officials, including police officers, civil bureaucrats, and members of parliament during the Awami League government, held dual citizenship. It is alleged that Sheikh Hasina knowingly appointed or allowed these individuals to continue in office due to their unquestioning allegiance to herself and her government. Such practices undermined the constitutional framework and created conflicts of interest that had eroded public trust in the government.

Article 66 of the Bangladesh Constitution explicitly disqualifies individuals holding dual citizenship from serving in public offices, including members of parliament. This disqualification is rooted in the principle of ensuring exclusive loyalty to Bangladesh, which is critical for maintaining the integrity of the country's governance structures.

The interim or future governments should conduct a thorough review of the citizenship status of all public officeholders. This review could involve cross-referencing immigration records and legal documentation to ensure full compliance with constitutional requirements..

To prevent future violations, we propose the implementation of an oath system for all public job seekers. This oath would require individuals to declare that they do not hold citizenship of another country and that they will not seek or accept foreign citizenship while holding public office. Such a system would formalise the expectation of exclusive national loyalty and serve as a deterrent to potential conflicts of interest.

The enforcement of these measures could set a strong precedent for upholding constitutional principles in the country. It would reinforce the importance of national loyalty in public service and ensure that the country's governance remains free from divided allegiances. However, the successful implementation of these reforms will require political will and robust legal frameworks to ensure that enforcement is fair, transparent, and universally applied.



Allan Donald (AD): One of my biggest challenges was to get the fear factor out of the dressing room. What I mean by fear factor is that guys are a little bit fearful of making mistakes. I always knew that every single one of these guys had unbelievable talent, natural talent and great wrists. But for me, the biggest challenge was always going to be to work with them mentally, make them understand what a pack mentality means and how to combat the fear. For me, it was about constantly reminding our group of the process. I think slowly, within a year, we started to get the rewards. I think the biggest thing was for them to trust me, that I'm always with them and not to worry about making mistakes. I think once the acceptance happened, they trusted me. I never talked about mistakes and always gave positive reinforcement. I was giving the guys roles within the group. I made them feel wanted and watching them now in the cricketing scene is a great satisfaction for me.

I met Nahid Rana a couple of years ago in Chattogram where he was part of a young group that came to play against Sri Lanka. I was really excited about watching him. I'm glad he has now got a role. Seeing Hasan Mahmud doing so well, a five-fer today [yesterday], and Nahid with a four-for, it's so, so amazing to see how these guys have stood up now and running with the process. I think that's the most amazing

DS: Bangladesh now regularly picks more pacers in home and away Tests. them perform like they have in the

The Daily Star (DS): The Bangladesh How do you see the change?

AD: I think it's all about mindset.

Test cricket is brutal and you have a pack of bowlers who have the collective mindset of hunting hard and exerting pressure on every single ball. I still speak to them regularly in their WhatsApp group. We had a good time in the WhatsApp group last night [Sunday]. The belief of this group is now at a stage that I have never seen before. It's just so satisfying to see them run with the process and this is the reward against the very strong Pakistan side. Pakistan is the hardest place in the world to go bowl. But to do that back-to-back in a venue

like Rawalpindi, which can be so flat and tough to bowl, I take my hat off to that group.

Hasan Mahmud was a regular in the white-ball setup before transitioning the Test into side, was intentional?

AD: I remember Russell Domingo's words to me before I met Hasan Mahmud. He said you will be impressed by a young man called Hasan Mahmud. He can play all formats. He even said that he thinks Hasan's Bangladesh's most skillful bowler. He rated him like this back then and I agreed. I asked Hasan, do you want to play Test cricket, and he said yes. For me, the message was always that he's going to prove that he can play all formats. I am so, so pleased that he is in the Test side. It was intentional and it was always planned. I expected that at some point you were going to see

two-match Test series in Pakistan. It's hard on Khaled Ahmed, who is a regular in Tests. But the bowling group is so strong that you can go and pick three different people on different surfaces.

DS: With so many matches coming up, how crucial will it be to manage the workload of the pacers?

AD: You want to be in a position when you can rotate and you can give guys two Test matches off. I think that's what Australia do so well. Because they have such a conveyor belt of quicks, they can rotate and rest other guys.

Workload management is absolutely crucial so vou can have three guys fresh for the next series. I think Bangladesh don't have much time before their next series in India.

DS: Where do you see the Bangladesh pace attack in the next five years?

AD: I just want them to keep growing. This would be the biggest achievement in the history of Bangladesh cricket from the pace bowling point of view. You just can take this confidence now and keep building. The learnings and confidence out of that are just superb. I think they should search for more young crops and the pool of young fast bowlers in Bangladesh must continue to get bigger. The more this group grows, the more learnings will be passed on to the youngsters. I think they need to make the pool bigger and find youngsters.

Hasan Mahmud's five-wicket haul was his first in Tests and the first-ever by a Bangladesh pacer against Pakistan.

Hasan's 5-43 is the fourth-best figures by a Bangladesh pacer in

He became the seventh Bangladesh pacer to complete a fifer away from home after Manjurul Islam, Robiul Islam, Shahadat Hossain, Rubel Hossain, Ebadot Hossain, and Khaled Ahmed.

Bangladesh pacers have taken five-wicket hauls on 11 occasions overall in Tests. Hasan's five-for is the eighth time that a pacer has taken five wickets overseas. The last time a pacer achieved the feat at home was when Shahadat Hossain picked up five against India in 2010.

Hasan's fifer, Nahid Rana's four-wicket haul and Taskin Ahmed's solitary scalp meant that Bangladesh pacers accounted for 10 wickets for the very first time in their history in a single innings of a Test.

The lowest total that Pakistan have ever defended in a Test at home is 198 against England in

Nahid Rana took giant strides vesterday in showcasing he is the 'X-factor' in that Bangladesh pace battery. His raw pace hurt Pakistan, but in the manner in which he dismantled the hosts showed there was a matured head on his shoulders.

He clocked 152kmph yesterday in Rawalpindi but it was the sheer confidence with which he set up batters titled the Test match in Bangladesh's favour.

Shan Masood was looking good but in Nahid's very first over, he was late to a slash through point twice, and the second time it happened, the Pakistan skipper was caught behind. Babar Azam was too late to his defensive shot and the result was similar. Mohammad Rizwan was beaten by a gem of a delivery that just whizzed over the stumps, the delivery too good to take a nick and in that very same over, he produced another gem to remove Saud Shakeel. Three wickets in three successive overs, Nahid competed for a fifer with Hasan Mahmud and ended one short with a haul of four for 44 in 11 overs.

A few weeks ago, the 21-year-old speedster had been training alone at Mirpur's Academy Ground before the Pakistan Tests when this reporter queried on what he had been working on. 'Reverse-swing' came the reply, with his customary smile. By the end of the session, he was getting it to tail in quite a bit. Before leaving, Rana informed he had bowled eight overs on that hot day but the smile said he was happy with the effort.

The fire to improve had to be there and his coach in Dhaka Premier League (Shinepukur) and Bangladesh Premier League (Khulna), Talha Jubair, feels the fire is what keeps Nahid ticking.

"Yes, he has that drive. I have seen him from pretty early and if he did not have that, he would not arrive at where he is now," Talha told The Daily Star yesterday.

"Whatever I told him, he took care of those aspects word for word," Talha said.

A former pace star himself, Talha had been watching Nahid since the days and says Nahid had bowling big no balls at the which eventually led to making the U-19 World squad. Talha talked with local coach Alamgir Kabir Chapainawabganj to fix

that he only worked run-up. His smooth action will allow him to bowl at more pace in future but it is his accuracy that will make the difference," Talha noted.

However, coaches identified that pace should not be compromised on, instead length was something that was focused on and in Rawalpindi, Pakistan batters' struggled because of length.

"He is still young. If you tell him to keep runs in check rather than bowl at pace, he will not be Rana anymore. You have to let him bowl at pace. You can't tell him not Nahid's to bowl fast but rather get accurate at pace. I worked f r o m with him in BPL too and told him not to compromise the issue. on pace, rather talked about his lengths. DOCTORS' PROTESTS Regular services stay suspended at DMCH

Emergency dept struggles to cope with huge rush of patients

With no inpatient or outpatient services amid a strike following an assault on a doctor, the emergency department of Dhaka Medical College Hospital (DMCH) yesterday witnessed a heavy workload. The protesting doctors, however, agreed to resume

treating outpatients from 10:00am to 1:00pm and inpatient care on a limited scale from today. They said the emergency department would remain open as before.

They reiterated their two demands at a press conference around 4:00pm yesterday, where Abdul Ahad, resident surgeon of DMCH neurosurgery department, spoke to the reporters on behalf of the protesting doctors.

The demands include the arrest and punishment of the culprits who attacked the doctor. Physicians also want the introduction of a health police force under the Directorate General of Health Services (DGHS) to ensure the security of healthcare workers at hospitals.

The protesters announced a sit-in programme to be held from 8:00am to 10:00am today.

The doctor came under attack after the death of a private university student from road crash injuries on Saturday. The attack was carried out allegedly by the SEE PAGE 6 COL 5

Israeli forces killed at least 48 Palestinians in the past 24 hours across the Gaza Strip as they battled Hamas-led militants, Palestinian officials said yesterday, while medics conducted a second day of polio vaccinations for children in the enclave.

80,000 children had been vaccinated in central areas of Gaza on Sunday, the first day of the campaign.

Hamas and Israel have agreed to brief pauses in fighting to allow the campaign to vaccinate some 640,000 children to go ahead. No violations have been reported near vaccination facilities.

Meanwhile Israeli protesters took to the streets for a second day yesterday and the largest trade union launched a general strike to press the government to reach

a deal to return hostages still held by Hamas, after six more captives were found dead in Gaza.

The strike disrupted transport and medical services in several Israeli districts and many shops and businesses were closed after the head of the Histadrut union, which represents hundreds of thousands of workers, called a national stoppage.

The recovery at the weekend of the six hostages, who authorities said were shot dead between just 48-72 hours before being found by Israeli forces, triggered a wave of grief and fury in Israel, prompting at least half a million people to take to the streets in Jerusalem and Tel Aviv on Sunday.

The demonstrators are demanding Prime Palestinian and UN officials said more than Minister Benjamin Netanyahu reach a ceasefire

agreement with Hamas to bring the remaining 101 hostages home.

thousands Yesterday, again gathered in Tel Aviv, waving blue and white Israeli flags or carrying photographs of hostages.

Washington, In President Joe Biden said he was close to presenting a final proposal for a deal to release the hostages but said he did not think Netanyahu was doing enough to secure such an agreement.

MONSOON RAINS

Short-term flood may hit parts of country in Sept Death toll climbs to 67; Feni hospital struggling

At a time when the country is still recovering from last month's devastating floods, the Met office has issued a warning about potential short-term flooding in certain northern, northeastern, and southeastern areas due to heavy monsoon rains this month.

However, the overall rainfall in the country is expected to remain at typical levels in September, according to the Bangladesh Meteorological Department (BMD).

"One or two low-pressure systems may form over the Bay of Bengal, with the potential for one to develop into a monsoon depression."

September rainfall predictions indicate that Sylhet division may experience 365-450mm of rain, Chattogram 285-350mm, Rangpur 375-460mm, and Rajshahi 285-345mm. Other regions, including Khulna, Barishal, Dhaka, and Mymensingh, are expected to receive between 250mm and 385mm of rainfall.

The forecast was made during yesterday's BMD's expert committee meeting on long-term weather

In August, Bangladesh experienced 46.2 percent more rainfall than usual. The national average rainfall in August is 612mm over 22 days.
