Six killed as violence flares again in Manipur

Six people, including one civilian, were killed as fresh violence broke out between two warring ethnic communities in the northeast Indian state of Manipur yesterday, authorities said.

The majority Meitei community and the tribal Kukis have clashed sporadically since last year after a court ordered the state government to consider extending special economic benefits and quotas in government jobs and education enjoyed by the Kukis to the Meiteis

More than 225 people have been killed and some 60,000 have been displaced in the violence so far.

Yesterday's gunfire incident represents the most number of casualties for a single day in the latest spurt of violence that began a week ago. The attacks earlier this week have also seen the use of drones to drop explosive devices in what authorities have called a significant escalation.

Police say they suspect that the drones were used by Kuki militants - a claim denied by Kuki groups.

"Fighting has been going on between armed groups of both the communities since the morning," said Krishna Kumar, deputy commissioner of the state's Jiribam district where the clash occurred.

JOINT DRIVE 53 firearms recovered in last 3 days

A total of 53 firearms, including an AK-47, have been recovered in a joint drive for the last three days.

As many as 25 suspects were also arrested during the joint drive, the Police Headquarters (PHQ) said in a statement yesterday.

Members of the armed forces, Border Guard Bangladesh, Coast Guard, police, Rab, and Ansar took part in the drive.

The other firearms recovered during the drive include two revolvers, 18 pistols, two rifles, 11 shotguns, one pipe gun, six shooter guns, three LGs, three guns, one gas gun, one Chinese rifle, one airgun and three singlebarrel breech loader firearms.

Enamul Haque Sagor, assistant inspector general (media) of the PHQ, told The Daily Star yesterday that the joint drives targeted three types of firearms: those stolen or lost from the police, SSF, and other security forces; firearms with suspended licences; and illegal firearms.

"It will take time to open the terminal for passengers as the necessary manpower will have to be recruited and they need to get training," the CAAB chairman said.

Subsequently, the terminal will not be operational for another year and a half, according to CAAB officials.

The state-of-the-art terminal was partially opened by former prime minister Sheikh Hasina on October 7

The CAAB and the civil aviation on various occasions ministry announced that passengers will be able to use the third terminal from October

But CAAB suffered its first setback when Aviation Dhaka Consortium (ADC), the contractor for the terminal, could not finish its necessary works before the April 6 deadline.

Subsequently, CAAB extended the deadline for handover by five months.

ADC, a consortium of Mitsubishi Corporation, Fujita Corporation and Samsung C&T Corporation, began the construction of the third terminal on December 28, 2019.

The government contributed Tk 5,000 crore towards the cost of the third terminal, with the rest of the amount coming from the Japan International Cooperation Agency in the form of

The third terminal will boast a floor space of 230,000 square metres, housing 115 check-in counters, 66 departure immigration desks, 59 arrival immigration and 3 VIP immigration

Upon full-fledged operation of the third terminal, HSIA's annual passenger and cargo handling capacity is expected to double.

The annual passenger handling capacity of the HSIA would be 24 million (including the old terminals). At present, the Dhaka airport can handle eight million passengers and 500,000 tonnes of cargo each year.

the spot after the incident primarily suspected that the explosion occurred when workers were trying to break open the fuel tank of the scrapped ship. Following the incident, the injured were taken to Chittagong Medical

College Hospital (CMCH). Ten of the victims are in critical condition, said Prof Dr Rafique Uddin Ahmed, head of the Burn and Plastic

Surgery Unit at CMCH. As critical patients require fulltime ICU facilities, we had to send seven patients to Dhaka due to a shortage of ICU beds at CMCH," said Brig Gen

Taslim Uddin, director of the hospital. Abul Kashem, executive member of the Bangladesh Ship Breakers and Recyclers Association (BSBRA), told The Daily Star that the dismantling of the ship, around 8,500 tonnes, had nearly been completed.

"The incident happened when the workers went to inspect the fuel tank in the ship's engine room before cutting it open," he added.

He went on to say that BSBRA would form an inquiry committee to identify the cause of the incident.

SN Corporation has a green compliance certificate for shipbreaking yard.

Contacted, Md Barkat Ullah, chief executive officer of SN Corporation, said, "This is a certified green shipbreaking yard. Every ship undergoes inspection before being dismantled. Similarly, this ship too was inspected. So, we are also shocked by this incident. We will conduct an internal probe to find out why and how the explosion happened.'

SN Corporation owner Showkat Ali Chowdhury could not be reached on the phone despite several attempts.

Around three lakh livestock have been affected by floods in Noakhali.

Abul Kalam Azad, Noakhali district livestock officer, reported an estimated loss of around Tk 44 lakh due to deaths of livestock.

Over 85,000 fish enclosures and ponds have been washed away in the district, leading to a loss of around Tk 576 crores, said Noakhali District Fisheries Officer Mohammad Igbal. "I have been farming fish for

around 16 years. All my 10 enclosures and four ponds have been washed away," said Rahima Akhter Baby, 45, of Darbeshpur village in Noakhali Sadar upazila.

In Cumilla, crops on around 70,000 hectares have been spoiled, causing a loss of around Tk 850 crores, said the district agriculture "I farmed vegetables on around

3 bighas, but the crop has been damaged. I have incurred a loss of around Tk 70,000," said Rup Miah, a farmer from Kamarkhara village in the district's Burichang upazila. Some 2,500 fish enclosures and

ponds have been washed away, resulting in an estimated financial respective districts contributed to loss of Tk 400 crores, said District this report.

Around 2 lakh livestock have been affected by floods, causing a loss of around Tk 350 crores, said Chandan Kumer Poddar, Cumilla district livestock officer. In Moulvibazar, crops on around

15,221 hectares have been damaged, leading to a financial loss of around Tk 205 crores, according to the local DAE office. Over 41,000 farmers have been

affected by floods, said Samsuddin Ahmed, deputy director of DAE in the district. "I cultivated Aman paddy on

around 23 decimals. But my entire crop has been damaged," said Saifur Rahman, a farmer from Patanushar village in Kamalganj upazila.

Floods in Brahmanbaria have damaged crops on around 8,326 hectares, causing a financial loss of around Tk 219 crores, according to the local DAE office.

At least 1,188 ponds in the district have been washed away, resulting in a monetary loss of around Tk 20 lakh, said Rounak Jahan, acting fisheries officer of Brahmanbaria.

In the interview with PTI last Sunday, Yunus criticised ousted prime minister Sheikh Hasina, now in India, for commenting on the developments in Bangladesh.

He also said India should move beyond the "narrative" that every political party other than Hasina's Awami League is "Islamist".

"If India wants to keep her until the

time Bangladesh wants her back, the condition would be that she has to keep quiet," Yunus said. "Sitting in India, she is speaking

and giving instructions. No one likes it. It's not good for us or India," he added. There has been no comment so far from India on Yunus's remarks.

The chief adviser is scheduled to leave Dhaka for New York on September 22 on a five day visit to the US.

Govt moves to rein in easy ride to secy post

Some competent officials were indeed deprived of promotions during the AL's 15-year rule, they added.

However, after the interim government took power, many took advantage of the situation and managed promotions as additional secretaries. Now, they are lobbying for promotion to secretaries, ministry sources said.

Soon after the interim government took power, some officers got multiple promotions within days.

Babul Mia, a 15th batch BCS cadre, was promoted to deputy secretary on August 13, joint secretary on August 15, and additional secretary on August 18.

Former secretary and public administration researcher AKM Abdul Awal Majumder said, "Some officers deserved promotions because they were deprived for a long time while others did not. But, when a promotion to the post of secretary is concerned, experience is crucial."

The new decision to require oneyear experience is good, he told The Daily Star.

A Cabinet Division official, requesting anonymity, said some of his senior colleagues were genuinely deprived of the post of a secretary.

He lauds the recent contractual appointment of several retired 1982 batch officers as secretaries to the

ministries of education, home, and health. Those officers have a good reputation.

In the same vein, other skilled officers who were deprived should be duly recognised.

corrupt or incompetent individuals are appointed in top posts now, the government will suffer, he warned.

A secretary, speaking on condition of anonymity, said the non-partisan government which does not want to stay in power for long, can set an example by rewarding the right individuals.

In 2001 and 2009, several officials were promoted under the BNP Awami League governments, bypassing the standard practice.

A government official, who was recently promoted from deputy secretary to additional secretary in just a week, said, "If the government implements the new decision, those of us who were genuinely overlooked will continue to remain so. I urge the government not to enforce this restriction when it comes to the truly deserving individuals. If needed, they can take examinations."

communal and audacious statement." Brig Gen Azmi was detained for eight years in Aynaghar, a secret detention centre of the military intelligence, through enforced disappearance during the Awami League government's tenure. He and many other detainees were released after the AL government's fall in

The citizens said they have been vocal against such human rights violations and are still against these types of activities. "We want justice for all victims of enforced disappearance, including this former military officer."

"But we would like to remind him that freedom of expression does not mean one can speak whatever one The statement by the citizens said

Azmi "deliberately insulted" national anthem and the principles of Bangladesh's constitution to hurt the emotions of the country's people. It noted hundreds of thousands of youths, students, farmers, workers, members of the armed forces, and police irrespective of their faith, race, gender and ethnicity made the supreme sacrifice to liberate the country. They had to face the cruelty of the Pakistani military and its collaborators, including the Jamaat.

"The people of this country have remembered this history for generations and will continue to remember. No one should dare to ask for forgetting this history."

The 48 signatories also warned against pitting the recent studentled mass movement against the Liberation War. People trying to do so are "enemies of the victory of the anti-discrimination movement", the statement said. "All need to be careful so that no

quarter can use this victory, achieved through the deaths of hundreds of students, children, adolescents and other people, for their malicious partisan and communal interests," the statement added.
