# Country must be back in business without delay

Bankers, factory owners and telco CEOs suggest a way forward for the economy as they join a roundtable organised by Star

Amid worker unrest and insecurity in the industrial sector, entrepreneurs and bankers have urged the new administration to focus on rebuilding confidence in the

Businesses suffered heavily because of street protests and internet blackouts with production disrupted and shipments delayed during the anti-discrimination student movement that toppled the Sheikh Hasina government on August 5.

The political turmoil in Bangladesh has significantly impacted the economy, eroding the confidence of both domestic and international investors. The police force, fearing reprisal attacks, was hesitant to return to work, further worsening the situation. Worker unrest fuelled more concerns later.

Now, Bangladesh must make sure that the country is back in business and also needs to set a communication strategy for channelling the information to the domestic and international business community, according to Syed Nasim Manzur, managing director of Apex Footwear Ltd.

Nasim Manzur and other entrepreneurs and bankers shared their ideas about short and long-term measures at a roundtable titled Current Business Challenges & Way Forward, organised by The Daily Star at its office in Dhaka yesterday.

Mahfuz Anam, editor and publisher of The Daily Star, moderated the discussion. SECURITY AND UNREST

Speaking at the roundtable, Sk Bashir Uddin, managing director of AkijBashir Group, said the elephant in the room is the law and order situation. "Of course, I was personally almost assaulted in one of my factories," he said.

Rupali Chowdhury, managing director of Berger Paints Bangladesh, described the "huge labour unrest" as "a dire problem' for the manufacturers.

are turning to the army but confusion remains over whom to talk to to resolve the issues raised by the workers, she said.

"So ultimately, they [entrepreneurs] do not know who to contact and how to run the factory. This is going to give a certain amount of uncertainty for the multinational companies who are actually investors. They are seeing that this kind of labour unrest happens and there is nobody to support them," Rupali said. REGAINING CONFIDENCE

Normalcy appears to be returning slowly to the industrial sector now with the workers and law enforcers getting back

to their jobs, while army personnel have joined the efforts to ensure safety in the industrial belts.

Nasim Manzur suggested ensuring safety in the five major industrial belts, including Ashulia, Narayanganj, Narsingdi, Chattogram and Cumilla so that no further untoward incidents take place in these industrial zones.

He mentioned that several factories were burnt out or vandalised, which impacted the production and business of these industries heavily as a section of people took advantage of the volatility.



# 39 more DCs likely to be withdrawn within a day or two

New ones may be appointed a day after withdrawal; 25 districts get new DCs

The interim government is likely to withdraw 39 more deputy commissioners within a day or two.

It will appoint new DCs to the

districts a day after the withdrawal, said sources of the Cabinet Division and the public administration

ministry. The decision has been made to expedite the fieldlevel administration activities that became slow after the fall of Awami League government on August

5, they said. Meanwhile, public administration ministry yesterday appointed 25 DCs

withdrawn on August 20. It issued a gazette notification to this effect.

The DCs are the head of civil administration in the districts. They play a vital role in overseeing local

governance, ensuring the effective delivery of public services, and maintaining law and order. "The government will issue a

# Power outages on the rise again

Power cuts are getting more frequent as power generation has failed to keep up with the high demand caused by the rising mercury.

For instance, the power generation shortfall hit nearly 2,000 megawatts (MW) yesterday -- the highest in recent weeks, according to data from the Bangladesh Power Development Board.

From this month, PDB has started

demand of 16,200MW, which is much area of Mymensingh. higher than the previous month's average. Last month, the demand was 14,000MW to 14,500MW.

The temperature in Dhaka is now in the mid-30s during the day.

Rajshahi, Rangpur, Cumilla, Mymensingh and Sylhet areas are mostly affected by power cuts, the PDB data shows.



# Two cops arrested over Abu Sayed's murder

Two suspended police personnel were arrested in connection with the killing of Abu Sayed, a student of Begum Rokeya University, on July 16 during a student movement in Rangpur.

Rangpur Metropolitan Police arrested Assistant Sub-Inspector Md Amir Ali and Constable Sujan Chandra Roy and subsequently handed them over to the Police Bureau of Investigation (PBI) in Rangpur.

Amir was posted at Tajhat Police Station while Sujan was posted at Rangpur Metropolitan

PBI Superintendent of Police Md Zakir Hossain confirmed the arrests yesterday, saying that the two officers had been under surveillance at the police lines before their arrest.

According to a press release issued by the Rangpur Metropolitan Police, Abu Sayed, a student from the 12th batch of the English department, was shot and killed by police during a student-led protest at Begum Rokeya University on July 16.

On August 18, Abu Saved's elder brother, Ramzan Ali, filed a murder case with Tajhat Police Station, naming 17 individuals as suspects. ASI Amir Ali and Constable Sujan **Chandra Roy were** among the accused and had been suspended from duty on August 3 prior to their arrest.

Development Fund (EDF). He also recommended overhauling the overburdened insurance sector and setting up priorities for reforms in key sectors.

Khan Ahsan Chowdhury, chairman and CEO of PRAN-RFL, said: "In terms of export, we are nervous because of unpredictability in Bangladesh."

"We have to see how quickly we can make Bangladesh more predictable so that we can continue to fulfil our export demands. We have to involve all respective ministries and secretariats to this end," he said.

About agriculture, he said the government needs to think deeply about fertiliser import and other needs of the farmers to reduce production costs. "We have to think how we can grow more agricultural products that have got the potential

to reduce food inflation," he said. Bangladesh Bank Governor Ahsan H Mansur said business associations bear more responsibility for restoring

confidence in the economy. Industries are national assets and these need to be protected, he said and added, for the greater interest of the industries, the central bank is not freezing bank accounts of any business group.

The governor also emphasised putting an end to extortion and corruption. "If extortion can be stopped, the cost of doing business will fall a lot. A section of government officers accumulated a lot of wealth by using public offices like land registration and passport offices. These should stop.

He assured that he would not deprive any business unit of its "oxygen", namely the credit line.

"Optimism will be generated with committee. the work we deliver. 'We' means the government as a whole.

"There is a nervousness regarding export. There is no question about it. I have been getting calls from inside, from outside as well," he said. "The destruction at the Gazi Tyres

factory is a sad affair. It shouldn't have happened. It should have been protected," he said, emphasising the need for political reforms. "Without political reforms, no other reform will be lasting," the central bank governor said.

Mansur said there is a lot of misinformation, disinformation and also "some genuine concern which needs to be very clearly addressed".

For example, he said he got a phone call from the US on Monday that some of the big companies were very much concerned and would shift their orders if some large factories

were not allowed to operate. "My answer to them was that not a single company has been prevented from operating. We have to fight those things collectively and also individually in our respective

capacities," he said. Mansur also spoke about the formation of three separate taskforces for streamlining the banking sector.

AkijBashir Group's Bashir said it is "sad" that the buyers are dictating the terms most of the time. "I think this needs to change," he said.

Multinational banks are earning a lot of money just by confirming the credit of the local banks. Bashir said. "This is an aggregate lack of confidence in the overall financial industry and this needs to be relooked."

Ali Reza Iftekhar, managing director of Eastern Bank Ltd, urged the BB governor to revisit the Banking Company Act.

He said he was a part of the committee that finalised the act. But at the last minute when the act was Governor Mansur said optimism about to be placed in parliament, many things were omitted and

be backed by credible steps as well. changed without the consent of the

"So, I request the governor that we can relook at the Banking Company Act and try to re-establish those things."

If the law is amended with recommendations from the industry, it will be richer and more effective, Ali Reza added.

Mahfuz Anam said The Daily Star will be a key platform to discuss all important business issues.

"Please don't shy away," he said, inviting the participants to suggest ideas that need to be covered in the newspaper.

"If the economy grows and can be more efficient, more productive, there are more jobs created, then Bangladesh moves ahead," he said. EASE OF DOING BUSINESS, DIGITALISATION

Ali Reza also suggested measures for ease of doing business and to increase the cash flow in the banking system, as in some cases even Tk 5 lakh cheques are bounced back.

Selim RF Hussain, managing director and CEO of BRAC Bank, said the area that the country needs to focus on very strongly is real digitalisation.

"We need to learn from India: the cost of doing business, ease of doing business. The cost will come down significantly if everything will move into the official channels," he said.

He said about 50 to 60 percent of cash is now outside the banking system. If everything becomes digitalised, similar to China, undisclosed income and funding in the unofficial sector will go away.

At the same time, government's revenue will increase when everything will be recorded.

Syed Mahbubur managing director and CEO of Mutual Trust Bank, said the foreign exchange rate was not fixed timely. He suggested further strengthening the central bank for ease of doing

Md Miarul Haque, a director of the Foreign Investors' Chamber of Commerce and Industry (FICCI) and managing director of DHL Express, called for simplification of the customs procedures and for bringing more transparency in the business processes. He also suggested eliminating face-to-face interaction in business processes to curb corruption.

He suggested proper implementation of the Trade Facilitation Agreement to reduce time in business processes.

TELCOS AND TECH Yasir Azman, CEO of Grameenphone, that although said telecom companies act and innovate locally, and solve the problems for Bangladesh, they need foreign investors to bring global best

practices in technology. He recommended restoring investor confidence in the country and presenting the nation as an opportunity for them.

According to him, the industry's main challenge is the heavy tax burden, with a corporate tax rate of 40 percent. "We actually at times get confused about who our regulator is. Our regulator is also a collector."

He said as a CEO for the last four to five years, he had to spend more time on resolving financial disputes with the regulators than on focusing

on innovations. Rajeev Sethi, CEO of Robi Axiata, said the government needs to think about what is the role of the telecom

industry and how to treat it. have been treated in the past? Or are we a force multiplier? We believe the latter. Is it just to maximise the revenue or is it a maximum dividend for the people? I think it's always better in case we do the latter," he

# People suffer as students block road

Students from Polytechnic Institute and other technical institutions blocked Satrasta Mor in Dhaka's Tejgaon for six hours yesterday, causing severe traffic congestion and immense sufferings to commuters.

Hundreds of students of the Bangladesh Technical Education Board gathered at the intersection around 11:30am under the banner of "Karigori Chhatra Andolon".

Their six-point demand include reserving the designation of deputy assistant engineer solely for diploma engineers, ensuring four-year courses for diploma engineering, limiting each semester to six months, and calling for 100 percent seat allocation for diploma engineering students in the four proposed engineering colleges to expand higher education opportunities.

management and engineering dams, barrages, and embankments must be re-evaluated.

She also called for the government to create a comprehensive list of the country's dams, assess their conditions, and evaluate their engineering integrity.

Sheikh Rokon, secretary general of Riverine People, highlighted the need for unified agreements for all shared rivers.

"While it is often said that we have 54 transboundary rivers, the actual number is 123. Not all of these are covered in agreements. Therefore, we need agreements for all our rivers," he said.

Mihir Biswas, joint general secretary of the Bangladesh Environment Movement, stressed the importance of ensuring river navigability while avoiding environmental damage. He also called for better disaster preparedness related to the rivers.

Abu Sayeed Khan. advisory editor of Samakal, who attended the seminar as the chief guest, concluded by emphasising the need to preserve the country's riverbased civilisation.

"Just as we have established maritime boundaries, we must do the same for our rivers," he said.

The National Human Rights Commission (NHRC) yesterday took suo motu cognisance of a story published in The Daily Star on September 8, 2024, titled "Baby girl sold to pay injured father's hospital bills," asking the deputy commissioner of Dinajpur to submit a report on the news.

The commission is gravely concerned by the contents of the report and has initiated action to ensure the rights of the affected family, said an NHRC press release.

NHRC has directed the DC of Dinajpur to investigate the matter and submit a report by October 15.

This includes ensuring proper treatment for Abdur Rashid, gathering the couple's views on the situation of their sold child, and verifying the child's welfare. Additionally, the commission has called for financial assistance to be provided to the family, it added.

In the suo motu, the commission termed the incident a tragic violation of human rights.

# 'Shono Mohajon': The unlikely anthem that became the voice of a generation

In the sweltering summer of this year, as Bangladesh erupted in what would later be known as the July Revolution, an unexpected soundtrack emerged from the chaos. Shono Mohajon, a song released nearly a decade earlier by the local band Shunno, suddenly found new life as the unofficial anthem of a nation in upheaval. This feature explores the journey of the song, its creators, and the profound impact of music on social

The birth of an unlikely anthem

Formed in 2007 by vocalist Imrul Karim Emil and former lead guitarist Shaker Raza, Shunno quickly established itself as a prominent voice in Bangladesh's music scene. The band, completed by bassist Andrew Michael Gomez, drummer Rafatul Bari Labib and guitarist Ishmamul Farhad, had already tasted success with their song Shoto **Asha** becoming the unofficial theme for the 2011 Cricket World Cup in our country. However, it was **Shono** Mohajon, a track from their earlier days, that would ultimately define their legacy.

Written by popular lyricist Shahan Kabondho and produced by Fuad Al

Muqtadir, Shono Mohaion was not created with any specific political agenda in mind. As Emil explains, "When we made the song 9-10 years ago, we didn't target any political party." Instead, the song spoke to a universal experience of oppression under dictatorship, its lyrics a poignant cry against abuse of power:

"Amar bichar tumi koro, tomar bichar korbe ke

Kobe tomar dokhol theke, mukti amay

Shono Mohajon, ami noyto ekjon Shono Mohajon, amra onekjon."

The chorus loosely translates to:

"You judge me, but who will judge you? When will you free me from your control?

Listen, lord, I am not alone Listen, lord, we are many."

As students took to the streets in July as part of the anti-discrimination student movement, demanding an end to the corrupt governance and repressive regime, Shono Mohajon found new resonance. Its lyrics, once a general critique of power structures, now

Students used the song as background music for countless social media reels documenting the protests, spreading its message far beyond its original reach.

The band, touring in Canada at the time, watched in awe as their creation took on a life of its own. "We were surprised and proud to see the mass circulation," Emil recalls. "We were out of the country at that time, but we felt happy that we could contribute to the cause through our music."

On July 30, as the protests reached a fever pitch, Emil changed his profile picture to solid red, an act of solidarity with the students back home. Meanwhile, in Toronto, the band dedicated their performances to the protesters, using their platform to raise awareness about the situation in Bangladesh.

As the country enters a new era of newly-found freedom of expression, the music industry stands at a crossroads. The potential for a renaissance of creative expression is immense, but so too are the challenges. Emil and the band see both opportunities and responsibilities for artistes. "Since now we have got the 'license' to tell stories, hopefully, we will be able to tell more interesting, compelling stories now," Emil muses. He emphasises the importance of artistes staying conscious and continually challenging those in power. "Asking the right, conscious questions will help in the long run. We, as musicians and artistes, can also raise questions through our creation."

Michael, the band's bassist, expresses optimism about the potential for more authentic and diverse artistic expression: "Other musicians and artistes who could not fulfil their artistic potential due to censorship would be able to exercise the newly found freedom, and I am really happy for them." However, Emil also notes the importance of responsible use of this freedom, particularly in an age of misinformation. "The youth are much more aware now. People verify every piece of news before believing it. So, if censorship is eliminated, I am sure people will make good use of it," he says.

Regarding the reform of the music industry, Emil suggests, "We should welcome all kinds of music," advocating for more diverse representation in music events and festivals. He also emphasises the need for established industry associations to provide better resources and guidance to emerging artistes, helping to build a strong foundation for the next generation of musicians.

The legacy of **Shono Mohajon** serves as both an inspiration and a caution. It reminds us of music's power to unite and inspire, but also of the need for critical engagement with the art we consume and create. As Bangladesh's artistes step into this new era, they carry with them not just the opportunity to create and express freely, but also works that can be reinterpreted, or to the weighty responsibility of shaping cultural narratives and social discourse.

sent separate letters to local and police administration, medical colleges, media houses, and university authorities and sought information concerning the student movement.

In a letter to all metropolitan commissioners, commissioners, and superintendents of police, the agency sought a list of casualties between July 1 and August 5, information about graveyards and a list of martyrs buried there, information about any mass grave and list of martyrs buried there, names and addresses of victims' families, and the role of law enforcers and the then ruling party cadres in quelling the movement.

In a letter to all directors of medical college hospitals and civil surgeons, the agency sought a list of the casualties, their attendants, and treatment-related documents.

In a letter to all editors of the national dailies and the heads of news at TV channels, the agency sought reports that quoted the speeches or comments given by the then ministers, advisers, lawmakers, party leaders, and law enforcers to suppress the movement and stories or footage related to killing, mass killing, torture, confinement, disappearance, arson, etc.

In a letter to vice-chancellors of the public and private universities the agency sought information about students, teachers, and staffers who were killed or injured and information about the role of law enforcers and the then ruling party

cadres in quelling the movement.

Sheikh Hasina, who was ousted on August 5 following a student-led mass uprising, is facing 12 charges of crimes against humanity and genocide.

Eleven complaints were filed in connection with the recent student movement, while another complaint was connected with the crimes committed centring the Hefajat-e-Islami rally in Dhaka in May 2013.

Besides Hasina, her party leaders and several journalists, were also included in the complaints filed with the ICT.

Hasina-led government formed the International Crimes Tribunal in March 2010 to try the people who committed crimes during the Liberation War in 1971. Later, a second ICT was formed.

At least six BNP and Jamaat leaders were executed for their 1971 crimes following the ICT verdicts.

Filing of complaints with the investigation agency started after Law Adviser Asif Nazrul on August 15 said the interim government decided to hold the trial at the International Crimes Tribunal for the killings during the mass uprising that toppled the Hasina-led government.

## Fuel tanker explosion in Nigeria kills at least 59

AFP, Lagos

A fuel tanker exploded after colliding with a truck carrying passengers and cattle in northern Nigeria, killing at least 59 people, a rescue agency said yesterday.

Photographs released by the Niger State Emergency Management Agency or SEMA showed workers burying more than a dozen blackened and charred bodies of victims from Sunday's early morning incident.

Images showed burnedout shells of the vehicles, one still billowing with smoke and flames after the incident in Niger's Agaie local government district.

Ibrahim Husseini, spokesman for the Niger SEMA, told AFP the number of fatalities had risen to 59 yesterday from an initial toll of 52, when more victims were discovered in the wreckage and one of the injured died.

On Sunday, most of the victims were given a mass burial.

"It is possible that more dead bodies could be discovered," Husseini said in a text message.

The explosion happened after a petrol tanker loaded with PMS (fuel) collided with a trailer truck loaded with travellers and cattle, according to SEMA.

Two other vehicles, a crane and a pickup truck, were also involved, it added, while more than 50 cattle were burnt alive.

Fuel tanker explosions are common in Africa's most populous nation, where roads can be poorly maintained, and residents often look to siphon off fuel following accidents.

According to the Federal Road Safety Commission (FRSC), more than 5,000 people died in road accidents in Nigeria in 2023, compared to nearly 6,500 the previous year.

# Iran sent missiles to Russia

Says EU citing 'credible information' as war rages in Ukraine

AFP, Brussels

The European Union yesterday said its allies had shared "credible" intelligence Iran had supplied Russia with ballistic missiles, a claim rejected by Tehran but not explicitly denied by the Kremlin.

US media outlets reported last week that Washington believed Iran had transferred the weapons to Russia for use in Ukraine, citing anonymous sources.

"We are aware of the credible information provided by allies on the delivery of Iranian ballistic missiles to Russia," EU spokesman Peter Stano said.

"We are looking further into it with our member states and if confirmed, this delivery would represent a substantive material escalation in Iran's support for Russia's illegal war of aggression against Ukraine."

Stano added that "the EU leaders' unanimous position has always been clear. The European Union will respond swiftly and in coordination with international partners, including with new and significant restrictive measures against Iran".



Iran's foreign ministry vehemently rejected the accusations.

The West has been warning Tehran against sending Russia missiles for months, and the EU has already repeatedly hit Iran with sanctions for supplying drones to Moscow for the war in Ukraine.

"We strongly reject the claims on Iran's role in exporting arms to one side of the war," Iranian foreign ministry spokesman Nasser Kanani said during a weekly press conference.

The Kremlin did not issue a denial on Monday when asked specifically about the Wall Street Journal report that Iran had sent missiles.

"We have seen this report, it is not every time that this kind of information is true," Kremlin spokesman Dmitry Peskov said.

"Iran is our important partner, we are developing our trade and economic relations, we are developing our cooperation and dialogue in all possible areas, including the most sensitive areas."

The United States has said any deliveries would invoke a "severe" response and damage Tehran's efforts to improve relations with the West following the election of reformist Masoud Pezeshkian as president.

Faced with punishing Western sanctions, Moscow has turned to Iran and North Korea for weapons supplies to keep its war machine going in Ukraine.

Ukraine says it has been attacked with Iranian-designed Shahed drones on an almost daily basis from Russia, and has found fragments of North Korean missiles on its torritory.

The reported delivery of missiles to Russia comes as the Kremlin has once again stepped up its bombing campaign against Ukraine's key infrastructure ahead of winter.

# Vietnam death toll from Yagi jumps to 59

AFP, Hanoi

The death toll in Vietnam from Typhoon Yagi jumped to 59, state media reported yesterday, as business leaders said the storm had been a "disaster" for the country's vital manufacturing sector.

Yagi, according to meteorologists the most

powerful typhoon to hit northern Vietnam in 30 years, downed bridges, tore roofs off buildings and damaged factories after making landfall on Saturday carrying winds in excess of 149 kilometres (92 miles) per hour.

Power blackouts caused major disruptions to

Power blackouts caused major disruptions to factories in northern Vietnam, which is a major production hub for global tech firms such as Samsung and Foxconn.

The north was also battling serious flooding yesterday, with several communities partially underwater.

The storm killed 59 people in Vietnam, state media reported, 44 of them in landslides and flash floods. The death toll had earlier been put at 21.

At least 24 others were killed as Yagi tore through southern China and the Philippines before hitting Vietnam.

Some 1.5 million people were still without electricity in Vietnam yesterday and a major bridge across the swollen and fast-moving Red River collapsed in northern Phu Tho province.

## AFGHANISTAN 'VICE' LAW UN rights chief voices 'abhorrence'

AFP, Geneva

The UN rights chief yesterday slammed Afghanistan's latest laws curtailing women's rights, decrying the "outrageous" and "unparalleled" repression of half the country's population.

Speaking before the United Nations Human Rights Council, Volker Turk made clear his "abhorrence of these latest measures".

The Taliban government in Afghanistan published a widely criticised law in August further tightening restrictions on women's lives.

The new "vice and virtue" law dictates that a woman's voice should not be raised outside the home, and that women should not sing or read poetry aloud. It requires them to cover their entire body and face if they need to leave their homes, which they should only do "out of necessity".

These measures, Turk pointed out, come on top of previous measures that included "forbidding girls from attending secondary school and women from attending university; denying women's rights to freedom of peaceful assembly, opinion, expression and freedom of movement; and severely curtailing women's rights to seek employment".

# Can we change the story of our banks?

Restoring trust in the sector crucially important

The extent of damage done to the banking sector during the Awami League's 15 years of rule is truly shocking. Despite this daily's frequent coverage of various irregularities during its tenure, and more transparency emerging in the wake of the mass uprising that brought down Sheikh Hasina, the true scale of corruption in the banking sector seems unfathomable, with new revelations coming to the fore every day. This just shows how daunting the challenge will be for the interim government as it sets its sights on reforms and recovery. Nevertheless, it must perform its duties diligently.

The new administration has already taken some positive steps in this regard. The decisions to form a banking commission to undertake reforms and a task force to identify key areas of concern are notable. According to this daily, the Bangladesh Bank (BB) has also decided to rescue struggling banks, including some Shariah-based banks formerly controlled by the S Alam Group, by managing liquidity or merging a few. It is important to note that the old regime had promised similar objectives. However, instead of working towards them, it gave preferential treatment to corrupt, politically connected bank owners and stakeholders, which further compromised the health of these banks, put depositors' funds at risk, and damaged the economy as a whole.

In contrast, the present authorities are believed to be supporting these banks for three main reasons: to safeguard the country's economy, to protect depositors, and to assist customers involved in production. These are the exact factors that should drive all reform decisions. Though many of the banks were mired in corruption, their bankruptcy would cause significant harm to both depositors and the economy. The central bank is therefore obligated to try to rescue them, but it must do so in the right way and for the right reasons. For instance, as the central bank has now promised, it must avoid providing liquidity support by printing money—as was done before—and instead allow lenders to access support through inter-bank money supply, with the BB acting as the guarantor for struggling banks. Additionally, the BB must ensure that these banks take every possible measure to recover defaulted loans in order to alleviate their liquidity crisis. So far, most of the banks have not performed well in this regard. That needs to change.

Reportedly, out of the Tk 70,000 crore that left the banking sector, Tk 30,000 crore has been recovered. This, along with the government's decision to insure up to Tk 2 lakh for each depositor, should help restore some confidence in the sector. While we welcome the direction in which the banking sector is moving under the interim government, coordinated efforts involving various agencies-including the Anti-Corruption Commission (ACC), Criminal Investigation Department (CID) of police, and home and foreign ministries, among othersare essential to recover the remaining funds. They should also complement the long-term reform measures currently

# Stop armed violence at Geneva Camp

Dismantle groups fighting over drug trade, ensure safety

We are concerned at the repeated incidents of violence at the Geneva Camp in Dhaka's Mohammadpur area in recent weeks. According to a report by this daily, since the fall of the Awami League government, clashes between armed gangs inside the camp have become common as drug dealers are trying to take control of the area. Locals have reported hearing gunshots almost every day, which was not the case before. Over the past month, two men were also killed in such gunfights. The situation remains tense, requiring immediate attention from the authorities.

The Geneva Camp has always been known as a hub of drug dealers. Reportedly, there are various groups involved in drug trade, and clashes generally occur over establishing supremacy. For example, in April, a major clash occurred between rival groups over controlling the trade. And after August 5, new players have entered the scene trying to take control of the trade. Particularly, the rampant use of firearms has raised alarms among the residents of the camp and adjacent areas. From the photos and video clips taken by locals during the clashes, police assume that the firearms were probably looted from police stations earlier last month. If that is the case, our law enforcers should immediately take action to recover them.

According to data from the Police Headquarters, 5,829 firearms including rifles, SMGs, pistols and shotguns were looted in early August from police stations across the country. Of them, 3,933 were initially returned. And the joint drive led by armed forces, which began operations since September 4, has thus far recovered 53 more firearms. There are concerns that if the remaining weapons are not recovered soon, those could be used to cause further violence by criminals.

The residents in and around the Geneva Camp are living in fear because of the rampant clashes, with many young people also getting involved in them, which is a serious concern. The law enforcement agencies must take prompt actions to tackle the dual threats of drug trade and illegal firearm use. It's time a joint operation was also conducted in the camp to dismantle the threats posed by these illegal drug businesses, which many camp residents have also urged. Ordinary people must not be held hostage by criminal groups.

# An education memorandum

Action priorities for the interim government

Yunus addressed the nation on August 25, two weeks after the student-led mass uprising put the interim government led by him in power, education was not expected to be on top of the agenda. But he did make four important points: i) the misrule of the past government has maimed the education system and has created chaos at all levels of education; ii) taking the initiative for a comprehensive reform in education is a pledge of the interim government; iii) work on developing a curriculum fit for the changing times will begin; and iv) an urgent task is to resume the activities of the educational institutions in a creativity-generating, safe and learner-friendly environment.

Speaking about the multitude of demands arising from the "state repair" agenda put forth by the mass uprising, Prof Yunus said, actions on various reforms have already begun and the process of consultation would have to continue. The interim government has to decide guidelines for the minimum reform targets to achieve, and where to begin. In this regard, the ultimate decision has to emerge through political consultation. The time frame for reform—i.e., the decision about the life span of the interim government-will also emerge from political dialogue involving all citizens, including students, he said.

A CRIPPLED EDUCATION SYSTEM Fourteen years ago, the government adopted a national educational policy setting the guidelines for educational development. The key objectives of the 2010 policy remain unmet: i) a core unified curriculum for all types of school education with a minimum common standard of school provisions for all students; ii) major change in the professional training of teachers, their performance standards, their status and incentives, and assurance of adequate numbers;

Researchers see development in subsectors of education as fragmented and partial, devoid of a holistic view of the sector. Government actions have not addressed the root problems; they have reacted to symptoms, often without success.

Public investment in education has remained at or below two percent of GDP—one of the lowest among developing countries. Under the present structure of planning, management and accountability, larger budgets are actually likely to create more waste, inefficiency and mismanagement.

When Chief Adviser Prof Muhammad much fanfare, has become an example of partial and fragmented action without adequate preparation for major required collateral steps. The curriculum has caused widespread anxiety and confusion among students, teachers and parents. It has put students' future at risk.

#### THE EDUCATION PRIORITIES

As implied by Prof Yunus in his speech, the interim government needs help in at least two areas: a) advice on immediate and short-term steps required for restarting the educational institutions and their normal activities, getting rid of the egregious practices of the past that vitiated the academic operations and environment of the institutions; and b) ideas for long-term changes. The interim government may take up some major decisions; for others, a reform process may be initiated with the outcomes to emerge over a longer

the frustrations of stakeholders. A comprehensive and well-structured approach is necessary to ensure a smooth transition. Most educationists want a pause in the rollout of the new curriculum. In order to minimise disruption, two steps can be taken: i) textbooks already introduced in some grades under the new curriculum may continue and existing textbooks may be used for other grades; and ii) conventional end-of-year or public student evaluation based on written examinations should continue, separating formative and practical work-based evaluation in classrooms from summative written examinations.

A pause spanning a year or so should be used to review and rethink the curricular reforms, particularly student evaluation, a highly controversial aspect of the new curriculum, and effective implementation in classrooms. Experts and stakeholders should be involved in this rethink.

#### **MEDIUM-TERM ACTIONS**

Initiate a continuous curriculum development process: curriculum reform mechanism and process should be initiated in a holistic way for the entire school education, understanding curriculum as an ongoing process rather than a singular event. Core


programme should be initiated with businesses and private sector social enterprises to enhance employment generation and skill development. Good examples should be supported and employers' bodies should be involved in creating social businesses for employment generation and skill development.

Pilot projects in decentralising management: The decades-long talk about decentralising education governance should take concrete shape through initiating a pilot project of decentralisation, establishing district education authorities for finance, planning and management.

This list is not exhaustive. An education consultative group would consider and advise on both the short-term and medium- and longerterm policy questions, and might come up with other issues deserving priority attention. Being strategic means having a choice of actions with probable success, rather than attempting many things all at once.

#### FROM RHETORIC TO ACTION: HOW TO GO ABOUT IT

An education consultative group of experts and stakeholders should examine the status of and priorities in the education sector and advise the interim government. They would examine the issues and suggest actions



should be articulated, action plans pathways. made, actions implemented, and progress monitored and evaluated.

#### URGENT AND SHORT-TERM **ACTIONS**

Restarting with a "new normal":

The extraordinary recent events call for urgent actions. Students need to be in school and normal operations need to resume. A "new normal" has to be defined at each level of education, renouncing many past practices. At the university level, the University Grants Commission (UGC), in consultation with students and other stakeholders, should provide guidelines, but not seek to micromanage. Each institution should consult students, teachers and parents at the school level in implementing the guidelines.

Right people at the right place: The recent spate of resignations in top university and other positions and the demand for resignations in institutions point to the need for the right people in the right place. Appointments must be based on merit, not political or other considerations. The process must ensure impartiality through clearly defined job qualifications and use of search committees. A professional UGC can facilitate the process and consult teachers and students. To fill the vacuum in administration, people may be placed in institutions and key education administration positions for a short term, with regular appointments made through due deliberation.

Elected student unions: With their sacrifice and maturity demonstrated in the recent popular movement, students have earned the right to a role in managing the education and co-curricular activities of their institutions. This opportunity should be created by forming non-partisan elected student bodies in institutions, beginning with universities and

Pause and rethink the new curriculum: The interim government has begun to take steps to address the ongoing contentious issues.

foundational skills: One of the priorities should be a national assessment of primary-level students' ability to read and do basic arithmetic, and actions based on the assessment to reach these targets. Bangladesh could adopt the simple biannual early grade ASER (Annual Status of Education Report) reading and arithmetic athome surveys, which was pioneered by Pratham in India and adopted in several countries.

Invest in teachers: Steps should be taken to increase the number of teachers, strengthen the quality of teacher preparation, and provide teachers with a career path. Teachers' professionalism and performance are the pivot of change in education. A reimagined teaching profession should attract and retain the best talents in the profession. Teachers' and other education workers' preparation, performance standards, status, incentives, remuneration and career path should be redesigned and applied across the board for all schools, state and non-state. Teachers should be the role model for their students. This rethinking about teachers will be a longer-term task, but it should begin in earnest now.

Unify school education under one ministry: A unified government leadership and policy guidance should be established by bringing all school education, pre-school to preuniversity, under one ministry. This would be important in the context of decentralising education governance with planning and decisions devolved to district, upazila and institutional levels.

Bring in industry experts: A

subjects across all school systems are on the matters noted above. They longer-term vision. This group may commission as recommended in the 2010 National Education Policy. The consultative group should consider priorities and steps related to SDGs and national goals for building an equitable, inclusive and quality education system for all.

This larger agenda would include: i) promoting an equitable society through education; ii) a time-bound plan for equitable and inclusive early childhood development and K-12 school education of acceptable quality for all; iii) strengthening the teaching profession and the education workforce in respect of their professional skills, motivation, performance and adequacy of numbers, as well as the effective use of digital technologies; iv) establishing decentralised district education authorities for planning and managing equitable K-12 education in every community; and v) ensuring academic autonomy of the education system and education institutions, protecting

them from partisan politics. As Prof Yunus envisaged, there has to be systematic consultation and dialogue with all stakeholders, not token gestures. The energy and idealism of students and the youth have to be harnessed to this end. A social compact on education has to be backed up by a political consensus.

The interim government is not expected to complete all the needed reforms. But if it realises at least some of the key reforms and charts the way ahead for others, it will have done justice to the sacrifices of students and citizens during the July-August movement.

# Can we break the cycle of migrant exploitation?

of due process in terms of the sentencing, as well as a glaring lack of support from relevant ministries and officials in Bangladesh prior to the chief adviser's intervention, point towards a worrying status quo for migrants. It is clear that, working in precarious conditions under repressive regimes with little knowledge of their rights (and limits to it), our workers are on paper celebrated for their role in propping up the economy, but in reality, they are isolated, ignored, and left to fend for themselves.

Nothing makes this stark reality more obvious than the huge number of migrant workers that continue to return home in body bags and coffins. Last year, a record 4.552 Bangladeshi workers died abroad, with a majority of these deaths occurring in Gulf states. Almost all of them were chalked up to "natural causes," despite rights groups arguing that unsafe working conditions, including lack of protections against extreme heat, are a major driver behind these untimely deaths.

We have seen this most recently in the Malaysia recruitment chaos, where thousands of workers spent their life savings, yet never found employment. Currently, Bangladesh has the highest labour recruitment costs in South Asia, a large proportion of which is spent on bribes and illegal fees. These fraudulent practices are not only a crushing burden on ordinary workers, but it harms the economy by creating a trust deficit with host countries and limiting access to labour markets. In 2023, an average of 8,200 Bangladeshis were travelling to the UAE every month, whereas this year, the figure has dropped to 6,500 per month, reportedly due to employers' reluctance to take on workers who

brokers who work as go-betweens for them and agencies. Ensuring easy access to information is a necessity to protect workers, as is a particular authority, preferably separated from recruitment, where complaints can be lodged regarding such unscrupulous practices. The recent events in the UAE have

made it clear that workers' ability to organise and collectively bargain for their rights in destination countries are severely restricted. Given how vulnerable this makes them, it is shocking that over the past few decades, so little effort has been put into creating a proper bureaucratic infrastructure and setting up support systems that migrant workers can directly access. In contrast, if we are to look at the Philippines model for inspiration, we will find that their foreign consulates hold a resource centre for migrants, as well as a specific migrant workers office and social welfare attachés in host countries. We can definitely take a leaf out of their book in terms of building a migration management system, streamlining migrationrelated bureaucracy and investing in human capital, alongside updating labour laws to protect migrants.

We have also witnessed recently that a little bit of diplomacy can go a long way. It is time for us to realise that there is safety in numbers, and to collaborate with India, Pakistan and other South Asian countries with big migrant populations to put pressure on destination countries. One immediate push that is needed is health coverage for our workers. For too long they have been treated as dispensable, receiving little to no healthcare and being unceremoniously kicked out of their workplaces after might ultimately fail to meet legal falling ill. example by introducing a social insurance system for both nationals and migrant workers that covers sickness, and it is high time for us to raise our voices so that others follow suit.

If you're wondering whether such efforts will ultimately hamper migration, it must be clear by now that there is an obvious power imbalance between migrant importing and exporting nations that devalues our workers, especially if they are "unskilled." But if the July uprising has taught us anything, it is that power cannot be endlessly abused. Alongside dealing with the exploitation of workers within our own economy, we must also tackle global exploitative practices headon, whether it is in the migrant labour sector or in the RMG industry. If the Qatar World Cup is an example to go by, Saudi Arabia will also rely heavily on migrant workers for construction if it is to host the 2034 FIFA World Cup. It is high time for host countries to come to the realisation that they need us as much as we need them too.

authoritarian regime and interim government in place, the expectations and demands of people in Bangladesh are skyrocketing, and there is a desire to take full advantage of new opportunities and possibilities. In a similar vein, conservationists and natural resource management professionals expect the management of forests and other resources to be more effective now, protecting the long-term interests of the country and its population.

Previous regimes were more concerned about success stories in all sectors, with fabricated success carefully covering unattended challenges. Political interference was widespread in institutional decision-making, leading to wastage of public resources, ignorance of expert opinions, and forsaking of participation and stakeholder consultation. Against this backdrop, the Forest Department and other related agencies gradually drifted far from their due course.

The interim government may weigh on several issues that I believe are crucial for transforming the public forest management system into a more transparent and accountable one.

One such issue is data tampering and the misrepresentation of facts. It has been customary, over the past decade, to present exaggerated scenarios in terms of achievement. For instance, the data regarding national forest cover, which was shown to be around 12.6 percent, while it is in reality around 8.6 percent. These has immense bearing on our national forest coverage targets, and the targets against the relevant SDGs, policy, plans, and strategies, as the distorted data places us on an impractical trajectory.

Therefore, the scholarly demand is to correct the course through as reserved forests, while most of updating Bangladesh's actual forest cover data, and reconsider various deputy commissioners representing national targets accordingly.

To ensure resourceful forest conservation activities, the Forest Department has drafted a forest policy and a forestry master plan using huge debt investment; it has been awaiting approval for eight years. These forest policy and forestry master plan should be discussed, approved and implemented immediately before these become obsolete.

Even more concerningly, the Forest Department does not have the capacity to prevent encroachment. Even though enormous lands-104,000 hectares-have already been encroached, the fieldlevel staff are still putting their life at risk to prevent encroachment and hill-cutting, resulting in physical assaults and even death of forest personnel in the recent past.

Shockingly, the Government and Local Authority Lands and Buildings (Recovery of Possession) Ordinance, 1970 currently in use did not retain the legal power of divisional forest officers for eviction, which was in the earlier ordinance. After sending the list to the deputy commissioners, the Forest Department must wait for the eviction orders and the appointment of magistrates. By the forest is already encroached upon and destroyed. Actions for evictions, if ever, are taken from the office of the deputy commissioner. However, these are often purely populist, bowing down to the wishes of political leadership.

If forests and wildlife habitats are to exist, necessary legal power needs to be given to stop encroachment and protect them. The misuse of appropriate forests cannot go on any further. forest People should stand up for forests,





Besides, recognizing Gold, Silver and Bronze positions in each category, entities that achieved a minimum threshold of scores are awarded the "Certificate of Ment." Overall winner has been selected from the winners which achieved maximum awards in 3 (three) categories of BPAR, CGD and IR. For the year 2023, RCPAR received 76 annual reports for evaluation. Out of the 76 annual report/entities, 22 were awarded with Gold, Silver and Bronze and 8 were given merit certificates for Best Presented Annual Reports, across 11 sectors. Similarly, 3 entities were awarded Trophies, and 3 received 'Merit Certificates' for 'Corporate Governance Disclosures. In the 'Integrated Reporting' category, 4 entitles were awarded Trophies, and 3 were given 'Men't Certificates'. Also overall winner has been selected following the SAFA guideline in this regard. The awards for the Infrastructure and Construction, and Agriculture

categories could not be considered because the participating entities scored below the threshold

The Annual Reports of these organizations have been evaluated following the criteria formulated by the South Asian Federation of Accountants (SAFA) which judges the compliance of the entities in respect of adequate disclosures and meaningful reports on transparency, accountability & integrity; thus ensuring good governance in the financial activities, operations and management of these entities. It also brings a greater sense of responsibility among the management of these entities towards safeguarding the interest of the stakeholders, society & environment and compliance to laws, rules & regulations in these regards.

Review Committee for Published Accounts and Reports (RCPAR) of the Council of ICAB diligently & objectively evaluated and assessed disclosures and the information provided in the Annual Reports of these organizations. It may be mentioned here that only a part of the annual reports is audited, e.g., the financial statements, which are prepared following the International Financial Reporting standards. # Tigers look to take fight to India with balanced attack

Bangladesh are going into the India series on the back of a historic away series sweep against Pakistan. Their previous tour of India in 2019 hadn't gone to well for them but all-rounder Mehedi Hasan Miraz is adamant that this time the side is ready for the 'fight' against the 'big side'.

On Sunday, India named their squad for the first Test with all their major redball stars in the mix. Their home record, unlike Pakistan's, is formidable, having won against strong sides like England and Australia in home Tests in the last two

Miraz hoped that the momentum from the Pakistan series will help them bridge the gap between the two sides.

"Every series is challenging. I feel that since we have done well in Pakistan and there is not too much gap [between series], everyone is in a good rhythm. If we can continue the same way, we can expect good results," Miraz told reporters in Mirpur yesterday.

"India is that obviously a very big side. If we think about performing instead of focusing on results, that would help us achieve positive outcomes at the end of the day," he added.

The Tigers had spoken about being competitive ahead of the Pakistan series, which they eventually won 2-0. The talks in the camp before the India has been similar with Miraz saying he wanted to put up a tough fight against India.

In their last trip to India, Bangladesh were blown over by India's pace bowlers and conceded an innings defeat in both Tests. This time, however, spinners are expected to come into play in the two-Test series in Chennai and Kanpur.

"The challenge is there. We have

played in India before and our past performance there was not that good. We are going in with confidence this time and we will try to make use of their conditions. If we can put up a fight, we can create chances to bring results."

If spin comes into play, Bangladesh have Miraz along with Shakib Al Hasan, Taijul Islam and Nayeem Hasan in their ranks. Miraz believes, however, that a message has been sent through their pace dominance in Pakistan and they are now

capable of dictating with spin or pace.

"We never had the right balance. When the spin attack was great, the pace attack wasn't and vice-versa. We have good

"Nahid Rana is bowling at 150 kph. You can send a message through that, that this side has a 150 kph bowler. The way Hasan Mahmud, Shoriful [Islam] and Taskin [Ahmed], obviously you have to credit the pace attack for how they

bowled in difficult conditions and took wickets.

"The batters were not being able to play big knocks but it happened in Pakistan with Mushfigur [Rahim] bhai scoring 190 plus and Liton bhai almost making 150. Shadman [Islam] was there too and I contributed as well. If batters can only get scores of 50-60, the morale comes down but in the last two Tests, it was perfect," he concluded.

# Nissanka scripts 'very special' Sri Lanka win

Sri Lanka completed a rare Test victory in England on Monday as they reached their target of 219 with untroubled ease on the fourth day at The Oval, with Pathum them to a consolation win in a 2-1 series defeat.

It was their fourth victory in 21 Tests in England over 40 years and their first since a 1-0 victory in a two-Test series 10 years ago.

"It is very special, winning in England," Sri Lanka captain Dhananjaya de Silva told the BBC. "The boys were tough enough to handle the pressure and get into some scenarios.

"It is not comfortable. There was hard work put in by the bowlers and batters. We were there in every match - had positive points. The boys wanted to win in the end.

"Credit to all of the bowlers. They



have been on target from ball one. In the second innings they were spot on. He (Nissanka) has proved he is the best opener in Sri Lanka right now."

Opener Nissanka, who had hammered a quick 53 not out in Sunday's final session to set up the chase, was initially more controlled

in his approach, but kept the scoreboard ticking and reached his second test century off 107 balls.

He then cut loose with some big hits and, with the experienced Angelo Mathews also looking untroubled for 32 not out, it turned into an absolute cruise that did not even need the entire first session.

England had been hoping for a 6-0 summer clean sweep after crushing West Indies 3-0 and claiming two more convincing victories over Sri Lanka.

"We had a poor day three and credit to Sri Lanka as well. We weren't at our best but that was a brilliant knock from Nissanka as well. There are a couple of good lessons we can learn from day three," England captain Ollie Pope.

England now turn their attention to white ball cricket against Australia, starting with a T20 on Wednesday.

# Bangladesh lose hosting rights

The 11th Commonwealth Karate Championship, which was supposed to take place in Dhaka from September 25 to 29, has been shifted to South Africa amid security concerns following the recent student-led people's movement in Bangladesh.

Bangladesh had been awarded hosting rights last year and the tournament was supposed to take place at the Suhrawardy Indoor Stadium where some 1200 participants from 35-40 countries were supposed to take part.

But the Commonwealth Karate Federation has shifted the competition to Durban, South Africa from November 27 to December 2.

"We were preparing to host the event but the Commonwealth Games Federation shifted the venue to Durban, we were informed on August 8 or 9," Bangladesh Karate Federation (BKF) vice president Mohammad Iqbal Hossain said yesterday.

The BKF vice president also said that Bangladesh might not participate in the tournament in South Africa owing to a financial crunch. "The former general secretary [Kaw Shaw Hla], whose resignation was accepted on last Saturday, helped the federation a lot financially. Now, I don't know how to manage the funds to send the squad to South Africa."

in Lamine Yamal's cross at the far post. Spain doubled their lead in the 13th minute when midfielder Fabian Ruiz blasted in the rebound after Nico Williams' shot was saved by the goal Spain suffered a setback seven minutes later as

their defender Le Normand was sent off, and the momentum shift led to Zeki Amdouni in pulling one back for Switzerland in the 41st minute, giving the hosts a glimmer of hope.

However, Spain were adamant in sealing a win. Ruiz struck again in the 77th minute, and substitute Ferran Torres hammered the final nail three minutes later.

"I am very proud of my players," Spain manager Luis de la Fuente said, expressing his satisfaction with their performance after recovering from being a man down.

In their first match since defeating England 2-1 in the Euro 2024 final in July, Spain began their Nations League title defence with a frustrating goalless draw against Serbia in Belgrade on

# New champions crowned, new rivalries forged

A US Open full of upsets and hungry, young contenders offered the latest sign that men's tennis has entered a new era, with 2024 marking the first time in more than two decades that none of the "Big Three" claimed a Grand Slam

With Roger Federer retired and Rfael Nadal struggling to get back on court due to injuries, Djokovic was the last man of that golden generation standing at Flushing Meadows, but the Serb crashed out in the third round to Australian Alexei Popyrin.

While Djokovic's wait for a record 25th Grand Slam goes on, Jannik Sinner picked up

Jannik Sinner produced a brutal display of baseline power as he became the first Italian man to clinch the US Open title with a 6-3, 6-4, 7-5 win over American Taylor Fritz in the final on Sunday.

his second major of the year with his victory over Taylor Fritz in Sunday's final.

The Italian also won the Australian Open and with 21-year-old Spaniard Carlos Alcaraz claiming the French Open and Wimbledon titles, the old guard were shut out of the Slams for the first time since 2002.



"Nice to see new champions. Nice to see new rivalries," said Sinner, who tuned out a doping furore before the tournament.

"I feel it's good for the sport to have some new champions.' Sinner and Alcaraz are the only two men

born after 2000 to reach a major final. There were early clues that it would not be business as usual for the favourites at Flushing

Meadows. Strained from his victorious Olympic campaign in Paris, four-time US Open champion Djokovic went down in four sets to Popyrin.

Pre-tournament concerns about how

the Olympians would fare with the tight turnaround from Paris to New York and the quick switch from clay to hard courts were validated as none of the singles medallists made it past the quarter-finals. Alcaraz, who lost to Djokovic in the energy-

sapping Olympic final, also went out early, stunned by Dutchman Botic van de Zandschulp in the second round. Olympic women's champion Zheng Qinwen,

who lost in the quarter-finals, said the quick turnaround did her no favours. Hailed as the 'City That Never Sleeps'. a sweltering New York put players through the wringer, the tournament featuring its latest-

latest-ever finish for a women's match. World number one Iga Swiatek was another leading contender who went out too soon, the five-time Grand Slam winner and 2022 champion losing in the quarters, while defending champion Coco Gauff exited in the

fourth round. With players struggling for fitness in tough conditions, it was perhaps little surprise that Aryna Sabalenka, who had been suffering a back injury for long, triumphed on the women's

The world number two finished runnerup a year ago and lost in the semi-finals twice before that, but there would be no New York heartbreak this time around.



Portugal substitute Cristiano Ronaldo struck a late winner as his side came from a goal down to beat Scotland 2-1 and continue their strong start to the Nations League on Sunday. After Bruno Fernandes had fired in Portugal's equaliser, Ronaldo pounced in the 88th minute for his 901st career goal. "Cristiano has a goal, today he scored 901 and now he's on his way to a thousand, which is what he wants," said Fernandes, who played his 600th career game.

His remarks came after a teenage boy, Jayanta Kumar Singh, 14, was shot dead by BSF along the Kantivita border in Thakurgaon's Baliadangi upazila early yesterday, according to police.

Asked whether the foreign ministry would lodge a formal protest, the adviser said the ministry would act after receiving confirmation of the incident from the Border Guard Bangladesh (BGB).

FBI would directly participate in the joint taskforce. "We initially agreed that the FBI will work as a consultant."

# Trump, Harris in final prep for crucial debate

Kamala Harris and Donald Trump made their final preparations yesterday on the eve of their first -- and possibly only -- televised debate before the knife-edge 2024 US presidential election.

With less than two months until election day, the face-off could be a turning point in a bitter contest between the Democratic vice president and Republican former president. Harris arrives at 4.40pm (2040 GMT) Monday in the eastern city of

Philadelphia where the debate takes place, while Trump is not due to touch down until hours before Tuesday evening's clash on ABC News. The two candidates

have never even met before, and the debate is set to be a contrast in styles between a former prosecutor and a convicted felon who has targeted Harris with racist and sexist insults

"There's no floor for him in terms of how low he will go and we should

be prepared for that," Harris told radio host Rickey Smiley in an interview broadcast Monday, when asked how she planned to handle "And we should be prepared for the fact that he is probably going

to speak a lot of untruths." Yet Harris in some ways has the most to prove, despite the scandals dogging a rival who has hinted that he won't accept the result of

November's election if he loses. The 59-year-old Harris's honeymoon after replacing the aging Joe

Biden at the top of the ticket appears to be fading, with polls showing she needs to reach out to voters who don't know much about her policies.

She addressed the growing pressure late Sunday when her campaign put out a policy page, touching on subjects from unions

# **CRIMES AGAINST HUMANITY** ICT starts fieldlevel probe into complaints against Hasina

The probe agency of the International Crimes Tribunal yesterday launched a field investigation into the complaints of crimes against humanity and genocide allegedly committed by former prime minister Sheikh Hasina, among others, during the student movement that later manifested in a mass uprising. On the day, the members of the agency

visited Dhaka Medical College Hospital and National Institute of Neurosciences and Hospital. There, they spoke to over 20 victims who were injured during the movement from July 1 to August 5 and recorded their statements.

They also collected the identities of 529 injured victims who took treatment at the neurosciences institute.

"With this, we have began our field level investigation into the recent complaints against Sheikh Hasina and others," Ataur Rahman, deputy director (administration) of the ICT probe agency, told The Daily Star yesterday.

Chief Prosecutor Tajul Islam, among others, was present during the recording of statements. Talking to the journalists yesterday, he said the agency

# UN fears of 'lost generation'

Gaza schools remain shut for 2nd year; Israeli strikes on Syria kill 18

The new school year in the Palestinian territories officially began yesterday, with all schools in Gaza shut after 11 months of war and no sign of a ceasefire.

As fighting continued, Israel announced new orders to residents of the north Gaza Strip to leave their homes, in response to rockets fired into Israel.

Umm Zaki's son Moataz, 15, was supposed to begin 10th grade. Instead he woke up in their tent in Deir al-Balah in central Gaza and was sent to fetch a container of water from more than a kilometre away.

"Usually, such a day would be a day of celebration, seeing the children in the new uniform, going to school, and dreaming of becoming doctors and engineers. Today all we hope is that the war ends before we lose any of them," the mother of five told Reuters by text message.

The Palestinian Education Ministry said all Gaza schools were shut and 90% of them had been destroyed or damaged in Israel's assault on the territory, launched after Hamas gunmen attacked Israeli towns in October

The UN Palestinian aid agency UNRWA, which runs around half of Gaza's schools, has turned as many of them as it can into emergency shelters housing thousands of displaced families.

The longer the children stay out of school the more difficult it is for them to catch up on their lost learning and the more prone they are to becoming a lost generation, falling prey to exploitation including child marriage, child labour, and recruitment into armed groups," UNRWA Director of Communications Juliette Touma told Reuters.
