## At least 24 hurt as students clash

A clash erupted between students of Dhaka College and Ideal College in the Science Lab area and its surroundings yesterday afternoon, leaving over two dozen students injured.

The clash, which began around 12:30pm, following an altercation, continued for over two hours, ending at 2:40pm.

During the clash, students of both colleges engaged in a chase, counter-chase, and hurled brick chunks at each other.

According to Dhaka Medical College Hospital sources, at least 14 students were injured in the clash -- ten from Dhaka College and three from Ideal College -- along with one pedestrian.

DMCH officials said the injuries were mostly caused by sticks and bricks, but none of the victims were critically wounded.

Mohsin Uddin, officer-in-charge of New Market Police Station, said the clashes between Dhaka College and Ideal College students were triggered by an altercation between the students.

Ideal College students claimed that the clash initially broke out over a dominance dispute, during which two of their students were assaulted by Dhaka College students.

## Delhi working closely with Dhaka

Says Pranay Verma; govt lodges protest to India regarding teen’s death in BSF firing

Indian High Commissioner Pranay Verma has said New Delhi is working closely with Dhaka to take the bilateral relationship forward.

“We are working to closely engage with Bangladesh to fulfil shared aspirations of our people on security and development,” he told reporters after a courtesy call on newly-appointed Foreign Secretary Jashim Uddin yesterday.

The bilateral relations between the two countries have been witnessing strains since the ouster of the Awami League government and the fleeing of former Prime Minister Sheikh Hasina to India following a mass upsurge on August 5.

Border killing and water sharing of transboundary rivers, alongside rail transit, were some of the issues that the people of Bangladesh have been critical about.

There are allegations that India fully supported Hasina during the entire 15-year regime despite the accusations of widespread vote rigging, corruption, and human rights violations.

Verma told reporters that during the discussion with the foreign secretary, they discussed the broader relationship between Bangladesh and India.

He also said the two countries will continue to take forward the relationship in multifaceted areas.

He did not take any questions from the media on border killing, which has been a crucial issue for Bangladesh.

## TAQI MURDER

### Three associates of Osman family held, remanded

Three men have been placed on remand by a Narayanganj court in connection with the murder of Tanwir Muhammad Taqi.

The arrestees are Shafayet Hossain Shipon, Mamun Mia, and Kajal Hawlader.

They are close associates of the Osman family.

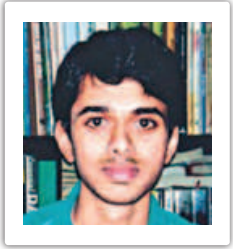
Their names were on the list of a leaked Rab investigation alongside Azmeri Osman, son of the late Nasim Osman.

Rab-II conducted a drive on Sunday night, arresting Shipon and Mamun from Chashara and Kalir Bazar in Narayanganj city, and Kajal from Dhanmondi in Dhaka on Monday afternoon.

Rab produced Mamun and Shipon before the court on Monday, requesting a seven-day remand.

Senior Judicial Magistrate Shamsur Rahman granted a six-day remand after hearing.

Meanwhile, Kajal was placed on a five-day remand by Senior Judicial Magistrate Haider Ali yesterday afternoon, said Inspector Abdur Rashid, in-charge of the court police outpost.

## Measures to be taken to stop border killings

Says home adviser after meeting on Durga Puja

Home Affairs Adviser Lt Gen (retd) Jahangir Alam Chowdhury yesterday said authorities concerned have been ordered to take measures so that border killings do not take place in the future.

The adviser made the remark in reply to a reporter’s query after a meeting at the secretariat on maintaining law and order during the upcoming Durga Puja.

“Another issue arises during the [Durga] Puja. People from this side go to see the puja on the other side [in India], and vice versa. That is why I have requested everyone to arrange good puja pandals on the border belt so that our people don’t need to go to the other side. And directions have also been given to ensure that people from the other side don’t come here,” he said.

He said the ministry has taken necessary steps to ensure a smooth and peaceful celebration of Durga Puja.

The adviser also said the allocation from the chief adviser’s fund has been

doubled to Tk 4 crore for indigent temples.

He said according to the information they have received so far, there will be 32,666 puja mandaps across the country, and the number will increase.

## US eager to work with interim govt

### Senator Dick Durbin offers full support to Yunus

The United States has trashed the speculation on US involvement in the recent student-led anti-government protests in Bangladesh.

“We continue to be ready and eager to work with the interim government led by Dr Muhammad Yunus as it charts its democratic future for the people of Bangladesh,” Deputy Principal Spokesperson Vedant Patel told reporters at a regular briefing in Washington on Monday, reports UNB.

He said they are continuing to monitor the developments in Bangladesh closely.

Drawing his attention, one of the reporters said there had been claims about Chinese influence in recent Bangladeshi student protests.

In reply, Patel said he was just not going to speculate.

The reporter said some Indian media outlets have suggested US involvement in the anti-government protest in Bangladesh while India has historically been a close ally of the ousted government.

Patel said he had not seen those reports. “But what I can unequivocally say is that they are not true. That’s probably why I’ve not seen them,” he added.

## Titas staffers protest new MD’s appointment

Around 200 staffers of Titas Gas Transmission and Distribution Company yesterday demonstrated and vandalised Petrobangla headquarters in Dhaka’s Karwan Bazar, protesting appointment of its new managing director.

They smashed the glass entrance of Petrobangla building around 10:20am and demonstrated for around 20 minutes.

Some of them also went up to the fourth floor and reportedly threatened Petrobangla staffers, said a staff member.

Later, Petrobangla employees gathered in large numbers and forced the agitating Titas staffers to leave the premises, said Tariqul Islam Khan, deputy general manager (public relations) of Petrobangla.

“A Petrobangla staffer was injured in the incident. The protesters even tried to

## Police role in Abu Sayed’s death ‘shameful’

Says new Rangpur commissioner; two cops on 4-day remand

Newly appointed Rangpur Metropolitan Police Commissioner Majid Ali yesterday expressed deep regret over the police’s role in Abu Sayed’s death, calling the incident “shameful.”

“It won’t take many witnesses to prove who shot Abu Sayed, and what followed was equally disgraceful,” he said, referring to the wrongful arrest and framing of an innocent boy as the culprit.

He made these remarks during a press briefing with journalists at the RPMP office.

The commissioner assured that a thorough investigation would be conducted to bring the true perpetrator to justice and emphasised that Sayed’s martyrdom had moved people worldwide.

“Abu Sayed’s example will be remembered as a symbol of bravery in the history of Bangladesh. After taking office, I personally visited Abu Sayed’s family and apologised on behalf of the police force,” he said.

Meanwhile, a court in Rangpur yesterday placed two

## BEATING WOMAN

### Former cop Kohinoor among three acquitted

A Dhaka court yesterday acquitted three former policemen, including former DMP deputy commissioner (west) Kohinoor Mian, in a case filed for beating up of a woman in the city’s Dhanmondi area in March 2006.

Two others are former DMP DC (south) Mazharul Hoque and constable Ruhul Amin.

Dhaka Chief Metropolitan Magistrate (in charge) Md Hasibul Haque delivered the verdict in presence of Mazharul and Ruhul at the courtroom yesterday, said a court staffer.

Kohinoor, an influential police officer in the 2001-06 BNP-Jamaat coalition government, is absconding in the case.

On May 14 last year, the court framed charges against the three accused.

## Sold for money, newborn returned to biological parents

Abdur Rashid, a day labourer from Dinajpur, was shot by law enforcers on August 4. Shotgun pellets struck him when police opened fire on anti-government protesters, leaving him incapacitated and in urgent need of medical care. With no steady income and mounting treatment costs, Rashid’s family was driven to make an unimaginable decision -- to sell their newborn daughter.

The girl, born to Rashid and Rokeya Begum on August 9, was handed over to a childless couple from Kurigram just three days after her birth. In exchange, the couple received Tk 37,000, of which Tk 25,000 was paid upfront.

“It was the hardest decision of our lives,” Rokeya said. “We couldn’t see any other way to save him.”

However, people across the country took notice of the matter after this newspaper published a report on this issue.



Locals reached out to authorities concerned for help. The social welfare department in Dinajpur and local officials intervened to reunite the baby with her biological parents.

Early yesterday, the child’s biological mother, accompanied by Md Moinul Huq, deputy director (acting) of the department in Dinajpur, visited the house of the couple who adopted the baby in Kurigram, said Foisal Raihan, upazila

nirbahi officer of Dinajpur Sadar upazila.

The couple agreed to return the child. The payment they had made was refunded, and Rokeya returned to Dinajpur, arriving around midnight with her daughter safely in her arms.

“Giving her away was a mistake. I am very happy that she was returned to us,” Rokeya said.

The local authorities vowed to bear the treatment cost of Rashid.
