Police arrested Joty in Uttara early yesterday.

September Robiossani Šhipu, student of a private university, filed the case with Ashulia Police Station against former prime minister Sheikh Hasina and 29 others.

According to the case statement, the complainant was shot around 4:00pm when he participated in the quota reform protests in front of the Bypail Central Jame Masjid in Ashulia on August 4.



# Hill cutting on amid lax monitoring

Illegal hill cutting has turned rampant in Dinarpur Pargana under Nabiganj upazila of Habiganj district in recent times.

The extracted soil was being transported to neighbouring Bangaon village.

# **EXPLOSION AT CTG SHIPYARD** Two more die, death toll now 6

Two more workers, who were injured in the explosion at a shipbreaking yard in Chattogram, died at Sheikh Hasina National Burn and Plastic Surgery Institute early yesterday.

Jahangir Hawlader, 45, and Barkatullah, 23, were declared dead between 6:00am and 6:30am, said Tariqul Islam, resident surgeon at the hospital.

Jahangir and Barkatullah had suffered burns on 70 and 50 percent of their bodies respectively,

With their death, the death toll from the incident has risen to six.

The explosion occurred at a shipbreaking yard in Sitakunda around 11:40am on September 7, according to Mohammad Solaiman, superintendent of Industrial Police, Chattogram

# Stop lifting sand from Kaliganga

## Locals demand at human chain

Local residents of Bara-Baroil village under Nabagram union of Manikganj Sadar upazila yesterday formed a human chain demanding authorities concerned to stop illegal sand extraction from Kaliganga river and remove a pipe from a government road in the locality that was installed for sand lifting.

People from different walks of life joined the event held at around 10:30am.



Speakers alleged that one Dewan Raju, using his political connection with Nabagram union parishad chairman Gazi Hassan-Al-Mehdi Suhas, had installed a large pipe connected with dredger machine on the north side of the village road to lift sand from the river and dump it in Nabagram area around two months back.

Despite protests by locals, they did not stop the illegal activities and instead harassed and threatened the villagers.

After the Awami League government's ouster on August 5, the UP chairman went into hiding, and the sand lifting stopped for a while, before Dewan Raju resumed the activities recently using support of local BNP leaders, the speakers also alleged.

Due to the pipe being installed on the road, movement of vehicles has become difficult, they also
