**Buet cancels dorm seats of several students**

**Social safety net fell short of expectation**  
**Speakers tell discussion**

Despite significant allocations in the national budget, the country's social safety net programmes have fallen short of their expected impact, speakers told a discussion yesterday.

Wave Foundation, in collaboration with The Asia Foundation, organised the national dialogue titled "Social Protection Programmes: Inequality and Rights" at The Daily Star Centre in the capital.

Asif M Shah, an associate professor of development studies at Dhaka University, presented the keynote paper at the event, said a press release.

Even though Bangladesh witnessed notable economic growth over the past few decades, the benefits of this progress have not been distributed evenly across society, the speakers said.

While the National Social Security Strategy was deemed a positive step forward in addressing social vulnerabilities, however, the selection of beneficiaries and distribution of benefits have been criticised for inefficiencies, irregularities, and discrimination, they also said.

These programmes lack proper monitoring in absence of institutional framework to assess the progress of beneficiaries or to devise plans based on their evaluations, leading to a significant gap in accurate statistics regarding poverty alleviation levels among beneficiaries, the press release also read.

Addressing the event, Zakia Afroz, director (additional secretary) of the Department of Women Affairs, said the lack of comprehensive needs assessments makes it difficult to accurately identify true beneficiaries.

**BANGLADESH'S WATER RIGHTS  
 Will start negotiations with India soon**

Says Adviser Syeda Rizwana Hasan

Bangladesh will soon initiate negotiations with India concerning its water rights and its share of common rivers, said Syeda Rizwana Hasan, adviser to the Ministry of Water Resources, yesterday.

These negotiations will take into account public opinion, and the results will be transparently shared with the people, she said.

Speaking as the chief guest at a seminar titled "Bangladesh's Fair Share of Water in Shared Rivers", held at Pani Bhaban in the capital to mark World Rivers Day, Rizwana, who also serves as an adviser to the Ministry of Environment, Forest, and Climate Change, made these remarks.

"Although the issue of sharing international river water is complex, sharing important information is not political. Details about the locations

of structures and rainfall data can be shared. In that case, many lives could be saved," she said.

She further explained that a country cannot approach the International Court on such matters unilaterally; as both nations must be involved.

"Sharing rainfall data is a humanitarian issue, crucial for saving lives. Bangladesh's claims will be made clearly and strongly," the adviser said.

She said Bangladesh not only seeks a fair share of international rivers but is also committed to protecting its internal rivers.

In his keynote presentation, Mohammad Ejaz, director of the River and Delta Research Center, pointed out that unilateral control is being exerted in the upstream portions of the Ganges-Brahmaputra-Meghna

**Petition seeks ban on hilsa export**

A Supreme Court lawyer yesterday filed a petition with the High Court challenging the legality of the interim government's decision to permit exporting 3,000 tonnes of hilsa to India.

Advocate Md Mahmudul Hasan submitted the petition, seeking the HC's order on the government to cancel the decision and issue a ban on the export of hilsa captured from the Padma and Meghna rivers.

In the petition, he said hilsa is not a freely exportable product, according to the Bangladesh Export Policy 2021-24.

"The commerce ministry did not follow the proper legal procedures to allow the export of hilsa. The fish is under jurisdiction of the fisheries and livestock ministry, and without its clear approval, the commerce ministry cannot single-handedly approve its export," he said.

The lawyer further said

**UK MP calls for probe into ex-land minister**

A UK lawmaker has called on the National Crime Agency (NCA) — UK's leading agency against organised crime, trafficking, cybercrime, and economic crime — to investigate allegations of corruption and money laundering against former members of the Bangladesh government, including former land minister Saifuzzaman Chowdhury.

In a letter to NCA Director General Graeme Biggar, Apsana Begum, a Labour MP of Bangladeshi origin, urged the agency to scrutinise Saifuzzaman's UK-based assets.

Apsana stated that Saifuzzaman is already under investigation by Bangladesh's Anti-Corruption Commission (ACC) for alleged embezzlement and claimed that he laundered millions of dollars into the UK.

Citing a Financial Times report, Apsana noted that entities controlled by Saifuzzaman have acquired at least 280 properties in the UK, valued at over 150 million pounds. Additionally, an Al-Jazeera investigation revealed that he owns 74 properties in her constituency of Poplar and Limehouse.

"The assets in question belong to Bangladesh and I believe they must be returned to support the people of Bangladesh as they strive for democracy

**SC launches helpline for service seekers**

The Supreme Court administration yesterday introduced a helpline number (+88 01316154216) to assist the litigants or service recipients so that they don't face obstacles at any section of its registry office.

An officer of the SC registry will operate the helpline and provide necessary assistance to the service recipients.

The helpline service will remain open from 10:00am to 4:00pm every Sunday to Thursday except public holidays.

The users can contact the helpline to get advice with the necessary information regarding the service.

On September 18, the chief justice issued 12 directives for SC officials to provide justice seekers and lawyers with better services and refrain from engaging in financial transactions or corrupt practices.

**TOFAZZAL KILLING  
 Ex-DU provost, 14 students sued**

Prof Shah Md Masum, former provost of Dhaka University's Fazlul Huq Muslim Hall, and 14 students of the hall were sued yesterday in connection with the killing of 35-year-old Tofazzal Hossain on September 18.

The accused students are Muhammad



Jalal Mia, Abdus Samad, Shahriar Kabir Shovon and Mehedi Hasan Imran of physics department; Suman Mia of soil, water and environment; Firoz Kabir of botany; Mottakin Shakin Shah and Rashed Kamal Anik of the institute of nutrition and food science; Ahsanullah and Fazle Rabbi of mathematics; Al Hussain Sajjad of geography and environment; Wajibul Alam of oceanography; Yeamus Jaman of pharmacy and Mohammad Sultan of zoology.

Asma Akter, 30, a cousin of the victim, filed the case with the court of Dhaka Metropolitan Magistrate Md Akteruzzaman, said Obaydul Mia, a lawyer for the complainant.

The magistrate set November 25 to know the progress of the investigation in the murder case, said a court staffer.

Six of the accused students -- Jalal, Suman, Mottakin, Ahsanullah, Sajjad and Wajibul -- confessed to their involvement in the crime before a magistrate on September 20 after they were arrested.
