Civil admin runs slow as top tier still jittery

The interim government is struggling to restore normalcy at the top and local administration despite being in power for more than seven weeks, leaving the implementation of government policies and service delivery in a wishy-washy state.

Secretary turnover accounts for the disorganised state of the civil administration, according to people informed with the discourse.

Of the 55 ministries and divisions, 34 have secretaries who were appointed during the Awami League's tenure and 15 under the current administration. Six ministries and divisions have no secretary.

The secretaries who were promoted during the AL era are uncertain about their future, so they are not running their ministries and divisions effectively and with an iron hand, The Daily Star has learnt from people familiar with the matter.

"A decision is needed on the fate of these individuals without further delay -- if they are staying on, the chief adviser must come out and tell these people that you are on my team, so do your jobs sincerely," said a secretary who has recently been made officer on special duty.

On the other hand, the secretaries promoted by the interim government are not familiar with the key government processes yet, which is delaying them from getting a handle on their new roles, they said

Negative information regarding the newly promoted and posted officials is being circulated by their batchmates, bringing down their morale.

Some retired officials are exerting pressure to be appointed as secretaries, creating fear among officials who are hoping to get promotion. The government has so far appointed six former officials as senior secretaries on contractual basis.

Many officials who felt they were deprived during the AL terms are also pushing for promotion and posting, adding to the chaos.

"It is right that the administration is experiencing a noticeable sluggishness," said AKM Abdul Awal Majumder, a former secretary and public administration expert.

An official from the Cabinet Division shared an example of bureaucratic latency: 200 vehicles purchased by the ministry of public administration for deputy commissioners (DCs) and upazila nirbahi officers have been ready for delivery for more than a month now but have yet to be allocated.

The vehicles are parked out in open fields, leaving them exposed to damages.

As is practice, the secretary committee on administrative development makes important decisions on creating or dissolving government job posts, revising rules and approving new regulations.

AGE BAR FOR GOVT JOBS 7-hour sit-in withdrawn after govt assurance

After a seven-hour-long sit-in in front of the chief adviser's residence, protesters last night withdrew their programme on the government's assurance that a committee will review their demand for raising the age limit for government job seekers.

They announced the withdrawal to journalists around 9:00pm after speaking to ICT Adviser Nahid Islam and Sports Adviser Asif Mahmud.

Speaking to reporters, Rasel Al-Mahmud, one of the coordinators of 35 Prottashi Somonnoy Parishad, said, "We'll attend tomorrow's [today's] meeting with the committee to reiterate our demand. The committee is to submit a report, based on our discussion, within seven days."

CYBER LAWS Cases over 'speech-based' offences to be scrapped

Says law ministry; 5,818 cases filed with 8 tribunals until August

The government has decided to quickly withdraw cases related to "speech-based offences" filed under cyber laws.

Additionally, anyone currently in custody under such cases will be released immediately through legal procedures, the law ministry said in a media release yesterday.

As of August 2024, a total of 5,818 cases were ongoing with eight cyber tribunals throughout the country. These cases were filed under the Information and Communication Technology (ICT) Act-2006, the Digital Security Act (DSA)-2018, and the Cyber Security Act (CSA)-2023.

Among these, cases filed for expressing free speech digitally have been categorised as "speech-based offences", while hacking or other digital frauds were categorised as "computerbased offences", reads the release.

According to the press release, at present 1,340 cases are ongoing related to speech-based offences, of which 461 are under investigation by law enforcement agencies and 879 are under trial in the cyber tribunals.

Of the 1,340 total cases, 279 are under the ICT Act, 786 under DSA, and 275 under CSA. Also, the 879 pending cases will be withdrawn in coordination with the law ministry and home ministry.

The release added that the government plans to expedite the withdrawal of these cases.

Investigators will be asked to submit final reports quickly for the 461 cases that are under investigation, the release said.

RMG worker shot dead during clash with law enforcers

30 hurt; 20 factories shut in Ashulia; workers blame owners of breaking promises; BGMEA seeks better security for RMG units

A garment worker was shot dead and around 30 people were injured during a clash between protesting workers and law enforcers in Ashulia of Savar yesterday.

Kawsar Ahmed Khan, 26, was a sewing machine operator at Mango Tex factory.

Five workers were in hospitals with bullet wounds.

The clash broke out in front of the office of Mondol Group in Tongibari area on Baipail-Abdullahpur Road around noon, workers said

They said a meeting was held yesterday morning between the owners of Mondol Group, and its workers, labour representatives, and law enforcers over workers' demands.

No agreement was reached and some of the workers gathered outside the factory. Later, employees of other factories joined them.

The agitated workers then vandalised five vehicles of the joint forces, compelling law enforcers to charge truncheons on them, witnesses said, adding that the law enforcers opened fire at one point.

Sumon, a worker of Natural Denims, said, "Everyone was working in our factory in the morning. When the workers of Mondol Group started protesting in front of their factory, our workers went there to
