## JOURNO MURDER Golam Dastagir shown arrested

Former textile and jute minister and Awami League lawmaker (Narayanganj-1) Golam Dastagir Gazi was shown arrested yesterday in a case filed over the death of journalist Hasan Mahmud at Khilgaon during the quota reform movement on July 31.

Dhaka Metropolitan Magistrate Md Syful Islam passed the order after Investigation Officer Md Azizul Haque Bhuiyan, a sub-inspector of Khilgaon Police Station, produced him before the court and submitted an application in this regard.

"Dastagir is an FIR-named accused in the case and it is needed to show him arrested," the IO said in his forwarding report.

On August 25, Dastagir was picked up from Dhaka's Shantinagar. Later, he was placed for a six-day remand in a murder case filed with Rugganj Police Station. He was also shown arrested in two more murder cases.

Hasan Mahmud, also president of the Dhaka south unit of the Bangladesh Nationalist Road Transport Workers Party, went missing after he went out of his house in Mugda on July 31.

His family later learned he had been taken away by 50/60 unidentified individuals in plainclothes.

Mahmud was found later in front of the Gorhan Chhapra Mosque and was pronounced dead at Mugda Medical College Hospital on that day.

## Former EC secretary Jahangir arrested

A team of the Detective Branch of Dhaka Metropolitan Police arrested Jahangir Alam, former secretary of the Election Commission, from Dhaka's Gulshan area yesterday.

Muhammad Talebur Rahman, deputy commissioner (media) of Dhaka Metropolitan Police (DMP), confirmed it.

Jahangir was also secretary of the home ministry and was sent on forced retirement on August 14, days after the ouster of Sheikh Hasina government amid mass protests.

After the arrest, DMP, in a message, said, Jahangir Alam was the architect of the 2024 "dummy election".

issues faced by the elderly must be recognised as genuine problems.

He suggested university students should be involved in finding solutions.

Prof M Shamsher Ali, former vice-chancellor of Bangladesh Open University, pointed to the media's role in promoting an elderly-friendly society.

Brig Gen (ret'd) Jalal Uddin, medical adviser to Gramen Telecom Trust, said family members must instill a sense of responsibility in children towards their elders.

Fazlul Haque, secretary general of the Bangladesh Senior Citizen Welfare Society, said healthcare remains the biggest issue

for the elderly, as many hospitals fail to provide proper services.

Sharifa Begum, senior research fellow at the Bangladesh Institute of Development Studies, called for improving the financial conditions of the elderly and establishing separate zones in hospitals and public transport for them.

Neglecting the elderly, she warned, will not benefit society.

Feroze Quader, president of the Society of Surgeons of Bangladesh, said caregiving institutions should prioritise compassion over profit.

Nahid Ferdous, a law professor at Bangladesh Open University, also spoke.

fish and meat in paper or jute bags? We used to get polythene for this, but what's the alternative now?"

At some stores, plastic food wrap was still being used to package fish, meat, and certain fruits.

When asked about this, Shawpno's branch manager, Saurav, said, "We have to use this amount of plastic to keep food fresh. Currently, there's no alternative."

Hasan Ali, a senior salesman at Meenabazar in Mirpur-10, said, "Many customers praised the decision, but some got into arguments with our staff because we couldn't

provide bags for free."

On September 24, Syeda Rizwana Hasan, adviser to the Ministry of Environment, Forest, and Climate Change, launched a "Clean-Up" campaign at Mohammadpur Town Hall to implement the ban.

She said supermarkets would be the first focus of the ban, starting from October 1, and from November 1, fresh markets would follow.

Raids on polythene-producing factories and legal measures are planned as part of the crackdown.

Rizwana also visited several supermarkets in Dhanmondi yesterday to monitor compliance with the new policy.

measure to fulfill the demands is not taken within three days, said the statement.

"Mayer Dak thinks the ISPR issued such a statement to cover up the fact. The statement must be withdrawn, the perpetrators must be tried, and masterminds of the incident must be unmasked," said the statement.

Such an incident is a result of evil attempts to put the incumbent government in an awkward situation and to bring Mayer Dak and army at a loggerhead, said the statement.

"We think the incident was committed to question the activities of Mayer Dak," it said, adding, "We think

it is a strategy to mount pressure on the victims' family members, who have started filing cases against forced disappearance."

"We demand protection of the families of the victims of forced disappearance," Tulee said.

Saiful is the elder brother of BNP leader Sajedul Islam Sumon, a victim of enforced disappearance in 2013. Tulee is their sister.
