Families of
five Shibir
leaders file
case with ICT

Families of five Islami Chhatra Shibir leaders have filed complaints with the International Crimes Tribunal's chief prosecutor, accusing the Rab and the Detective Branch of being involved in enforced disappearances.

The incidents reportedly occurred between 2012 and 2017 during the Awami League's tenure in power.

The complaints were submitted around 1:30pm yesterday at the tribunal's chief prosecutor's office.

The leaders include Shah Md Waliullah, bail-ul-mal secretary of Islamic University, and Mukaddes Ali, cultural secretary of the same university.

They also include Jakir

'Govt working
to bring
perpetrators
to book'

The government is working to determine how many individuals were victims of enforced disappearances during the Awami League's tenure, said two advisers of the interim government yesterday.

Adviser to Home Affairs Lt Gen (ret'd) Jahangir Alam Chowdhury and Adviser to the Information and Broadcasting Ministry Nahid Islam made the remark during a meeting with Mayer Daak, a platform representing families of the disappeared.

The meeting, held at the home ministry, was confirmed through a press release from the

**Pollution of Louhajang
river continues**

Within two months after being cleaned by 2,000 volunteers from "BD Clean," the Louhajang River in Tangail has quickly reverted to its polluted state.

Pollution and encroachment continue unabated in the river as local authorities remain inactive.

The 76 kilometre-long river, originating from the Dhaleswari in Boishnabbari and ending at the Bangshi River in Jamurki, was once a navigable waterway.

However, senior citizens say, in recent decades, it has turned into a dying canal due to siltation and the blockage of its water flow.

Waste from nearby households, markets, mills, and factories, discharged through drains and pipelines, has further worsened the river's condition. The stench of stagnant, polluted water, combined

with accumulating rubbish, has become unbearable for those living along the riverbanks.

Locals say their repeated calls for action have gone unanswered.

Ratan Siddiqui, general secretary of the District River Canal Water



Bodies Protection Committee, said efforts to clean the river have been limited to only a one-kilometre stretch in town.

The remaining 75 kilometres of the waterbody continue to suffer from encroachment and

pollution, as no one dares confront the powerful vested interests responsible for it, he added.

Meanwhile, Azad Khan Bhasani, president of Bhasani Parishad, said attempting to free the river from encroachment without restoring its original flow will be proven futile.

Ruhul Amin Sharif, assistant commissioner (land) in Sadar upazila, said reviving the river requires expert planning to address its silted source.

At a recent meeting organised by the environmental group 'Nongar,' civil society members criticised the exclusion of experienced environmental activists from new initiatives, claiming that local authorities are sidestepping real solutions.

Contacted, Tangail Deputy Commissioner Sharifa Haque said the administration will work with all stakeholders to resolve the issue.

**Man shot
dead in Ctg**

A youth was shot dead by a group of assailants in Shamsheer Para locality of Chandgaon in Chattogram city yesterday afternoon.

The deceased, Aftab Uddin Tahsin, 28, was allegedly a member of a gang led by Sarwar, a Shibir cadre, in Bayezid Bostami area, said police.

Members of a rival group, led by Sazzad Hossain alias Chhoto Sazzad, from the same area, is suspected to be behind the murder.

Sazzad and Sarwar groups have long been engaging in conflicts over establishing supremacy in the area, said police.

The assailants came on a black microbus and shot Tahsin at a tea stall in the area around 5:00pm, said OC Aftab Uddin of Chandgaon Police Station.

Locals took him to Chattogram Medical College Hospital where doctors declared him dead. The body has been kept at CMCH morgue for autopsy.

**Ensure legal
action against
child abusers**
Says adviser Sharmeen
Murshid; visits tortured
house help in DMCH

Sharmeen S Murshid, adviser to the Ministry of Social Welfare and Women and Children Affairs, yesterday called for nationwide campaigns to raise awareness and urged swift legal action against perpetrators of child abuse.

She paid a visit to the Burn Unit at Dhaka Medical College Hospital to meet Kalpana, 13, a house help who was subjected to severe physical and mental abuse by her employer.

The adviser also met with other child victims admitted to the One Stop Crisis Centre.

"We must take strong measures to ensure that cases of abuse, especially against women and children, are addressed promptly, with proper punishment to set an example. This will gradually reduce abuse in society," she stated.

Kalpana was tortured by her employer to the extent that four of her teeth were knocked out, and her body is covered with injuries. Hospital officials reported that Kalpana's condition is critical, with severe burns and other injuries inflicted over a prolonged period.

"Her body shows signs of burns from metal objects, and she didn't receive medical treatment when she needed it, leading to infections. She will require multiple surgeries and a long hospital

imposed in 4
Pabna areas**

The local administration yesterday imposed section 144 at four places of Sagarkandi union in Pabna's Sujanager upazila, as two rival groups of BNP organised separate rallies in the area.

Abdus Salam Mollah, a member of Sujanager upazila BNP convening committee, and a rival group led by Jubo Dal activist Tarikul Islam called rallies in the area at the same time yesterday afternoon.

Sujanagar UNO Meer Rasheduzzaman Rashed said, "For the sake of keeping the law and order situation under control, we have imposed section 144 from 12:00pm to 12:00am."

He also said, "We have come to learn that two rival groups took position to hold rallies at the same place in Sagarkandi, creating a tense situation in the area."
