National award-winning singer Fahmida Nabi, whose enchanting voice has graced hits like Lukochuri Lukochuri Golpo, Dur Dwipabashini, and Ektu Jodi Takao Tumi, remains one of the most beloved names in Bangladesh's music scene.

Often regarded as a 'pure artiste,' Fahmida's musical journey feels almost inevitable, given her lineage—her father, Mahmudun Nabi, who was a legendary playback singer—and music has always been a part of her life.

Currently, Fahmida is busier than ever. The versatile artiste has recently recorded three new songs and is preparing for two live performances in the United States, set to take

"I'm particularly excited about these songs because they were all penned by a group of talented female lyricists. Working with female artistes is a special joy for me," the renowned singer shared in an exclusive interview with

Besides lending her voice, the singer has also composed the music for the tracks. All three songs will soon be available on her official YouTube channel.

The music videos have already been shot, and post-production is underway. Ashik Mahmud, a very talented videographer, directed the videos. While choosing the words,

songs will resonate deeply with them. As for my performance, I leave that for the audience to decide," she added with a modest smile.

Speaking about the themes of her new songs, Fahmida explained, "One song, titled Jonaki O Jonaki, was written by Husne Ara Jolly. I composed and performed it. The song reflects how nature, much like fireflies, yearns for freedom and light, especially now, as trees and plants are being destroyed.

The rest two—**Sedino Mukhor Chhilo** and *Kacher Manush Dure Jay*— were written by Farzana Rahman and Ila Majid, respectively.

Despite her packed schedule, Fahmida never stops working on new music. "I'm always busy with music. I try to release a new song every two to three months on my YouTube channel." she said.

Her work in the film industry continues to flourish as well. Following in her father's footsteps, Fahmida also has a versatile record in playback singing. Recently, the singer recorded several playback songs, including a track for an upcoming movie, composed by Pintu Ghosh, which is set to release at the end of this month. She also contributed a song for the film *Chador*.

There's something magical about singing for films," she said. "I absolutely love it."

When asked about being labelled a 'pure artiste,' Fahmida remained humble.

I kept the listeners in mind, and I believe these don't think too much about titles. I'm just incredibly grateful for the love people give me. I want to keep that love alive by staying true to good music. That's something I'll always hold on to."

Offering advice to up-and-coming artistes, she said, "Humility, practice, and knowledge are key. There's no substitute for practice. The more they learn, the better they'll do."

Fahmida is also eager to learn from the younger generation. "I pick up a lot from them. I'm always trying to learn new things from younger artistes," she said.

As for what makes a song truly great, Fahmida believes it's a combination of elements. "Great lyrics, great composition, and great vocals-these are what make a song timeless.'

Wrapping up the conversation, Fahmida shared her thoughts on the future of music consumption. "I believe people might move away from watching music videos and go back to simply listening to music, as they did in the past. With time becoming more limited, only songs that truly touch the hearts of the listeners will stand the test of time."

Looking ahead, Fahmida announced her upcoming performance in Los Angeles, under the banner of the Sonar Bangla Foundation. She'll be sharing the stage with fellow Bangladeshi singer SI Tutul.

SC restores

The apex court bench also condoned 286 day's delay in filing Jamaat's restoration petition after this court had dismissed its appeal against the HC verdict.

On September 1 this year, lawyer Shishir Manir submitted the restoration petition to the apex court on behalf of Jamaat Secretary General Miah Golam Parwar seeking necessary directives.

On that day, the lawyer told The Daily Star that the Appellate Division earlier dismissed the Jamaat's appeal without holding a complete hearing.

On November 19 last year, a fivemember bench of the Appellate Division, headed by the then chief justice Obaidul Hassan, dismissed the Jamaat's appeal for "default" as its counsels did not appear before the court on that day.

Yesterday, Jamaat's Barrister Ehsan Abdullah Siddiq told the SC bench that senior counsel AJ Mohammad Ali, now dead, for the party in this case could not attend the court for placing arguments due to political programmes, including countrywide strikes, and his illness.

Maulana Syed Rezaul Haque Chandpuri, secretary general of the Bangladesh Tariqat Federation, along with 24 others, filed a writ petition with the HC on January 25, 2009, seeking its order declaring the Jamaat's registration illegal.

The petitioners said that the Jamaat is a religion-based political party, and it does not believe in the independence and sovereignty of Bangladesh.

Following the writ petition, the HC on August 1, 2013, declared the Jamaat's registration with the EC illegal.

The EC scrapped the Jamaat's registration in October 2018, making it clear that the party will not be able to contest the upcoming national election.

In the verdict, two judges of the three-member HC bench declared the registration illegal. However, the other judge disagreed with the decision made by his two colleagues.

The Jamaat then filed the appeal with the apex court challenging the HC verdict.

Ehsan Abdullah Attorney placed arguments on behalf of the petitioner, while a number of pro-Jamaat lawyers, including its leader Md Jashim Uddin Sarker and Shishir Manir, were present at the court during yesterday's hearing.

m) Relevantly, regarding the sale of the building owned by Mr. Quddus, an MOU dated December 12, 2022, was executed between the company and Mr. Quddus. This was evidently discussed in the 42nd Board Meeting as a proposed sale of the company's existing headquarters, subject to approval from IDRA and RAJUK. However, since no approval from IDRA was granted, subsequent formalities such as seeking permission from RAJUK, executing a registered sale deed, mutation, and transferring the title were not carried out.

Our report was based solely on the findings by Bangladesh Financial Intelligence Unit (BFIU), a government

The rejoinder basically makes two points – 1) the BFIU report is inconclusive and 2) a former official along with some other unnamed officials was involved in much of the irregularities.

None of these issues were the subject of our story. Also, none of the facts reported in our story was our own, and we did not claim so.

We stand by our report.

Labour MP Phil Brickell, who is on the all-party parliamentary group (APPG) on anti-corruption, has urged HM Revenue and Customs (HMRC), the Financial Conduct Authority (FDCA) and the Solicitors Regulation

regulators to ensure that companies involved in the transactions "undertook adequate checks on the source of Mr Chowdhury's wealth and funds", Guardian reports.

He wants regulators to check whether UK firms filed "suspicious activity reports", which they must submit to law enforcement if they are concerned about potential money

laundering, and whether they may have committed a criminal offence if they failed to do so.

"Showing that the UK is serious about making London the anticorruption capital of the world requires proactive, swift and robust investigation where allegations of these kinds emerge," he said in the letters seen by the Guardian.

spokesperson for the SRA told the Guardian: "We take the issue of potential breaches of money-laundering regulations very seriously and will take action if we find firms are not meeting these obligations.'

The FCA and HMRC declined the Guardian's request for comment.

Meanwhile, members of the APPG on antiparliamentary corruption and responsible tax met last week to discuss how to assist Bangladesh in tracking UK assets linked to people under investigation by Dhaka authorities, Guardian reports.

The chair of the group, Joe Powell MP, has written to the National Crime Agency urging it to investigate assets in the UK linked to members of the former Bangladeshi regime,

including Chowdhury. Meanwhile, I-Unit's investigation found Chowdhury's real estate empire in the UAE is bigger than what was reported in its 25-minute documentary The Minister's Millions

In the documentary, it was said

In undercover footage, Chowdhury boasted about owning a penthouse in the prestigious Opera District, and land records confirm he is the listed owner of a luxury apartment there, costing more than \$5 million.

Newly leaked property data from 2023 show that Saifuzzaman Chowdhury is the listed owner of more than 250 luxury apartments in the UAE worth over \$140 million.

The records reveal his wife Rukhmila Zaman, also under investigation for money laundering in Bangladesh, is the listed owner of another 50 properties in Dubai worth upwards of \$25 million.

With the new data leak, it is calculated that Chowdhury and his wife have spent nearly \$170 million buying over 300 high-end apartments in the UAE.
