## UK-based lawyer files complaint against Hasina at The Hague

A lawyer has filed a complaint with the International Criminal Court at The Hague accusing former prime minister Sheikh Hasina, the ministers of her government and its associated state actors of crimes against humanity.

Asraful Arafin, a lawyer of London's 3 Bolt Court Chambers, filed the case under Article 15 of Rome Statute on October 28, seeking an independent investigation into what he mentioned as targeted extrajudicial killings during the mass uprising, torture in secret detention centres, and and other atrocities.

He requested the ICC to issue arrest warrants for key suspects to prevent further impunity, according to a media statement.

In Bangladesh, over 200 murder cases have been filed since she fled to India on August 5.

Lawyers say the ICC may take cognisance of the complaint if it deems Bangladesh courts unable to do it. Member states of the UN Security Council have veto power over the ICC.

The statement said Bangladesh witnessed a shocking tragedy when the government launched a brutal crackdown on peaceful protesters in July and August.

will form a convening committee. Outside the cities, each upazila committee must have 21 members and in cities each thana-committee must have 31 members.

Twenty-five percent of the members must be women, 5 percent each from the family of a martyr, family of an injured, minority, worker, and local ethnic community. This condition must be met to form a convening committee.

The guidelines emphasise inclusion of teachers, lawyers, writers, doctors, engineers, journalists, homemakers, and young religious leaders.

Only local residents are eligible; no associates or beneficiaries of the Awami League will be allowed; and the committee must uphold the spirit of the mass uprising.

Spokesperson Samanta Sharmin said their mission is to dismantle the fascist system and implement a new political framework, with grassroots committees aimed at organising the forces of the recent uprising.

The Anti-Discrimination Student Movement has formed an 111-member convening committee in Kushtia, said a press release, signed by its Convener Hasnat Abdullah and Member Secretary Arif Sohel.

also marked the release of Unesco's biannual Director-General's Report on the Safety of Journalists, which showed a 38 percent increase in journalist killings since the previous

In his message for the Day, UN Secretary-General António Guterres pointed out that Gaza has seen the highest number of killings of journalists and media workers in any war in decades. He called on governments to take urgent steps to protect journalists, investigate crimes against them, and prosecute perpetrators.

The war in Gaza inevitably dominated the 2024 UN International Media Seminar on Peace in the Middle East on Friday, an event that has taken place annually for the past three decades, with the aim of enhancing dialogue and understanding between media practitioners, and fostering their contributions in support of a peaceful settlement to the Israeli-Palestinian conflict.

In a statement to the seminar, read out by UN head of global communications, Melissa Fleming, Guterres noted that journalists in Gaza have been killed "at a level unseen in any conflict in modern times". He said that the ongoing ban preventing international journalists from Gaza "suffocates the truth even further".

Every two years, the awareness campaign for commemoration of the International Day to End Impunity for Crimes against Journalists coincides with the findings of the Unesco report outlining the current state of global

and regional impunity. Expressing concern, Unesco said impunity damages whole societies by covering up serious human rights abuses, corruption, and crime. It asked governments, civil society, the media, and everyone concerned to uphold the rule of law to join in the global efforts to end impunity.

But in many countries, the governments will not ask questions if a Bangladeshi wants to buy a luxurious apartment there.

This is how a former Bangladeshi minister bought more than 300 properties abroad and it is the tip of the iceberg. There are many such cases. It proves that there is a demand side apart from the supply side ... . Many countries have created opportunities for money launderers."

While it is possible to retrieve the laundered money, it is extremely difficult and nearly impossible, Iftekharuzzaman said.

Until Bangladesh makes a law and signs agreements with other countries for returning the money, it is not possible to bring back the laundered money.

"France willingly returned the

financial troubles. All countries will not be proactive like France in to stop the laundering by ushering in returning the money."

Only Singapore returned \$9.3 million to Bangladesh in the Siemens case between 2007 and 2013 as the Singaporean government was cooperative. A coordinated approach is needed

among state agencies like the ACC, the Criminal Investigation Department, the National Board of Revenue, the attorney general and the Bangladesh Financial Intelligence Unit (BFIU) to retrieve the laundered money.

The government has started negotiations with some countries like the US, the UK and the EU to bring back the stolen money.

"But it will be a surprise if the interim government can bring back

One of them introduced himself as Captain Muslemuddin, who was attached to the Bangabhaban, entered the jail and shot the four leaders to death, says the complaint.

On November 4, Kazi Abdul Awal, (prisons) filed the FIR with Lalbagh Police Station.

ABM Fazlul Karim, the then officerin-charge of the station, was tasked with the investigation. He collected evidence from the scene after a magistrate made an inquest report of the bodies.

The Indemnity Ordinance, however, kept the investigation and trial halted for about 21 years until the Criminal Investigation Department resumed the probe on August 18, 1996.

In line with this, my next program will be to stage a sit-in in front of Hotel InterContinental on November 3 at 3:30 PM, followed by a march to submit the memorandum to the Chief Adviser," he wrote yesterday.

He also warned that "a 1929-style economic depression" would ensue if Harris were elected. Speaking on Fox yesterday, Trump described the weak employment data released Friday as "the worst job numbers," though analysts said the figures were a temporary blip.

Citing her hawkish foreign policy views, Trump earlier had conjured the image of Liz Cheney, a former Republican representative turned

About trial delays and low conviction, Rafiqul Islam, the public prosecutor of the Cyber Tribunal of Dhaka, told this correspondent, "One of the major reasons for the delay in trial and poor conviction is that witnesses did not appear in the court. And in many cases, the victims reach out-of-court settlements."

However, he said he did not think there was a lack of expert lawyers to deal with cybercrime cases. "We've expert lawyers in court now," adding that steps are being taken to resolve all the cases soon.
