



Govt will scrap CSA within a week

Says information adviser; all cases under the act will be withdrawn

The Cyber Security Act will be repealed within a week and all cases filed under the act will be withdrawn, Nahid Islam, adviser to the posts, telecommunications, and information technology ministry, said yesterday.

"Not only this law [CSA], but all laws that hinder freedom of expression are under review," he said.

Nahid, who is also the information adviser,

said decisions on reforms will be made after consulting the stakeholders. The adviser made the remarks during a meeting with Norway Ambassador Hakon Arald Gulbrandsen at his office at the ICT Division, said a ministry press release.

About the next parliamentary polls, Nahid, also information adviser, said an election based on national consensus will be organised after completing all necessary reforms.

"We have achieved a new Bangladesh through the student and public uprising. Over the past 16 years, the fascist government has committed numerous irregularities and corruption. The interim government has now started the work of rebuilding the country so that both the nation and its people can recover from the damage."

Nahid sought Norway's advice and cooperation in this rebuilding process. Ambassador Hakon assured the adviser of standing by the interim SEE PAGE 10 COL 4

A nephew of Monnujan former Sufian, minister for labour and employment, was killed allegedly in a mob beating in Khulna yesterday, said police.

The deceased is Sheikh Arifuzzaman Rupam, 34, said Md Shahidul Islam, inspector of Daulatpur Police Station.

The incident took place on Daulatpur's Anjuman Mosque Road in the city around 10:30am.

Rupam was the son of Sheikh Kamal Uddin Bachchu and Nargis Begum, the younger sister of the former state minister.

Inspector Shahidul said, "We came to know from the hospital that he [Rupam] was a victim of mob

Fresh probe into Pilkhana killings soon

Says home adviser; 20 special PPs appointed for BDR mutiny case

The government will carry out a reinvestigation into the 2009 killings at the Pilkhana headquarters of the erstwhile Bangladesh Rifles, said Home Adviser Lt Gen (retd) Jahangir Alam Chowdhury.

'An investigation team will be formed soon," the adviser told reporters yesterday at the headquarters of the paramilitary force, now Border Guard Bangladesh (BGB).

He said the country's law and order situation has improved, but there is still room for improvement. In a meeting with the senior BGB officials.

Jahangir discussed the ongoing efforts to step up national security. "We are making significant changes in the olice's posts in Dhaka, but it will take time for

the newly posted force members to familiarise themselves with the localities and build an effective intelligence network," he said. Stressing the BGB's crucial role in maintaining

law and order, the adviser said changes within the force are gradually yielding positive results. "We anticipate further improvements in the near future."

117 women were victims of violence last month 7 killed after rape, says rights body

At least 117 women and girls across the country were victims of violence in October, according to the Human Rights Support Society (HRSS).

Meanwhile, eight women and girls were victims of gang rape, while seven were killed after rape.

Additionally, 11 women and girls were victims of sexual harassment, while two women were killed over dowry-related issues. A total of 37 women were killed in family disputes; two were injured; and 10 died by suicide.

In a media release issued vesterday, the rights group said that, as per its monthly human rights analysis report, 55 females were

The Israeli military said yesterday it had killed a top Hezbollah commander it accused of overseeing rocket and anti-tank missile attacks against Israeli forces in southern Lebanon.

Abu Ali Rida, the Hezbollah commander of the Baraachit area in southern Lebanon, was "eliminated" in an airstrike, the military said, without specifying when he was killed.

"was responsible for planning and executing rocket and anti-tank missile attacks on IDF (military) troops and oversaw the terrorist

activities of Hezbollah operatives in the area", the military said in a statement. Israel has continued to pound Hezbollah targets in Lebanon since the war between the two sides broke out in late September.

Lebanon's Iran-backed Hezbollah group said it fired rockets at the northern Israeli city of Safed yesterday. Hezbollah fighters launched a "big rocket salvo" at the city, the group said in a statement.

Meanwhile, Israel formally notified the United Nations of its decision to sever ties with the agency supporting Palestinian refugees, it said yesterday, after lawmakers voted to ban the organisation vital to the occupied territories.

The ban, which sparked global condemnation including from key Israeli backer the United States, should come into force in late January, with the UN Security Council warning it would have severe consequences for millions of Palestinians.

BREACH OF DISCIPLINE Another 58 trainee SIs dismissed

Bangladesh Police Academy in Sardah, Rajshahi, yesterday discharged 58 more trainee sub-inspectors (SIs) from the 40th outside cadet batch on the grounds of "breaching discipline".

With them, 310 SIs, out of 804 who started the one-year basic training on November 5 last year, have been dismissed on charges of breaching discipline just before getting into the police service.


Earlier, 252 trainee SIs of the same batch were dismissed.

A senior official of the academy yesterday confirmed that the discharge letters were sent to the home addresses of the 58 trainees.

The police academy issued sho cause notices to 49 cadets on October 24 while 10 others were notified on October 21 over creating chaos by sitting randomly in training classes.

They were asked to respond within three days of receiving the showcause notices.

US music legend Quincy Jones passes away at 91

Jones, Quincy impresario who dominated American music decades and shaped the careers of stars including Michael Jackson, has died. He was 91 years old.

He was surrounded by family at his home in the Los Angeles neighbourhood of Bel Air at the time of his death on Sunday, his publicist Arnold Robinson said in a statement, without specifying a cause.

"Tonight, with full but broken hearts, we must share the news of our father and brother Quincy Jones' passing," his family said, according to the statement.

"And although this is an incredible loss for our family, we celebrate the great life that he lived and know there will never be another like him.'
