## Healthcare relief for rural residents

Bagerhat's 205 community clinics are making a significant impact on rural healthcare by offering free essential medicines, including treatments for chronic conditions like high blood

pressure and diabetes. This programme is designed to support low-income and vulnerable residents in remote areas, providing 23 types of medicines to address various health needs.

Clinics such those in Tangrakhali, Malipatan, Pingoria, Bilkul, and Baroikhari Kachua upazila are actively dispensing these medications, though Healthcare Community Providers (CHCPs) report occasional shortages due to high patient demand.

Sahida Begum, a resident of Tangrakhali, said, "Accessing these medicines for free is a lifesaver. I couldn't afford them otherwise."

Jalal Sheikh, another patient who now receives blood pressure medication at no

cost, echoed her relief, as he previously had to buy these medicines from private pharmacies.

Altaf Sheikh, also from Tangrakhali, highlighted the importance of these services, especially in rural areas. "These clinics are indispensable," he said.

Raisul Islam, a CHCP at Tangrakhali Clinic, pointed out the need for more frequent medicine supplies to keep up with demand.

> "We treat 23 different conditions, but we often run short. Expanding our supply would help us serve everyone more effectively.'

He urged government to consider nationalising jobs to provide stability for healthcare workers and

continuity for patients.Dr Md Habibur Rahman, deputy civil surgeon of Bagerhat, said medicines are delivered to each clinic on a set schedule, with redistribution from nearby clinics if shortages arise.

This coordination helps manage resources effectively, ensuring that clinics can meet community needs, he said.

# Protect journos, uphold press freedom: CPJ

The Committee to Protect Journalists (CPJ) has called on Dr Muhammad Yunus, chief adviser to Bangladesh's interim government, to urgently address press freedom in

In a letter sent yesterday, following a recent meeting at the 2024 UN General Assembly, CPJ outlined 10 key actions for the interim government to protect journalists and uphold freedom of expression.

Among the top priorities, CPJ urged a moratorium on repressive media laws, specifically following the announced repeal of the controversial Cyber Security Act 2023. This law, which replaced the much-criticised Digital Security Act, has been used to target journalists under previous administrations.

CPJ also called for the dismissal of hundreds of retaliatory criminal cases against journalists, many of whom face police investigations or imprisonment.

The letter emphasised the need to address the ongoing detention of four pro-Awami League journalists, urging the government to uphold their rights to a fair trial.

It also demanded investigations into the recent attacks on journalists, including fatal shootings in July 2024, unsolved murders, and numerous reports of custodial violence, torture, and abductions.

## Illegal canal excavation triggers road collapse

Kalapara-Dhankhali road in Patuakhali's Kalapara upazila has begun collapsing in several areas, with cracks forming in many

The poor condition of the road is due to illegal soil excavation from the nearby Rajpara canal, which flows parallel to the road. This has put locals at risk, forcing them to navigate the damaged road with caution.

According to the upazila administration, the total estimated damage to the road is around Tk 50

Last year, a local group illegally excavated soil from the Rajpara canal to sell to a brick kiln, significantly deepening the canal with the use of heavy machinery.

As the water levels in the canal dropped, the road started cracking, and despite warnings from locals to stop, Ferdaus continued to drain the canal, worsening the road's

By last week, the situation had escalated, with more sections of the road in danger, causing fear among the local residents.

Mahbub Mia, a local resident, reported that a significant portion of the road fell into the canal early Friday morning, while additional cracks had appeared.

"Any time, this road could completely collapse," he said. "We, and many other families living along the canal, are worried about the risks."



### **BARRING JUDGES FROM DUTIES** Lawyer wants info from SC under RTI

A lawyer yesterday submitted an application to the Supreme Court (SC) registrar general under the Right to Information (RTI) Act to know why 15 High Court judges have been kept away from judicial

SC lawyer Md Eunus Ali Akond placed the application to the SC registrar general with the names of 15 HC judges who are not being allowed to perform judicial activities.

The 15 judges are Justice Salma Masud Chowdhury, Justice Quazi Reza-Ul Hoque, Justice AKM Zahirul Hoque, Justice Md Ataur Rahman Khan, Justice Naima Haider, Justice Sheikh Hassan Arif, Justice Muhammad Khurshid Alam Sarkar, Justice Ashish Ranjan Das, Justice Khizir Hayat, Justice SM Maniruzzaman, Justice Khandaker Diliruzzaman, Justice Md Akhtaruzzaman, Justice Shahed Nuruddin, Justice Md Aminul Islam, and Justice SM Masud Hossain Dolon.

Among them, Justice Salma and Justice Ataur have been appointed during the regime of the BNPled alliance government, and the rest were appointed during the Sheikh Hasina-led government.

Eunus told The Daily Star that the SC registrar general is supposed to give him the information in 21 days under the Right to Information Act.

"If the Supreme Court registrar general does not respond to my application, I will move a writ petition before the High Court seeking necessary directives on this issue," he said.

However, Justice Salma, Justice Reza-Ul Hoque, and Justice Zahirul have been kept away from bench functions for five years in the wake of an inquiry against them.

The others have been excluded from judicial proceedings from October 20 amid the demand from the agitating students. The SC administration has not yet disclosed the

details of the reasons behind keeping the judges away from the judicial activities. The administration recently, in a press release, said the information about some of the judges is being scrutinised, as the Supreme Judicial Council led by the chief justice has been formed after the

SC delivered its verdict on the constitution's 16th amendment case on October 20. Only Chief Justice Syed Refaat Ahmed has the authority to constitute the benches of the Appellate and High Court Division under the constitution.
