Rab wants to shed its dark past

The force now wants to rebrand itself thru reform, regulations

Since its formation nearly two decades ago to curb organised crime and terrorism, the Rapid Action Battalion (Rab) has been dogged by serious allegations of human rights violations. Rights activists and critics accused it of morphing into a "government death squad" that operated with impunity.

From the infamous seven-murder case in Narayanganj to the killing of Cox's Bazar municipality councillor Akramul Haque in a so-called gunfight, the force has earned quite a notoriety, eventually inviting US sanctions on its top officials in 2021.

Over the last 15 years, the specialised crime busting unit became a household name for alleged extrajudicial killings, enforced disappearances and torture of opposition political figures and government critics. During this period, numerous reports from international rights bodies detailed Rab's rights abuse, including

Some of them could even be hired by willing parties, as proven in court in the Narayanganj seven-murder case. For years, rights organisations from home and abroad called for its reform, and the call intensified after Sheikh Hasina's fall on August 5 in the face of a mass uprising.

Against this backdrop. Rab is planning to change its name, logo and uniform and is drafting a new law to regulate its operations. Currently, there is no separate law for the force, and it operates under the police ordinance.

"We have taken steps to reform the force, including changing its name, rules and dress," AKM Shahidur Rahman, director general of Rab, told The Daily Star

'We have already made a draft for changing the name and dress. We have also taken steps to make a new law for the force, which is in the drafting stage," he said.

Some rights activists, however, call for dismantling the

"Rab should be abolished because there is no need for encounter or extrajudicial killing. Police have three to four departments, and are enough to ensure peace," said ZI Khan Panna, a noted Supreme Court lawyer.

Access to credit a human right Says Yunus at COP29,

highlights LDCs' need for support

Chief Adviser Prof Muhammad Yunus yesterday said that credit is a human right as it relates to the livelihood of the people.

'You can't establish the right to livelihood without ensuring the right to credit," he said in his speech at a side event of the COP29 in Baku, Azerbaijan.

The event titled "A Global Conversation: Access to Finance for Small Scale Farmer" at the Bangladesh pavilion of the conference was jointly hosted by Bangladesh and the

Netherlands. Dutch Prince Jaime Bernardo of Bourbon-Parma, also the climate envoy of the Netherlands, attended the programme.

He highlighted how credit, insurance, investment, research, and finance increased agricultural output. He said millions of farmers across the globe now needed this support.

Red notice sought for Hasina's arrest ICT chief prosecutor's office

writes to Interpol through IGP STAFF CORRESPONDENT

The chief prosecutor of the International Crimes Tribunal has requested police to seek Interpol red notice for the arrest of former prime minister Sheikh Hasina.

Chief Prosecutor Tajul Islam's office on Sunday wrote to the Interpol through the inspector general of police (IGP).

Hasina is accused of committing crimes against humanity and she is a fugitive, he told reporters in front of his office yesterday, adding that the IGP would forward the letter to the international organisation which facilitates worldwide police cooperation.

"There is an arrest warrant for her [in Bangladesh].... We requested Interpol to arrest her or at least issue a red notice," he said.

A red notice is a request to law enforcement worldwide to locate and provisionally arrest a person pending extradition, surrender, or similar legal action, according to the Interpol website.

Over 100 complaints of crimes against humanity have been filed against Hasina, said prosecutors.

Tajul said the tribunal also issued arrest warrants for four absconding police officers on charges of committing atrocities in the capital's Jatrabari during the mass uprising.

Political consensus needed to make reforms sustainable

Says BNP Vice-Chairman and business leader Abdul Awal Mintoo

Without proper institutions, it's not possible to prevent abuse of power, prevent corruption, and improve public life, said business leader Abdul Awal Mintoo.

"It is not the job of an adviser, not the job of a minister, not the job of a political party to do all that," he told The Daily Star in an interview recently.

During the Awami League's 15-year rule, self-interested groups took control of public

institutions, which ultimately served their purposes instead of providing services to people and businesses, said Mintoo, a former president of the Federation of Bangladesh Chambers of Commerce and Industry.

Those groups used to get all the privileges in almost every sector during the Awami League's last three terms.

'You can call them oligarchs, you can call them cronies, you can call them their allies. It doesn't matter which name you are going to use."

AL-affiliated groups particularly captured the banking, energy, road, and transport sectors, said Mintoo, also the chairman of Multimode Group, which has interests in agriculture, banking, insurance, consumer goods, energy, hospitality, food and beverage, manufacturing, real

Ekushey Boi Mela can't be in Suhrawardy Udyan

Public works ministry says it'll be on Bangla **Academy premises**

Bangla Academy has been instructed to organise the Amar Ekushey Boi Mela, the country's largest book festival, at the academy premises only, and not in Suhrawardy Udyan.

The Ministry of Housing and Public Works sent a letter addressing the academy authorities on November 6 with the request.

It said, according to the decision of the meeting held on November 21, 2023, Amar Ekushey Boi Mela 2025 should be organised on the premises of Bangla Academy instead of Suhrawardy Udyan.

The letter was sent from the Administration Department of the ministry, and signed by Deputy Secretary Farida Yeasmin.

14 RMG factories closed as workers resume protest

At least 14 readymade garment factories in Gazipur remained closed yesterday over a dispute between authorities and workers over payment of arrears and other benefits, said police.

Of them, five factories are owned by TNZ Group namely -- TNZ Apparels Limited, Basic Clothing Limited, Apparels Plus, Basic Knitwear Limited, and Apparel Art Limited, said Mosharraf Hossain, assistant superintendent of Gazipur Industrial Police.

Demanding arrears, workers of these factories had been protesting on the street since Saturday morning, blocking the Dhaka-Mymensingh

Although the workers withdrew from the highway Monday night, the five factories remained closed yesterday, said police and workers.

Meanwhile, workers of two factories--MM Knitwear Ltd and Mamun Knitwear Ltd -- in the Konabari area started work abstention around noon yesterday, demanding the reinstatement of the workers who were recently sacked.

Workers of Swadhin Garments in the Konabari Zarun area, who have been protesting for the last three days, demanding arrears, took position in

and was being taken away, when Zakir Hossain, then officer-in-charge of Jatrabari Police Station, went close to them and shot him in the chest to ensure his death," he said.

The tribunal has also granted permission to the prosecutors to interrogate Maj Gen (sacked) Ziaul Ahsan, now in jail, for a day.

The three-judge panel of the ICT led by Justice Md Golam Mortuza Mozumder gave the permission.

The date of Ziaul's interrogation will not be revealed for security concerns, he said.

"He was involved in numerous murders and enforced disappearances. The ICT probe body has evidence," he said.

Limon files case

Mazharul Islam, constable Md Abdul Aziz, Nayek Muktadir Hossain, and soldiers Prahlad Chanda and Kartik Kumar Biswas. Limon also accused six unnamed individuals of the incident.

Speaking to reporters after filing the complaint, Limon said, "I could not get justice for 13 years during the rule of Sheikh Hasina's government. I have now filed the complaint with the International Crimes Tribunal, hoping that justice will be delivered."

Demanding compensation from the government, he said, "Rab has been accused of numerous human rights violations, including enforced disappearances, killings, and extortion. As I think it is a terrorist organisation, I demand its disbandment."

Limon said he faced difficulties in taking legal actions against those responsible for the 2011 shooting incident during Hasina's rule.

"We faced many obstacles and threats. Tarique Ahmed Siddique, then Rab-8 camp commander Major Rashed, and former NTMC director general Ziaul Ahsan are among those who couldn't be accused."

He also said that his treatment at the National Institute of Traumatology and Orthopaedic Rehabilitation was hampered due to directives by then home minister Sahara Khatun.

His treatment later continued at Gonoshasthaya Nagar Hospital in the capital's Dhanmondi, said Limon, adding that he received support from Gonoshasthaya and Bangla daily Prothom Alo for his education.

Taking Limon for an aide of a notorious criminal they were looking for, Rab-8 members from Barishal shot him in Saturia village of Jalakathi's Rajapur upazila on March 23, 2011.

Rab had claimed that the shooting took place during a raid to arrest the criminal. Limon, then 16, was picked up and sent to a hospital. The force filed two cases against him the same day.

Four days after the shooting, Limon's left leg had to be amputated below the knee.

His mother filed an attempted murder case with a Jhalakathi court on April 10, 2011.

Limon completed his HSC in 2013, earned a bachelor's degree in law in 2018, and a master's (LLM) degree in

The government on July 9, 2013, decided to withdraw both the cases against Limon following a request from then National Human Rights Commission chairman Mizanur

Limon has been serving as a lecturer in the law department of Gono University in Savar since 2020. ICT Prosecutor Sultan Mahmud

said they have received the complaint. International Crimes Tribunal has the jurisdiction to hold the trial of such cases," he told The Daily Star.

Liton, also a member of Enforced Disappearance Enquiry Commission, said, "Their [Rab] actions are beyond imagination. After the seven murders in Narayanganj, there should not be any sympathy for them."

The Enforced Disappearance Enquiry Commission was formed on August 28 by the interim government. So far, the Commission received 172 complaints -- the highest against any of enforced disappearance

As of October 31, the five-member Commission received some 1,600 complaints. Of them, the Commission scrutinised 400 complaints and interviewed 140 people.

The Commission was formed to identify the victims of enforced disappearance by intelligence and law enforcement agencies from January 1, 2010 to August 5, 2024.

Sharing the findings of the Commission with this newspaper, Nur Khan said, "We have found a diary inside a cell operated by the Rab. The cell measures just 3.5 feet by 4 feet... there was no source of light, except a small peephole, and no sanitation system except an open drain, forcing the detainee to perform all basic functions there."

The detainees were able to identify the beginning of a new day when they were provided a piece of bread for line with the constitution, existing breakfast, he said.

The law will also specify statutory powers of preventive measures, arrest of the accused and investigation of offences under the jurisdiction of Rab.

Speaking on condition of anonymity, a top Rab official said that in response to the 2021 US sanctions, efforts are already underway to train their members on human rights.

"A counter-intelligence approach is used to prevent Rab members from engaging in unlawful activities. In cases where Rab members are found involved in such activities, appropriate actions are taken through the internal investigation cell," the official added.

Another official of the Rab Headquarters, requesting anonymity, said, "We have taken actions against 4,000 members of the force since its inception for their involvement in different crimes like seven murders in Narayanganj."

Citing their own data, the officials said they arrested 1,460 murder and rape suspects from January 1 to October 31 this year. During the same period, 617 people were arrested for robbery, 680 for mugging, 500 for kidnapping, 248 for cheating and 35 for human trafficking.

Since its inception, Rab arrested some 6,531 murder and rape suspects. Additionally, 3,783 were arrested for ensure accountability of the force in robbery, 11,855 for mugging, 5,628 for kidnapping, 7,641 for cheating and 1,802 for human trafficking, according to Rab data.

"But there is another side to it. Once you restrict the money supply, production will drop, demand will drop, and thereby prices will go up," he said, adding that there are 18 factors that influence prices and inflation.

Except for jute mills, almost all the industrial sectors have to import most of their raw materials to produce goods for domestic and export markets.

In addition, the rising interest rate, which is now almost 16 percent, will increase the financial cost of businesses, and it will ultimately be passed on to consumers.

'So, prices will go up.' The overall growth of the economy

may be lower than the four percent projected by the World Bank.

"Consumption has shrunk for two reasons: first, you don't have any money. Secondly, because of the price increase, you cannot buy enough. Inflation has been well above the wage rate growth for nearly three years, and it has affected consumption.

Besides, public expenditure has been reduced, which is clear from the low implementation of the Annual Development Programme.

The chief adviser said the countries should redesign the banking system by following the Grameen Bank model to make credit accessible to farmers, a considerable number of whom are

At an earlier event of the COP29 vesterday, he advocated for Least Developed Countries to get preferential treatment due to their unique circumstances and development needs.

He said most vulnerable countries with limited decarbonisation capacity need adequate financial and technical support to develop green industries, according to the chief adviser's press

"International collaboration required to foster economic growth and create new job opportunities in emerging markets, supporting a just and inclusive transition," Prof Yunus told the High-Level Climate Club Leaders Meeting, jointly hosted by Germany and Chile.

Today, he will address the Opening Session of the World Leaders Climate Action Summit at the conference.

Yunus said carbon leakage can dilute incentives for innovation in low-carbon technologies globally, as some sectors might prioritise cost over sustainable practices.

To mitigate these risks, he said policies such as carbon border adjustments and international cooperation are essential to balance decarbonisation efforts with economic stability.

"Conversely, these policies can affect the competitiveness of the companies of particularly vulnerable developing countries like Bangladesh, as strong emission policies will cause higher production costs, making them less competitive globally."

He also said many decarbonisation technologies require significant upfront investment. "These high capital costs can be a barrier for industries, particularly in most vulnerable developing countries like Bangladesh, with limited access to

He stressed financial support for

private sector industries of developing countries from developed countries to accelerate innovation and shared learning.

CA MEETS GLOBAL LEADERS Prof Yunus met at least 20 top world leaders and heads of international agencies, including Turkish President Recep Tayyip Erdogan.

President Erdogan invited him to visit Turkey and assured Bangladesh of all possible help in its journey to carry out deep reforms and build a prosperous

Yunus also invited the Turkish president to Bangladesh.

He also met UAE President Sheikh Mohamed bin Zayed Al Nahiyan and thanked him for releasing the 57 Bangladeshi nationals who were imprisoned for staging protests in solidarity with the students in July.

The chief adviser met and greeted Shehbaz Sharif, prime minister of Pakistan; Mohamed Muizzu, president of the Maldives; Tshering Tobgay, prime minister of Bhutan; and Ramchandra

Paudel, president of Nepal. Yunus has been calling for the revival of the SAARC as a top platform for

outh Asia's eight countries. He also met FIFA President Gianni Infantino and invited him to join the youth festival in Bangladesh in January. Infantino accepted an invitation.

Prof Yunus briefed him about the festival and sought his help in bringing reputed women's football teams to Bangladesh. While calling on Prof Yunus, Ahmed

Empower womenled green SMEs

Speakers tell roundtable

STAFF CORRESPONDENT

Innovative financing and collaboration with financial institutions is needed to support climate-resilient small and medium enterprises (SMEs), particularly those led by women in vulnerable communities, said speakers at a roundtable vesterday.

The event, titled "Climate-Resilient Cooperatives to Green SMEs: Enabling Resilience for Climate Vulnerable Women," was jointly organised by UNDP's LoGIC project and The Daily Star at the newspaper's office.

Presenting the keynote, AKM Azad Rahman, project coordinator of LoGIC, highlighted the role of collaborations in fostering socio-economic empowerment and climate action.

"Under this project, 247 Climate Resilient Cooperatives have been formed across seven districts, pooling capital through shares and savings to start green businesses," he said.

"Of these, 99 cooperatives have invested in green businesses, 219 have developed green business plans, and 55 green enterprises are operational. In total, Tk 30 million has been invested in green

businesses, with 14 cooperatives currently generating BDT 500,000 in revenue.'

Maliha Mujammel, climate change specialist at UNDP Bangladesh, said UNDP is working closely with the SME Foundation, Bangladesh Bank, and the Securities and Exchange Commission to identify financial barriers and design an innovative blended finance facility to support resilient green SMEs in vulnerable

Sonali Dayaratne, UNDP Bangladesh's deputy resident representative, stressed the importance of involving youth in sustainability efforts, which she said are critical for the long-term success of climate-resilient enterprises.

She also called for support from international financial institutions such as the Asian Development Bank, World Bank, and Islamic Development Bank to scale proven models through concessional loans.

Nayoka Martinez Backstrom, first secretary at the Embassy of Sweden, highlighted the transformative impact of the LoGIC project and suggested collaboration with government sectors like Agriculture and Fisheries, which are

Dalia Begum, 65, has spent decades rolling biri at a factory in the Kashipur area of Barishal.

Her late husband, Jalal Howlader, also worked in the same industry until he died of tuberculosis a few years ago.

Today, Dalia often feels feverish, relying on tablets her son brings from a nearby store. "My husband died of tuberculosis, and now I feel sick, too," she said.

"We live from hand to mouth and can barely afford three square meals a day, so, undergoing medical tests is a luxury we can't simply afford," she added.

Dalia's story is far from unique; the biri portrays a factories in Barishal have seen numerous cases of illness among workers.

Rahima Begum, another worker, was found at the factory with her two young children. She has been coughing up blood for months. "I don't know what's happening to me, but I'm taking medicine as the doctor advised," she said.

Together, these factories employ between 5,000 and 6,000 workers.

Despite the serious health risks, factory conditions go unmonitored, and there is little accountability from owners.

dream. The Daily Star has already covered how children are exploited inside these factories. But this doesn't mean the women or men working inside have it easier.

Karikor Biri, the oldest among seven biri ago, with Barishal city housing three factories in Barishal division, epitomises the traditional, labour-intensive process of handmade biri production.

Stepping inside one of its branch factories in Sadhur Battala area, this correspondent was immediately struck by the acrid stench of tobacco that filled the

The smell was overpowering, creating a feeling of suffocation that made breathing a conscious effort.

Under the dim light. hundreds of workers, mostly women, moved quietly, filling and packing biri sticks by hand.

During breaks, the silence was pierced by the sound of persistent coughing. Ventilation in this

10,000-square-foot shed is minimal: only four small windows and a single entrance allow fresh air to enter, leaving the cramped space

damp, and dark. Light barely filters in, and the artificial

bulbs are too dim to ease the atmosphere. The factory's sanitary conditions are equally alarming. Of the two washrooms, neither is maintained adequately; they are

Hope revives as BR resumes studies, designs

Bangladesh Railway (BR) has resumed the feasibility study and detailed design for a chord line from Dhaka to Cumilla via Narayanganj.

The line will reduce the distance between Dhaka and Chattogram by 90 kilometres and travel time by two hours, say BR officials. The authority also resumed the study

and designing for a bridge parallel to the existing century-old Hardinge Bridge over the Padma river. We have resumed the studies following

the ministry's directive," Project Director Abidur Rahman told The Daily Star yesterday.

The development came around six months after the railway authorities halted the study following the directive of the previous government reportedly over a financial crisis.

The previous government in June 2020 approved a Tk 235.37-crore Technical

Assistance Project, with the Asian Development Bank providing Tk 167.14 as a loan for feasibility studies and designs of 11 potential projects.

In February last year, a joint-venture firm was hired to carry out preparatory works for upcoming projects, including the chord line and second Hardinge Bridge.

After carrying out some work, the firm proposed four possible aliments for building the chord line.

In March this year, the then prime minister directed to postpone the study for the chord line and second Hardinge Bridge,

according to seniority, with veterans given the highest production targets of up to 32,000 sticks per week.

To stretch their earnings, these "permanent" workers resort to subcontracting most of their work to local women and children, while pull rickshaws and work in local tea stalls to earn extra money. subcontracted The

workers are paid a paltry Tk 35 for every 1,000 biri produced, while the permanent workers are left with a net profit of Tk 55. The process is broken into

three stages: assembling the biri sticks, filling them with tobacco, and sealing and packaging them. Subcontractors get just

Tk 16 for rolling the biri sticks, Tk 3 for filling, and Tk 16 more for final packaging. Abdur Rashid, general

secretary of the Karikor Biri Workers Union, voiced concerns about stagnant wages amid rising costs of living. "Prices are climbing, but our wages remain unchanged. Many of us are lucky if we earn between Tk 5,000 and Tk 12,000 monthly," he said.

A VICIOUS CYCLE

Meanwhile, in Barishal's biri factories, generations of workers mothers, daughters, grandmothers

generational toil capture a sad reality: the cycle of poverty that has entangled entire families within these smoke-filled sheds for decades.

Her own journey in this industry began much the same way - guided by her mother, Minara Begum, who, at 40, still works here, her health rapidly declining. sometimes need

Firoza Begum, 65, resides in the Palashpur slum 1. She began rolling biris after her husband's death. She makes just Tk 32 for 2,000 sticks.

Parul Begum, another resident, makes up to 25,000 sticks a week, earning only Tk 16 per thousand sticks.

The situation is no different in Kala Kha, where Chan Banu, 65, has spent over 40 years in the profession. Her home is a small, dark room with worn-out walls. She continues her work

significant correlation between exposure to harmful environments in tobacco factories, and an increased risk of respiratory diseases, including tuberculosis.

Research has shown workers in such environments particularly vulnerable to respiratory conditions due to long-term exposure to tobacco dust and poor air quality, which weakens their immune systems and heightens susceptibility to infections like TB, said experts. Siddiqur Rahman, a

former professor at Shere-Bangla Medical College in Barishal, treats around 2,000 TB patients annually, with over 60 percent caused by direct or indirect impacts of tobacco. Saiful Islam from BRAC

said 70 percent of people carry TB germs, and its symptoms often surface when the immune system weakened. Exposure to tobacco increases the chance of TB infections.

WHAT AUTHORITIES SAY Osman Gani, deputy director of the Barishal divisional department of labour, said, "We held awareness

Appointment of HC judges to be transparent Says chief justice

Chief Justice Syed Refaat Ahmed has said that necessary initiatives will be taken soon to introduce a transparent and accountable process for appointments of High Court judges.

"The Supreme Court has already revived the Supreme Judicial Council to ensure the independence of the judiciary. Steps will be taken soon for the implementation of e-judiciary to bring transparency in the judicial process along with the modernisation of the judiciary and increasing the accessibility of the judicial system," he said.

He said this while addressing as keynote speaker at a regional conference in Thailand's Bangkok on Monday. The conference, organised by UNDP, Thailand Institute of Justice, UNEP, IDLO, Unesco, Unicef, UN Women Asia and the Pacific, Pathfinders, and World Justice Project, was attended by representatives from different countries and Pacific region, an SC press release said yesterday.

Take effective steps to prevent dengue: HC

The High Court yesterday ordered the government and Dhaka city corporations to take all necessary and effective measures to prevent rapid spreading of dengue and other diseases infected by mosquitos in the capital as well as the whole country.

The authorities concerned have been asked to submit a report before the HC after complying with the directive in 30

In response to a petition, the HC asked the authorities to form a highpowered committee with the national and international experts in 60 days for exploring and suggesting a permanent solution on the matter of prevention, control and eradication of dengue and other diseases infected by mosquitos.

The court also issued a rule asking the officials concerned of the government and DCCs to explain why their inaction in preventing spread of dengue and other diseases infected by mosquitoes should not be declared illegal.

KMCH struggles to cope with dengue patients

Khulna is witnessing a surge in the number of dengue patients every passing day.

Now, Khulna Medical College Hospital is grappling with the surge of dengue patients getting admitted.

The hospital currently has 145 dengue patients being treated, up from an average of 80-100 patients last week.

However, KMCH authority has not appointed any specialist doctor to treat these patients and there is no separate ward for them.

Visiting the hospital recently, this correspondent observed that dengue patients were being treated across six different units in the Medical Ward. Amid an acute shortage of beds, many patients are being treated on the floors.

also complained that they are being compelled to buy medicines themselves. Lovely Khatun, a local, recently went

Some patients and their relatives

to Dhaka for a recruitment test, and fell ill. After seeking treatment at Islamia Hospital in Motijheel, she was diagnosed with dengue. Lovely then returned to Khulna and was admitted to KMCH last Friday. However, a shortage of beds has left her receiving treatment on the floor.

Lovely said although her platelet count has dropped to 42,000, the hospital has not been providing medication and saline, so she had to purchase those herself.

Halima Begum, another patient, was laying there without a mosquito net. "It is very hot, but there is no fan here, so I removed the net," she said.

"My oxygen level and hemoglobin have been dropping since yesterday. The hospital hardly provided any medicine. I have spent Tk 3,700 already for medicines and tests," she alleged.

According to KMCH sources, patients diagnosed with dengue or dengue symptoms have been coming from

across the city, different upazilas and neighbouring districts.

This year, 850 dengue patients have so far been treated in the hospital, while 13 died, the sources added.

Dr Suhash Ranjan Halder, focal person (dengue) at KMCH, said dengue patients were being kept separately, but pressure of incoming patients left them struggling to isolate them from others.

"We instructed to keep them inside mosquito nets, but some patients and attendants have not been listening," he

Dr Muhammad Nurul Islam, deputy director of KMCH, said they are working to prepare a separate ward for dengue patients if the number increases further.

"There are some 1,600-1,700 patients being treated against the available 500 beds. As such, there is not enough medicine for all. However, we are providing free medicine to dengue patients as much as possible," he added.

Says Fakhrul; Rizvi regrets comment on Bangabandhu's portrait removal

Anis: The quirky, naive intellectual In the wildly popular drama Aaj Robibar (1999), Zahid Hasan's Anis charmed audiences with his wit and eccentric mannerisms. Anis's quirky dialogues have recently found new life on social media, with memes and

clips reintroducing the character to a vounger generation, making him a fan favourite all over again.

Nilu: A reflection of Humayun's strengths

The character Nilu from Humayun Ahmed's debut drama serial Eishob *Dinratri* (1985) resonated with viewers as a reflection of the writer's ability to create relatable, multifaceted women whose stories touch upon the joys and struggles of everyday life.

The character was portrayed by veteran actor Dolly Zahur, which remains to be one of the most celebrated roles of the actress. The drama was aired on BTV and later adopted as a novel in 1990w with the same title.

Beyond these notable figures, work also unforgettable characters like Yunus from Matir Pinjira and Dhotara



Chacha, played by Challenger, in TV drama Urey Jay Bok Pokkhi. Mitra was born December 22. 1938, in a village in Satkhira district of undivided Bengal. His father was a government officer.

Though plays were enacted at his family home during the festive days of Durga puja, children were not allowed to watch them. Backdrops, props, costumes, and other articles associated with the staging of plays stored at home kindled his passion for plays.

Mitra permanently moved to India from erstwhile East Pakistan at the age of 12. He completed his Master of Arts degree in Philosophy in 1960.

During the college and university days, he wrote short stories and plays. However, after his play "Mrityur Chokhe Jal" earned him first prize at mesmerised veteran actors of that time as the 21-year-old youth effortlessly metamorphosed into an elderly man in "Mrityur Chokhe Jal".

WB points out myriad issues

officials, negotiations with the WB were completed on Monday, and the first round of talks with the ADB and JICA also concluded.

Officials of the Economic Relations Division of the finance ministry said they would soon finalise each development partner's contribution to the plan. The government would foot the rest of the bill.

The plan, titled "Health, Nutrition, and Population Sector Development Programme (HNPSDP)", is renewed every five years. The current plan is set to expire in June next year.

Experts said the existing budget for health is insufficient and that the sector has struggled to effectively use the funds allocated to it.

In recent review of the health sector, the WB said, "Bangladesh's Health, Nutrition, and Population (HNP) sector faces numerous challenges, including maintaining immunisation coverage, improving child nutrition, enhancing the quality and reach of services, reducing socio-economic and regional disparities, addressing emerging health challenges, and strengthening financial management in the health

lacks sufficient funding. We are unable to even fully utilise the limited funds. The money is often inefficiently spent," he told The Daily Star, adding that corruption was a major issue too.

The World Bank has identified several challenges, including the slow pace of poverty reduction amid widening inequality, as well as malnutrition. It noted that even though the

maternal mortality ratio has declined to 143 per 1,00,000 live births, it is still more than double the global Sustainable Development Goal target of 70. It observed that malnutrition threatens health outcomes and human

capital. Nearly one in five women in Bangladesh is undernourished, one in three women aged 15-49 is anaemic, and one in six babies is born with a low birth weight, it said.

Improving the quality of antenatal care by including measures like multiple micronutrient supplementation could help prevent these poor outcomes, stated the WB.

Action is urgently needed as Bangladesh is also vulnerable to climate change, which threatens to exacerbate malnutrition and increase the risk of climate-sensitive non-communicable diseases, it said.

"Underlying these trends is a lowquality health system," the WB said. adding that maternal health services suffer from poor quality, with issues like inadequate midwife support during

"The main issue is that the sector childbirth, overuse of cesarean sections, and ineffective referral systems for timely care of complications.

WB further mentioned The that "primary healthcare facility performance is about 60 percent", contributing to a high rate of preventable complications, increased reliance on more expensive and climate-intensive services, and a high out-of-pocket payment rate of 68.5 percent.

Prof Syed Abdul Hamid held the inefficient management accountable for these issues and suggested that recruitment managerial positions needs to be overhauled, with rigorous training provided for both managers and supporting staff.

He advocated for block allocations for public hospitals to address emergency crises and recommended involving the private sector for repairs of machinery. Hamid also called for streamlining

HIT-AND-RUN ATTACK

35 killed, 43 hurt in south China

A hit-and-run attack at a sports centre in the southern Chinese city of Zhuhai killed 35 people and severely injured 43, local police said yesterday.

The incident happened at 7:48 pm (1148 GMT) on Monday, when a small off-road vehicle was driven into a large group of people exercising outside the sports centre.

Zhuhai police said in a statement yesterday that the suspect, a 62-year-old man surnamed Fan, was being treated at a hospital after hurting himself with a knife in his car.

A video of the scene following the attack, verified by Reuters, showed at least 20 people lying on the ground. Cries of "terrorist" could be heard as ambulances arrived to take the injured to hospital. Fan was apprehended by police at the scene

after attempting to flee, police said, adding that he had self-harmed using a knife, causing severe neck injuries. Police said their preliminary investigation suggested the incident was triggered by Fan's discontent following a divorce.

President Xi Jinping, cited by Chinese state television CCTV, ordered all-out efforts to treat the injured and demanded severe punishment for the perpetrator. The central government has dispatched a team to provide guidance on handling of the case, CCTV said.

Violent crime is rare in China due to tight security and strict gun laws. However, a rise in reports of knife attacks in large cities has drawn public attention to safety in public spaces.

ABUSE SCANDAL Justin Welby resigns as Archbishop of Canterbury

Archbishop of Canterbury Justin Welby resigned "in sorrow" yesterday, saying he had failed to ensure there was a proper investigation into allegations of abuse by a volunteer at Christian summer camps decades ago.

Welby, the senior bishop of the Church of England, had faced calls to resign after a report last week found he had taken insufficient action to stop a person it described as arguably the Church's most prolific serial abuser.

"The last few days have renewed my long felt and profound sense of shame at the historic safeguarding failures of the Church of England," Welby said in a statement. Welby resigned five days after the independent Makin Report singled him out for criticism over his handling of abuse allegations dating back to the 1970s.

Protect Bhabadaha from waterlogging

Govt should implement TRM to resolve this long-standing issue

We are gravely concerned by the persistent waterlogging in Jashore's Bhabadaha area following the heavy rains in August. This area, in fact, has been plagued by waterlogging since the early 1980s, primarily due to the construction of embankments and sluice gates that disrupted the natural flow and dried up nearby rivers. In recent years, waterlogging has not only deteriorated in Bhabadaha but also spread to neighbouring areas. Currently, at least 300 villages in Jashore's Abhaynagar, Manirampur, and Keshabpur, Khulna's Dumuria and Phultala, and Satkhira's Sadar and Tala upazilas are grappling with severe waterlogging, affecting around 10 lakh people.

Reportedly, over 200 schools in these areas have been inundated, depriving thousands of children of education, while around 50,000 farmers in 10 upazilas of the three districts are facing uncertainty over growing the Boro crop this season, as about 96,000 hectares of farmland remain waterlogged. The situation is dire and requires proper interventions.

Unfortunately, the authorities have allowed this problem to persist for decades despite a proven solution being available: the Tidal River Management (TRM). Since 1982, the Bhabadaha Water Drainage Movement Committee has advocated TRM to policymakers, yet their calls have largely gone unheeded. Local influential figures, benefitting from shrimp farming in the waterlogged areas, have also obstructed efforts to address the issue, leaving farmers and ordinary residents to bear the brunt. Although the previous Awami League government implemented several projects spending crores of taka, these were not scientifically sound and failed to provide lasting

Pumping out water from the affected areas and dredging nearby rivers can offer only temporary relief, so locals need a permanent solution. That's why implementing TRM is crucial. Under this method, a canal, which connects a river to a beel, is dredged to allow river water to flow into the beel so that the sediment is carried in and the low-lying area is elevated. Some sediment is then carried back into the sea during low tide. This approach allows water to enter the beels for gradual land reclamation. Over time, the raised land within the embankment becomes higher than the surrounding riverbed. Local communities have previously implemented TRM in some beels with successful results, but political influences, including those of shrimp businessmen, have repeatedly hindered this

Reportedly, if waterlogging continues even for a few more days, it will severely impact Boro crop cultivation for the next season. Therefore, immediate action is needed from the government. For a long-term solution, the government should begin implementing TRM in the region. It is promising that Syeda Rizwana Hasan, adviser to the environment ministry, has pledged to resolve the issue. We hope her words will soon translate into action.

A welcome move for migrant workers

Dedicated airport lounge highlights the critical role of remittance earners

We applaud the opening of an exclusive lounge for migrant workers at the Shahjalal International Airport in Dhaka. Long demanded by migrants to ensure seamless journey, this step by the interim government aligns with other reassuring measures it has taken since August 8, including securing pardons for 57 jailed Bangladeshi migrant workers in the United Arab Emirates (UAE) and initiating talks with Malaysian authorities for re-recruiting Bangladeshi workers.

Reportedly, migrant workers, whose remittances form the backbone of Bangladesh's economy, are often subjected to neglect and harassment at the airport. Although fancy displays were installed inside the airport during the last regime, hardly any arrangements were made to ease migrant workers' travel experience. Many workers travel from remote parts of the country, enduring long journeys and the anxiety of venturing abroad, only to face unkind treatment from airport staff upon arrival. The same poor reception greets them when they return

The newly opened lounge provides much-needed rest and relief for the workers-before they embark on another long and sometimes hectic journey—as well as subsidised snacks priced lower than the typically overpriced airport food. Moreover, 100 volunteers sponsored by the International Organization for Migration (IOM) will assist them at the airport. These efforts, however, should not diminish the need for training regular airport staff to ensure better treatment for our remittance

Given that remittances are one of our primary sources of foreign currency, it is extremely important for the government to prioritise this sector, especially in light of the country's foreign currency debt. Authorities should also address other key issues faced by migrant workers including high cost of migration, recruitment irregularities, wage theft, abuse by foreign employers, and inadequate support from Bangladeshi missions abroad. Expanding into new labour markets through diplomacy, or expediting recruitment in established ones like Malaysia and UAE, should remain our priorities, but not at the cost of workers' rights.

We hope the government will continue to take meaningful steps to support them in their journey to earn remittances, and ensure that they are treated with the respect and dignity they deserve, both at home and abroad.

nationality or residency rights in foreign countries, it signals that its politics has reached an impasse—a dead end—with leaders hedging their bets with an exit strategy should their careers become untenable. This disturbing tendency has become evident in Bangladesh after a report revealed that 24 politicians who served as ministers, advisers or members of parliament during the tenure of the ousted Awami League government hold foreign citizenship or residency cards. They have allegedly acquired these privileges by concealing information, which constitutes a breach of both the law and Bangladesh's constitution. Article 66 of the constitution clearly states that a person who acquires foreign citizenship or pledges allegiance to a foreign state cannot serve as a member of parliament.

This disregard for the people and country they were supposed to serve can be attributed to the erosion of the electoral system, breakdown of good governance, pervasive financial corruption, and unchecked money laundering over the 15-plus years under deposed autocrat Sheikh Hasina. Her misgovernance displayed traits commonly associated with fascism, such as curtailing electoral democracy, stifling political and cultural liberalism, establishing family-centred rule, using security forces for personal and crony interests, and scapegoating political or social groups to deflect blame for any national failure or crisis. Above all, there was an extensive personality cult built through statefunded propaganda.

In Bangladesh 2.0—following Sheikh Hasina's fall and her subsequent refuge in India on August 5, 2024—the state reform drive of the interim government has focused on various areas, including the electoral system, constitution, judiciary, civil administration, and media. However, one of the most essential components of state reform-politics and political parties—has been relatively absent in the reform agenda or even public



Further reforms should be made to the Representation of the People Order, 1972. Key positions within political parties must be elected by secret ballots in councils, ideally under the Election Commission's supervision, to prevent unopposed or uncontested selections. The commission should also audit party finances annually, mandating transparency in political funding by requiring parties to disclose their donors.

Finally, we must ask: should individuals who lack absolute loyalty political parties? Should parties voluntarily revoke membership of difficult to reach.

Can we reduce income inequality by 2030?

The first target under Sustainable Development Goal (SDG) #10 reads, "By 2030, progressively achieve and sustain income growth of the bottom 40 percent of the population at a rate higher than the national average." This calls upon all nations to bolster the income of the bottom 40 percent of the population by promoting economic, social and political inclusion of all people, irrespective of their sex, age, physical conditions such as disability, religion, race, class, ethnicity, etc. The achievement of this global target requires creating appropriate and equal opportunities, empowerment of women, and reduction of poverty and inequality. The ongoing work of the interim government's public administration and constitutional reform commissions needs a focus on these aspects so that the future elected government may work to fulfil SDG 10, as Bangladesh has only six years in hand to establish substantial improvements on this global goal.

Therearedatachallengeswithregard to having a proper understanding of the income inequality situation in Bangladesh. According to UNDP data, the income share of the bottom 40

is 11 percent. In sharp contrast, for the top 10 percent, the income share is 43 percent. Based on Household Income and Expenditure Survey (HIES), 2022, the income of the bottom 40 percent population grows at 7.7 percent per annum, while the annual growth rate of income of the total population is 9.1 percent. The HIES 2022 shows that the top 10 percent of households increased their share of wealth to 40.91 percent, around 2.83 percent rise since 2016. The bottom 50 percent of the households had 19.05 percent of the total income in 2022, which came down from 20.23 percent in 2016.

Even though the country achieved progress in poverty reduction, the income Gini coefficient has been on the rise. It increased from 0.458 in 2010 to 0.499 in 2022. During the same period, consumption Gini coefficient increased from 0.321 in 2010 to 0.334 in 2022. The data from surveys over the last two decades clearly shows that income and wealth inequality is growing in Bangladesh. Whether we consider the well-known measure, the Gini coefficient, or an alternative measure like the Palma ratio, and compare the income share percent of the country's population of the top 10 percent with the income

the same result, which demonstrates that inequality is consistently rising in our society.

The constitutional commitment of ensuring social and economic equality among the citizens of the country can sustain without resulting in major social and political unrest. However, there is no reason to assume that income and wealth inequality will come down automatically. The common strategic options that are available to reduce inequality are participatory planning and inclusive development, pro-poor budget formulation and implementation, development, progressive taxation of income, adoption of appropriate legislation, scrapping of discriminatory laws, realistic minimum wage fixation, improved governance, effective measures against corruption, containment of inflation, promotion of social protection measures, investment in small and medium enterprises, and greater investment in the social sector.

Bangladesh, the major challenges hindering the achievement of economic and social equality are: low public expenditure on education, training, health, rural development and social protection; poor direct tax collection and a culture of tax evasion; high level of selection error in social protection schemes; and high percentage (12.6 percent) of femaleheaded households with limited assets and means of production. The benefits of economic growth in the country have gone to the upper-income groups while the poor

share of the bottom 40 percent, we get remain marginalised. The "pro-poor growth" concept is not being applied properly. Programmes and projects that benefit the poor need to be taken up in a greater number. Micro-credit and SME loans should be increased to help accumulate assets of small entrepreneurs and create additional employment in the formal sector. The high inclusion and exclusion errors in the social protection programmes must be corrected through a bold and one-time correction of the beneficiary list. Irregularities in the banking sector, money laundering, and tax evasion must be curbed with a strong hand. Health and nutritional services must be freed from corruption and mismanagement, so that the vulnerable population gain access to

the benefits of these public services. A vital issue that exacerbates inequality is the overwhelming centralisation of the decision-making process. The politician-bureaucracy nexus is strong, and this keeps people out from participating in the governance process. Unless the attitude of the politicians, bureaucrats and policymakers change towards a more people-centric approach in planning and development as well as local governance, the level of inequality is unlikely to come down in the near future. Additionally, the political parties should be committed to the greater good of the general people instead of continuing the culture of benefiting a select few, and adopt social-democratic norms for economic development with strong emphasis on securing socioeconomic equality in the country.



Nvidia becomes first company to surpass \$3.6 trillion market value after Trump's election win

Nvidia Corp has made history as the first company to reach a stock market valuation of \$3.65 trillion, surpassing Apple's previous record of \$3.57 trillion. The surge in the chipmaker's stock comes as Wall Street celebrates renewed optimism following Donald Trump's recent return to the US presidency, with expectations of tax cuts and reduced regulatory measures.

On Thursday, Nvidia's shares rose 2.2%, driven by investor confidence in the tech sector's potential under a pro-business administration. This

performance helped Nvidia's market value outpace Apple's, which also saw gains, with its stock climbing 2.1% to a value of \$3.44 trillion.

Nvidia's extraordinary rise has been bolstered by its dominance in the artificial intelligence (AI) chip market. The company has benefited significantly from a technological arms race among industry giants like Microsoft, Alphabet, and other major players, who are striving to expand their AI computing capabilities. As a result, Nvidia's stock has skyrocketed, tripling in value since the start of 2024 and posting a 12% gain in November alone.



Bangladesh's batting evolution stuck in limbo

Bangladesh were mulling a change of approach in white-ball batting before the 2023 ODI World Cup. However, the very topic now appears so outdated that it begs the question of whether any lasting progress has actually been made.

Against South Africa in March 2022, when Shakib Al Hasan started his hitting early -- just after the 30-over mark -- he successfully disrupted the Proteas' tactic of saving Kagiso Rabada's overs for the death. Ūsually, Bangladesh build until the 40th over and, depending on wickets in hand, go for late blows, but Shakib was going against the grain of what is considered the norm for the Tigers, who snatched the ODI series 2-1.

Bangladesh's batting was once again in the limelight due to the approach taken by the whole unit in the just-concluded series against Afghanistan. The Tigers were missing a few key players in one match or another during the three-match ODI series, but overall it provided a chance to refresh the approach.

Soumya Sarkar and Tanzid Hasan Tamim became the latest opening batters, the 14th different opening pair within a period of two years. Soumya showed promise in getting runs, but, just like the opening pair -- which perhaps changed to accommodate Liton Das' injury -- there has been no continuity of ideas in terms of

The openers started the third ODI on the front foot, both looking in form, but once they departed, the innings quickly lost momentum. Neither Zakir Hasan nor



Towhid Hridoy appeared to play to their

Bangladesh appeared a few runs short despite Mahmudullah Riyad and Mehedi Hasan Miraz's heroics, simply because team management had believed the wicket would behave differently, favouring the bowlers under lights. When that did not happen, the result became a forgone conclusion as there were simply not enough runs to make Afghanistan

The three ODIs in Sharjah almost appeared to be from a different era, not what is usually the norm in ODIs played today. There were no 300-plus scores from teams batting first. Generally, that favours the Tigers, especially as seen over the years when they played in Mirpur, where 240 has been a challenging score.

Before last year's ODI World Cup in India, where venues in Mumbai, Hyderabad, and others had scores over 360, there was talk about a more attacking approach under Chandika Hathurusingha. Mushfiqur Rahim had been demoted to number six, Hridoy had been promoted, and Shakib appeared to be setting a tone during that South Africa series. There was talk of focusing on acceleration in the middle overs.

Yet, when push came to shove, without ome of their more recognised profiles in Mushfiqur or Shakib present, and also without skipper Najmul Hossain Shanto in the third ODI, their approach reverted back to familiar territory -- targeting 250 scores. Meanwhile, no players have seized opportunities when regular batters in the ODI setup have been absent.

In terms of continuity, they have not carried forward the gusto from 2023 with which they wanted to take on an attacking approach. Also, despite much talk of improving practice and match wickets to boost batters' confidence, little has changed under the new board president. If this approach is to change, it starts with getting into the flow of how modern white-ball cricket is played. However, the Tigers still look well off the mark.

Politics vs cricket leaves Champions Trophy up in the air

The fate of the upcoming Champions Trophy still hangs in the balance as India refused to travel to Pakistan for the tournament, with the Pakistan Cricket Board (PCB) on Tuesday asking the International Cricket Council (ICC) for clarification regarding Board of Control for Cricket in India's (BCCI) refusal in sending its team across the border.

The PCB has responded to last week's ICC letter seeking clarifications for the Indian board's decision not to travel to Pakistan for next year's Champions Trophy," Sami-Ul-Hasan told AFP.

It marks another instance of politics between these two nuclear-armed nations interfering with cricket. India and Pakistan have not played a bilateral series for over a decade -- squaring off only in ICC multination events. India last visited Pakistan in 2008, for the Asia Cup.

The neighbouring countries have fought three wars since being carved out of the subcontinent's partition in 1947 and that rivalry is often reflected on the cricket field.

Pakistani media reported on Tuesday that the PCB would be unwilling to accept security reasons for India's refusal to visit.

New Zealand have toured Pakistan three Naqvi termed disappointing. times in the past two years, with England visiting twice and Australia once in the same period.

Pakistan also visited India for last year's ODI World Cup and the PCB had expected the gesture to be reciprocated for the Champions Trophy.

"Pakistan has shown great gestures to India in the past, and we'd like to say clearly India shouldn't expect such friendly gestures from us every time".

India is due to host the women's ODI World Cup and Asia Cup next year and will

Pay up or face climate disasters

Warns UN chief; host nation Azerbaijan defends fossil fuels

United Nations Secretary-General Antonio Guterres yesterday told world leaders at the COP29 summit to "pay up" to prevent climate-led humanitarian disasters, and said time was running out to limit a destructive rise in global temperatures.

Nearly 200 nations have gathered at the annual UN climate summit in Baku, focused this year on raising hundreds of billions of dollars to fund a global transition to cleaner



energy sources and limit the climate damage caused by carbon emissions.

But on the day of the summit designed to bring together world leaders and generate political momentum for the marathon negotiations, many of the leading players were not present to hear Guterres' message.

After victory for Donald Trump, a climate change denier, in the US presidential election, President Joe Biden will not attend. Chinese President Xi Jinping has sent a deputy and European Commission President Ursula von der Leyenis attending because of political developments in Brussels.

India's top anti-money laundering probe agency yesterday raided multiple locations in West Bengal and Jharkhand states to examine money laundering activities tied to suspected unlawful entry of Bangladeshi nationals.

Ranchi office of the Enforcement Directorate conducted raids at 17 places in the two states yesterday, a day before today's first phase of polling in Jharkhand where illegal immigration dominated the campaign.

The raids also came a day after the National Investigation Agency (NIA) -- India's anti-terror probe -- conducted searches at multiple locations across six states, including Assam and West Bengal, in connection with the alleged activities promoted by some Bangladeshi nationals as part of the banned terror group al-Oaeda's conspiracy to "destabilise" India

In a statement posted on its official X handle, ED said it has recovered "incriminating" items like fake Aadhaar cards, forged passports, illegal arms, immovable property documents, cash, jewellery, printing paper and machines and blank proformas used for forging Aadhaar cards during the raids. Searches are continuing, reads the post.

The agency launched this probe under the Prevention of Money Laundering Act (PMLA) in September to investigate the alleged trafficking of Bangladeshi women into Jharkhand, which allegedly generated illicit funds.

During recent election campaigns, Indian Prime Minister Narendra Modi and other BJP leaders accused the Jharkhand state government of "letting" such infiltration, impacting the demographic balance in the tribal areas of Santhal Pargana and Kolhan.

At a rally in Seraikela, Jharkhand, on Monday Indian Home Minister Amit Shah said if BJP returns to power in the state, a committee would be formed to identify and drive out infiltrators from the state and reclaim land grabbed by them.

International aid groups said that Israel had failed to meet a series of US demands intended to improve the humanitarian crisis in Gaza by a deadline that ended yesterday.

The United States told its ally Israel in a letter on October 13 that it must take steps to improve the aid situation

within 30 days. If not, it could potential face restrictions on US military aid.

"Israel not only failed to meet the US criteria that would indicate support to the humanitarian response, concurrently took

actions that dramatically worsened the situation on the ground, particularly in northern Gaza," a group of eight aid groups including Oxfam, Save the Children and the Norwegian Refugee Council said in 19-page report.

For more than a month, Israeli forces have been pushing deeper into north Gaza, surrounding hospitals and shelters and creating fresh waves of displacement in an operation they say is designed to prevent Hamas fighters regrouping there.

On Friday, global food security experts released a rare warning of

imminent famine in parts of northern Gaza unless immediate steps were taken to ease the situation.

Israel said on Monday it had met most of the US demands. Some things remain under discussion and they touch on safety issues, an Israeli official told reporters.

During a summit of Arab and Muslim countries in Riyadh on Monday, Hamas

called on the Arab leaders to translate their of support into action and take measures to stop Israeli aggression. Arab

Muslim demanded that Israel withdraw from occupied Palestinian

territories as a precondition for regional peace, while denouncing "shocking" Israeli crimes in Gaza. Israel's military campaign has

levelled much of Gaza and killed more than 43,665 Palestinians, Gaza health officials said. Palestinian and United Nations officials say there are no safe areas in

the enclave, home to more than 2.1 million people and now largely in ruins. Yesterday, residents said Israeli tanks
