CHATTOGRAM Private clinics hiring unregistered nurses

Many private clinics and diagnostic centres in Chattogram have been hiring unregistered nurses, disregarding The Medical Practice and Private Clinics and Laboratories (Regulation) Ordinance, 1982.

The Chattogram Civil Surgeon's Office revealed this finding following a series of drives conducted in January and February this year.

During the drives, some 15 private clinics and diagnostic centres were temporarily closed for violating the rule, while some 40 others were warned and directed for taking corrective measures, according to sources at the civil surgeon's office.

Of the 15 closed, four were in the port city, five in Banshkhali and Raozan upazilas each, and one in Fatikchhari upazila.

During a drive on February 27, authorities of Innova Hospital and Metropolitan Hospital got warnings after unregistered nurses were found working there, said the sources.

On that drive, the civil surgeon fined Max Hospital Tk 1 lakh, National Hospital Tk 1 lakh, Surgiscope Hospital Tk 15,000, Delta Healthcare Tk 5,000 and Ekushey Hospital Tk 5,000 over different

irregularities.

In another drive on March 4, Central City Hospital was closed as the hospital did not have an adequate number of registered doctors and nurses.

On August 19, students of different nursing institutions in Chattogram lodged a complaint with the district civil surgeon against different private clinics that have been running with unregistered nurses. They also submitted a memorandum to the civil surgeon to conduct drives to the clinics.

Dr Ilias Chowdhury, the then civil surgeon of Chattogram, visited the port city's Metropolitan Hospital on the same day accompanied by students, and found unregistered nurses working there.

"I wrote to the Director General (Hospital and Clinic) of the Directorate General of Health Services on August 19 seeking permission to conduct drives in private clinics," Dr Ilias said.

Contacted, Dr Jahangir Alam, incumbent civil surgeon of Chattogram, said they are yet to get any response from DGHS.

"However, such drives are routine work to identify fake doctors and nurses, and clinics running without licenses. We are SEE PAGE 4 COL 7

A Jubo Union rally came under attack by a group of unidentified people Jamalpur yesterday in evening, injuring some 20 persons including a journalist of The Daily Star. Sahidul Islam Nirab, Jamalpur correspondent of this newspaper, was admitted to Sarishabari Upazila Health Complex with head injuries.

Nirab, also convener of Sarishabari Upazila Press Club, was attacked while he along with some local journalists were covering the Jubo Union programme at Pogoldigha Degree College auditorium.

Idle jute mills, rising costs Workers demand state management as private leasing fails to deliver

In 2020, the Bangladesh Jute Mills Corporation announced the closure of 25 state-owned jute mills, promising upgrades and a restart within three months. Nearly four years later, these mills remain shuttered, with most now leased to private companies with little experience in the jute sector.

Jute workers and citizens are demanding the mills be reopened under government management, fuelling continuous street demonstrations in Khulna.

In April 2021, the government opted to lease the mills to private firms on contracts ranging from 5 to 30 years.

The closures on July 1, 2020 affected over 33,000 workers, excluding official staff.

In Khulna's juteproducing belt, nine mills were closed, 516 occupying

acres, of which 288 acres have heen leased

Machine operators earn Tk 8,000, while loom operators earn Tk 9,000; their pay should be Tk 32,000 to Tk 38,000," he said.

Workers who have been with the mill from the outset now earn Tk 11,000. Shoemakers, hired from Dhaka, are paid Tk 18,000 a disparity adding to worker frustration, he said.

'Salma was killed by tenant, not her son' Say police contradicting Rab's claim

Salma was killed by her "drug peddler" tenant, not by her 19-year-old son, said police yesterday contradicting Rab's claim.

Police said this after arresting three persons on Thursday night. The arrestees are Mabia Begum, 40, and her associates Moslem Uddin, 26, and van driver Sumon Rabi Das, 28.

Umme Salma Khatun, 50, wife of Azizur Rahman, was killed in her house in Joypirpara area of Dupachachia upazila in Bogura around 12:30pm on November 10.

On November 11, Bogura Rab-12 claimed in a press briefing that the deceased's younger son Saad-Bin-Azizur Rahman, a 12th-grader at a local madrasa, killed her and kept the body in a freezer. Rab arrested Saad on November 11.

At a press briefing on November 12, Rab-12 company commander Mai Ehteshamul Haque Khan told journalists after the murder, Rab interrogated the victim's husband Azizur Rahman and Saad. "During interrogation, Saad confessed SEE PAGE 4 COL 2

"There are 250 looms at Daulatpur Jute Mill, but only 10 are operational," he said.

"In my first month, I was paid Tk 7,400, despite the government

Habib, another worker at the leased Daulatpur Mill, said the shift to private management has driven most jute workers out of their field, with only 130 remaining as the focus has turned to the shoe sector. According to BJMC sources, Daulatpur Jute Mill was leased to Fortune Group in September 2023, whose subsidiary, Uni World Footwear Technology, now produces footwear at the site.

In November, Akiz Group started production at the JJI Jute Mill

When approached, three BJMC employees declined to comment, though security guard Miraj Ali said, "Sometimes, officials visit for lease purposes, but no progress has been made yet.'

Tea workers demo for arrears

Hundreds of tea workers took to the streets in Sylhet yesterday, demanding immediate payment of unpaid wages and rations.

Organised by the Sylhet District branch of the Bangladesh Trade Union Centre, the protest march highlighted the dire financial and humanitarian crisis faced by thousands of workers from tea estates across the region.

Abul Kalam Azad, acting president of the Sylhet District Trade Union Centre, presided over the rally.

Speakers urged the government and tea estate authorities to swiftly address the crisis and ensure the basic rights of tea workers. "Our struggle is not merely for wages; it's for survival and dignity," a labour leader declared.

The march, which began at 2:00pm from Keane Bridge premises and proceeded through Zindabazar, called for urgent government intervention to alleviate the plight of approximately 12,000 workers from 12 tea estates managed by the National Tea Company (NTC).

Workers alleged that they have been deprived of wages and rations for nearly three months, pushing their families to the brink of desperation.



Despite submitting memorandums to the government and staging a 26day continuous strike, they claim no action has been taken, they added.

Protesters warned that over 40,000-50,000 individuals, including tea workers and their families, are now facing starvation.

"At a time when living costs are soaring, we are denied even the meager daily wage of Tk 178.50. How can we survive?" one protester questioned.

The workers demanded immediate implementation of a fair minimum wage structure for 2023-24, aligned

with current market conditions, as well as regular payment of wages and rations. Other demands included full rations for families, land rights, democratic labour laws, and the resolution of disparities in casual and earned leave entitlements.

Key labour leaders, including Harinarayan Hazra, general secretary of the Moulvibazar Tea Workers Union, and other union representatives, also addressed the rally.

The protest concluded with a call for unity among workers and a pledge to continue their movement until their demands are met.
