Financial woes force Khasi people to scrap festival

The Khasi Social Council has announced the cancellation of this vear's annual Khasi Seng Kutsnem programme, citing an ongoing economic crisis that has gripped the community.

Traditionally held on November 23, the festival is a significant cultural event for the Khasi people, marking the end of the old year and welcoming the new one.

Speaking to The Daily Star, Philah Pohthmi, general secretary of the Khasi Social Council, explained that the community's primary source of income -- betel leaf cultivation -- is currently facing a severe downturn.

"Farmers are not receiving fair prices for their betel leaves, which has led to widespread financial hardship," she said.

The program typically costs around Tk 2 lakh to organise, a sum the community has been unable to raise this year due to economic challenges. Instead of the usual grand celebration, the Khasi people will observe the day with smaller, domestic programmes, Pohthmi confirmed.

The Khasi Seng Kutsnem folk dances, songs, and communal festival, held at the Magurchhara activities like fishing, sports, and Khasi Community grounds in cultural performances, aimed at Kamalganj, Moulvibazar, usually strengthening social ties. FROM PAGE 3 that an election roadmap be announced soon but refrained from providing a specific timeline. His remarks that the polls could still be delayed even after the roadmap's release have further fuelled suspicions among BNP leaders.

Top BNP figures believe a faction within the government is opposed to holding elections in the near future.

They cautioned that such an approach could escalate tensions and provide ousted autocrats with opportunities to exploit the situation and incite disorder.

"Any election delay will further alienate the government from political parties and deepen the crisis," a standing committee member told this correspondent.

Earlier, BNP Secretary General Mirza Fakhrul Islam Alamgir called on the interim government to quickly announce a roadmap to maintain public confidence. He urged advisers to avoid making misleading or unguarded statements, saying, "It is not your responsibility to govern the country. Organise the election and let politicians take over."

The BNP accused the government of taking advantage of their support, with leaders arguing that until a free and fair election is held, the Awami League will continue leveraging domestic and international allies to undermine the interim government.

Standing committee Iqbal Hasan member Mahmud Tuku criticised the government for neglecting its primary responsibilities. "Organising the election is their top priority, followed by addressing inflation and maintaining law and order. Their inaction is sowing uncertainty in people's minds," he said.

Another top leader Abdul Moyeen Khan said reforms and elections can proceed simultaneously. "Reforms are a continuous

process and should not be used as an excuse to delay
