# **Mindless** mayhem

Around 100 injured as students of 3 colleges clash, ransack campus of one

The clashes between students of three colleges continued yesterday, leaving over 100 injured in the capital's Jatrabari.

Hundreds of students from Shaheed Suhrawardy College and Kabi Nazrul College, armed with sticks, iron rods, and sharp weapons, stormed Mahbubur Rahman College around noon, witnesses said.

Nearly 300 DMRC students who were at the entrance of the college in anticipation of the attack were chased away by those from the two other colleges -- both government institutions in Old Dhaka. They assaulted 15-20 DMRC

Nearly 1,000 marauding students then entered the 11-story DMRC building and damaged everything on their path, set fire to furniture, damaged documents and looted cash, computers, and laptops, said six witnesses.

They ransacked the library, tore hundreds of books,

## Plot afoot to create unrest

#### Govt suspects, warns against vandalism

STAFF CORRESPONDENT

The government believes that the chaos and vandalism in different parts of the capital that happened in the last two days

may be part of a bigger plan. Two advisers of the interim government spoke at a briefing of the chief adviser's press wing at the Foreign Service Academy yesterday.

"It is not a coincidence that so many incidents happened in just one day," said Nahid Islam, information adviser.

"Many do not want to see the government function successfully," he

Attacks, vandalism and battery will not be tolerated, he said.

Local Government Adviser Asif Mahmud Shojib Bhuyain said law enforcers did not show heavy-handedness in preventing clashes between students in Old Dhaka and Jatrabari to avoid a direct confrontation with the pupils.

"We admit that police may have shown weaknesses in acting against the students," he said.

"You know that the police are in the middle of the process of reforms. As so many students were engaged in clashes,

# Govt will carry out sweeping labour reforms

Yunus tells US delegation STAR REPORT

#### Press freedom faces serious attack: Noab

The Newspaper Owners' Association of Bangladesh (Noab) yesterday expressed concern over continued attacks on the freedom of the media.

Strongly condemning the recent sit-ins, attacks, and vandalism in front of the Prothom Alo and The Daily Star offices, Noab said such attempts to chaos" were disrupting the practice and environment of journalism.

"If anyone has objections to any news or the editorial policy of a particular newspaper, they can clarify their intellectual stance and views through writing," Noab said in a media statement, signed by its President AK Azad.

# Won't tolerate attack on media Says information adviser

The government will not stand for the vandalism of any newspaper office or the shut down of any media outlet through the use of force, Information Adviser Nahid Islam

Those involved in vandalising newspaper offices and intimidating the media will be brought to book," he said at a press briefing at the Foreign Service Academy yesterday.

"There was tension regarding Prothom Alo over the last few days Tension was created in front of its Dhaka office yesterday [Sunday]. The newspaper's Rajshahi office came under attack today [yesterday]. Besides, demonstrations took place in different parts of the country,

including in Chattogram and Brahmanbaria [in this

"Reforms first or elections first? Those who raise such questions to create confusion among the people have ulterior motives," he said while virtually addressing the annual general meeting of the Dhaka Union of Journalists at the Jatiya Press

#### Govt to speed up dev

spending

The interim government is going to ask ministries to accelerate the implementation of ongoing development projects, Planning Adviser Prof Wahiduddin Mahmud said, as he believes this would help avert a further economic slowdown.

Citing how the economy is facing turbulence such as political turmoil, labour unrest, expensive loans and stubbornly high inflation, the adviser yesterday said that it was time for policy adjustments.

This came a day after the government reported at least 14year low development spending in the July-October period of this fiscal year.

## Prothom Alo Rajshahi, Bogura offices attacked

A group of people attempted to create chaos in front of the Prothom Alo's head office in the capital's Karwan Bazar yesterday.

The situation was also chaotic provocative speeches delivered against the Bangla daily in Chattogram, Sylhet, Barishal, Chandpur, Munshiganj, Jahangirnagar University.

The newspaper's office in Bogura came under attack last night.

In the capital, chaos ensued outside the Prothom Alo's head office as a group of people chanted slogans and blocked roads, continuing the bedlam until around 4:45pm.

Police on Sunday evening detained five people from the same area. Later that day, the detainees were released

In Rajshahi, a group of people vandalised the Prothom Alo's regional office in the city's Kumarpara and set fire to its sign

yesterday afternoon. Under the banner of "Alem Olama and Tauhidi Janata, Rajshahi", they gathered at Shaheb Bazar Zero Point. They later marched towards the Prothom Alo office, tried to break in

The attackers also burned copies of the Prothom Alo and The Daily Star in front of the office.

and threw brick chunks at it.

Mehedi Hasan, officer-in-charge of Boalia Police Station, said he was unaware of the sign being broken or set on fire.

However, after videos of the incident were sent to his phone, he did not receive calls from a journalist. In Bogura, some unidentified

people attacked the Prothom Alo's local office in the town's Joleshwaritola around 10:40pm.

According to witnesses, about 15 people on five-six motorbikes reached the office. They hurled brick chunks and stones at the office, leaving a window pane broken.

The attackers also vandalised the digital sign of the office.

Chaos was also observed in Chandpur, where a group of people gathered at Hasan Ali Government High School playground yesterday afternoon. They chanted slogans against the Prothom Alo and The

Agitators took out processions, formed human chains, and delivered provocative speeches against the two newspapers in Chattogram, Sylhet, Barishal, Chandpur and Munshiganj.

# Students to launch

On October 22, the Anti-Discrimination Student Movement formed a four-member convening committee with Hasnat Abdullah, Arif Sohel, Abdul Hannan Masud and Umama Fatima as members.

The student platform and the Jatiya Nagorik Committee have so far announced 12 and 15 district-level committees respectively.

According to their plan, the new party will contest the upcoming national election and rope in heavyweight candidates who have the potential to win.

They have already started reaching out to potential candidates in each constituency.

"Our target is to field national figures as candidates, and the Jatiya Nagorik Committee is also working on how to create more national faces," a top leader of the Jatiya Nagorik Committee told The Daily Star.

"To achieve this, we are grooming leaders in each constituency. By following these strategies, we aim to participate in the upcoming elections and secure victories," he said.

They initially plan to announce central convening committee of the party and gradually complete forming committees at district and upazila levels before the next election.

The leaders of the two platforms divisive politics and binary narratives that have dominated Bangladesh for

Their party will focus on agendadriven politics and addressing critical issues like unemployment, economic development, and national unity.

"We want a political discourse centred on how to improve the lives

of the people and create jobs, moving away from the politics of division," said a leader of the Nagorik Committee. He said they were stressing the need for a party rooted in "the spirit of

the 1947, 1971, and 2024 movements". They also want to ensure inclusivity, especially for women who

constitute half the population. "A truly functional democracy requires active participation of women at all levels, not just in passive roles," he said.

The new political force will uphold democratic values by ensuring accountability, even for itself, the

He assured that if the party deviates into authoritarianism or fascism, the Nagorik Committee will hold it accountable.

However, members joining the new party must sever ties with any existing political organisation and be willing to critique past wrongdoings of that party.

Nasiruddin Patwary, convener of the Jativa Nagorik Committee, said that his organisation is primarily a platform for civil society, functioning as a pressure group.

"It will continue to operate the same way in the future," he told The Daily Star.

As they were leaving the building, locals along with DMRC students clashed with them, said a resident named Amir Hossain.

The groups threw pieces of bricks at each other, leaving 70 to 80 people injured and damaging properties in the vicinity.

Many of the injured were treated at hospitals and clinics in Demra. Thirty-five students, mostly from Suhrawardy College and Kabi Nazrul College went to Dhaka Medical College Hospital for treatment. Three of them needed inpatient

Later in the day, DMRC Principal Obaidullah Nayan issued a statement requesting the authorities to ensure justice, students' safety, and recovery of looted assets and damaged documents.

He told reporters that the students took away 20-30 laptops, computers, damaged many certificates, laboratories, security cameras and five lifts. The damage done to the institution could be worth around Tk 60 to Tk 70 crore, according to

In the statement, Principal Nayan He acknowledged that they were also alleged students of other Nazrul, and a group of outsiders entered the building to cause massive destruction.

Muktadir Mamun, a wounded DMRC student, said, "Everyone knew they would attack our college. Many policemen were only half a kilometre away. We called them, but they did not come."

Salah Uddin, deputy commissioner of Dhaka Metropolitan Police's Wari division, denied the allegations of police's inactivity as false.

'We tried our best to stop the clash, but did not succeed fully, as several thousand students gathered and carried out the attack," he

Education Adviser Wahiduddin Mahmud said the interim government will accept any logical demand of the students, but no unjustified demand will be

Rezaul Karim, a Jatrabari resident and father of a 12th grader, said locals knew that the students from the Old Dhaka colleges would attack DMRC.

"If the law enforcers had been here, this destruction would not have happened," he said, adding that the mayhem and clashes went on for nearly one and a half hours.

The authorities deployed six platoons of Border Guard Bangladesh personnel to maintain law and order in Jatrabari and Demra, said a press release around 4:00pm.

Police blocked Demra Road, causing long tailbacks in the area.

The student unrest began on the night of November 18, hours after a DMRC student, who had dengue, died at Dhaka National Medical College Hospital. His family members and friends from the college then vandalised the hospital.

On November 20, 500-600 DMRC students again demonstrated at the hospital, DMP said in a statement

Students from Suhrawardy College and Kabi Nazrul College attempted to join the DMRC boys, but faced rejection that led to

again attacked the hospital and Suhrawardy College. They also tried to attack Kabi Nazrul College. Yesterday, nearly 12,000-15,000

students from Suhrawardy College and Kabi Nazrul College gathered at Bahadur Shah Park and began marching, the police said.

"They broke through multiple police barricades and caused extensive destruction," said the DMP press release.

DMRC Principal Navan said representatives of his and the other colleges and government officials were scheduled to meet at 4:00pm.

The students of the two other colleges were notified about the meeting, but they still went on the rampage.

He alleged that he talked to the police several times in the morning, but they did not show up.

# **Institutions** failing to ensure justice Savs MJF

The progress in addressing violence against women and children in Bangladesh has been slow, said Manusher Jonno Foundation (MJF) in a statement

MJF issued the statement on the occasion of the 16 Days of Activism against Gender-Based Violence.

The organisation expressed strong concern over the slow progress and condemned the existing ineffective structures designed to combat such violence.

The statement highlighted that women and girls continue to face significant insecurity, with reports of rape, gang rape, and other forms of sexual assault on the

MJF called for a stronger commitment from the state to ensure the security of women and girls and to prevent violence and child marriage by making local committees functional and accountable.

The statement also said current institutions and legal frameworks have failed to ensure justice for survivors, with



the conviction rate for rape remaining low at just 2-3 percent.

MJF also demanded the launch of a national campaign to challenge victimblaming and promote respect for women.

Women and girls deserve to live in safety, security, and without discrimination in the "New Bangladesh", the statement said.

# Specific laws needed to combat cyber harassment

Discussants tell roundtable

There is an absence of a clear legal framework and proper definitions when it comes to cyber violence against women, speakers said at an event yesterday. They urged for specific legislation to combat such crimes

The roundtable, titled "Scanning the Horizon: Addressing Cyber Violence against Women and Youth Through Policy and Awareness", was jointly organised by UNDP and The Daily Star at The Daily Star Centre.

> Anowarul Haq, assistant resident representative at NDP, said digital violence is a reality we cannot ignore.

"As the legal framework is weak and there is no clear definition of cyber violence, this issue must be addressed under specific legislation," he

He urged the government to strengthen law enforcement agencies through specialised training, recruit gender-sensitive personnel, incorporate cyber violence awareness into school curricula.

Supreme Court lawyer Barrister Jyotirmov Barua criticised the lack of clarity regarding digital rights and laws.

"Our laws fail to define and address



globally recognised forms of cyber violence, let alone ensure justice... We haven't even established the National Telecommunication Monitoring Center." he said.

He called for judicial training on sensitive gender-related issues.

Rezwan Islam, regional editor at Global Voices, stressed the absence of institutional policies on cyber violence.

"A comprehensive policy is urgently needed in organisations," he said. Investments are necessary to create

safer digital spaces, he added. Sharmin Ahmed, senior

president at Mutual Trust Bank, linked a lack of digital literacy to harassment and fraud in cyberspace. She called for private sector involvement in enhancing digital literacy.

UNDP Research Analyst Faisal Bin Majid urged women to remain vigilant and resilient against growing cyber

Sharmin Islam, gender team lead at UNDP, said her organisation is working to bridge the digital divide. "Women

forms face new harassment regularly, even while engaging in e-commerce. When they seek police help, a lack of expertise often worsens their problems," said. She she advocated for smarter policing victim

counselling services.

Misinformation and disinformation targeting women, particularly during elections, were also discussed. Qadaruddin Shishir, fact-check editor at AFP, said such tactics are used for personal vengeance or political gain.

"Alarmingly, the state was previously involved in spreading disinformation. and now political parties and groups are adopting these tactics," he said.

The lack of counselling services for victims was highlighted by Maliha Tabassum, assistant professor at the Department of Mass Communication and Journalism at Bangladesh University of Professionals. She called for culturally driven programmes and a shift in the mindset of law enforcement.

Stop bullying, misinformation targeting women

Speakers tell event

Women must be given adequate space in politics and the freedom to express their opinions without falling victim to rumours or mob justice on social media, speakers said at an event yesterday.

The event, titled "Unmasking Violence: Combating Misinformation, Disinformation, and Cyberbullying", was jointly organised by USAID and Dhaka Tribune as part of the 16 Days of Activism Against Gender-Based Violence campaign at the capital's Krishibid Institution Bangladesh Auditorium.

Umama Fatema, coordinator of the Anti-Discrimination Students' Movement, talked about the online harassment faced by female students and mothers who were at the forefront of recent mass protests.

They have been subjected to derogatory comments about their clothing, behaviour, and speech on social media. The political space is already underserved for women, and the politics of misinformation and rumours has made the situation worse," she said.

Barrister Mitin Sanjana, a Supreme Court lawyer and researcher, criticised the inadequacies in Bangladesh's cyber security laws. "Girls are particularly vulnerable to cyberbullying, yet only one in 100 victims seek legal

against such actions. The laws require urgent reform," she said.

Sirazum Munira, former lead member of the Grassroot Network of the Youth Policy Forum, said 89 percent of cyberbullying victims in Bangladesh are aged between 18 and 30, with 73.4 percent not seeking legal

She identified deepfake and generative AI technologies, lack of digital literacy, and insufficient fact-checking infrastructure as significant challenges. "Pornography, offensive messages, and derogatory statements dominate crimes against women," she added.

Maliha Tabassum, faculty member of Bangladesh University of Professionals, pointed out that while urban youth are aware of AI, teens at the grassroot level lack digital literacy and often overlook online harassment, enabling perpetrators.

"We need to raise awareness at the personal level," she

According to attendees, the group claimed it would recover laundered money from abroad and distribute loans. Some attendees were interrogated by Shahbagh police, who are yet to identify anyone directly associated with the organisation.

 $Banners\,featuring\,the\,group's\,leaders, ABM\,Mostafa$ Ameen and Rafiqul Islam Hridoy, were seen attached to buses. Police reported that buses, pickups, and microbuses began arriving late Sunday night. Students and locals urged those gathered to leave the area.

At 12:30pm yesterday, a bus from Fulbaria, Mymensingh, arrived with 32 people. Lipi Akter, who led the group, claimed she contacted the passengers, who were promised loans. Lipi and an associate were reportedly beaten by onlookers before being handed to

A Jashore businessman sued policemen, including superintendent of police Rahman, Anisur Sunday night for allegedly abducting him, attempting to kill him in 2014.

Masudur Rahman Nannu, the businessman, lodged the case with a court. The accused include former officers and constables, among them Milu Mia Biswas, then assistant superintendent of police, and several others.

According to the complaint, Nannu was abducted on May 31, 2014, near Manihar Cinema Hall following Anisur Rahman's orders.

Не was taken to Chanchra Police Outpost, tortured, and threatened with "crossfire" unless Tk 25 lakh was paid. His brother managed to pay Tk 10 lakh, securing his release. However, the accused shot Nannu in the leg before admitting him to Jashore General Hospital.

An arms case was filed against Nannu, who was later transferred to a Dhaka hospital under police custody and eventually sent to prison.

Nannu alleges he was unable to seek justice earlier due to the accused's influence. He now feels the conditions are favourable for legal action.

"The road on the east end of the bridge collapsed into the Bhairab river at several points. Only a narrow stretch of the road still remains, through which only rickshaws, easy-bikes and motorcycles can ply at present," said Abdul Halim Shiplu, a resident of Barandipara

"We use Lichutala Bridge to travel to and from Fatehpur and Jhumjhumpur areas, as it takes less time. On this route, we travel around 2.5-kilometre less compared to the alternative route. We urge the authorities concerned to repair the road as soon as possible," he added.

Echoing him, Abdul Jabbar and Mohammad Ali, two other

local residents, said there is no lighting on the bridge, making it dark at night and posing risk for commuters using it after dusk.

"Also, at present, private cars and ambulances are unable to ply the bridge. As such, if someone falls ill, it will be a difficult task to take them to hospital we would have to depend on easy-bikes," said Ali.

Contacted, Zayed Hossain, executive officer of Jashore Municipality, said they are still unaware whether the route has become risky.

"Steps will be taken after inspecting the site," he added.

Sharmin Akhter, upazila nirbahi officer of Jashore Sadar, said engineers will be sent to inspect the collapsed road and initiatives will be taken to repair it quickly.

## **DEMENTIA IN BANGLADESH** Lack of awareness leaves patients vulnerable: speakers

More than 1.1 million elderly people in Bangladesh are suffering from dementia, with women comprising 75 percent of patients, speakers said at a seminar yesterday. They warned that the prevalence of dementia is rising, yet visible initiatives to address the issue remain scarce.

The seminar, titled "Dementia Care and Conservation of Universal Human Rights", was jointly organised by the National Skill Development Authority and the Alzheimer Society of Bangladesh at Biniog Bhaban in Agargaon.

Dr Halida Hanum Akhter, senior faculty member at Johns Hopkins Bloomberg School of Public Health, presented findings from a 2020 study by the Directorate General of Health Services (DGHS) and

icddr,b. She said that of the 1.1 million dementia patients, 2,80,000 were men (24.5 percent) and 8,30,000 were women (75.5 percent). By 2025, the number is

projected to exceed 1.3 million. Dr Halida also cited Bangladesh Bureau of Statistics data from 2015, saying 72 percent of women experience domestic violence, and 42 percent of teenage wives face abuse. She stressed that both physical and psychological abuse contribute to dementia, alongside longer life expectancy, with old age being the primary risk factor.

She called for a combined effort from families, society, the private sector, and the government to improve old-age healthcare and reduce the burden of dementia.

## SEPTIC TANK EXPLOSION Teenager killed, sister injured

A septic tank explosion in Gazipur's Tongi area left a teenage boy dead and his younger sister critically injured on Sunday night.

The deceased was identified as Habibullah, 19, son of Ruhul Amin from Baherchar Kadamtali village in Shariatpur district, said Iskandar Habibur Rahman, officer-in-charge of Tongi West Police Station.

The incident occurred around 10:00pm on the first floor of a rented house in Mollapara area of North Auchpara.

Quoting the tenants, the OC said the explosion caused the walls of three rooms, including the washroom, to collapse. Habibullah and Jannati were in one of the affected rooms when the blast

Neighbours rushed the critically injured siblings to Dhaka Medical College Hospital, where doctors declared Habibullah dead around midnight.

His sister Jannati, 13, was undergoing treatment at the hospital.

Shahin Alam, a senior officer of Tongi Fire Service, attributed the explosion to the lack of a bypass line in the septic tank.

A case of accidental death has been filed in this regard, the OC added.

## Probe killing of stray animals Rizwana urges livestock ministry

Environment Adviser Syeda Rizwana Hasan has called for an impartial investigation into the recent poisoning of stray dogs and cats in Mohammadpur, Dhaka.

In a letter to Farida Akhter, Adviser to the Ministry of Fisheries and Livestock, Rizwana urged immediate action to uncover the truth and ensure exemplary punishment for those responsible. The incident, which occurred on Friday night

at Japan Garden City, left 10 dogs and one cat dead. Witnesses reported symptoms of poisoning, including convulsions, vomiting blood, and severe distress among the animals. Animal rights activists and local residents

alerted police, who reportedly recovered the remains of three dogs and one cat. However, it is alleged that the remains of seven other dogs were concealed by the authorities. Rizwana cited the Animal Welfare Act 2019, which


prohibits cruelty to animals, including poisoning, and wrote such acts are punishable by law. She also referenced the City Corporation Act

2009, which designates city corporations as responsible for managing stray animals.

Dhaka North City Corporation has initiated an investigation into the matter.

In her letter, Rizwana Hasan described the killings as "a horrific act of cruelty towards innocent animals" and a blatant violation of the law.

She urged the livestock ministry to ensure a thorough investigation and exemplary punishment for the perpetrators.

"Bacteria naturally develop resistance against antibiotics if used for a long time or irrationally [leaving the medicine course incomplete]. However, it might lose the resistance gradually if the drug is used after a long interval," he explained.

Pratik Chowdhury, professor of medicine at Chandpur Medical College, recommended a unified effort by doctors, city corporation, and WASA authorities as most drinking water is contaminated due to poor sanitation systems.

## **Pro-Russia** candidate leads Romanian polls

PM out of the race

A pro-Russia far-right candidate took a surprise lead yesterday in Romania's presidential election, as the EU-leaning premier was knocked out of the race that will be decided in a December run off.

The result is a political earthquake in the country of 19 million, a Nato member which has so far resisted nationalist appeals, setting itself apart neighbours Hungary and Slovakia.

Far-right candidate Calin Georgescu was in pole position with 22.95 percent of the ballot, followed by Elena Lasconi, the centre-right mayor of a small town.

Prime Minister Marcel Ciolacu was in third place with 19.15 percent of the ballot in Sunday's election after 99 percent of the vote was counted, eliminating him from the December 8 run off.

Exit polls in the race for the largely ceremonial post initially had showed the premier with a comfortable lead and put another far-right candidate, George Simion, in fourth.

## One woman killed by partner, relative every 10 mins in 2023: UN

One woman was killed by a partner or relative every 10 minutes worldwide in 2023, the United Nations warned yesterday, stressing that femicides remained at "alarmingly high levels".

Almost 85,000 women and girls were murdered by people last year, according to a joint report by the United Nations Office on Drugs and Crime (UNODC) and the UN Women agency published yesterday.

The report is based on available data from 107 countries or territories, and information the UNODC has collected from responses submitted by member states.

About 60 percent -- or more than 51,000 women and girls -- died at the hands of their partner or relative, the report found.

This equates to 140 women killed per day or one every 10 minutes by those closest to them.

"The home remains the most dangerous place for women and girls in terms of the risk of lethal victimisation," the report said. While men were four times more likely

than women to fall victim to homicide forming 80 percent of all murder victims they more often than not died at the hands of a stranger.

# Russia fires drones, missiles across Ukraine

23 hurt; Russia downs 8 ballistic missiles fired by Ukraine

Russian missiles damaged residential buildings in Ukraine's eastern city of Kharkiv and Odesa in the south, and a blizzard of drones caused temporary power cuts in Mykolaiv region and targeted the capital Kyiv, Ükrainian officials said yesterday.

Russia, which is making territorial gains in Ukraine's east, is conducting nightly attacks on faraway cities using missiles as well as cheaply produced "suicide" drones and low-cost "decoy" drones, which tie up Ukrainian air

145 drones used overnight, Ukraine shot down 71 and lost track of 71 more, likely due to electronic warfare measures used against them, the air force said. Meanwhile, Russia

said its air defences had shot down eight ballistic missiles fired by Ukraine. Ukraine fired US-made

ATACMS ballistic missiles into Russia for the first time last week after receiving approval from Washington, prompting a furious reaction from Moscow.

Zelenskiy called on Kyiv's Western allies to step up pressure on Russia to prevent the components needed for the weapons systems reaching it.

"These Russian attacks on Ukrainian life can be stopped," he said.

"With pressure, sanctions, blocking the occupiers' access to the components they use to create the tools of this terror, arms packages for Ukraine, and a resolve that must be unwavering," he added.

# Chinese balloon detected near island: Taiwan

Taiwan's defence ministry yesterday reported that a Chinese balloon had been detected over the sea to Taiwan's north, the first time since April it has reported such an incident in what Taipei views as part of a pattern of harassment by Beijing.

Taiwan, which China claims as its own territory, complained that in the weeks leading up to its presidential election in January Chinese balloon activity took place at an "unprecedented scale".

It described the incidents as part of a Chinese pressure campaign - so-called grey-zone warfare designed to exhaust a foe using irregular tactics without open combat.

Taiwan strongly objects to China's sovereignty claims and says only the island's people can decide

The ministry, in its regular morning update on Chinese military activities over the previous 24 hours, said the single balloon was detected at 6:21 pm (1021 GMT) on Sunday 60 nautical miles (111 km) to the north of Taiwan's Keelung port.

It then vanished some two hours later, having flown at an altitude of 33,000 ft (10,000 metres), but without crossing Taiwan itself, the ministry said.

China's defence ministry did not respond to a request for comment.

# 39 foreigners flee Myanmar scam centre: Thai police

Thirty-nine foreigners have fled an online scam centre in Myanmar across the border to Thailand, where officials are working to identify potential

trafficking victims, police told AFP yesterday.
Scam compounds have mushroomed in Myanmar's borderlands and are staffed by foreigners who are often trafficked and forced to work, swindling their compatriots in an industry analysts say is worth billions.

The group from Sri Lanka, Nepal, Malaysia and Russia crossed into Thailand's Tak province, according to the police chief in the city of Mae Sot.

They had fled from Myawaddy across the border, Colonel Pittayakorn Petcharat said.Myawaddy is controlled by a militia group and is a hotbed of drug production and online scam outfits.

## Fix the system to prevent rape

#### Existing justice mechanisms for rape crimes are not working

A report published by this daily on Monday reveals a disturbing yet familiar picture of women's safety in Bangladesh. Citing data collected by the Ain O Salish Kendra (ASK), it states that a female has been raped every nine hours on average in the country between January 2020 and September 2024. This translates to at least two rapes each day. To call this horrifying would be an understatement. More importantly, this highlights yet again how the country has been systematically failing half

During the above-mentioned period, a total of 4,787 cases of rape were reported in the media. Of those, police cases were filed for 3,419, meaning about one-third were not reported to law enforcement. It's not unreasonable to assume that there were even more incidents that didn't reach the media, as the stigma surrounding rape as well as threats of retribution continue to deter victims and their families from seeking justice. Unfortunately, despite numerous awareness campaigns and the authorities' promises to ensure safety and justice for women, our society has yet to undergo an effective shift to prevent gender-based violence.

For those who can overcome initial barriers, however, more hurdles await, as victims must endure distressing environments in court, lengthy legal battles that can be mentally and financially taxing, and also a lack of empathy across the justice system (from police stations to courts). Police data from the first nine months of 2024 also shows their arduous and often futile legal battles, with around 68 percent of those accused in cases of violence or abuse against women remaining at large. Police authorities say this is not due to a lack of capacity. Should we then assume a lack of interest?

The existing justice system for sexual and gender-based violence is deeply flawed. Delays in arrests in rape cases, combined with protracted legal proceedings, place the burden on victims and their families rather than on the perpetrators. Furthermore, there is still no specific law for victim and witness protection, despite the existence of a vetted draft. Nor is there a state-sponsored compensation mechanism which could encourage victims, especially those from underprivileged communities, to pursue justice. This cannot be the norm in a civilised, modern nation.

We urge the government to address the harsh reality that half of our population endures, and to incorporate modern, empathetic mechanisms for pursuing justice in cases of rape and other forms of gender-based violence into ongoing reform efforts. Ensuring women's safety and access to justice is essential if we are to build a society that truly values and protects all its citizens.

## Dengue taking a deadlier turn

#### Relevant agencies must answer for failure to check its spread

We are deeply concerned by the rising number of denguerelated deaths at a time of year when such fatalities typically decrease. This November has already seen the highest number of deaths in the year, with 144 fatalities reported in the first 24 days of this month, including 11 in just the past 24 hours as of Sunday morning. Overall, according to the Directorate General of Health Services (DGHS), 459 patients have died this year from this mosquito-borne disease. This is only the second time in the last 24 years that dengue deaths have surpassed the 450-mark. Clearly, such a tragic toll could have been avoided had the authorities acted decisively and in a timely manner.

Admittedly, this year's dengue control efforts were disrupted by the July uprising, which left city corporations and municipalities unable to carry out their regular duties in the absence of mayors and councillors. However, once the interim government appointed administrators to replace the latter, we expected a swift resumption of mosquito-control drives. Unfortunately, both city corporations in Dhaka failed to do their part, and the situation was equally dire outside the capital. This daily has published many editorials urging action before it was too late, but nothing seemed to spur the authorities into action. It reflects not just inefficiency but also a certain disregard for public health, for which they must be held accountable.

Experts and entomologists have repeatedly warned about the shifting dengue patterns, but their warnings went unheeded. Previously, dengue was largely concentrated in Dhaka, but this year, cases outside the capital have exceeded those within, according to an October report by this daily. Furthermore, dengue cases that would typically decrease in winter show no signs of abating this year. If this trend continues, the situation may worsen in the coming days. Therefore, our dengue management strategy must account for these changing realities. Reportedly, many deaths this year have been due to late detection, with patients being diagnosed when it was too late. Since early detection is key to effective treatment, all healthcare facilities, including upazila health complexes, must be equipped to diagnose and treat dengue promptly. The government should also ensure that dengue tests are available at subsidised rates.

As for city corporations and municipalities, they must conduct regular anti-mosquito drives and awareness campaigns as these can have a significant impact on reducing cases. With dengue now endemic, we need sustained, yearround measures to curb its spread and prevent needless deaths.

# Monuments of resistance and the politics of memory

It was no easy victory. After enduring massive carnage and 15 years of unjust dominance by a single political party, Bangladesh experienced a reincarnation. This resurgence, marked by bloodshed and violence, claimed the lives of individuals ranging from toddlers—like Zabir (6), Abdul (4), Roya (6)—to university students and civilians, totalling over a thousand. This shadhinota differs vastly from what the post-1971 generation knew. These voung people did not seek martyrdom; they were killed, forced into it by police brutality-gunshots, severe burns, or shrapnel—in the homeland they thought would rightfully be a safe haven. Ultimately, the student movement-or rather, the studentled people's movement-triumphed on July 36 (August 5), 2024. These horrific vet historic moments must be memorialised. But where and how? How can we, as common citizens, claim our victory? Thus arises the urgency of spatial claim/reclaim/[un]claim to reveal a fresh historical narrative-one that does not disregard 1971 but builds upon it. This nuevo-nationalism version 2.0 deviates from the Mujib-centred, post-1971 chetona (spirit) and its mononarrative of Bangladeshi nationalism.

Immediately after the revolution, people spontaneously began to historicise and monumentalise urban spaces across broiling Bangladesh. Spaces of protest, martyrs, and carnage were transformed into markers and monuments, turning the major towns and cities-and particularly Dhakainto open-air museums. These ad-hoc actions are techniques for historical recording. Notable examples include the commemorations of Abu Sayed (1999-2024) and Mir Mahfuzur Rahman Mugdho (1998-2024).

Sayed, just 25, died after enduring baton charges and being shot four times, becoming what Shahidullah Faraj called the "hero of the generation." His name has now been immortalised. The people renamed the Rangpur Park intersection to "Shaheed Abu His death further galvanised people.

was renamed "Mugdho Mancha." Police brutality, deaths, and political caricatures have been illustrated and replicated through recurring visual representations—wall paintings, cartoons, and street art-across Dhaka and beyond. These artworks, often created by hand and reproduced shortly after the incidents, carry a weight that counters Walter Benjamin's The Work of Art in the Age of Mechanical Reproduction. Though transient, the proliferation of these artefacts plays a crucial role in ensuring that Bangladesh's evolving narratives are not forgotten. In this way, these spatial moments serve as agencies of historical

extreme suffering, and death-where many were subjected to extrajudicial killings for political gain. While some prisoners eventually returned, many did not. Like the concentration camps of the Holocaust, Aynaghar rightfully demands to be a museum for the atrocities. However, transforming Gono Bhaban—literally meaning the "People's House"-into a museum presents a conundrum. Should it be reclaimed, or perhaps unclaimed, for "Bangladesh" 2.0?" Ironically, despite its name, Hasina asserted ownership of it in a meeting held inside Sangsad Bhaban in 1991. Often referred to as "Hasina's

# Breaking the cycle of juvenile crime

As Bangladesh surges forward into a newera of political change, a darker tide is rising within our communities—a troubling spike in juvenile crime. While our leaders focus on national reform, an underground world of teen gangs and criminal networks is quietly taking root, ensnaring our youth in cycles of violence, crime, and despair.

But why are so many of our children and teenagers drawn into the shadows of gang culture? It is a complex web woven from poverty, broken homes, peer pressure, and a search for identity. In underserved neighbourhoods, gang life can offer a twisted sense of family, protection, and power. Without strong family support or access to opportunities, young people can feel adrift, easily lured by the false promises of gang culture.

Yet the influences stretch beyond poverty. Across economic divides, some youths are captivated by the glamorisation of gang life on social media and in popular culture, where figures of crime are idolised as symbols of defiance and "success." With such distorted role models, many teenagers begin to see violence and lawlessness as pathways to respect and recognition.

and security they once relied on. The administrative reorganisation following the revolution has left gaps in law enforcement, creating space for gang activities to flourish. As political power shifted, gang leaders capitalised on the upheaval to recruit young people who feel isolated, restless, and overlooked.

corruption among Moreover, local power figures has emboldened gang networks, as some councillors and "big brothers" enable these gangs for their gain, using them as pawns for influence. This erosion of integrity at the local level has turned neighbourhoods into battlegrounds, where teenagers become unwitting soldiers and gang affiliation becomes a deadly game for respect.

What may start as minor acts of mischief often spirals into something much darker—drug distribution, theft, extortion, and even murder. Innocent people live in fear as communities are disrupted, their streets claimed by teenagers who see no future outside gang life. Schools are no longer sanctuaries but places of intimidation, where innocent students can fall victim to violence. Families are left shattered. watching as their children slip further turmoil, many communities are away, trapped in a dangerous world

for a united, strategic response—a plan that addresses root causes, not just symptoms. Here is a blueprint for a future where youth have a real chance to thrive:

Family and community engagement Parents and guardians must be the first line of support, fostering open communication and offering a stable foundation. Communities can strengthen this support by creating safe spaces for young people, offering mentorship, mental health resources, and educational support. Government programmes can aid families facing financial hardship, reducing the vulnerabilities that gangs exploit.

#### **Transforming schools**

into safe havens Educational institutions have the power to reshape the trajectory of young lives. Beyond academics, schools must provide social and emotional support with activities that encourage positive self-expressionsuch as sports, arts, and leadership opportunities. Through community partnerships, students can engage with role models and mentors who demonstrate that success is attainable without resorting to violence.

#### A culture of awareness

and empowerment Awareness is key. Community organisations, local leaders, and the media must collaborate to shine a light on the dangers of gang life, offering clear, powerful messages that dispel the myths surrounding it. Real stories of resilience and redemption should be amplified so that young people see that strength lies in integrity, not in crime. Social campaigns, events, and

#### Reinforcing law and order with compassionate solutions

While strengthening law enforcement is essential, it must go hand in hand with rehabilitation efforts. Quick and fair punishment serves as a deterrent, but so does the chance at a future. By establishing rehabilitation programmes for juvenile offenders, we can guide them back to a constructive path. Police should also work in partnership with community organisations, ensuring they are not only enforcing laws but also supporting

prevention efforts. Bangladesh stands at a pivotal moment. The path we choose today will shape our future for decades to come. By ignoring the rise of juvenile crime, we risk losing a generation to violence, perpetuating cycles of poverty and fear. Yet, by coming together—parents. teachers, community leaders, and law enforcement-we can reclaim our neighbourhoods, giving our youth the chance to thrive in a world free of

violence and corruption. Bangladesh's youth are not inherently lost or violent. They are searching for purpose and direction in a society that too often looks the other way. It is up to us to show them that real power lies in courage, honesty, and lifting each other up. By building a society that values resilience and respect, we can protect our young people from the lure of gang culture and create a safer, more just Bangladesh.

The time for action is now. Let us break the cycle, together.

# The unresolved question of 'non-economic' loss and damage

capital, Baku, is the Gobustan State Historical and Cultural Reserve. After the first week of the Baku Climate Conference, the 29th Conference of the Parties (COP), we had the opportunity to visit these relics of our ancestors.

As I observed the stone-carved cavities in Gobustan, I wondered what Stone Age humans might have stored in them—perhaps meat, fruits, herbs, or seeds. Cooking rice was not yet part of civilisation, as rice had not been discovered; only later domesticated by Homo sapiens. Over time, wild rice was tamed, but the "Green Revolution project" transformed agriculture into a profit-driven industry, eradicating the diversity of traditional rice and other crop genetic resources.

In parallel, the discourse on climate change adaptation and payment for loss and damage is growing, with the Global South advocating for an Adaptation Fund and a Loss and Damage (L&D) Fund. Yet, L&D negotiations largely focus on economic losses, leaving noneconomic loss and damage underrepresented in the global climate negotiations.

On our way back from Gobustan, I wondered: could we ever put a price tag on these priceless remnants? If these artefacts were to be lost to a volcanic eruption or another climate-induced disaster, the losses would fall under what we describe as the category of non-economic loss and damage in climate discourse.

The Baku Climate Conference, dubbed the "Finance COP," focused more on promoting carbon credits and false solutions than addressing people-led adaptation and loss and damage. The unresolved, irreversible impacts of climate change continue to grow. Disasters like cyclones, droughts, floods, and heatwaves not only cause economic losses but also destroy traditional knowledge, rituals and even rare species. Can humanity survive without these non-economic, intangible cultural heritages? Acknowledging and incorporating these losses into global climate action is not just necessary-it's urgent for conserving the essence of human existence.

#### Non-economic loss and damage in global climate discourse

The issue of "Loss and Damage" due to climate change gained prominence through small island nations (Small Island Developing States/ SIDS and Alliance of Small Islan

Some 64 kilometres southwest of Azerbaijan's towards non-economic loss and damage (NELD), a concept often overlooked. Based on the UNFCCC's report (2013) on Non-economic losses in the context of the work programme on loss and damage' refers to losses not traded in markets—loss of life, health, human mobility, loss of territory, cultural heritage, Indigenous local knowledge and social capital, biodiversity and ecosystem service. Measuring these losses is challenging as they lack a market value, yet they are integral to human civilisation.

Following the Paris Agreement, a 2019 report identified key sectors for assessing NELD, and the "Santiago Network" was established to support developing nations. The Intergovernmental Panel on Climate Change (IPCC) Sixth Assessment Report included NELD examples, such as loss of life and ecosystems. NELD's scope varies across different cultures, ecosystems, and communities, shaped by diverse social, cultural, and historical contexts. This article presents examples of NELD caused by climatic stress from various eco-regions of global countries including Bangladesh to illustrate the broader concept.

#### Lost rain, lost rituals

The Huni Kui people, who reside in the Brazilian and Peruvian parts of the Amazon, believe that after death, humans are reborn as trees in the forest, according to Ninawa Inu Huni Kui, leader of the Huni Kui. To them, every plant and tree is sacred. The Mukaya (shamans or healers) venture deep into the forest to collect flowers, leaves, and roots used in herbal medicine and various rituals.

Due to irregular rainfall and rising temperatures, many plants are going to be extinct in the Amazon. Ninawa's account parallels the experiences of the Indigenous Tripura community in Bangladesh's Rema-Kalenga forest. The Tripura believe the KuthuiRuganiKhlum plant guides dead's souls to heaven, but prolonged droughts have made this sacred plant harder to find.

In the Bengali Hindu tradition, 108 lotus flowers are essential for Sharadiya Durga Puja. From 2022 to 2024, excessive rainfall during the flowering season destroyed many blooms in wetlands. While some devotees managed to acquire lotus flowers at high prices, a very few could gather the full 108 required for rituals.



Meanwhile, U Khing Nu Chak, a Vikalpani National Women's Federation, face youth climate activist from the Indigenous Chak community of Naikhongchhari in Bangladesh's Bandarban, shared her Grandmother Janingme Chak's memories of colourful maize varieties that once flourished in their mountain villages. These varieties are now disappearing, driven by drought, water shortages, and rising temperatures.

#### Erosion of genetic resources and biodiversity

In Sherpur of Bangladesh, the floods during August-September this year, submerged rice fields, including those growing the indigenous Tulshimala variety, a crop with Geographical Indication (GI) status. Rukasen Beypi, a climate activist from India's Assam, highlighted a similar plight among the Karbi Indigenous people, whose traditional crops are rapidly vanishing. Droughts have made finding two wild banana varieties, Lorup and Lochin, increasingly difficult.

Bolivian food rights activist Aira

farmer-scientists from Philippines told that, they are trying to conserve the traditional climate resilient varieties.

#### Alien territories, new conflicts

Cyclones, floods, droughts, and rising temperatures are increasingly displacing both humans and wildlife, forcing migration in Bangladesh's Satkhira and Netrokona regions. Young people, particularly women, are seeking jobs outside their villages due to the loss of agricultural land and employment opportunities. Unlike cultural migration, this displacement forces people to leave behind everything they've known: villages, ancestral graves, temples, and communities.

Makereta Waqavonovono from Fiji shared how frequent tidal surges displace her community a situation mirrored by those AOSIS) initially focusing on economic impacts. Vikalpani National Women's Federation, face increased violence and insecurity in these situations. The emotional toll of leaving one's birthplace is immense, and adapting to new settlements often leads to social, cultural, and environmental conflicts.

#### Indigenous knowledge, beliefs and new doubts

The devastating floods in Sunamganj and Sylhet in Bangladesh in 2022 not only led to loss of life and property but also wiped out many Dhamail songs, a cultural heritage of the *Haor* region. Women in these areas have their Dhamail songs written in songbooks, which were submerged and lost in the floods. Thus, climate change is causing the daily disappearance of numerous songs, languages, Indigenous knowledge, and cultural expressions around the world. Traditional practices related to weaving, agriculture, local adaptations, rural architecture, culinary arts, herbal medicine, and disaster management are all critically endangered due to climate

In the hills of Bandarban, only six speakers of the Rengmitcha language remain. The scarcity of water and land crisis is exacerbating the survival challenge of Indigenous communities. When the last speaker of the Sare language from India's Andaman-Nicobar Islands passed away during the first wave of the Covid pandemic, the language went extinct.

Stephanie Stephens, a representative from Vanuatu's Ministry of Climate Change, explained that as coastal villages are submerged by tidal surges, people are being forced to move to mountain areas. In these new regions, the medicinal plants they once relied on are no longer available, leading to the erosion of indigenous knowledge about herbs and healing.

#### Non-economic loss and damage, human rights, and political commitments

While Bangladesh has made strides in disaster management and adaptation, it has yet to fully address NELD. There is an urgent need for policies and management frameworks in this area. Although Bangladesh presented a national L&D assessment framework at the Baku Conference, NELD must be explicitly integrated. This requires the consent of all regions and communities, along with coordinated research on the impacts of NELD on ecosystems and people.

In climate finance negotiations, countries must include NELD in their Nationally Determined Contributions (NDC), National Adaptation Plan (NAP), and National Biodiversity Strategic Action Plan (NBSAP) to ensure that NELD are addressed in both national and international climate policies. After undue delays and false oaths, the global leaders at the Baku conference agr

# A roadmap for rickshaw management is essential

The unplanned growth of our cities has exacerbated the management crisis surrounding rickshaws, adding to the woes of an already chaotic transport sector. Batterypowered rickshaws, in particular, have gained popularity nationwide as a more convenient to pedal rickshaws. However, since these vehicles are unsafe by design and poorly regulated, accidents occur frequently, which shows the urgency of formulating a comprehensive policy to manage their operation effectively.

Over the years, the authorities have made various attempts to control the spread of batterypowered rickshaws. In Dhaka and Chattogram, battery-run rickshaws were banned by the High Court in 2014, with a subsequent directive in December 2021 prohibiting their import. In August 2015, the government banned threewheeled, non-motorised vehicles on 22 roadways across the country. The Road Transport Act of 2018 further restricted battery-powered rickshaws, along with vans and other three-wheelers, and in 2023, the government unveiled the "Registration and Movement of Electric Vehicles Policy." However, this policy neglected to address battery-operated rickshaws specifically, leaving a regulatory gap.

From pedal rickshaws to batteryrun rickshaws

The history of the origin of rickshaws in Dhaka goes back to 1938 when six rickshaws were brought into the city by a zamindar from Sutrapur and a Marwari trader from Wari. This significant moment, documented in a 1986 BIDS publication, marked the beginning of Dhaka's rickshaw industry. By 1944, according Robert Gallagher's 1992 research book "The Rickshaws of Bangladesh", Dhaka licensed its first 100 rickshaws. By 1948, it was 575, and by 1972, the number increased to 23,000. However, there were more pullers than there were rickshaws, as many drivers shared the same vehicle. The Dhaka City Corporation (DCC)—the sole licensing authority until 1986-issued 79,554 rickshaw licenses, yet since its bifurcation, the city's North and South corporations have conspicuously lacked data on the number of rickshaws in operation. This added complexity to managing the industry.

The transition to battery-powered rickshaws began between 2007 and 2009 when local workshops outfitted the vehicles. Autorickshaws and easybikes are the two primary varieties of battery-powered rickshaws. An electric motor and lead-acid batteries were added to the rickshaw frame, allowing it to operate at high speeds. However, these rickshaws or easybikes, often built with low-quality parts and batteries, lack essential safety

drivers, passengers, and pedestrians

#### Rickshaw-related research findings

Research on rickshaws and their pullers/driverscanhelppolicymakers understand the industry's scale and impact. According to a 2019 study by the Bangladesh Institute of Labour Studies (BILS), Dhaka alone has around 1.5 million rickshaw operators, with five million nationally relying on the vehicles for their livelihood, contributing around Tk 30,000 crore to the rural economy each year. Therefore, regulation and registration, especially zone-based management, are essential to address the issues posed by unregulated battery-

powered rickshaws. A May 2024 study by CLEAN found that 1.4 million easybikes collectively use approximately 659 MW of electricity daily, serving about 25 million people for shortdistance transport. The easybike system contributes approximately Tk 97.625 crore to the national economy, according to the study, with major contributions from manufacturing, battery, and services related to charging, servicing, and commuting. The study suggests that proper regulation of easybikes could add Tk 8,000 crore to the national exchequer if they were legalised, licensed, and subjected to regular renewals. To promote sustainable use, the study also recommended shifting to lithium-ion batteries, offering driving courses and licenses, setting up solar-powered charging stations, etc.

From October 2021 to September 2023, the Bangladesh Energy and Power Research Council (BEPRC) carried out a project titled "Development of a Design

features, making them dangerous for Standard for Easy Bike in Bangladesh." Conducted by BUET's mechanical and electrical engineering departments, the project focused on creating a standard for easybike manufacturing, assembly, and importation. The project findings suggested that safety could be enhanced by improving the braking system, adding doors, and altering seating capacity. Replacing lead-acid batteries with lithium-ion batteries would reduce pollution and extend battery life. However, largescale adoption of these changes could be hindered by the significant amount of illicit money involved in the unregulated sale of battery rickshaw number plates and inferior batteries.

**Guidelines for sustainable** 

#### rickshaw management

Immediate action is needed to establish and enforce operating guidelines for both pedal and battery-powered rickshaws. But first, public walkways should be cleared for pedestrian use, and a rental bicycle system could encourage more people to cycle. Improved public transportation could also gradually reduce the dependency on rickshaws. Temporarily halting the production and sale of all rickshaw models and banning battery rickshaw imports are further steps to curb proliferation. That said, we should ensure that all these vehicles are properly registered and standardised. Communitybased rickshaw systems, similar to efficient, and economically beneficial those in DOHS and Bashundhara, system for all.



The 295-run win was India's largest margin of victory against Australia away from home in terms of runs, surpassing their 222-run triumph in Melbourne back in 1977.

In the overall contests between these two nations, it was the second biggest Test win (in terms of runs) after the Mohali Test (2008), when India had won by 320 runs.

The emphatic victory was only India's second in Perth and first since their triumph at the WACA Ground back in 2008.

Jasprit Bumrah became only the second captain from Asia to lead his team to a Test win against Australia in Perth - after Anil Kumble (2008).

The victory propelled India to the top of the World Test Championship standings with a points percentage of 61.11, while Australia dropped to second place with 57.69.

The last time Australia won a home series after losing the opening Test was 55 years ago against West

# Rana resurfaces after two-year hiatus

Once a bright prospect for the national team, left-arm pacer Mehedi Hasan Rana, who rose to prominence with his stellar performances in the Bangladesh Premier League (BPL) in 2019, had been absent in first-class cricket for 25 months.

His struggles began just a day before the last National Cricket League (NCL) season, when the 27-year-old fractured his hand, forcing him to miss the first-class competition and the subsequent Bangladesh Cricket League.

After regaining fitness, Rana was signed by BPL's Fortune Barishal, who eventually won the title. However, he did not get a chance to play due to team composition. Reflecting on his struggles,

Rana admitted, "I blame myself for not performing in the 2023 BPL for Chattogram Challengers," referring to his earlier success in the 2019-20 BPL, where he bagged 18 wickets for Chattogram Challengers. He followed that season with 11 wickets in eight

matches for Fortune Barishal, who were runnersup that year.

Meanwhile, in the last Dhaka Premier Division Cricket League in April this year, he got only one match for Legends of Rupganj, who relied more on pacers like Abdul Halim, Al-Amin Hossain, and Mashrafe bin Mortaza. As a result, Rana, along with Sumon Khan, spent most of the season on the bench.

"I was unlucky last season," Rana told The

Daily Star after claiming 5-65 for Khulna Division against his former side, Chattogram Division, in the first innings in Sylhet in the sixth-round match of the ongoing NCL.

Rana's return to the field was far from easy Initially drafted into the Chattogram squad, he had to secure an NOC from the management before finally joining Khulna to feature in his first first-class match since October 2022. "I was out of red-ball cricket for the last two

years... I felt I might not get a chance to play for Chattogram this season," he said.

Rana also faced challenging days in 2022 when Bangladesh Cricket Board (BCB) banned him for a month after he made "unacceptable" comments about a national selector on his Facebook page.

Rana now says he has moved past the incident and is focused on reviving his career. "I don't think the selectors have kept these [previous misconducts] in their minds," he said.

"I have always tried to remain fit... After the Premier League, I worked with [Mohammad] Salahuddin sir at the MASCO for three months. I was waiting for my turn to come, and it finally arrived.

"I have been in regular communication with Hannan [Sarkar] bhai... He wished me good luck to perform well here," said Rana, who, however, is yet to secure a BPL team for the upcoming season and also remains uncertain about being picked in Barishal's final squad for the NCL T20.



# Parties want caretaker govt, 2-term limit for PM

#### Jamaat, CPB, Gono Odhikar for introduction of proportional representation system of voting

Bangladesh Jamaat-e-Islami, Communist Party of Bangladesh (CPB) and Gono Odhikar Parishad (GOP) proposed a proportional representation electoral system and the restoration of the caretaker government to oversee the national polls.

In separate proposals to the electoral reform commission, Jamaat and the 10-party alliance Jatiyotabadi Somomona Jote sought to limit the tenure of the president and the prime minister to two

Jamaat, which lost its registration as a political party with the EC in 2018 following a court order, also called for repealing the law under which political parties get their registration.

Khelafat Majlis and the GOP want a provision to disqualify the Awami League and its allies from the election. The Somomona Jote and GOP sought bicameral legislation.

"Political parties are making the proposals as we sought proposals from them," Badiul Alam Majumdar, chair of the electoral reform commission, told The Daily Star yesterday.

The interim government constituted the electoral reform commission on October 3 and sought its report within 90

including legalising the caretaker government system by incorporating it in the constitution.

It proposed six election commissioners in place of four at present. The party is in favour of the selection of candidates by the grassroots leaders, non-partisan local elections and CCTV cameras in all polling

Israel's security cabinet was preparing to decide whether to accept a proposed ceasefire in its war with Hezbollah, an official said yesterday, as the White House announced it believed a deal to end the fighting in Lebanon was "close".

The United States, European Union and United Nations have all been actively pushing in recent days for a truce in the long-running hostilities between Israel and Hezbollah, which flared into all-out war in late September. Lebanon says at least 3,768 people

have been killed in the country since October 2023, most of them in the past Speaking on condition of anonymity,

an Israeli official told AFP that the country's security cabinet "will decide on Tuesday evening on the ceasefire deal". US National Security Council

spokesman John Kirby expressed optimism over the prospects for a truce but said talks were ongoing.

"We believe we've reached this point where we're close," Kirby told reporters, adding "we're not there yet".
