
Academic life of 40,000 in disarray

Classes, exams halted following series of clashes

Academic activities in five major educational institutions in Dhaka remain suspended for the past week amid multiple incidents of clashes, affecting at least 40,000 students.

- Classes remain suspended in at least five colleges
- Multiple exams cancelled across 10 educational institutions
- DMRC suffered significant losses
- Authorities call for permanent solution
- Special assistant to education adviser says 'situation contained'



The institutions are Government Shaheed Suhrawardy College and Kabi Nazrul Government College, which are among the seven institutions affiliated with Dhaka University, Dr Mahbubur Rahman Mollah College (DMRC), Dhaka National Medical Institute Hospital and St Gregory High School and College.

On Sunday and Monday, students of these institutions engaged in separate clashes, halting academic activities.

The clashes also prompted the DU authorities to postpone final examinations of first- and fourth-year students of all seven affiliated colleges. The five other affiliated colleges are Dhaka College, Eden Mohila College, Begum Badrunnesa Government Mohila College, Government Titumir College, and Mirpur Government Bangla College.

Principals of the colleges expressed concerns over the disruption of academic activities due to infrastructural damage, calling for prompt and permanent solutions to resume normal operations.

Ashraf Chowdhury, managing director of DMRC, which will remain closed until Saturday, said they might not be able to start academic activities even next week considering the amount of damage done to the institution.

"We'll try to resume official work next week. If we can repair the damages and get the classrooms ready for the students, we'll try to resume classes the week after," he told The Daily Star.

Prof Kakoli Mukhopadhyay, principal of Shaheed Suhrawardy College, said, "We've been trying to restart academic activities in our college, but we've been SEE PAGE 2 COL 5

CTG LAWYER MURDER Cops identify 8-10 attackers 7 more held, lawyers blame police mishandling

Police have identified 8 to 10 people who hacked lawyer Saiful Islam Alif to death on Tuesday when followers of Chinmoy Krishna Das Brahmachari clashed with police and lawyers on the Chattogram court premises.

Scrutinising CCTV footage of the murder scene, the police learnt that 30 to 35 people gathered on the spot and some 10 of them attacked Saiful, police said.

Of the attackers, five were wielding sharp weapons and three were wearing helmets.

Police on Wednesday filed three cases against 79 named and 1,400 unnamed people in connection with assault, vandalism, and obstructing police in discharging their duties on that day.

However, a murder case was yet to be filed.

Police arrested seven more people yesterday in connection with the violence

Political parties strongly endorse press freedom

Call for an end to intimidation of the media during talks with Noab

Political parties yesterday expressed their unwavering support for press freedom, highlighting its vital role in strengthening democracy and securing the nation's future.

They blasted the recent attacks on the press and called for an immediate end to such activities. They also cautioned that if such activities go on, the aspirations of the July uprising would not be fulfilled.

Top leaders of 13 political parties made these

remarks at a views-exchange meeting on "Independent Journalism and Media Institutions Under Threat". The Newspaper Owners' Association of Bangladesh (Noab) organised the programme at the Pan Pacific

Sonargaon Hotel.

Speaking at the event, BNP Secretary General Mirza Fakhrul Islam Alamgir said it is quite unfortunate that he had to discuss press freedom in a free environment

after the fall of a fascist regime.

\$14b lost to capital flight a year during AL years

Finds committee preparing white paper

Bangladesh has lost around \$14 billion a year on average to capital flight during the Awami League's 15-year tenure, according to the draft report of the committee preparing a white paper on the economy.

The actual amount of capital flight

could not be determined due to time constraints, Daily Star has learnt from members 12-member the committee. However, separate chapter has been prepared on the topic using scientific methodology, government documents and global reports.

The committee, which was formed on August 28, was given three months

to prepare the report to inform on the true state of the economy, battered from years of mismanagement and data obfuscation.

"We have incorporated the ways money laundering takes place and how it could be stopped," said one of the committee members asking not to be named.

Earlier on November 2, Transparency

International Bangladesh said \$12 to \$15 billion was siphoned out of the country in a year over the last 15 years.

Bangladesh lost approximately \$8.27 billion on average between 2009 and 2018 only from misinvoicing of values of import-export goods by traders to evade taxes, according to the SEE PAGE 2 COL 5

Polls date after reforms

Two advisers say at press briefing

The government will announce the date of the national election immediately after completing the reforms, Syeda Rizwana Hasan, environment, forest, and climate change adviser, reiterated yesterday.

She said six reform commissions are supposed to submit their reports by December 2024, but some commissions have informed them that they may need one or two more weeks to submit their reports.

"We are repeatedly saying that we will go for elections as soon as possible after completing the reforms. The primary work of holding the polls has been completed. The Election Commission has been formed," Rizwana told a press briefing at Foreign Service Academy in



Hajj registration deadline extended till December 15

The government has extended the Hajj registration deadline for 2025 to December 15 to prevent last-minute

The Ministry of Religious Affairs announced this change through a notice signed by Deputy Secretary Md Rafikul Islam yesterday.

The notice said the registration period for both government and private Hajj pilgrims now runs until December 15, 2024. During this period, pilgrims can complete their initial registration by depositing Tk 3 lakh and must finalise their registration by paying the full amount for the Hajj package.

The notice added that no further extensions will be given after this deadline. Pilgrims must complete all necessary procedures within the stipulated timeframe.

Bangladeshi fisherman shot by Myanmar Navy

A Bangladeshi fisherman sustained injuries after being shot by the Myanmar Navy while fishing near Saint Martin's Island in Teknaf, Cox's Bazar, said BGB yesterday.

Mohammad Ershad, 40, has been taken to Teknaf for advanced medical care.

The incident occurred Wednesday around 3:00pm in the Baddar area of the southeast Bay of Bengal, close to St Martin Jetty.

The fishing trawler Ershad was aboard inadvertently entered Myanmar's waters in the Baddar area due to an engine failure, said Major Mohammad Ishtiaq Murshed, acting commanding officer of the Teknaf-2 BGB Battalion.

"At that time, a ship of the Myanmar Navy stationed there opened fire at the trawler. Ershad was shot in his arm."

The navy then provided first aid to the injured fisherman before releasing him and the other crew, along with their trawler. "Inquiries are being made in this regard."

Meanwhile, Shuvo Kanti Das, a fourth semester student of LLB at the BGC Trust University, was expelled yesterday after alleged evidence of his involvement in the murder surfaced.

BGC Trust University's Deputy Registrar Salauddin Shahareir told The Daily Star, "Soon after photos [allegedly of the murder incident] went viral on the social media, his classmates and other students identified him in the photo. The university made the decision based on students' information and evidence.

"The university did not launch any investigations on its own in this matter," he said.

He said the BNP always fought for freedom of speech, right to vote, and

"Some people are attempting to divide the people. Certain remarks are being made that could lead to complete anarchy. Together, we must stop this; or else, the sacrifices of the students and the masses will go in to address any such crisis.

Fakhrul pointed out that certain actions lead to depoliticisation at times, which must be consciously avoided. He said that an elected government is the best option, but imposing control on it or on democracy is unacceptable.

"Creating anarchy or acting recklessly would lead the nation towards the gravest danger."

Urging caution, he warned against taking actions that could allow the ousted prime minister Sheikh Hasina to manipulate incidents from abroad and this would ultimately spoil the opportunity to rebuild the nation.

He reaffirmed his party's commitment to protect freedom of the press, freedom of expression, and voting rights at all costs.

Andaleeve Rahman Partho, chairman of Bangladesh Jatiya Party, said it is not unlikely that press freedom would be under threat after the fall of such a fascist regime.

He said that when the interim government assumed office on August 8, the media outlets had said that the government should stay in power for two to three years. "They also said there is no difference between an Awami League government and that of the BNP's, and that the two parties are two sides of the same coin. This view of the media hurts us."

Partho said no one should think that if one government is replaced by another one, nothing will change. "Thinking along such line is another form of fascism.

"It is ultimately up to the people to decide. A gap has been created between political parties, the government, and the media. Many have tried to capitalise on this gap."

He also said the interim government has failed to keep in touch with the

"Had the government maintained more matured informal and formal relationships with the political parties, these problems would not have arisen.

Terming the incumbent government a weak government, Partho said no one can expect they would be protected by such a weak administration.

"Only a people's government, be it good or bad, can be held accountable. A political government can stand by

the media and protect it." Hamidur Rahman, assistant secretary general of Jamaat-e-Islami, said democracy and independent

journalism are intrinsically linked. He said his party thinks any attempt to weaken independent journalism is a conspiracy to undermine the state.

"Such actions constitute a new conspiracy aimed at obstructing the path of democracy and paving the way for the return of old fascism."

Highlighting Jamaat's continued support for independent journalism, Hamidur said, "Arson and other attacks and vandalism targeting newspaper offices are regrettable. We do not support such activities."

He called for a national consensus

Mahmudur Rahman Manna said, "When you talk about practising inclusive politics and democracy, vou will also have to accept the idea of letting a hundred flowers to bloom. You cannot gag any opinion. Democracy is undoubtedly the rule of the majority, but at the same time, you must also acknowledge you cannot muzzle the minority communities."

He said every opinion must be allowed to be expressed.

"From this perspective, I believe that be it the Prothom Alo, The Daily Star, or any other newspaper or TV channel, they must be granted full freedom. If we cannot foster the expression of diverse opinions freely, it will be difficult for us to move forward."

Zonayed Saki, chief coordinator of Ganosamhati Andolon, said press freedom was the "key verdict" of the 1971 Liberation War and the 2024 mass uprising.

"For that, we need to stand for the media and its rights. Even if a media outlet is ideologically opposed to me, will stand for its rights as well."

He said he believes there should be one standard for everyone.

"Even if we do not consider a particular media outlet ideologically correct, it still has the right to exist as a media entity. Ideological and political debates will continue, but committing a nuisance in front of a newspaper office aligns with fascist practices. Shutting a media outlet is an extension of this approach, and everyone should realise this."

Saki said there can be criticisms, and ideological differences among the people, but their freedom of speech should not be obstructed by any means.

"These issues should be clearly mentioned in the constitution in

There should be no compromise on oress freedom because people rely on the media, he added.

Nasiruddin Patwary, convener of the Jatiya Nagorik Committee, called for unity among the stakeholders to resolve the problems facing the media through dialogue.

"Those who have resentment or complaints about any particular media outlet can resolve those issues

through discussions," he said. Nasir urged the media owners, workers, political figures, and all other stakeholders to come to a common platform so that no media house

in the country would fall victim to aggression.

"Wherever there is an attack, we will collectively stand against it," he added. Bazlur Rashid Firoz, general secretary of Bangladesh Samajtantrik Dal, said attacks on newspapers and media outlets are effectively assaults on democracy and the mass uprising of 2024. "To counter these attacks, we must unite and move forward collectively.

Saiful Haque, general secretary of Biplobi Workers Party, described the slaughter of a cow for a feast in front of a newspaper office as an unbelievable,

Condemning the incident, he said, "The question of who was behind this remains unaddressed. Who will uncover this? There must be provocation and instigation behind

Communist Party of Bangladesh General Secretary Ruhin Hossain Prince criticised the arbitrary cancellation of the accreditation cards of some journalists and filing of murder cases against some others.

He said people must stand united

against the attacks on the media. Rashed Khan, general secretary of Gono Odhikar Parishad, said his party strongly believes in freedom of speech and freedom of press.

"If the journalists cannot write independently even after the mass uprising, it would be deeply saddening."

He said the media did not play its due role over the past 15 years, and the authorities should investigate into this

Mujibur Rahman Manju, member secretary of Amar Bangladesh (AB) Party, highlighted a "gap" between the media stakeholders and those protesting against some media outlets.

"It was the government's responsibility to engage with the demonstrators outside the Prothom Alo office. What could have been resolved through discussion has instead been allowed to evolve into an ideological or commercial issue."

Manju suggested that the Media Reform Commission or the Noab make recommendations to prevent such incidents.

Maulana Imtiaz Alam, assistant secretary general of Islami Andolan Bangladesh, said, "We believe in freedom of the media and we want to assist them. However, the media also need to make sure it do not write or say anything that goes against the belief of the majority. The media also need to show respect to our belief."

Jalaluddin Aĥmed, joint secretary general of Bangladesh Khelafat Majlish, urged the owners of media outlets not to discriminate between political parties while running news on them.

Reading out a written statement, Noab President AK Azad expressed deep concern that at a time when media outlets should be operating in a pressure-free environment after the mass uprising, some newspapers and media houses are still facing threats, and even warnings of closure.

He said incidents such as laying siege to newspaper offices in the name of protests, creating chaos, attacking regional offices, and obstructing the distribution of newspapers in different parts of the country are totally

These actions are fostering an atmosphere of fear and intimidation. posing a serious threat to press freedom, he said.

'The actions and campaigns against the Prothom Alo and The Daily Star are not merely protests or expression of dissent, rather those involve issuing threats, making hatred, creating chaos outside their offices, and resorting to violence whenever possible. Such actions are causing financial losses to the newspaper industry."

Azad stressed the need for taking strong measures against such undemocratic activities that threaten press freedom.

He said the safety of the media outlets and their employees must be ensured at all costs.

The Noab leader called upon all political parties to assist and cooperate with the media to safeguard press freedom.

Mahfuz Anam, executive member of Noab and also the president of the Editors' Council, said the media want to see an end to the oppressive measures taken to suppress independent journalism and stifle the

press over the last 15 years. He said the media had hoped that the situation would improve after the mass uprising, allowing journalists to carry out their duties freely and independently.

"Unfortunately, independent journalism is being attacked in new ways, which is highly condemnable and alarming. We believe political parties play a significant role in supporting independent journalism," said Anam, also the editor and publisher of The Daily Star.

He urged political parties to ensure press freedom.

Muntasir Ali, joint secretary general of Khelafat Majlish, also spoke at the

The college announced that its academic activities will remain halted until December 2, while Kabi Nazrul Government College remained shut until yesterday since the clash erupted on Monday (November 25). It has not given a date of reopening till the filing of this report at 9:00pm last night.

On November 24, students of DMRC went to Dhaka National Medical Institute Hospital to protest an alleged medical mistreatment of a

At one point, they vandlised the hospital, compelling the institute authorities to postpone all MBBS and BDS classes from November 26 to 28.

As some students of Shaheed Suhrawardy College, located near the hospital, intervened, the DMRC students attacked and vandalised that college as well.

St Gregory High School and College also came under attack at that time, leading to suspension of all classes, and exams until vesterday. The authorities of the institution yesterday said they will begin classes on Saturday.

On November 25, in response to the attack, students of Suhrawardy College, with support from students of other DU-affiliated colleges like Kabi Nazrul Government College, severely vandalised the 11-storey DMRC building, leading to a series of clashes

In a separate incident, students of Bangladesh University of Textiles (Butex) and Dhaka Polytechnic Institute got locked in a clash on November 24 night, resulting in the suspension of nine exams of Butex.

Since the fall of the Sheikh Hasinaled government, the education sector has been in a state of instability. Several protests were held at different institutions across the country as students demanded the resignations positive outcomes soon."

of their respective teachers or principals. This too had resulted in disruptions to academic activities in those institutions.

In August and October, the government saw multiple student movements.

Samina Luthfa, a teacher of DU and member of the University Teachers Network, said that in the past, teachers aligned with the Awami League failed to stand by the students. "Instead, they aided the repression, which created a significant divide between these

teachers and the students. "As a result, the relationship between teachers and students has been severely damaged, making it increasingly difficult to maintain control over the students."

She said the recent clashes are deeply concerning, and they cannot be allowed to escalate further.

"When we know there are problems in these colleges, immediate security measures should be implemented. dialogue between teachers and

Samina emphasised that the government must take responsibility for these issues, as the education ministry holds significant accountability.

"The failure to control the situation indicates that the changes people hoped for in the uprising have not been implemented effectively. Moreover, she said, if appointments

in educational institutions are made based on political affiliations, no real solutions can be achieved. "In such cases, teachers might exploit students for political purposes,

which should never happen. To resolve

these issues, both the government and teachers must take responsibility." Contacted, Prof M Aminul Islam, special assistant to the education advisor, said, "The situation is contained now. We are taking the necessary steps to bring normalcy to

The 250-page report titled "White Paper on the State of Bangladesh Economy" will have 22 chapters, including their findings on GDP growth, inflation, external balance, banking sector situation, power and energy situation, government's debt, quality of statistics, trade, revenue, expenditure, mega projects, business environment, poverty and equality, capital market, education, health,

women and climate issues. The report will be handed over to Chief Adviser Muhammad Yunus on Sunday and made available for public consumption the following day.

"We will provide the real picture of Bangladesh's economy," said one of the committee members.

The committee -- led by Debapriya Bhattacharya, a distinguished fellow at the Centre for Policy Dialogue made its observations on mega projects like Padma bridge and the railway link, the Rooppur nuclear power plant, Matarbari power plant and Karnaphuli tunnel.

"We have incorporated our observations on the corruption

charges by the World Bank in the Padma bridge project and the issue of the Canadian court. We have our observations on building the bridge with own funds," said another committee member.

The 6.15-kilometre Padma bridge cost Tk 30,193 crore, or \$3.56 billion. Of the amount, \$2.4 billion was paid through foreign currency provided by the Agrani Bank. Total public debt, especially the

repayment of foreign loans over the next four years for the ongoing 215 foreign-funded projects, was incorporated in the report, said another committee member.

The committee has suggested pathways to rationalise the huge subsidy expenditure, improve the bad loan situation and strengthen market management for inflation control.

The committee members include economists AK Enamul Haque, Kazi Iqbal, Mustafizur Rahman, Selim Raihan, Sharmind Neelormi, Mohammad Abu Eusuf, Ferdaus Ara Begum and Zahid Hussain; energy expert Mohammad Tamim; and manpower export expert Tasneem Arefa Siddiqui.

'16 DAYS OF ACTIVISM' Make justice more accessible for victims Say speakers at MJF event on gender-based violence

Access to justice should be easier when it comes to any sort of gender-based violence (GBV). Police and the judiciary must actively work to prevent violence against women, said speakers at a discussion yesterday.

They made the remarks at an event, titled "Towards Beijing +30: UNITE to End Violence against Women and Girls", organised by Manusher Jonno Foundation (MJF) at its auditorium in the capital, observing "16 days of activism against Gender-based Violence 2024".



Women with physical disabilities, members of the hijra community, and young women from various professions shared their struggles and stories at the event.

Mohammad Al Mamun, director of National Legal Aid and Services Organisation, said, "The number of women seeking legal aid is increasing yearly. If the judiciary and judges work to prevent GBV and more punitive measures are taken, it will help."

Gitanjali Singh, representative of UN Women, said, 'Although we survived the pandemic, we haven't been able to eliminate the pandemic of violence against women. Every 10 minutes, a woman is killed by her partner somewhere in the world. Bangladesh has laws SEE PAGE 4 COL 7

With 837 new dengue cases reported yesterday, the total number of cases this year has surged past 90,000.

This is an alarming rise as the year enters November, a time when cases typically start to decline. The Directorate General of Health Services reports

482 deaths, with the total number of dengue cases reaching 90,440 as of yesterday. Experts are attributing

the prolonged dengue season to ineffective mosquito control measures, favourable weather conditions for mosquito breeding, and the failure to implement preventive actions during the lean period earlier in the year.

Entomologist Manzur Chowdhury pointed out that the unusual combination of high

humidity and warm temperatures in November has created ideal breeding conditions for Aedes mosquitoes. "This level of dengue transmission in November is uncommon, as cases usually decrease at this time. Warmer temperatures have allowed mosquito

populations to thrive," he said.

Manzur stressed that early intervention could have limited the spread. "If authorities had acted during the lean period from January to March, the outbreak could have been controlled," he said. He also highlighted the

need for more comprehensive measures beyond mosquito control. "Authorities focus on killing mosquitoes, but we also need to prevent the virus from spreading through human movement," Manzur

He also called for better tracking of all dengue cases, including asymptomatic ones.

"Currently, the DGHS only records hospitalised patients, which is a small fraction of the total cases. A nationwide system to monitor all dengue cases is crucial," he added.

He also suggested declaring dengue a reportable disease from January to June, which by reducing mosquito would help better track eliminate and cases mosquito breeding sites.

Entomologist GM Saifur Rahman from the National University of Bangladesh agreed that the lack of effective control measures has contributed to the outbreak.

"This year, we have not seen weather conditions reduce mosquito populations, and Aedes mosquitoes are breeding in large numbers,"

He pointed out that breeding, are particularly vulnerable.

Both experts stressed the need for identifying asymptomatic dengue patients, who make up 70-80 percent of cases and act as reservoirs for the virus. "Without tracking these patients, controlling the spread of Aedes mosquitoes is nearly impossible," Saifur warned.

Both Manzur and Saifur emphasised that colder weather is crucial for slowing the virus's spread breeding.

"The presence of the dengue virus across the country and ineffective control measures have allowed the outbreak to continue," Saifur concluded.

The experts are urging for coordinated action from the government, including improved surveillance, early intervention, and increased public awareness, to control the spread of the virus in the coming months.

"Environmental protection is not only the responsibility of the administration, but local residents also need to work from their respective positions," she added.


Addressing as the chief guest, Abu Bakar Sarkar, upazila nirbahi officer of Savar upazila, called for formulating development project proposals centring the upazila.

At a press conference at ISKCON Bangladesh's headquarters, General Secretary Charu Chandra Das Brahmachari said, "A series of false, fabricated, and malicious campaigns have been targeting ISKCON Bangladesh, particularly in connection with recent events. These efforts are aimed at discrediting our organisation and creating societal unrest."

The leaders categorically denied any involvement in the murder, which occurred near the Chattogram court premises, and in the related movements.

Murshidpur Darbar Sharif looted, torched

An unruly mob of over a hundred once again attacked the Doja Pirer Darbar, also known as Murshidpur Darbar Sharif, in Sherpur Sadar upazila, vesterday.

This marks the second attack on the shrine in three days.

On Tuesday, a clash ensued following an attack on the shrine which resulted in one casualty.

Yesterday's attack continued for some three hours during which the mob torched the shrine reportedly before looting it.

On Tuesday morning, they attacked the shrine, leaving more than 10 persons injured.

One of the injured, identified as Hafez Uddin, 40, a local resident, died at a Dhaka hospital on Wednesday. His namaz-e-ianaza was scheduled at

the local Jamshed Ali Memorial Degree College ground, half a kilometre away from the shrine, at 10:00am yesterday. Before the janaza, funeral attendees got enraged, leading to the attack on

the shrine. Police, Rab, and army personnel deployed in the area tried to avert the situation but were overwhelmed by the number of attackers.

Contacted, Sherpur Superintendent of Police Md Aminul Islam said additional police personnel were deployed in the area.

Md Jubaidul Alam, officer-incharge of Sherpur Sadar Police Station, said a case was filed over Tuesday's attack against 25 named

SONADIA ISLAND SC upholds HC order to protect mangroves

The Supreme Court vesterday upheld a High Court order that directed the government to immediately stop destruction of mangrove forests in Sonadia Island and neighbouring areas, including Gatibanga, Taziakata and Hamidardia in Cox's Bazar.

Justice Md Rezaul Haque, chamber judge of the Appellate Division of the SC, passed no order on a leave to appeal petition filed by six locals. The chamber judge, however, asked

the HC to dispose of the rule issued over this matter in two months. Senior lawyer Md Ruhul Quddus

Kazal argued for the appellants, while lawyers Mohammad Shishir Manir and Saddam Hossen appeared for the writ petitioners during hearing yesterday. Following a writ petition, the HC on

October 23 ordered officials concerned of the government to demolish all illegal shrimp projects from Sonadia Island and neighbouring areas, take appropriate legal action against the persons involved in the destruction of the mangroves, and submit a compliance report before this court within 90 days.

The HC also issued a rule asking the respondents (officials) to explain why they should not be directed to protect the mangroves under the Bangladesh Environment Conservation Act, 1995.

In the writ petition, the petitioners annexed a report published in The Daily Star on May 20 last year under the headline "Destroying the last line of defence: Coastal residents at great risk of cyclones as mangrove forests cut down, leased and grabbed for development".

SC proposes formation of judicial council

If the Judicial Appointment Council is formed, transparency and accountability will be ensured in the recruitment of judges to the Appellate and High Court divisions. Supreme Court's Special Officer Muajjem Hussain told The Daily Star.

He said the proposal was prepared after conducting detailed research on the laws, regulations, SC decisions, customs, and relevant issues related to the appointments of judges in different countries.

There are independent and impartial commissions or similar institutions for appointing SC judges in many countries, including England, Ireland, Kenya, Malaysia, and

South Africa, according to Muajjem. The draft of the proposed ordinance was earlier sent to both Appellate and High Court division judges, seeking their opinions. As many as 15 judges sent their opinions to the SC, he said.

Contacted, Law Secretary Sheikh Abu Taher told this correspondent that he did not know whether his office

received the proposal from the SC.

Formulating a law for the appointment of SC judges under the constitution is a longstanding demand from different sections of people, particularly the Supreme Court Bar Association.

In an address to lower court judges on September 21 after assuming office, Chief Justice Syed Refaat Ahmed announced a roadmap for reforms in the judiciary. He said he would take steps for the formulation of a law on the appointment of SC judges and the establishment of a separate secretariat for the judiciary.

In a previous proposal sent to the law ministry on October 27, the SC proposed the establishment of a separate secretariat for the judiciary. The proposal aims to make the judiciary truly independent, separate it from the executive branch effectively, and bring an end to the law ministry's control over the lower

appointed by the president, and the other judges shall be appointed by the president after consultation with the chief justice.

A person shall be qualified for appointment as a Supreme Court judge if he or she has "qualifications as may be prescribed by law", according to article 95(2) (c).

Article 98 states that the president may appoint one or more duly qualified persons to be additional judges of a division of the Supreme Court if the president is satisfied that the number of judges of that division should be increased. The tenure of these judges will not exceed two years as the president may specify.

Or, if the president thinks fit, may require a judge of the High Court Division to sit in the Appellate Division for any temporary period.

"Provided that nothing in this article shall prevent a person appointed as an additional judge from being appointed as a judge under article 95 or as an additional judge for a further period under this article," article 98 adds.

Asked who the instigators are or whether they have any particular identity, and what their motives are known so far, Colonel Intekhab said, "I cannot tell their identity exactly. Instigators will always be there. But it is our, the ordinary people's responsibility not to be provoked."

In reply to a question if there was a lack of intel, he said, "I would not call it a lack of intelligence. We are working in coordination with everyone on intelligence gathering. I have already explained that in some cases we have to think a lot. That is why many may think that the law enforcement agencies did not take appropriate steps.'

There are reports that the joint forces have been involved in crimes during operations.

Asked how many personnel involved in such crimes have been identified and

what action has been taken against them, Col Intekhab said retired and incumbent members of the army may have been found involved.

"I do not have specific information right now. However, every allegation is being investigated. Some investigations have been completed. As far as I know, various disciplinary measures have been taken — ranging from four years to one year in jail, and dismissal from service," he said.

After the arrest of Chinmoy Das, the leader of a Hindu group, a lawyer was killed in Chattogram during clashes between Chinmoy's supporters, law enforcers and lawvers.

Asked why steps were not taken to prevent violence although the situation was already tense, Colonel Intekhab said, "The death is definitely very painful. But due to law enforcers' presence and quick response, a major incident was avoided.'

At the start of the briefing, Colonel Intekhab reviewed the army's activities over the past two weeks, starting from November 13.

During this period, the army seized 24 illegal firearms and 365 rounds of ammunition. They responded to 40 incidents of unstable situations and cleared 18 road blockades in industrial zones. The army also addressed 63 disorderly situations, including those related to political conflicts, educational institutions, and government offices.

The army apprehended 1,328 individuals linked to various criminal activities, including 228 involved in drug-related offences. They played a key role in ensuring the peaceful celebration of religious and cultural festivals, collaborating with Buddhist organisations to protect 444 monasteries across the country

The army officer also highlighted the ongoing efforts against the Kuki-Chin National Front, an armed separatist group in Chattogram Hill Tracts. Since April, the army has arrested 179 KNF members or collaborators and seized 60 weapons, along with a significant amount of ammunition and military equipment.

Throughout this period, the army has faced substantial challenges, with 122 personnel injured, and one officer killed in the line of duty.

Pakistan journo probing protest deaths arrested

A Pakistani journalist investigating alleged fatalities during protests in support of jailed ex-prime minister Imran Khan has been arrested under anti-terror laws, his lawver said vesterdav

This week more than 10,000 marchers flooded Islamabad, defying a ban on public gatherings before being evicted in a sweeping security crackdown.

The government said at least five security personnel were killed whilst Khan's Pakistan Tehreek-e-Insaf (PTI) party allege at least 10 of their own were shot dead by security forces. Government ministers have denied the allegations.

Cabinet picks targeted by bomb threats

Says Trump transition team

Trump, 78, was holding a campaign rally in Butler, Pennsylvania - a key state in the November 5 election when a 20-year-old man with an AR-15-style rifle got close enough to shoot at the former Republican president from a rooftop.

One shot hit Trump's upper right ear, leaving his face streaked with blood, but he was not severely wounded. His campaign said he was doing fine.

Lebanon's education crisis deepens as half of public schools converted to shelters

Air pollution from fires linked to 1.5m deaths a year: study

Air pollution caused by fires is linked to more than 1.5 million deaths a year worldwide, the vast majority occurring in developing countries, a major new study said yesterday.

This death toll is expected to rise in coming years as climate change makes wildfires

more frequent, according to the study in The Lancet journal. The international team

of researchers looked at existing data on "landscape fires", which include both wildfires that rage through nature and planned fires such as controlled burns on

Around 450,000 deaths a year from heart disease were linked to fire-related air pollution

between 2000 and 2019, the researchers said. A further 220,000 deaths from respiratory disease were attributed to the smoke and particulates spewed into the air by fire.

From all causes around the world, a total of 1.53 million annual deaths were associated with air pollution from landscape fires, said the study.

Australia passes social media ban for under 16s

Tech giants face fines of A\$49.5m for non-compliance

Australian lawmakers yesterday passed landmark rules to ban under 16s from social media, approving one of the world's toughest crackdowns on popular sites like Facebook, Instagram and X.

The legislation ordering social media firms to take "reasonable steps" to prevent young teens from having accounts was passed in the Senate with 34 votes in favour and 19 against.

The firms -- who face fines of up to Aus\$50 million (US\$32.5 million) for failing to comply have described the laws as "vague", "problematic" and "rushed".

The new rules will now return to the lower house where lawmakers already backed the bill on Wednesday -- for one final approval before it is all but certain to become law. Speaking during the Senate debate, Greens

politician Sarah Hanson-Young said the ban would not "make social media safer for young She said it was "devastating" that young people were "finding themselves addicted to these



Unity is vital as tensions spill over

Rising unrest is preventing us from achieving desired progress

We welcome the call for national unity amid rising tensions over seemingly unconnected reasons in different parts of the country. Both Chief Adviser Professor Muhammad Yunus and top BNP leaders have underscored the importance of peace and unity as the nation grapples with post-uprising challenges. At a recent meeting, Prof Yunus has emphasised the need to deescalate tensions across societal divides, while BNP Secretary General Mirza Fakhrul Islam Alamgir called for dialogue with political parties to bridge divisions and build unity. However, unity is easier sought than achieved—it requires decisive action, collective resolve, and an unwavering commitment to addressing the underlying causes of unrest.

While remnants of the ousted regime may be partly to blame for the recent turbulence, the alarming frequency of disruptions suggests deeper fissures within our society. In recent weeks, we have seen attacks and hostile mobilisations targeting media houses as well as violent clashes among college students. On Tuesday, unrest surrounding the arrest of a former ISKCON leader led to the brutal killing of a lawyer. Frequent public demonstrations by various groups have also become routine. Though these incidents may appear isolated, they form part of a broader pattern of instability following August 5. While the uprising reignited hopes for democracy, it also exposed the fragility of our sociopolitical fabric, with dissent and disillusionments festering in various quarters. The question is, if the accomplices of the fallen regime are indeed weaponising their divisions, why haven't they been conclusively identified yet? Or are there other forces also at

Adding fuel to this fire is the unchecked proliferation of incendiary narratives on social media. The newfound freedom of expression under the government—while commendable has also become a double-edged sword thanks to minimal oversight, creating a fertile ground for propaganda, hate speech, and baseless rumours. Some are openly advocating destructive action, while others are sowing division under the guise of activism. These digital battlegrounds are making conflicts more likely and resolutions more elusive. Compounding this issue is a perception among many that they can disrupt public life without consequence, taking advantage of the government's relatively lenient approach to

So, how can we navigate these complex challenges to achieve peace and unity? Dialogue, as BNP leaders have suggested, is indeed essential, not just between the government and political parties but also among sociopolitical groups with competing interests. But for the sake of national interest, all must be sincere so that their interests are aligned with the common goal of peace. That said, dialogue alone is not enough. The authorities must prioritise enhancing law enforcement, ensuring that laws are enforced strictly and impartially to deter and punish those inciting violence. Misuse of freedom of expression, especially online, must also be addressed carefully but firmly to curb the spread of hate and misinformation. At the same time, the call for a Truth and Peace Commission deserves serious consideration. Such a commission could play a pivotal role in rebuilding trust, fostering reconciliation, and promoting restorative justice.

The challenges we face today require us all to act responsible and judiciously. A failure to do so risks undermining the gains of the uprising achieved through so much sacrifice and

Act now to check air pollution

It is taking a heavy toll on our lives

We are once again at that time of the year when the air we breathe becomes dangerously polluted, not just in the capital but across the country. This year is no exception. Over the past few days, Dhaka's air quality has consistently been classified as unhealthy or hazardous, and there is a concern that pollution levels will worsen as winter intensifies. For instance, on November 27, the concentration of PM2.5 in the city exceeded the WHO standard by 43 percent—an ominous sign for public health.

According to a report by IQAir, a Switzerland-based organisation, Dhaka has ranked among the top two or three most polluted cities globally throughout November. On November 24, Dhaka's air was rated the second worst in the world, with an IQAir pollution score of 291. Just two days later, the score rose to 324, indicating hazardous conditions. The situation is clearly dire, and without immediate action, we risk a public health crisis in the near future.

It's unthinkable that we have come to a point where air pollution has become so dangerous, thanks to the failure of successive governments. Between 2000 and 2019, \$6.5 crore was reportedly spent on two major projects to combat air pollution, in addition to other initiatives funded by hundreds of millions of dollars in foreign aid. Yet, despite these efforts, Dhaka remains one of the most polluted cities globally. High Court directives aimed at curbing air pollution-over 20 rulings, summons, and orders—have also been ignored, reflecting a failure of accountability and enforcement.

Today, illegal brick kilns continue to operate on the city's outskirts, spewing toxic smoke into the air. Outdated vehicles emitting black smoke ply the roads, while poorly planned construction projects scatter dust and debris throughout the capital. These persistent issues reveal the mismanagement and inefficiencies of successive governments.

Therefore, it is imperative for the interim government to take decisive action to combat this invisible yet deadly threat. We welcome the recent formulation of a national action plan to tackle air pollution. However, its immediate and effective implementation is critical. Additionally, the government must provide clear guidelines to citizens on how to protect themselves from the health hazards posed by polluted air. The time to act is now. Failure to address this crisis will only deepen its impact on public health and the economy.

The purpose of a "free" and "fair" election is to ensure accountability of those participating in it. In the past, parties in Bangladesh won elections with around one-third of the votes cast, while a third of the constituencies were won with around 30 percent of the votes cast. The problem lies in putting the emphasis on the election, not its purpose. Hence, the electoral system must be reformed carefully.

Among the three commonly used methods of determining the outcomes of legislative electionsplurality, majority, and proportional representation—the third one seems to be most effective. A study of elections in Muslim-majority countries reveal that the re-democratisation in Indonesia has been peaceful and uninterrupted since 1997 because of the proportional representation system in its parliament; the parties must cooperate to get any bill passed, becoming a "check" on one another.

In a proportional representation voting system, votes are cast for the parties, either in an open or a closed list system. The voters can give preference to a particular candidate in the former system, but not in the latter. An individual or a party must get a minimum threshold of votes to for individuals, two to seven percent

However, a reformed electoral system may bring the desired political effects only with an accountable, independent, and honest Election Commission that is adequately funded and staffed to regulate the political parties and election candidacy. A survey of dozens of constitutions shows that many countries, because of having political will and experience, have provisions that the constitution of a political party must have a time limit for executive positions (including the party presidency), and restrictions on directly inheriting party presidency (or senior executive positions). Moreover, a political party or group should not be able to participate in an election if it has been disrespectful to the country and its constitution, or has to leave the government under political compulsion (before completing its tenure in office).

Eligibility of election candidacy includes, among others, loyalty to and residency in the country, high moral standing, financial credibility, distance from criminal activity, and so on. Disqualification for election candidacy includes, among others, involvement in financial crime or in acts and ideas against the interest of the country, among others.

The reformed electoral system should focus on making the election beneficial to the voters, not the party, and the election candidacy laws should promote inclusion of the best persons in every party candidate list. Rule of law begins with laws, not arbitrary rules, and would save the government from making arbitrary decisions regarding the elections.

Deepfakes pose significant security risks across international, national, and personal domains, potentially destabilising political environments, manipulating elections, and disproportionately harming women through non-consensual explicit content.

According to ActionAid's 2022 report, the consequences are severe: 65.07 percent of victims suffered psychological trauma, including depression and anxiety; 42.79 percent lost confidence in online expression; and nearly a quarter experienced a devastating loss of self-dignity.

absence of specific timelines for investigation and prosecution means cases can drag on indefinitely, leading many victims to abandon their pursuit of justice. Perhaps most critically, there are no provisions for emergency protection orders or immediate content removal, leaving victims vulnerable to ongoing harassment while their cases slowly move through the system.

Addressing digital violence and creating safer digital spaces require a comprehensive, innovative approach that goes beyond traditional legal frameworks. Legal reform must begin by reclassifying cyberbullying as a cognisable offence and establishing specialised cybercrime units with gendersensitive training. Fast-track courts for digital violence cases and stricter penalties for and responds to digital violence.

essential steps forward.

A mandatory AI ethics training programme should be established, requiring social media and tech platform employees to undergo rigorous certification in digital consent and gender-based harassment prevention. Simultaneously, the government should develop a unified, encrypted national reporting platform powered by advanced AI tools capable of detecting and flagging potential harassment patterns, with blockchain technology ensuring evidence preservation.

Education must be a cornerstone of this strategy, integrating comprehensive digital safety and consent modules into the curricula from primary to tertiary levels. These programmes should teach responsible digital citizenship, focusing on understanding consent, recognising harassment, and promoting respectful online interactions. Complementing this, a corporate accountability framework would impose legal penalties on social media platforms that fail to respond to harassment reports promptly, with mandatory quarterly transparency reports and the establishment of a national digital ombudsman office.

To support victims, the government should create a tech-enabled support network featuring counselling resources, anonymous support groups, and real-time legal consultation channels. Free digital security audits and protection services would provide immediate assistance to those experiencing online harassment. Additionally, international collaboration will be crucial, with cross-border mechanisms for tracking and reporting digital violence, enabling the sharing of technological solutions and best practices across different jurisdictions.

The promise of Digital Bangladesh cannot be fully realised until digital spaces are safe for all citizens, regardless of gender. As we advance technologically, we must ensure that progress doesn't come at the cost of women's safety and dignity in the digital landscape. This requires not just institutional change, but a fundamental shift in how society views

In the heart of Digital Bangladesh, where technology promises progress and connectivity, a darker reality lurks in the shadows of social media platforms and messaging apps. Women across the country often face digital violence with devastating consequences that ripple through their lives, families, and society at large.

Farzana Sithi, who became a familiar face during the July-August uprising for raising her voice against the authoritarian Awami League regime, faced severe cyberbullying in what appears to be a targeted attempt to discredit her advocacy. "They posted trimmed clips of me and turned them into weapons against me. While the officer present at the scene received a medal for 'handling the situation well,' I became the target of relentless online attacks, trolling and bullying," she recounted. The scale of the assault was staggering. "I discovered 117 fake accounts using my name and photos on Facebook. They used AI to create deepfake videos of me that gained millions of views," she shared. The most disturbing part of it was that the majority of those attacking her questioning her character, clothes, and her very existence—were other women.

pattern where online violence is deliberately used to intimidate women activists and distort public narratives around their contributions to social movements.

Recent statistics paint a disturbing picture: Since 2016, gender-based case consideration has shown that 70 percent of women have faced cyberbullying, while the number for men has been 30 percent so far. A 2019 study published in the Asian Journal of Psychiatry found that cyberbully victimisation affects

Bangladesh showing a concerning 32 percent prevalence rate among youth aged 14-17 years. More troubling still, 27.3 percent of these victims developed psychiatric disorders, with major depressive disorder being significantly higher among victims compared to non-victims.

Moreover, fear of victim-blaming often prevents women from seeking justice in cybercrime cases. Dhaka University student Promiti Sankar Atri recently discovered that an unknown person had accessed her private social media photos and created a fake account to distribute these personal images without her consent. When encouraged to pursue legal action, Promiti's response revealed a deeper systemic issue, "I am going to get blamed for it and harassed with inappropriate questions instead. It would be of no help." Her hesitation reflects a common predicament faced by female victims of digital harassment, who must weigh the trauma of their privacy violation against the potential for further victimisation within the legal system. Recent data from the Police Cyber Support for Women, which was formed in 2020, reveals the scope of institutional failure. Between 2020 and April 2023, the unit received 34,605 complaints, with 26,592 from women. Alarmingly, 8,947 victims explicitly refused to pursue legal action, indicating a deep distrust in the system.



The Bashundhara Group Bangladesh Premier League begins today, amid concerns over diminished competitiveness due to the absence of two former champions, subpar pitch conditions, and reduced player wages.

On the opening day, five-time champions Bashundhara Kings face Chittagong Abahani at the Bashundhara Kings Arena in Dhaka, runners-up Mohammedan SC meet promoted Dhaka Wanderers Club in Gazipur, while Brothers Union host Bangladesh Police SC in Mymensingh.

The withdrawal of three-time champions Sheikh Jamal DC and one-time champions Sheikh Russel KC has added to the league's challenges. Meanwhile, six-time champions Abahani are competing without foreign players for the first time, further diminishing the league's competitiveness compared to last season.

Despite these setbacks, Kings technical director BA Jubair Nipu believes the league will remain competitive, despite the absence of two major clubs and Abahani's decision to forgo foreign players.

"It might seem that it's going to be easy [to win the league], but we lost some quality players this season. And the standard of local players of all clubs are almost the same," said Nipu, adding that Mohammedan, Abahani -- even without foreign players -- Fortis FC and Police are capable of going the distance.

Mohammedan coach Alfaz Ahmed noted that with the withdrawal of Sheikh Jamal and Sheikh Russel, along with a redistribution of quality players, most teams -- except Kings and Mohammedan -- now have comparable strength.

"Our target is to improve on last season's secondplace finish," Alfaz said.

Fortis coach Masud Parvez Kaiser, however, reckons "the financial crisis affecting most clubs" will make it "challenging for coaches to consistently keep players

Five of the league's venues, excluding the Kings Arena, are reportedly not up to professional standard. Kaiser, also a former national team assistant coach, added that "substandard" grounds in Dhaka will "make it difficult to distinguish between top-tier and lowertier players".



end 15-year Real drought

Second-half goals from Alexis Mac Allister and Cody Gakpo saw Liverpool register a 2-0 win in the Champions League over Real Madrid in front of a raucous home crowd at Anfield on Wednesday, ending the Reds' 15-year winless streak against the reigning European champions. The defeat saw Real drop down to 24th in the standings, the final spot to earn a place in the play-offs in the new-look Champions League format. Liverpool moved to the top and are well on course for being one of the top eight teams that will directly qualify for the round of 16.

- Liverpool are just the fifth side to win their opening five games of a Champions League campaign and concede no more than one goal after Milan in 1992-93, Juventus in 2004-05, Atletico Madrid in 2016-17 and PSG in 2017-18.
- Liverpool are also the only side with a perfect record in this Champions League.
- This victory marked Liverpool's first win over Madrid since 2009, breaking an eight-match winless run against the reigning European champions. Real had won seven times and saw one game end in a draw (in 2021) against the Reds in the previous eight matches.
- Arne Slot has led Liverpool to 17 wins in his first 19 games in charge and did something his predecessor Jurgen Klopp was unable to do in his

six attempts as a Liverpool manager -- beat Real Madrid.

- Kylian Mbappe's missed penalty in the 61st minute meant the French forward is still one shy of his 50th Champions League goal.
- Real Madrid are the first reigning champions in Champions League history to lose as many as three of their first five games of a campaign
- **Solution** Each of Alexis Mac Allister's last four goals for Liverpool in all competitions have come at Anfield.
- Luka Modric is the seventh player to start 100 games for Real Madrid in the Champions League, the joint-most by a side in the competition's history along with Barcelona.

This NCL, I tried to give 200 percent: Anamul

For more than five months, pace bowler Anamul Haque had to patiently wait for an opportunity to play a professional game. The 24-year-old, who had been

a regular face in both the High Performance Unit and the Bangladesh Tigers' programme in the last few years, struggled to get matches in both white and red-ball domestic competitions last season.

Anamul featured in five first-class matches in the National Cricket League (NCL) and Bangladesh Cricket League (BCL) combined in which he captured only 10 wickets.

competitions, white-ball Anamul featured in three matches for Shinepukur in the Dhaka Premier League (DPL) and could take only one wicket while he went wicketless in his lone appearance for Durdanto Dhaka in the Bangladesh Premier League

The right-arm pacer, without any hesitation, accepted that his poor performances led to him getting drop from the HP Unit and Bangladesh Tigers camps and also miss out on the HP team's tour of Australia and 'A' team's tour in Pakistan.

"I didn't play enough matches and also didn't perform well enough. That's why I wasn't part of their [selectors'] plans," Anamul told The After some much needed self-

reflection, Anamul focused all his efforts on maintaining his fitness and improving his skills so that he is ready when the next opportunity arrives. "I maintained my processes

properly so that I can give my all on the field. I always go to sleep early and after practice I take ice baths, I sometimes do swimming and sometimes I take a hot bath. My trainer and doctors are happy with my disciplined life," said the right-arm pacer.

"I tried to take tips from four to five top local coaches regarding different topics. I consulted one to develop my pace, I talked to another about my swing and even spoke to another coach to improve my bowling in different match scenarios.

"I even had a personal trainer with whom I worked on improving my fitness. I worked continuously in these five months under their guidance," he

When the opportunity finally arrived during the ongoing NCL 2024-



25, Anamul grabbed it with both

Representing Dhaka Division, he is currently the leading wicket-taker in the competition with 32 wickets from six matches at an average of 14.93, with two five-wicket hauls to his name.

Anamul said that he had a plan to go to the next level in this year's NCL and so far, he has succeeded.

"Throughout my career, I have always tried to give my 100 percent. This year in the NCL, I tried to give my 200 percent.

"Those who saw me bowl can vouch that I bowled with the same aggression throughout the day. Sometimes I felt tired but still I tried to bowl with the same pace and aggression. Compared to previous years, this year my dedication is next level.

"Along with my inswing, I have improved my outswingers quite a lot. I have also learnt to bowl a delivery that goes straight after pitching... I hope that the selectors will look at my performance and give me an opportunity, seeing the variations in my bowling," he said, adding that he wants to finish the tournament with 40 wickets.

Anamul is likely to get an opportunity to do so when his side takes on Barishal Division in the last round match of the NCL in Bogura, starting on Saturday.

"When I started the tournament, I planned to be in the top three. Now I want to set a benchmark of 40 wickets this year. I will definitely try to take eight wickets in the next match," Anamul concluded.

However, Shanto, who missed the third and final ODI against Afghanistan in the UAE due to his injury, was seen doing light running sessions at the Sher-e-Bangla National Stadium in Mirpur yesterday.

The dearth of middle-order batters may see Bangladesh look to familiar faces for the three-match ODI series and as many T20Is against the Windies. Jaker Ali played the last two ODIs against Afghanistan following Mushfiqur's injury and may get the nod for the white-ball part of the Windies series after getting some runs in the first Test in

Meanwhile, ace left-arm paceman Mustafizur Rahman, who returned to training in Mirpur yesterday, was granted leave from the Windies tour for family reasons.

"Mustafizur will not be playing the white-ball series," a BCB official

JUDGES' APPOINTMENT **SC** proposes

formation of judicial council

Writes to law ministry for taking steps to issue ordinance incorporating a provision

The Supreme Court yesterday formally proposed the formation of a Judicial Appointment Council led by the chief justice through an ordinance to select judges for recruitment to both divisions of the apex court.

The court sent the proposal to the law ministry to incorporate the provision for constituting the council that will select competent candidates for the judges' posts in the Appellate and High Court divisions.

The council, at the request of the president, will issue a public notice inviting applications from the candidates, according to the proposed ordinance. After receiving applications, the council will send recommendations to the president for the appointment of judges under articles 95 and 98 of the constitution.

The draft of the proposed ordinance states that the council will be able to invite any person concerned to its meeting to take opinions or suggestions about the candidates. It will also be able to instruct any government and private organisation to present information about

"The Israeli enemy is attacking those returning to the border villages," Fadlallah told reporters after a parliament session, adding, "there are violations today by Israel, even in this form"

A Lebanese military source said the armed forces deployed troops and tanks across the country's south. Israeli army spokesman Avichay Adraee on X repeated a warning to Lebanese residents not to return to areas adjacent to the border, listing a series of villages and towns along the frontier.

Israeli tank fire hit six areas within that border strip yesterday morning, striking Markaba, Wazzani and Kfarchouba, Khiyam, Taybe and the agricultural plains around Marjayoun, state media and Lebanese security sources said.

MEETING WITH DMP CHIEF OCs demand logistical support to curb crimes

Officers-in-charge of the police stations in the city said crime prevention activities are being seriously hampered because of damaged stations, shortages of vehicles, manpower, and poor logistical support.

They made the statements at a meeting with newly appointed Dhaka Metropolitan Police Commissioner Sk Md Sazzat Ali yesterday.

Almost all the OCs of 50 police stations in the city raised the issue and demanded immediate supply of vehicles and other logistical support for proper crime prevention activities, meeting sources said. Commissioner Sazzat said some logistical support

have already been provided. He also assured the OCs of supplying all necessary vehicles and others in a quick possible time. During the July-August student-led mass uprising,

21 out of 50 police stations under the DMP came under attack and some of them were left in ruins. Officials said 97 police vehicles were torched while 187 others were vandalised.

Besides, computers, furniture, and other equipment in the badly affected police stations were destroyed.

"The completely damaged police stations still lack 50 percent vehicles and other logistical support," said an OC, wishing anonymity.

Five OCs, who joined the meeting, said almost all the police stations have poor logistical support and the shortage of the required number of police personnel, though the situation is improving.

At the meeting, the commissioner instructed the OCs to be transparent and not to make money by illegal means, said the sources.

He also asked them to serve the people effectively, SEE PAGE 6 COL 1

Israel steps up bombing of central Gaza

21 Palestinians killed; tanks push deeper into the north, south of enclave


Israeli military strikes killed at least 21 Palestinians across the Gaza Strip yesterday, medics said, as forces stepped up their bombardment of central areas and tanks pushed deeper into the north and south of the enclave.

Six people were killed in two separate air strikes on a house and near the hospital of Kamal Adwan in Beit Lahiya in the northern Gaza Strip, while four others were killed when an Israeli strike hit a motorcycle in Khan Younis in the south.

In Nuseirat, one of Gaza's eight historic refugee camps, Israeli planes carried out several air strikes, destroying a multi-storey building and hitting roads outside mosques. At least seven were killed in those strikes, health officials

Medics said at least two people, a woman and a child, were killed in tank shelling that hit western areas of Nuseirat, while an air strike killed five others in a house

In Rafah, near the border with Egypt, tanks pushed deeper into the northwest area of the city, residents said. There has been no Israeli comment on the latest fighting.
