27 EU envoys to meet CA today

Diplomats from 27 European countries will hold a meeting today with Chief Adviser Prof Muhammad Yunus in Dhaka, demonstrating support for the interim government.

Twenty of those envoys are stationed in New Delhi, and the rest in Dhaka.

They will also explore new areas of cooperation with Bangladesh.

"We want to support the current government and its reform initiatives," a diplomat from the EU delegation in Dhaka told this correspondent.

A foreign ministry official said the EU always promotes the values of human rights, labour rights, democracy, inclusion, and the environment, and the current government is committed to this.

"Thus, the EU has full support for the current government. At the same

Shot, blinded, abandoned

Saidul's story mirrors plight of the forgotten heroes of July uprising

Saidul Islam, a 25-year-old from Dashmina upazila in Patuakhali, once dreamed of building a stable life for his family. But the light of that dream has been extinguished — both figuratively and literally.

Saidul lost his eyesight and his livelihood after shotgun pellets lodged in his body during a demonstration in Dhaka's Jatrabari.

Like all the martyrs and injured of the July uprising, his story is one of struggle, despair, and the unforgiving consequences of standing up against oppression.

Saidul, the eldest son of Mohammad Mridha, was born into a poor family in Banshbaria village. Unable to afford further education, he migrated to Dhaka, where he earned a modest living as a driver of a battery-run auto-rickshaw.

Life was hard, but Saidul managed to provide for his wife, Panna Akhter, and their one-and-a-half-year-old daughter, Sumaiya. But everything changed on August 5.

Saidul, compelled by his desire

for change, joined the anti-government protests aimed at toppling Sheikh Hasina's regime. During the protests in Jatrabari, he was struck by over 50 pellets when police opened fire. His left eye was completely blinded, and splinters

remain embedded in other parts of his body to this day.

He spent two weeks in hospitals — the Dhaka Medical College Hospital and the National Institute of Ophthalmology — undergoing surgeries and treatment. However, despite these efforts, his vision could not be saved, leaving him permanently blind in one eye and struggling with excruciating pain.

LIFE AFTER PROTESTS

Upon his release, Saidul's life began to unravel further.

Unable to work, he returned to Banshbaria to live with his ageing parents. Poverty tightened its grip on his already struggling family.

The final blow came last Thursday when his wife divorced him, taking their young daughter with her. "I have no income and can't provide for my family. My wife couldn't bear it anymore," Saidul said.

"I am living a miserable life. The pain from the splinters is unbearable, and my blindness has taken away my independence," he added, in tears.

ACC must be overhauled

Says Transparency Int'l Bangladesh

The Anti-Corruption Commission (ACC) has been undermined by partisan politics and bureaucratic interference since its inception in 2004, said Iftekharuzzaman, executive director of Transparency International Bangladesh (TIB) yesterday.

"Corruption, misconduct, and inequity have further weakened the institution internally, turning it into an ineffectual body. To address this, we must overhaul the ACC through comprehensive and targeted initiatives," he said.

Iftekharuzzaman made these remarks at a human chain held at Manik Mia Avenue, organised by TIB to mark International Anti-Corruption Day on December 9.

While speaking at the event, he said, "One of the primary reasons behind the ACC's degradation was the previous authoritarian regime, which sought to consolidate power through corruption, enjoy impunity and render institutions, including the ACC, ineffective and politically compromised. Overcoming this legacy is imperative."

We must align ourselves with the youth's demand to instil an anti-corruption ethos across politics, bureaucracy, and society at large.

Revive Saarc for regional prosperity

Says foreign adviser

Foreign Adviser Touhid Hossain has called on Saarc nations to overcome conflicts and work towards a prosperous and peaceful South Asia.

Speaking at a seminar marking the 40th Saarc Charter Day at Jatiya Press Club yesterday, Hossain stressed the need to revitalise the organisation, which has been inactive for a decade.

"SAARC's dormancy affects all members. Chief Adviser Prof Muhammad Yunus is committed to reviving the bloc and has discussed the matter with Pakistan's Prime Minister Shahbaz Sharif, who responded positively," he said, expressing hope for a high-level meeting to resume the Saarc Summit.

5 CASES AGAINST YUNUS

SC upholds HC verdict to scrap all proceedings

The Appellate Division of the Supreme Court yesterday upheld the High Court verdicts that scrapped all the proceedings of five cases filed against Nobel Laureate Professor Muhammad Yunus, now the chief adviser to the interim government.

The cases were filed under the Labour Act in 2019 on charges of illegally terminating some workers of Grameen Telecommunications as Prof Yunus was the chairman of the organisation that time.

Yesterday, a three-member bench of the Appellate Division headed by Justice Md Ashfaqul Islam dismissed five separate leave-to-appeal petitions filed by the state challenging the HC verdicts on October 24 that had scrapped all proceedings of the five cases after hearing five petitions filed by Prof Yunus challenging the legality of filing the cases.

Barrister Mustafizur Rahman Khan appeared for Prof Yunus, while Additional Attorney General Aneek R Haque represented the state during the hearing yesterday.

Battling bias at every step, a hijra entrepreneur turning pain into purpose

Life has never been easy for Avaa Muskan Tithi. However, a fateful day in 2022 made things worse.

During her nursing internship at Suhrawardy Hospital in Dhaka, as she entered a ward, a patient noticed her hijra identity.

He started shouting, "Hijras kill people with injections." He demanded Tithi be removed from there.

That moment was not just humiliating; it was an awakening for Tithi, forcing her to rethink her future in the service sector.

"Will I ever be accepted for who I truly am?" she wondered.

Meanwhile, she was forced to leave her family during the training, as her father couldn't accept her identity.

Yet, Tithi channelled her pain



into purpose. Drawing on the artistic and sewing skills she inherited from her mother, she launched her own business, creating a Facebook page called "Chondrolota."

With just Tk 2,000 and two saris, she stepped into the world of entrepreneurship.

However, the journey has been anything but smooth, with

countless obstacles — no financial safety nets, no institutional support, no access to traditional loans, and no opportunities for professional training.

For her, this endeavour is not just about business; it's about asserting her right in the unjust world.

Currently, Tithi sells a variety of handcrafted items online and offline, including patchwork bags, tote bags, upcycled bags, patchwork saris, hand-stitched

saris, block-printed saris, and handmade jewellery.

She has recently focused on participating in fairs to showcase her products, as she lacks the necessary funds for online promotion and operations.

"Funding has always been a significant hurdle for me," Tithi shared. "I'm unsure where to seek loans for my business, what the eligibility requirements are, or whether I even qualify for them."

She received two small grants from Bandhu Social Welfare Society, an organisation dedicated to the welfare of hijras and marginalised communities.

"I had to buy a sewing machine, leaving me with little for other supplies. I can't introduce new products to keep the business going, as I'm worried about incurring losses. I also lack the funds for online promotions."

Participating in offline fairs also presented its own challenges.

"I remember taking a stall at a fair in Dhanmondi, where I
