Supernumerary promotions result in over 3 officials against one post

After the interim government took over, the number of officials in the upper echelon of the civil administration has become over three times the posts.

Giving officials promotions without vacant posts caused the number of additional secretaries, joint secretaries, and deputy secretaries to swell to this state.

Experts say this is upsetting the balance of the civil administration which would take years to recover from, because promotions given to officers cannot be taken

The situation in the administration is also angering officials of other cadres, most of whom only get promoted once there is a vacancy. They say officials of administration cadre are getting undue benefits and raises through supernumerary promotions.

Against an approved post for 150 additional secretaries, the ousted Awami League government had promoted 395



The army took position at the Tongi Bishwa ljtema ground around noon yesterday as Gazipur police banned the movement of more than one person within a 3km radius of the ground. The ban was placed following a violent clash between the followers of Maulana Saad and Maulana Zubair over taking control of the ground. 4 killed in clash over control of Ijtema ground

50 others hurt; all forms of gatherings banned in the area

At least four people were killed and 50 others injured early yesterday in a clash between two factions of Tabligh Jamaat over control of the Ijtema Maidan, a large field in Tongi where thousands of Muslim devotees congregate every year.

The clash broke out between the followers of two Tabligh leaders Maulana Zubair Ahmad and Maulana Saad -- around 3:00am, said Iskander Habibur Rahman, officer-in-charge of Tongi West Police Station.

After meeting leaders of both groups at the Secretariat, Home Adviser Lt Gen (retd) Jahangir Alam Chowdhury said four people were killed in the incident.

A senior police officer, requesting anonymity, said three people died in the early hours, while another died in the morning.

HC clears Babar in 10-truck arms haul case

5 others including ex-DG of DGFI also acquitted; ULFA leader Paresh's death sentence commuted to life imprisonment

The High Court yesterday acquitted former state minister for home affairs Lutfozzaman Babar and five others, who were sentenced to death by the trial court, in a case filed over the sensational 10-truck arms haul in Chattogram.

Two separate cases were lodged with Karnaphuli Police Station a day after the arms were seized at Chattogram Urea

Fertiliser Ltd (CUFL) jetty in the early hours of April 2, 2004 during the BNP-Jamaat government's tenure.

The arms and ammunition included 4,930 sophisticated firearms, 840 rocket launchers, 300 rockets, 27,020 grenades, 2,000 grenadelaunching tubes, 6,392 magazines and 11.41 million bullets.

One case was filed under the Special Powers Act 1974 for smuggling of firearms and the other was lodged under the Arms Act for illegal possession of firearms.

interim government has decided to cancel the education policy adopted in 2010 during the Sheikh Hasina government's tenure, describing it as "improper and unimplementable".

Since the country's independence, it is the sixth education policy scrapped by successive governments, according to education ministry

"We have decided to scrap the current education policy. We will soon declare a new education commission to formulate a new education policy. We are confident

that the members of this panel will do a wonderful job," said Prof Aminul Islam, special assistant to Education Adviser Prof Wahiduddin Mahmud.

"The new commission will ensure that no controversy centring the new policy arises," Prof Aminul told The Daily Star, adding that they will announce the names of the commission members soon.

When asked about the reasons behind scrapping the 2010 policy, Prof Aminul said it was "totally improper and it will not bring any

Prof Aminul, who enjoys the status of state minister, said that many major features of the current education

policy remain unimplemented, which

proves that it is "unimplementable". While talking at Daffodil International University yesterday, Prof Aminul said the new commission comprise distinguished, will renowned, talented, and skilled individuals from both national and international arenas,

Efforts were underway to bring transformative changes through increased budget allocations and other forms of support, he added.

A top education ministry official said that they initiated the move to scrap the education policy and formulate a new one recently. The SEE PAGE 2 COL 4

Raped, tortured for 3 months, girl dies in Mymensingh

An eighth grader who was allegedly abducted, raped, and tortured for over three months, has succumbed to her injuries at her village home in Mymensingh's Nandail upazila.

The girl was a student at Bakchanda Fazil Madrasa in Nandail.

According to the girl's family, Hossain, 19, of the adjacent Kuchuri village used to tease the girl. As the girl refused his advances, he, also a tenth grader at a local madrasa, and his unidentified accomplices abducted the girl on June 1.

Over the next three months, Hossain repeatedly

raped and tortured her keeping her at an unknown place, they added. She was tortured to the extent that her right eye was severely damaged.

On September 6, the girl, belonging to a poor family, was left adjacent to her house in a critical

The girl was first taken to Mymensingh Medical College Hospital for treatment. Later, she was referred to an eye hospital in Dhaka where the doctors removed the affected eye for the safety of

She was later sent home where she died Tuesday. SEE PAGE 7 COL 5

IMF to give \$645m in fourth tranche

The SDR (Special Drawing Rights) is an international reserve asset created by the IMF to supplement the official reserves of its member countries.

If the IMF executive board approves the request for additional funds, its total loan package for Bangladesh will reach \$5.3 billion from the existing \$4.7 billion.

The formation of an interim government has "fostered a gradual return" to economic normalcy in Bangladesh, the statement said.

Economic activity in Bangladesh has slowed significantly and inflation remains elevated. Capital outflows, particularly from the banking sector, have put pressure on foreign exchange reserves.

Additionally, tax revenues have declined, while spending pressures have increased, it pointed out.

'These challenges are further exacerbated by stress in parts of the financial sector."

Real GDP growth is projected to slow to 3.8 percent in fiscal 2024-25 due to output losses caused by the public uprising, floods and tighter policies but is expected to rebound to 6.7 percent in fiscal 2025-26 as policies relax.

Inflation is anticipated to hover around 11 percent (annual average yearon-year) this fiscal year before declining

by tighter policies and easing supply pressures.

"However, the outlook remains highly uncertain, with risks skewed to the downside. To address the emerging external financing gap and persistently high inflation, near-term policy tightening is crucial.'

Fiscal consolidation should prioritise the swift implementation of additional revenue measures, such as removing tax exemptions while restraining non-essential spending.

with Coupled monetary tightening, greater exchange rate flexibility and safeguarding foreign exchange reserve buffers will strengthen the economy's resilience to external shocks.

Bangladesh's low tax-to-GDP ratio calls for urgent tax reforms to establish a fairer, more transparent system, focusing on rationalising exemptions, improving compliance and separating tax policy from administration.

A comprehensive strategy is also needed to curb subsidy spending and address arrears in the electricity and fertiliser sectors, the statement said.

"Addressing vulnerabilities in the banking sector is essential."

Immediate priorities include accurately assessing defaulted loans, ensuring the effective implementation existing regulations

sector restructuring, it said.

Key actions involve conducting an asset quality review and adopting a recovery and resolution framework aligned with global standards.

Simultaneously, the authorities should advance risk-based supervision, while legal reforms are needed to strengthen corporate governance and regulatory frameworks.

"Institutional reforms to enhance the Bangladesh Bank's independence and governance will be critical for the successful implementation of financial sector reforms.'

Enhancing governance, along with greater transparency, is critical to improving the investment climate, attracting foreign direct investment and diversifying exports beyond the garment sector, the statement said.

Furthermore, building resilience to climate change is vital to reduce macroeconomic and fiscal vulnerabilities.

Strengthening institutional capacity and optimising spending efficiency will aid in achieving climate

The government should focus on implementing climate-sensitive fiscal reforms and investing in sustainable, resilient infrastructure.

Furthermore, robust management of climate-related risks will reinforce the stability of the financial sector, it

Officials said the two factions blamed each other for the violence.

Against this backdrop, Dhaka Metropolitan Police imposed a ban from 2:00pm onwards on all forms of gatherings, processions, and rallies in Kamarpara, Abdullahpur, Uttara Sector-10, and the areas along the banks of the Turag.

Border guards and army personnel have been deployed in the area.

Zubair's supporters said Saad followers attacked them with knives, hammers, and cricket stumps after 3:00am when they were fast asleep.

Saad followers, on the other hand, told reporters that while they were preparing to go to sleep in their tents by the road between Kamarpara and Sluice Gate, Zubair's men attacked them around 3:30am.

Teams of law enforcers have also been deployed near Kakrail Masjid, the headquarters of Zubair-faction in the

HOW THE CLASH ERUPTED

According to locals, Saad followers were trying to enter the Ijtema ground to hold a five-day "Jor-Ijtema" from December 20.

As Zubair followers were already there, Saad followers failed to enter the field. And stayed outside. After 3:00am, hundreds of devotees crossed the Kamarpara Bridge and entered the Ijtema ground. Zubair followers then tried to stop them, leading to a clash, said locals.

Locals and witnesses said Zubair supporters threw brick chunks at Saad followers who retaliated. For almost an hour, the groups

hurled bricks and stones at each other. Saad followers eventually forced Zubair's men to leave.

Saad supporter, said, "We are now in control of the Ijtema Maidan. One of our brothers has been martyred in an attack by Zubair followers.'

Officials identified three of the deceased as Aminul Islam Bachchu, 70, of Kishoreganj; Taizul Islam, 65, of Bogura; and Belal Hossain, 60, of Dhaka. They could not identify the other victim as of filing this report at 12:30am today.

At least 40 injured individuals were treated at Dhaka Medical College Hospital, according to sources.

After meeting the home adviser, Mamunul Haque, secretary general of Khelafat Majlish and a follower of Zubair, told reporters, "Zubair's supporters do not want chaos. Many have termed it a clash between the two factions. But it's not. Rather, Saad's men inflicted casualties on us. Those involved in the murders should be arrested by today. There is video footage of those involved."

In 2017, a rift developed between the leaders of Tabligh Jamaat, the organiser of the Biswa Ijtema. Factions of Zubair, based in Kakrail Masjid, and Saad, who is from India, later organised Ijtema in two phases.

The feud came to light in November 2017 when two factions clashed at Kakrail. The following year, there was a clash between the two factions over gaining control of the Kakrail Masjid.

In July 2018, late Hefazat-e-Islam leader Ahmad Shafi, popularly known as Maulana Shafi, formally extended support to the Zubair faction.

Reza Arif and several others from Saad group, held a nearly one and a half hours long meeting with the adviser starting at 11:00am. Advisers

of the ministries of land, industries information, and religious affairs, and special assistant to the chief adviser on defence and national integration development, and special assistant to the home adviser attended the meeting.

After the meeting, Reza said, "Of course, we, as Muslims and citizens of the country, regret what happened. A fight between Muslims and Muslims is not right. We sincerely apologise. I request my fellow devotees to leave the [Ijtema] ground."

He added that the advisers requested the leaders to vacate the ground to prevent further escalation of tension. "We decided to leave the place so

that no more problems arise," he said. He expressed hope that Zubair's men would also leave the ground.

"We will make every effort necessary to ensure no such incident happens in the future."

Later in the day, the advisers held a meeting with Zubair followers led by 1amunul Haque.

After 2:30pm, Mamunul along with the home adviser addressed the media. He described Saad followers as terrorists and demanded a ban on their

Mamunul said, "The Ijtema of the Zubair followers will definitely be held. But there is no scope for Saad followers to hold litema."

The home adviser said if the two sides solve the problems through talks, then the Saad followers would be able to participate in Ijtema.

The government has not cancelled the date of Ijtema, he said, adding "Let them discuss.'

The adviser further said that the attackers would face justice. "There

The picture is very similar when it comes to the 250 posts for joint secretaries. During the previous regime 650 officials held these positions and now the interim government has promoted 226 more, making the total

It is the same in the case of deputy secretaries -- 450 posts, 1,450 officials during the previous government and now there are 1,599.

After the previous regime was toppled, officials previously deprived had hoped that they would get promoted. Which has happened, but it has created the new problem of topheavy administration.

Abdul Awal Mazumder, a retired secretary, told this paper, "It'll take years to fix this imbalance in the civil administration that was caused by too many promotions.

"Provided that the person is qualified and there is a vacancy, only then that person should be promoted. If this can

be done, the balance could be protected." When asked for comments, former secretary and NBR Chairman Badiur Rahman told The Daily Star, "The practice of rewarding party loyalists with promotions became a bad tradition under the previous government. However, it is unclear from what perspective the current government

has decided on these mass promotions." He further stated, "The government could have promoted qualified officers who were previously deprived due to political reasons. Instead, like the previous administration, this government has also promoted en masse, putting unqualified individuals on par with deserving ones. This diminishes the respect for truly competent officers."

Senior Secretary to the Ministry of Public Administration Mokhlesur Rahman, said, "It is true that there are more officials than required in some higher positions. We are also addressing the cases of those who were deprived during the autocratic government."

Regarding irregularities, he said, "Before I took charge, there were some

Uddin Miah, principal secretary to the chief adviser and the second-highest official in the administration, came down heavily on civil administration officials.

During an event organised by the Bangladesh Administrative Service Association at Dhaka's Biam Auditorium on November 16, he said, "With regret, I must say that since taking charge, I have received complaints from officers at various levels about personal grievances and dissatisfaction, but no proposals

considering the bigger perspective." Currently, there are 26 cadres in the public administration.

Among them, administration, foreign affairs, and police cadre officers get supernumerary promotions, which is promotions without vacant posts.

Most of these promotions are made in the administration cadre.

Officials of agriculture, health, education, information, roads, and railways only receive promotions when posts are vacant.

Now, officials of these cadres want what the administration cadres have been getting, promotions even if there are no vacant posts.

Omar Faruq Dewan, coordinator

of officers of 25 cadres, except admin, seeking benefits similar to that of the administration cadre, told The Daily Star, "The officers who joined alongside us in the administration cadre are receiving promotions even without vacancies on top of better benefits. Why should we be left out?"

"We also want regular promotions against vacancies, but this must be

The five others who got acquittal are former director of the Directorate General of Forces Intelligence (DGFI) Maj Gen (retd) Rezzakul Haider Chowdhury; ex-CUFL managing director Mohsin Talukder; former CUFL general manager (admin) Enamul Hoque; former additional secretary of industries ministry Nurul Amin; and

The other acquitted people, however, were not freed from jail since they had been sentenced to life imprisonment in the illegal arms possession case and their appeals are pending with the HC, Babar's lawyer Mohammad Shishir Manir told The Daily Star.

All the 14 accused in the arms

The HC bench of Justice Mustafa Zaman Islam and Justice Nasreen Akter also commuted death sentences of six other convicts to 10 years' imprisonment in the case.

The six are former NSI director wing commander (retd) Shahab Uddin; former NSI deputy director Maj (retd) Liakat Hossain; ex-NSI field officer Akbar Hossain Khan; local smuggler Hafizur Rahman; labour supplier Deen Mohammad; and trawler owner Haji

The HC also commuted the Tk 5 lakh fines slapped on each of the six by the trial court to Tk 10,000 each.

In this case, former director general of the NSI Brig Gen (retd) Md Abdur Rahim was sentenced to death and fined by the trial court. Yesterday, the HC in its judgment declared his appeal abated (ended) as he had died earlier. However, the HC imposed a fine of Tk 10,000 on him. The successors of Rahim will have to pay the fines, Shishir Manir said.

Domestic workers seek legal protection, dignity

Share ordeal at Star-CAMPE roundtable

"When I am thirsty, my employers do not let me drink water from a clean glass. They only offer me a dirty one that is designated for house helps. Even though I clean their sofa everyday, I am not allowed to sit on it. During Eid or other festivals, if I ask for a holiday, they refuse. If I accidentally break anything, they demand compensation from me," said Laiza Banu*, a domestic worker who resides in a slum in the capital.

"There are no fixed working hours. Even when I am sick, if I ask for a leave, they threaten to fire me. If I lose my job, then how will I raise my children and pay for their education?" she

Another domestic worker from the same slum, Salma Akhter* said that she was forced to keep working even when she was pregnant. If she even makes the slightest of mistakes, her employers torture her physically by slapping her. Other times, they just make her feel stupid.

The two house helps shared the stories of their struggles at a roundtable titled "Protect domestic workers and improve their quality of life: What we can do?" which took place at The Daily Star Centre in the capital yesterday.

The event was jointly organised by The Daily Star and Campaign for Popular Education (CAMPE) in collaboration with Oxfam in Bangladesh and sponsored by the European Union.

Alongside Laiza and Salma, numerous other house helps were present at the event and shared their own stories and struggles. They

demanded that their profession be included under Bangladesh Labour Law as soon as possible so that their rights are secured.

Other speakers stressed the need for the immediate implementation and monitoring of The Domestic Workers' Protection and Welfare Policy, 2015.

Women and Children Affairs Adviser Sharmeen S Murshid, the chief guest of the event, said that this issue should have been solved years ago.

"How can people neglect the humiliation faced by domestic workers from a human

perspective? We must understand that as fellow human beings, they also need health, education and holidays. The state can only protect them by making laws. Often times, many children are also engaged in domestic work, which should be completely banned as they are more likely to be abused," she noted.

"We are trying to create a structure through the Ministry of Women and Children Affairs to address the violence faced by house helps. There can also be a separate authority for domestic workers as well," she added.

Five die of dengue

Only 3pc teachers trained in pre-primary edn: study

Teachers lack the capacity to employ effective learning methods, particularly at the preprimary and secondary education level, as only three percent of teachers received specialised training in pre-primary education, said a study by Educo Bangladesh. Moreover, only one or two

teachers in secondary schools of semi-urban to rural areas received training on generating and delivering multimedia materials effectively, the study noted.

Also, around 60 percent of teachers said they did not participate in any mental or physical well-being sessions, it added.

The findings of the study, titled "Child Rights and Wellbeing Situational Analysis", were unveiled in a ceremony held at a hotel in the capital yesterday.

The findings were presented by Mohammad Adnan Rahman, The primary data of the portfolio manager of Inspira Advisory and Consulting Limited.

He highlighted major issues with children, faced by children in areas such as education, protection, and well being, such as child marriage and child labour.

Around 88 percent of children aged one to 14 years were subjected to either physical punishment or psychological aggression by their caregivers, the study shared.

According to the study, around 42 percent of students dropped out while transitioning to secondary $education\ from\ primary\ education$ due to academic struggles, financial constraints, and the need to earn money often leading to a lack of motivation.

Due to the lack of motivation, most children do not have a happy time at school, it said.

Furthermore, 50 percent of children did not participate in extracurricular activities, while 75 percent of parents did not know about the ambitions of their children, it added.

HC delivers first-ever

rule on adult custody

The High Court for the first time pronounced a judgement addressing the issue of guardianship and custody of an adult person with intellectual disabilities. A civil suit was filed by the person's father against the maternal aunt under Section 21(1) of the Mental Health Act 2018, seeking guardianship and custody, according to Bangladesh Legal Aid and Services Trust. Previously, the Senior District Judge Court, Dhaka, ruled in favour of the aunt. Following the father's petition, the HC issued a rule requiring the aunt to explain why custody should not be given to the father. Upon hearing the parties, Justice AKM Zahid Sarwar discharged the rule, stating that mental illness is distinct from intellectual disability, and the Mental Health Act does not apply in cases of guardianship for

individuals with intellectual disabilities.

Senior Advocate Sara Hossain, representing the maternal aunt, said the judgement is a significant step in interpreting the 2013 Rights and Protection of Persons with Disabilities Act. She highlighted that the 2013 Act aligns with Bangladesh's obligations under the 2006 Convention on the Rights of Persons with

Disabilities, emphasising autonomy, independence, and equal rights for individuals with disabilities.



Identify killers within 24 hours

Demand private university students regarding deaths of fellows

Students from several private universities demonstrated on the streets yesterday demanding investigations into a string of student deaths that they claim are targeted killings.

Jatiya Nagorik Committee also issued a statement in solidarity, demanding justice for the killings of students.

They were protesting the deaths of American International University of Bangladesh student Wazed Alam Shimanto and East West University student Tasbir Hossain Sheehan, both of whom were attacked on December 12.

Another young student organiser named Jashim Uddin, residing in Chattogram, was killed on December 17, said the committee's statement. He was hacked to death by unidentified assailants.

Shimanto, a student of Computer Science, was killed in Narayanganj, while Sheehan was killed in Gazipur's Kaliakoir, said the statement.


The private university students led a torch-lit procession upon the Rampura bridge. They walked up to BRAC University in Badda and returned to East West University, concluding their demonstration around 6:40 pm.

They demanded that the government identify the killers in 24 hours and also investigate the killings and publish a report within seven days.

Meanwhile, in their statement, Jatiya Nagorik Committee said Awami sympathisers are "calling for the blood" of student protesters and have made statements ordering attacks on

"This hints at their probable involvement with these murders," said the statement.

They urged the home ministry to take steps to improve the law and order situation proactively and called upon all students to remain united.



Farmers in different districts under Rangpur region are now gradually opting to cultivate ginger in sacks on commercial basis as many of them are earning a good profit from the spice item.

Meanwhile, seeing ones success many other farmers are also getting interested in ginger farming in plastic sacks. By cultivating ginger in such method,

not only farmers are benefiting, but the country's dependence on ginger import is also decreasing day by day. department, Local agriculture

however, sees a bright prospect for commercial cultivation of ginger in sacks on a large scale. Bangladesh Currently,

Research Centre is encouraging farmers to cultivate ginger variety Bari-1 and Bari-2 using the sack method.

According to Bangladesh Spices Research Centre, the country has a demand of nearly 2,40,000 tonnes of ginger annually.

Of them, the country only produces about 80,000 tonnes of ginger, while the rest 1,60,000 tonnes has to be imported from other countries.

At present, about 30 percent of locally produced ginger comes from the sack

"Now I am encouraging other farmers in my locality to cultivate ginger using this method so that they can use their abandoned land," Babu said.

Uzbek suspect held over Russian general's killing

Russia said yesterday it had detained an Uzbek man who had confessed to planting and detonating a bomb which killed a top general, Igor Kirillov, in Moscow on the instructions of Ukraine's SBU security

Kirillov, who was chief of Russia's Nuclear, Biological and Chemical Protection Troops, was killed outside his apartment building on Tuesday along with his assistant when a bomb hidden in an electric scooter went off.

Russia's Investigative Committee, which probes serious crimes, said in a statement yesterday that the unnamed suspect had told them he had come to Moscow to carry out an assignment for Ukraine's intelligence services.

In a video published by the Baza news outlet, which is known to have sources in Russian law-enforcement circles, the suspect is seen sitting in a van describing his actions.

It was not clear under what conditions he was speaking and Reuters could not immediately verify the video's authenticity.

Dressed in a winter coat, the suspect is shown saying he had come to Moscow at the orders of Ukraine's intelligence services, bought an electric scooter and received an improvised explosive device.

He describes placing the device on the electric scooter and parking it outside the apartment block where Kirillov lived.

Investigators cited him as saying he set up a surveillance camera in a hire car which, they said, was watched in the Ukrainian city of Dnipro by people who organised the killing.

The suspect, who is thought to have been born in 1995, is shown saying he remotely detonated the device when Kirillov left the building. He says Ukraine had offered him \$100,000 and residency in a European country.

Investigators said they were identifying other people involved, and the daily Kommersant newspaper reported that one other suspect had been detained. Reuters could not independently confirm the

Maria Zakharova, a spokeswoman for Russia's Foreign Ministry, said Moscow would raise the assassination at a session of the United Nations Security Council on December 20.

A UN envoy has warned that Syria's protracted conflict "has not ended yet", even as victorious rebels stepped up contacts with governments that deemed ousted president Bashar al-Assad a pariah.

living in the Kutupalong camp, also said some Rohingyas have crossed the border recently.

Some of the Rohingyas who recently entered Bangladesh, said they had to come in the face of extreme food crisis and restrictions on their movement in Rakhine.

Seeking anonymity, they said brokers are taking around 15 lakh Myanmar Kyat (Tk 85,348.51) to sneak them into Bangladesh, while the AA is also charging them to cross the border.

Mohammad Mizanur Rahman, chief of the Refugee, Relief and Repatriation Commission, said they also heard that some Rohingyas are entering Bangladesh after the AA claimed to have captured the entire border.

He added that around 67,000 Rohingyas have 50kg sack of rice now costs entered the country since may, however, be some

Set a new benchmark for migrant welfare

Our workers must be protected from abuse and corruption

Since taking over in early August, the interim government has taken a few positive steps to recognise the contributions of migrant workers and address their grievances. However, these isolated attempts fall far short of the comprehensive reforms needed across the labour migration process. As a result, feelings of neglect persist among the workers. This is why news of the record \$24.24 billion in remittance earned up to November 2024 feels less like a triumph for migrants and more like a reminder of how the state continues to view them: as mere economic tools to boost its foreign reserves.

On the occasion of the International Migrants Day, The Daily Star talked to a number of migrant workers who expressed frustration over the lack of measures to ensure their welfare. One worker said, "They (Bangladesh authorities) don't care about how we live, our health issues, or whether we are safe. Their only concern is how much money we send." Even the embassies, he added, "do not respect us; they treat us like slaves." Such sentiments are rooted in years of systemic corruption, irregularities and mismanagement suffered by migrants. Reports of fraudulent recruitment practices and exorbitant migration costs remain alarmingly common. Once abroad, workers also face abuse, contract violations, and poor living conditions, with little recourse or support from the authorities.

The interim government has a chance to change this narrative and ensure that our workers receive the support they deserve. There are many issues that need to be fixed, from recruitment to reintegration. While the need for increasing remittances-through upskilling workers and deterring the reliance on informal channels such as hundi-is understandable, it is secondary to tackling the exploitative practices that plague the life cycle of migrant workers, directly affecting their wellbeing. The time has come to shift the focus from what migrants can do for the country to what the country can do for them. The formation of a commission to undertake this task, as recommended by experts, is an essential first step in that direction.

One area that needs urgent attention is the costs of migration. It is unacceptable that Bangladesh remains one of the costliest countries for migration, with aspiring workers often paying up to six times the governmentstipulated costs due to corrupt practices and intermediaries. Moreover, they are also harassed while getting a passport, completing medical check-ups, etc. Clearly, stricter oversight of recruitment practices is crucial. The plight of workers stranded or mistreated abroad is another pressing concern. From Malaysia to the Gulf states, thousands face exploitative conditions, delayed salaries, and even threats of deportation. The government must enforce stricter monitoring of our recruitment agencies and embassies, and negotiate better protections with destination countries. Additionally, it must ensure proper reintegration for returning migrants who often struggle to rebuild their lives after years abroad.

There is a lot that needs to change, and for that, all relevant departments and agencies must undergo a cultural and operational overhaul. The interim government, and any administration that follows, must understand that we cannot honour our migrant workers without a full recognition of their rights and dignity.

Inflation is pushing us to the brink

Quick, effective measures needed to curb the menace

A recent study has revealed a rather distressing picture of inflation's impact on the lives of ordinary people. The study, conducted by the Research and Policy Integration for Development (RAPID), found that high inflation over the last two years has pushed at least 78 lakh people into poverty, with 38 lakh of them slipping into extreme poverty. A further one crore people are at risk of falling below the poverty line if the current inflationary pressure continues. This does not bode well for a country undergoing a massive political transition, underscoring the need for a comprehensive action plan to bring the situation under control as soon as possible.

Bangladesh has been battling high inflation for more than two years now, a situation caused by external shocks but made more severe and persistent due to delayed and shortsighted decision-making-such as excessive money printing by the previous regime, etc. Overall inflation has remained above nine percent since March 2023. In November this year, inflation hit a staggering 11.38 percent, while food inflation soared to 13.8 percent. The persistently high prices of essentials have been causing financial distress for citizens, a majority of whom have yet to recover from the shock of reduced income caused by the pandemic and other factors, including natural disasters. As a result, many households have been forced to cut back on basic needs such as education and healthcare, and even on daily food intake. According to the Bangladesh Bureau of Statistics (BBS), around 3.77 crore people experienced food insecurity in 2023.

We need prompt, effective measures that can support the poor as well as help curb inflation. For immediate relief, social protection programmes must be beefed up to provide support to those who urgently need it. This should include cash support and/or provision of basic essentials at subsidised rates. For a long-term remedy, the government must take a multipronged approach. Public spending, for example, has to be adjusted to prevent wastage, while government resources should be used more effectively to support social protection programmes as well as to create jobs for those suffering due to reduced income opportunities. Simultaneously, the government must employ measures to complement its ongoing efforts to curb inflation, such as strengthening market management to prevent price manipulation and monitoring supply chains to stop extortion.

The interim administration has a mammoth task ahead. To deliver on its promises, including stabilising the economy, it must make prudent and timely decisions to bring the raging inflation under control. This is also vital for a smooth political transition.

Reform imperatives of our police

The police reform of Bangladesh requires an in-depth examination of the police organisation, its mandate, its functional dynamics. It also highlights the need to establish effective structures to oversee police performance and ensure the realisation of the organisational mission. The reform process has to touch all ranks and be all inclusive, calling for a commitment and sense of purpose from the political executive since what is involved is basically a redetermination of the whole governance paradigm.

Every organisation, whether public or private, can perform well only if it is founded on valid organisational principles. In the case of Bangladesh police, these principles were not followed over the years, resulting in a corrupt, inefficient, and highly politicised force. Increasingly, the police were rendered agents of the political executive rather than instruments of a democratic state. The selective application of law against opponents, whether political or personal, at the behest of influential individuals, became the norm rather than the exception. People perceived the police as agents of the party in power, not as members of an organisation publicly maintained to enforce the rule of law.

The key question relevant to the reform is: what kind of organisation will the police of Bangladesh need to meet the law-and-order challenges of the 21st century? As a first step, the responsibility of maintenance of law and order will need to rest unambiguously with the police. The police hierarchy must be made responsible not only for the organisation and the internal administration of the force but also exclusively for all matters connected with maintaining law and order. In short, policing operations should no longer be subjected to general control and direction from outside the police

operationally neutral, functionally and

improved discipline within the force, and revamped accountability mechanisms. The role, duties, and responsibilities of the police must be orientated to prioritise service function, ensuring that the prevention and detection of crime serve a social purpose. The reform strategy should seek to solicit voluntary support and

With the focus on climate finance. COP29 concluded on November 24 in Baku. Azerbaijan, with a \$300 billion annual pledge by developed nations until 2035. The amount will go to support developing nations such as Bangladesh in adapting to the climate emergency. While a step in the right direction, the outcome fell short, paling in comparison to the actual needs. Bangladesh alone requires \$176 billion to implement its climate action plan to meet the Paris Agreement goals—known as the Nationally Determined Contribution (NDC). What's more, COP29 failed to clarify where these funds will come from, and the annual Global Stocktake dialogue—meant to assess the collective progress to inform the next round of NDC-was postponed until June 2025. This delay is especially concerning, given the critical role the NDCs play in driving climate progress when international mitigation negotiations are failing to

outcomes signal a dire "code red" for both their present and their future. Every year, extreme weather events floods, heatwaves, and cyclonescontinue to offer no respite. This year has been particularly unprecedented and devastating. During monsoon season, the worst floods in 34 years swept through the homes, schools, and villages of over 20 lakh children in eastern Bangladesh. These tragedies came on the heels of earlier disasters, including June floods in northern Bangladesh and Cyclone Remal in May—the three combined emergencies affected over 1.8 crore people, including 70 lakh children. Flooding, along with increasingly severe storms, has a direct impact on children: it increases stunting; drives pre-term pregnancy complications; and results in increased maternal and newborn mortality. This is not just a science reality. It is killing women and children, and this alone should be the justification for action.

Meanwhile, children are growing up in an increasingly unhealthy

Emissions are a driving factor for the climate crisis, but also a damaging factor for children's health. In 2021 alone, air pollution was responsible for over 235,000 deaths in Bangladesh. Higher temperatures is another harmful outcome of the climate crisis. Heatwaves, which are becoming more frequent and intense, reached record-breaking temperatures of 43 degrees Celsius in April and May. These extreme temperatures forced nationwide school closures and worsened the learning loss, especially for most vulnerable children, who have no access to digital means of education.

But this crisis is not just about rising temperatures or polluted air and water-it is about injustice. Children in Bangladesh are paying the highest price for a crisis they did not cause. Developed countries are responsible for the bulk of global emissions, yet it is countries on "ground zero" like Bangladesh that face the worst consequences.

These disparities become even more glaring as the 2030 deadline looms just five years away. While countries largely postured and avoided the urgency of the 1.5 degrees Celsius target and Sustainable Development Goal 13 for Climate Action at COP29. children in Bangladesh cannot afford to wait another year. Stronger actions are desperately needed to protect their rights, lives, and futures. Climate finance must be accessible, transparent, and sufficient. We need infrastructure-schools, hospitals, and water systems-that

can withstand climate shocks. Stricter environmental laws must be enforced to control pollution. Most importantly, as young people in Bangladesh continue to speak up on the devastating impacts of climate change, their voices must be central in decision-making; they want and should be a part of driving the solutions. To do this, UNICEF joins their call for i) a youth climate envoy in the office of the chief adviser and ii) a climate youth advisory body to be officially consulted on inclusion of children and young people in the NDCs, and to support the Ministry of Environment, Forest and Climate Change to create a dynamic plan of

For children and young people, inaction is not an option. There are many demands at this time, but this is not a focus and investment that can be addressed at a later date-it has to start now, or it will be too late. Echoing the statement from UNICEF Executive Director Catherine Russell at the conclusion of COP29, UNICEF is working with the Interim Government of Bangladesh, partners and the private sector to ensure tangible climate actions for children. Looking ahead, we, along with young people demanding change, urge the interim government to embed and prioritise children's rights in the country's next round of NDC.

To avert catastrophe, we must act now-with children's rights at the heart of every decision. The future is theirs, and it's time we give them the tools to secure it.

Bangladesh's dark chapter of abduction and torture

The term "enforced disappearance" carries with it a harrowing silence—an emptiness that is louder than any scream. Behind the faceless statistics and clinical reports lies an abyss of grief, fear, and unspeakable torment. The interim report by the Commission of Inquiry on Enforced Disappearances has finally given shape to the shadows, unmasking one of the darkest chapters in Bangladesh's contemporary history under Sheikh Hasina's Awami League regime. From 2009 to 2024, a systematic machinery of abduction, torture, and killing unfolded like a grotesque opera of

The numbers alone are enough to chill the bones-1,676 complaints of enforced disappearances registered over 15 years, with 758 cases reviewed so far. These figures, however, are mere echoes of untold stories. The lives that have been erased or shattered cannot be quantified. What makes this ordeal even more disturbing is its systematic and well-organised nature—an invisible machinery of surveillance, kidnapping, and annihilation, fuelled by political orders and weaponised institutions.

The commission has revealed that disappearances occurred in five horrific stages: target selection, surveillance, kidnapping, torture, and execution or release. Victims were dragged from their homes or streets into unmarked vehicles, blindfolded and cuffed before disappearing into the ether. The darkness that engulfed them was literal and metaphorical-secret prisons where light and hope were extinguished. Stories of abuse uncovered by the commission defy human comprehension. Lips sewn shut without anaesthesia, electric shocks to the ears and genitals, bodies buried in rivers, and corpses left for trains to mutilate-such horrors belong in the annals of medieval tyranny, yet they happened here, in modern Bangladesh.

The commission speaks of nine secret prisons run by entities such as DGFI, RAB, and CTTC—facilities reminiscent of historical military juntas. This is not just a Bangladeshi tragedy. It is a human tragedy.

"When the truth is buried underground, it grows, it chokes, it gathers such an explosive force that on the day it bursts out, it blows up everything with it," said the French writer Émile Zola. The victims of enforced disappearances are not only individuals but the truth itself-buried, gagged, and annihilated by a regime that operated beyond accountability.

Enforced disappearances have been a recurring curse across the world, often carried out under the guise of political stability or national security. The haunting parallels with Latin America's military dictatorships are undeniable. In Argentina during the "Dirty War" (1976-1983), an estimated 30,000 people were forcibly disappeared. The Argentinian military junta, like the Awami regime, abducted citizens at night, detained them in secret prisons, and dropped their bodies into rivers or seas. "They are neither dead nor alive. They are disappeared," said

This eerily resembles the commission's report-victims abducted at night, bodies

the Buriganga and Shitalakshya rivers. Such methods are not born from chaos but are orchestrated with diabolical precision. The parallels remind us that tyranny wears the same face across borders.

The horrors of enforced disappearances have long been reflected in art and cinema, where fiction blurs uncomfortably with reality. In The Secret in Their Eyes (2009), an Argentinian film inspired by the Dirty War, we

In The Nightingale of Tibet (2011), the titular character symbolises resilience against oppression. The story speaks to the silencing of voices and the erasure of cultural and individual identities—a theme that echoes in Bangladesh, where victims of disappearance have been framed as criminals and subjected to false charges under draconian laws like the

see justice denied in the shadow of political corruption. A line from the film resonates deeply: "You can change everything about yourself—your face, your family, your city, your country—but there's one thing you can't change: you can't change your passion." For the families of the disappeared in Bangladesh, their passion for truth remains unshakable, despite the state's attempts to erase their loved ones from memory.

Similarly, the American film Rendition (2007) explores the terror of enforced disappearances under the pretext of counterterrorism. The protagonist, rendered to a foreign country for interrogation, becomes a victim of a faceless system that denies him identity or justice. The parallels are unsettling—the commission's findings reveal Bangladeshi victims handed over to India under international conspiracies, as in

The commission's findings do not shy away from naming the architects of these horrors. The involvement of institutions such as RAB, DGFI, DB, and CTTC paints a grim picture of state-sponsored terror. Lower-ranking officers claim ignorance about their actions, while higher officials supervised and ordered these atrocities. This dissonance-between blind obedience and orchestrated crueltyexposes a system rotten to its core.

The commission goes further, highlighting cross-border operations with Indian security forces. This revelation adds a layer of geopolitical intrigue to the disappearances, turning Bangladesh into a theatre of international complicity.

History has shown us that regimes that wield enforced disappearances as a weapon eventually crumble under the weight of their crimes. As Mahatma Gandhi once said, "There gulags or infamous detention centres of weighed with cement bags and thrown into the cases of BNP leader Salahuddin Ahmed is no god higher than truth." Truth has an

uncanny way of piercing through darkness, even when regimes attempt to suppress it with violence and fear.

To understand enforced disappearances, one must confront the silence. It is not only the silence of the abducted but also the silence forced upon their families-a silence that gnaws at the soul. A mother waiting for her son, a wife searching for her husband, a child growing up without a father—these silences are louder than the state's propaganda or the click of handcuffs in the dark.

"The dead cannot cry out for justice. It is the duty of the living to do so for them," wrote Lois McMaster Bujold. For the victims who were thrown into rivers, buried in unmarked graves, or mutilated beyond recognition. justice remains elusive. Yet their families refuse to give up.

Bangladesh's recent signing of the International Convention for the Protection of All Persons from Enforced Disappearances is a step forward, but mere paperwork cannot heal the wounds or bring justice to the victims. The abolition of RAB, as recommended by the commission, would be a symbolic first step—but what about the accountability of the architects? The report hints at the responsibility of former Prime Minister Sheikh Hasina as the "instructor of disappearances." History will judge her legacy not by her rhetoric but by the bloodstains that cannot be washed away.

The interim report is not the end of this story. It is a crack in the wall of silence. The truth will emerge, piece by piece, no matter how deeply it has been buried. The families of the disappeared deserve more than condolences. They deserve justice, accountability, and the return of dignity to the names that were erased.

In times of darkness, art, history, and literature remind us of resilience. The words of Seamus Heaney echo for Bangladesh today: "History says, Don't hope / On this side of the grave. / But then, once in a lifetime / The longed-for tidal wave / Of justice can rise up, / And hope and history rhyme."

The commission's findings are the first wave—a warning bell that the silence is breaking. The stories of those disappeared will not remain in the shadows. As the river currents carry their lost bodies, let their memories rise above the tides, a testament to the cost of truth and the undying resilience of those left behind. Bangladesh must confront its past, for only then can it build a future where no one vanishes into the night, never

Democracy needs civil society to thrive

Civil society in Bangladesh recently demonstrated its strength the July-August uprising. When the coordinators of the anti-discrimination students' movement were detained in July 2024, civil society groups—including university teachers, artists, journalists, and human rights defenders mobilised to demand their release. Their protests brought attention to human rights violations, such as brutal crackdowns and arbitrary arrests, bolstering public resolve. Despite oppressive measures like internet shutdowns, university dormitory evacuations, and night raids on protesters, civil society's actions became a rallying force, re-energising the movement in late

This spirited intervention contrasts sharply with civil society's broader inaction over the past decade. From 2013 to mid-2024, Bangladesh witnessed flawed elections, rampant corruption, enforced disappearances, and systemic governance failures. While civil society organisations (CSOs) like Transparency International Bangladesh (TIB), Centre for Policy Dialogue (CPD), Center for Governance Studies (CGS), and a few others have continued to raise alarms, many professional networks and NGOs remained silent or complicit, aligning with the former regime's "development" narrative. This raises critical questions about civil society's role in fostering democratic accountability.

Several factors have contributed to the erosion of civil society's influence in Bangladesh. Repressive laws, including Section 57 of the ICT Act and its successor, the draconian Digital Security Act (DSA), fostered fear and self-censorship. These laws, with vague provisions criminalising actions deemed offensive or detrimental to public order, were weaponised to silence dissent. Similarly, the Foreign Donations Regulation Act (2016) granted authorities significant control over CSO operations, limiting initiatives critical of government policies. These restrictions, coupled with bureaucratic delays, undermined the

independence of many CSOs.

funding Moreover, constraints further weakened civil society. Most Bangladeshi CSOs rely heavily on foreign donations, which often prioritise servicebased programmes like healthcare and education over rights-based initiatives promoting democracy and governance. Grassroots organisations, resource-strapped, struggle to survive in such an environment. The NGO Affairs Bureau's stringent oversight exacerbates these challenges by delaying or denying funding approval for initiatives that diverge from the government's narratives. This dependency on external funding and the overly regulated approval process limits CSOs' ability to advocate boldly for human rights and accountability.

Bangladesh's challenges mirror a global trend of shrinking civic spaces. According to CIVICUS, the country's civic space has been downgraded to "closed," placing it among the most restricted in Asia last year. Crackdowns on activists, journalists, and opposition voices ahead of the January 2024 national elections contributed to this decline. Several studies and indicators echo these findings, showing significant barriers for CSOs engaged in human rights, transparency, and anti-corruption efforts. While Bangladesh excels in service-oriented activities, its civic space for rights-based advocacy has been increasingly constrained over the years. The July uprising, marked by immense bloodshed and sacrifice, successfully ousted the autocratic regime on August 5, sparking hope for reopening civic spaces. The interim government is making efforts to restore these spaces, but the deep divisions within society pose significant challenges, requiring sustained time and effort. However, recurring incidents of mob lynching remain a major concern, hindering the development of a liberal and inclusive civil society.

Historically, civil society has been instrumental in advancing democracy worldwide. In Poland, the Solidarity Movement resisted communist rule and

activists dismantled apartheid through decades of advocacy. The US Civil Rights Movement, led by groups like the National Association for the Advancement of Colored People, achieved landmark victories for racial equality. Similarly, the Indian National Congress began as a civil society-led initiative, mobilising a non-

violent movement under Gandhi to secure independence and lay the foundations of democratic governance. Bangladesh itself boasts a proud history of civil societydriven transformation. Organisations like BRAC and Grameen Bank have significantly contributed to poverty alleviation and women's empowerment, gaining global recognition. However, in recent years, many professional groupsjournalists, academics, and cultural figures—have prioritised personal gains over their roles as defenders of democracy.

Addressing these shortcomings requires a multifaceted approach to reinvigorate civil society's capacity and independence. Diversifying funding sources is crucial. Over-reliance on foreign donors sometimes compromises CSOs' autonomy and subjects them to political interference. Domestic philanthropy and corporate social responsibility (CSR) initiatives can bridge this gap, fostering sustainable funding models. Encouraging local contributions can also strengthen CSOs' accountability to their communities.

The government must also create an enabling environment for civil society. This involves repealing or reforming restrictive laws like the DSA (rebranded as the Cyber dissent and undermine CSO independence. civil society institutions.

In South Africa, Although the government channels a significant portion of donor lunds to CSOs, widespread corruption in allocation often diverts resources to organisations unlikely to challenge authority. Policy reforms are urgently needed to ensure transparency and direct these funds toward initiatives that hold power accountable and benefit the public. Transparent mechanisms for allocating government-administered funds can ensure these resources are used meaningfully.

Equally important is the need for civil society to maintain impartiality and objectivity. CSOs must resist aligning with political factions and focus instead on their mission to promote democratic values, accountability, and social justice. This requires a cultural shift within civil society, emphasising integrity and courage over expediency.

The successes of civil society in other parts of the world offer valuable lessons for Bangladesh. During the Velvet Revolution in Czechoslovakia in 1989, civil society organisations united diverse groups around democratic goals, achieving a peaceful transition from authoritarianism. Similarly, civil society's role in transitional justice in Chile and Argentina in the 1990s underscores its ability to hold governments accountable and promote transparency.

These examples demonstrate that even in repressive environments, resilient civil ociety institutions can drive meaningful change. As Nelson Mandela aptly noted, "If we want any significant development, we must co-opt civil society." For this to happen in Bangladesh, state institutions, private sectors, and international development partners must collaborate to ensure that civic spaces remain open and

The stakes for civil society in Bangladesh have never been higher. Amid mounting challenges to democracy, human rights, and the rule of law, civil society must rise to the occasion. As Larry Diamond, a renowned political sociologist, observed, civil society plays a vital role in limiting state power, fostering participation, and advocating for democratic values. These responsibilities are especially pressing in Bangladesh, where the erosion of civic freedoms threatens the very fabric of democracy.



The phrases "cyber safety" and "cyber lives" may seem vague and not very well understood among Bangladesh's netizens. Yet, every day it seems as if understanding the nuances of the lives we lead online has become crucial. On December 13, Sister Library hosted their newest event, 'Catfish and Avatars', which laid the groundwork for an open discussion about the many ways the platform provided by the internet, and social media in particular, has been subjected to abuse and misuse. The event was organised jointly by Star Books and Literature along with Sister Library, in a collaborative effort among experts to bring to light the problems around cyber safety.

The event was split into four segments, each of which delved deeper and deeper into the myriad of questions that arise with a topic such as this. The discussions took place in the presence of Sharmeen Murshid, Adviser to the Ministry of Women and Children's Affair and the Ministry of Social Welfare of the Interim Government. There was, perhaps, no better person to partake in the conversations as all the talking points eventually led to an attempt to understand how women and minority communities have suffered greatly, especially in the last few months, due to a lack of regulation on the internet.

Kicking things off was a modest poetry session, with poems revolving around the theme of the Internet—the lives lived in it and the ways in which it has become a modern graveyard. Following this, came Barrister Priya Ahsan Chowdhury, who delved into the legalities of cyber safety, and the many issues that may arise with attempting to ban certain uses of language. After all, attempting to regulate what people say can be a slippery slope if not handled carefully. The talk was an in-depth session focused on the technical aspects of cyber safety from a lawyer's perspective.

This was quickly followed up by the discussion session moderated by Nazia

BOOK REVIEW: NONFICTION Redefining aviation safety culture

Review of 'Research on **Aviation Safety: Safety** is a Mindset' (Bartoman Somoy, 2024) by Air **Commodore Munim Khan** Majlish, BPP, psc.

Research on Aviation Safety: Safety is a Mindset by Air Commodore Munim Khan Majlish is a fresh look at the concept of aviation safety challenging standard ideas about safety. In the preface to the book, the author demonstrates that the existing safety policies and procedures are adequate for ensuring safety in aviation. However, these policies and procedures are not properly practiced or implemented in aviation organisations.

Majlish's many years of experience of managing aviation safety has helped him develop the core

Majlish's work underscores the importance of ongoing education and training in developing a safety aviation culture. The author emphasises that safety is not a one-time lesson but a continuous journey that changes with emerging problems and technological improvements.

ideas of the book. At the outset, the book provides a background in safety theory by shedding light on important models and frameworks that apply to flight safety. This theoretical foundation is supplemented with references to both old and new studies in the field.

One vital aspect about the book is that it presents real-life case studies and human stories to make its major arguments. Majlish uses real-life accidents to show how important it is to have a "safe" attitude. For example, he talks about times when good communication and the right attitude has kept bad things from happening. These case studies not only put the theory into real-life situations that people can relate to but also teach readers useful lessons that support the idea that good judgment is important for preventing or lessening accidents.

Majlish's work underscores the importance of ongoing education and training in developing a safety aviation culture. The author emphasises that safety is not a one-time lesson but a continuous journey that changes with emerging problems and technological improvements. He calls for regular



training for aviation staff to refresh their expertise and instill a sense of vigilance and responsibility. Majlish recommends that training programs contain features addressing human variables such as fatigue management, stress management, and decision-making psychology. He argues that training can assist aviation professionals in developing a comprehensive understanding of safety that takes into account both technical and human factors.

Majlish calls for the transformation from a reactive to a proactive culture in aviation. He reprimands the tendency of adopting safety measures only after an incident occurs. Heredefines a proactive safety culture as a commitment to recognising, assessing, and minimising possible dangers at all stages of aviation operations. One of his primary recommendations in this approach is to implement comprehensive safety management systems (SMS). These systems enable organisations to systematically document, monitor, and address safety risks. Majlish discusses how SMS frameworks can foster accountability and transparency and guarantee that safety efforts are deeply embedded in the organisational structure.

The author concludes with specific proposals to redevelop a safety culture in the aviation industry. He argues for strong leadership commitment to safety, safety audits, and ongoing learning activities that involve employees at all levels. He feels that top-down support is vital for building a safety-first culture, and encourages leaders to develop a tone of vigilance and accountability. He urges the introduction of safety award programs to honor employees who have that mindset.

Shamim shows his niche as finisher

Bangladesh batter Shamim Hossain marked his return to the T20I fold with consecutive cameo knocks, paving the way for his team's maiden bilateral T20I series win in the West Indies.

A T20 specialist of sorts, Shamim's blistering 35 off just 17 deliveries gave Bangladesh crucial momentum in the second T20I in St Kitts yesterday, earning him the Player of the Match award.

The left-hander said he always had the confidence to play his game, and his stroke-play came to the Tigers' aid again, following a 13-ball 27 in a seven-run win in the series opener. However, a poor run of scores in the 2023 Asia Cup, played in the ODI format, had sealed Shamim's fate as he was dropped from the ODI World Cup squad.

Shamim also impressed at the Emerging Asia Cup, where he struck 61 runs at an average of 61 and a strike rate above 138. When David Moore organised Bangladesh HP's tour of Australia for the Top End T20 tournament, Shamim, already armed with national team experience, delivered steady 40-plus scores, maintaining his rhythm and confidence.

When he moved across his stumps yesterday to Obed McCoy and found the ropes at the Arnos Vale Stadium, Shamim displayed his inventiveness. His fast hands allow him to clear the ropes with both finesse and power when needed.

"I always think that, whatever situation the team is in, if I play well, we'll reach a decent total. I played well in HP, the emerging team, and wherever I have plaved recently, I gained the confidence that, given an opportunity, I would do well," he said.

"This is just the beginning. I have a long way to go; there is a long way left in my career," Shamim added, as the Tigers will be hoping for more daring finishes from their enforcer at the death.

Batters around the world heaved a sigh of relief on Wednesday as Ravichandran Ashwin brought down the curtain on an international career that saw the India spinner take more than 500 Test wickets with an arsenal that included the dreaded 'carrom ball'.

The 38-year-old was not selected for the opening Test against Australia in Perth but returned to the side for the day-night second match in Adelaide, where he took one wicket.

That would prove to be his final Test after Ashwin was again left out in Brisbane where India snatched a draw in a rainblighted contest. Ashwin's

vickets from 106 Tests is the second highest by an Indian bowler behind Anil Kumble's 619. He also played 116 one-dayers and 65 Twenty20 Internationals,

finishing with 765 wickets across formats. "This will be my last day as an Indian cricketer in all formats at the international level," a composed Ashwin told reporters with captain Rohit Sharma by his side.

"I do feel there's a bit of punch left in me as a cricketer, but I would like to express that and probably showcase that in clublevel cricket."

Since making his India debut in an ODI against Sri Lanka in 2010, Ashwin went on I will be marking this as my date of having to fill the void created by the retirement of

A cerebral spinner with a fast bowler's aggression, Ashwin grew to become a match-winner on India's turning tracks, where his impeccable control and ability to bowl long spells made him a huge asset.

Obsessed with the small details of his craft, the off-spinner constantly tinkered with his technique in his relentless quest for perfection.

Ashwin bowled leg spin in domestic cricket to expand his repertoire and mastered the 'carrom ball', in which he flicked the ball with knuckle.

The Indian was a big influence on his peers, with Australian spinner Nathan Lyon calling him one of his "biggest coaches' in the run-up to the ongoing series for the Border-Gavaskar Trophy.

Ashwin, who will return

home on Thursday, also evolved into a decent Test allrounder, hitting six hundreds in the format. India captain Rohit said he

convinced Ashwin to stay on for the pink ball Test in Adelaide after learning of the spinner's retirement plans. "I have created a lot of memories alongside Rohit and several of my other

teammates, even though I have lost some of them (from the India side) over the last few years," Ashwin said of his contemporaries.

"We're the last bunch of OGs, if we can say that, left out in the dressing room, and played at this level."

Vinícius aims dig at critics after FIFA The Best award win

Vinicius Junior hit back at his critics after winning FIFA's The Best men's player of the year award on Tuesday, accusing his detractors of trying to "invalidate" and "diminish" him.

Real Madrid and Brazil forward Vinicius, 24, took the 2024 prize -- which is voted on by a combination of national team coaches and captains, journalists, and fans -- with 48 points, ahead of Manchester City midfielder Rodri who earned 43 points and Madrid teammate Jude Bellingham with 37 points.

It comes after Rodri beat Vinícius to the Ballon d'Or, which is organised by France Football and UEFA, leading Real Madrid to boycott the ceremony in protest.

"Today I write to the child who has seen so many idols lift that trophy," Vinícius posted on Instagram. "His time has come. Or rather, my time has come. The time to say ... yes, I am the best player in the world and I have fought hard

"They have tried and tried to invalidate me, to diminish me. But they are not ready. No one is going to tell me who I should fight for, how I should behave. When I was at Sao Goncalo, the system didn't care about me. It almost swallowed me up.

"I won for myself, for my family. With a lot of support along the way: Flamengo, Real



Madrid, the Brazilian national team, my hundreds of teammates over the years ... the people who accompany me every day in my routine, those who admire me ... The best player in the world."

Vinicius won The Best -- for the first time after a 2023-24 season which saw him help Madrid win a LaLiga and Champions League Barcelona's Aitana Bonmatí won the

women's award, with Carlo Ancelotti being named men's coach of the year. In October, Vinicius reacted to missing out

on the Ballon d'Or: "I'll do it 10x if I have to. They're not ready," he wrote. Madrid's delegation had opted not to

travel to the Ballon d'Or ceremony in Paris when it emerged that Rodri was likely to win, with none of the club's multiple nominees or officials attending.

President Florentino Perez criticized the Ballon d'Or voting system -- which involves 100 journalists from different countries -- in a speech at Madrid's AGM last month, saying "nobody knows who they are" and arguing the award should be "independently organised" and voted on by "people who are well-known."

Neymar was among the stars to praise Vinícius after his triumph on Tuesday, encouraging his compatriot to "keep flying" in an Instagram story.

CONFLICT IN RAKHINE 300 Rohingyas wait to enter Bangladesh

Say border sources; BGB beefs up security along Myanmar border

At least 300 Rohingyas have been waiting to enter Bangladesh after the rebel Arakan Army (AA) claimed to have full control of Rakhine's Maungdaw district, which includes the entire 270km of the Bangladesh-Myanmar border, according to locals and other sources at the border.

They said the Rohingyas, faced with an extreme food crisis and forced labour, have been gathering in the hilly areas of Rakhine, opposite the Bandarban border.

Those living in Cox's Bazaar refugee camps said the Rohingyas across the border are now being pressured by the AA to leave Myanmar, and many have already entered Bangladesh recently.

The AA, who on December 8 claimed to have full control of the border, has imposed restrictions on the Myanmar side of the Naf River, which divides the countries, making it inaccessible to any Myanmar citizen.

On the other side, the Border Guard Bangladesh and Coast Guard are on high alert, with round-the-clock surveillance near and on the river.

Colonel Mahmudul Hasan, BGB sector commander of Ramu sector, said, "We have information that some Rohingyas have gathered on the other side to enter Bangladesh. We have beefed up security

Rahima (not her real name) left Bangladesh for Oman to work as a domestic help and support her five-member family after her husband Although she travelled abroad with the

hope of securing a better future, she returned

as a domestic help, she

was assigned various other tasks, including working in a poultry farm and carrying heavy water drums up mountainous paths with her bare hands. "I wasn't given adequate

rest, and after missing work for a day due to illness, they didn't allow me to eat."

When she asked for food, she was met with a torrent of verbal abuse.

"When my health deteriorated from the hard labour, my employer told me to see a doctor at my own expense, which meant walking five kilometres to the hospital."

Eventually, Rahima fled and returned to Bangladesh, where she learned that she had developed uterine problems.

She turned to the Wage Earners Welfare Board (WEWB) for assistance, which has over the past three years given medical help to 125 women migrant workers. Most of them had

returned from Saudi Arabia, Jordan, Oman, Lebanon, Qatar, the UAE, and other Middle Eastern countries.

WEWB's records show a concerning trend most of these women, like Rahima, were suffering from uterine issues

In 2023 alone, 56 women applied for medical assistance from the organisation and home within a year — in bad shape. 20 were diagnosed with uterine problems. Despite being told she would have to work Meanwhile, 19 had endured physical abuse, 10

> were suffering from kidney issues, and seven were battling cancer.

> Fifty-four-year-Maksuda Khatun, from Mymensingh's Gafargaon, returned to Bangladesh from Saudi Arabia on March 16 this year after diagnosed with being kidney disease.

Upon her arrival, doctors found that both of her kidneys were damaged. She now requires dialysis

thrice a week, costing her family Tk 35,000 per month. After applying to the WEWB, she received

Tk 1.50 lakh to cover a portion of her medical "Apart from this money. I had to spend all

the money I saved while working as a domestic worker abroad and even sold a piece of land. "I don't know how I will manage my

treatment costs in the future," said Maksuda, SEE PAGE 6 COL 4

US worried over conflict in Rakhine State: Millar

The United States has expressed concern over the ongoing conflict in Myanmar's Rakhine State and its potential to destabilise the region.

Speaking at a press briefing in Washington yesterday, US State Department Spokesperson Matthew Miller emphasised the urgency of addressing the crisis.

"We remain concerned by the conflict and its potential to undermine regional stability and security. Helping resolve the Rohingya refugee crisis remains a priority for us. "We will continue to work with Bangladesh

to support the Rohingya and members of other vulnerable communities from Burma [Myanmar] who have taken refuge there," Miller added. The ongoing conflict has significantly escalated the

humanitarian crisis in the region. The Arakan Army, an ethnic armed group, now controls more than 80 percent of Rakhine State, according to media reports. Meanwhile, UN Secretary General António Guterres

has assured UN's full support for the high-level conference on Rohingya to be held in early next year. SEE PAGE 6 COL 7

Hopes for Gaza truce deal rise

The United States, joined by Arab mediators, yesterday sought to conclude an agreement between Israel and Hamas to halt the 14-month-old offensive in the Gaza Strip where medics said Israeli strikes killed at least 20 Palestinians overnight.

On Tuesday, sources close to the talks in Cairo, the Egyptian capital, said an agreement could be signed in coming days on a ceasefire and release of hostages held in Gaza in return for Palestinian prisoners held by Israel.

Medics said an Israeli airstrike killed at least 10 people in a northern town of Beit Lahiya, while six were killed in separate airstrikes in Gaza City, Nuseirat camp in central areas, and Rafah near the border with Egypt.

In Beit Hanoun in the northern Gaza Strip, medics said four people were killed in an airstrike on a house.
