## 'Jubo League leader' hacked to death

A man was hacked to death by unidentified miscreants in Rangamati's Kaptai Upazila on Monday night.

The incident occurred in the Balukhali area of Raikhali union, said the union parishad's Chairman Monky Marma.

The deceased, Obaid Ullah, 43, was the vice president of the Raikhali Union Jubo League, said local sources and party activists.

They said Obaid Ullah was returning home after closing his shop at Karigorpara Bazaar when he was hacked to death by miscreants. Police and party members could not determine the motive of the murder immediately.

We have not yet confirmed the political identity of the victim. He was hacked and injured in the Balukhali area between 10:30pm and 11:00pm last night (Monday). He was later taken to Chattogram Medical College Hospital, where doctors declared him dead," said Muhammad Shahjahan Kamal, officer-in-charge of Chandraghona Police Station.

Tanvir Siddiqui, general secretary of the Kaptai Upazila Jubo League, said, "Balukhali is a remote area, and we have not yet identified those responsible for the murder. We demand justice for the killing."
