

BNP leader arrested for sexual harassment

An expelled BNP leader was arrested on the charge of sexual harassment in Sirajganj Sadar upazila on Sunday.

A local court sent the arrestee to jail on Sunday afternoon, police confirmed yesterday.

The arrestee, Juel Rana, hailing from the Char Solimabad area in Chowhali upazila, was the organising secretary of the Chowhali upazila unit of BNP before he was expelled from the post on January 14.

Juel allegedly sexually harassed a young boy in his village on January 11, said Jiaur Rahman, officer-in-charge of Chowhali Police Station.

The victim's father filed a case against Juel with the police station. Juel has been in hiding since then, added the OC.

Acting on a tip-off, Rab arrested Juel from Sirajganj town and later handed him over to police, the OC said.

The Sirajganj district unit of BNP expelled Juel from his post for violating the party's decorum.

Tobacco cultivation surge sparks alarm

Tobacco cultivation in the Rangpur region has increased significantly this year, with 19,250 hectares of land now under cultivation, up from 13,349 hectares last year, according to the Department of Agricultural Extension.

The department has expressed concern over this rise, noting that the cultivation area stood at 10,820 hectares in 2023.

Officials report that 60 percent of the region's tobacco is produced in Lalmonirhat, followed by 20 percent in Rangpur, 15 percent in Nilphamari, and 5 percent in Gaibandha.

Farmers, meanwhile, cite the high profitability of tobacco as a reason for its increased cultivation.

Sejab Ali, a farmer from Tiparbazar village in Aditmari, expanded his tobacco farming from four bighas last year to seven this year, earning Tk 2,77,200 from 33 maunds of tobacco in 2024 while spending Tk 86,000.

Abdul Quader, a veteran farmer from Mominpur village in Rangpur Sadar, has

been cultivating tobacco for 39 years and noted a sharp rise in its production this year. He doubled his cultivation from five to 10 bighas, attributing the trend to higher market prices and the support provided by tobacco companies, including seeds, fertilisers, pesticides, and interest-free loans.

Omar Faruk, agriculture officer of Aditmari upazila, criticised tobacco companies for encouraging cultivation, which he said depletes soil fertility and hampers food production.

Obaidur Rahman Mandal, additional director of DAE in Rangpur, said tobacco cultivation, though lucrative for farmers, harms the soil, environment, and human health.

He said the DAE cannot take firm measures as tobacco cultivation has not been officially banned, adding that its unchecked growth poses a severe risk to agriculture. Lalmonirhat Deputy Commissioner HM Raqib Hayder said measures to curb tobacco cultivation would be taken in consultation with the agriculture department, and the matter has been reported to higher authorities.

US Coast Guard team to visit Ctg port today

A delegation from the United States Coast Guard is scheduled to visit Chattogram Port today to evaluate its security and operations related facilities.

The four-member delegation of US Coast Guard, led by Lt Commander Khiem Nagy, arrived in Dhaka on January 18 on a six-day visit under its International Port Security (IPS) programme.

The team, during its two-day visit to Chattogram, will meet Chattogram Port Authority Chairman Rear Admiral SM Moniruzzaman, and inspect and assess if the port's security measures are in place and related facilities including private off-docks comply with the International Ship and Port Facility Security (ISPS) Code, sources said.

The team will visit different port facilities, a private off-dock Ispahani Summit Alliance Container Terminal Ltd, another private ICD named Incontrade Container Ltd, and Patenga Container Terminal of the port.

Ctg-Cox's Bazar route gets 2 new trains from Feb 1

Two new intercity trains will start operating on the Chattogram-Cox's Bazar route from February 1.

Bangladesh Railway issued a letter in this regard yesterday, and instructed its departments to allocate manpower, locomotives, coaches for the trains' operation.

The trains – Saikat and Prabal express – will have 743 seats each, said the letter signed by Kamal Akter Hossain, additional chief operating superintendent of BR (East Zone).

BASHUNDHARA GROUP Probe 470-acre Ctg land allocation: HC

The High Court yesterday ordered the government to form a committee to investigate allegations of irregularities in allocating 470 acres of land in Chattogram to Bashundhara Group by misclassifying the land as wetlands.

The land secretary, cabinet secretary, chairman of the Anti-Corruption Commission, director general of Land Records and Survey Department, and divisional commissioner of Chattogram have been directed to comply.

The committee has been asked to submit a report to the court within three months, stating its progress.

The HC also issued a rule asking why the land allocation to Bashundhara Group should not be declared illegal.

The bench of Justice Fahmida Quader and Justice Mubina Asaf issued the order after hearing a writ petition filed by Supreme Court lawyer Mohammad Kawsar in December last year as public interest litigation.

The petition was based on a report published on October 10 by the online portal "Bangla Outlook," titled "Bashundhara allocated land by showing them wetland."

The petitioner challenged the legality of the allocation and sought an order of probe into the allegations. Lawyer Kawsar moved the writ petition before the HC himself.

After the HC order, he told The Daily Star that the land, originally classified as sandy beach land, was reclassified as wetland to facilitate its allocation.

This reclassification resulted in a long term lease at a significantly lower cost, depriving the
