

# Shops running illegally on CWasa lands

At least 16 shops are being run illegally on lands of Chattogram Water Supply and Sewerage Authority in different areas of the port city.

Allegedly, the CWasa Employees Co-operative Society Limited built the shops on the government lands without permission.

Sources said the society receives Tk 2.5 lakh in advance payment and Tk 2,000-4,500 as monthly rent for each shop.

As per data from CWasa's estate department, there are seven shops on its land in Bolirhat, five in Monsurabad and four in Technical Intersection area, all constructed by the society between 2019 and 2023.

The society was launched in 1988, and currently has over 150 members.

Visiting the CWasa's colony in Technical Intersection area, this correspondent observed several businesses being run in the newly constructed shops.

"I rented the shop, paying Tk 5 lakh in advance and Tk



4,000 monthly," said Yeasin Akram Rabby, who runs a grocery shop.

Several other shopkeepers echoed the same.

"Initially, the society rented shops to its members to avoid internal conflict. Then the member rented it to me," said an occupant of a shop in Monsurabad pump house area.

The CWasa's estate department wrote a letter to the society in February last year, requesting it to stop constructing shops on its lands. A probe body was also formed by the ministry concerned to investigate the issue last year.

"We are yet to get the probe report. We also wrote to the society to stop this illegal activity. They, however, ignored the call," said Babul Alam, estate officer of CWasa.

Asked why they built shops by occupying state's land without permission, Mohammed Yousuf, president of the society, said they are doing commercial activities for the welfare of society members.

However, if these shops are built illegally, the CWasa can take action as per the rules, he added.

Contacted, Muhammad Anwar Pasha, managing director of CWasa, said, "I will look into the issue. Action will be taken as per rules if any irregularities are found."

# 8 years on, bridge remains incomplete

Residents of 16 villages in Phulbari upazila of Dinajpur have been suffering for the past eight years due to the incomplete construction of a bridge over the Chhoto Jamuna river.

The bridge, intended to facilitate local travel, remains unfinished, forcing villagers to take a 7-kilometre detour for what would otherwise be a 2-kilometre journey.

The project began under the leadership of former union parishad chairman Abdul Aziz Master. Using funds from the UP and community voluntary labour, six concrete pillars were constructed on the river. A temporary bamboo and wooden platform were then installed between the pillars to allow pedestrian use.

However, the lack of additional funding left the project incomplete, exposing the structure to weather damage and making it increasingly dangerous to cross.

Villagers from Polipara and Harhariapara in Phulbari upazila, as well as neighbouring areas in Nawabganj, expressed frustrations over the incomplete bridge, citing the significant impact it has on their daily lives.

They said long detours have made accessing schools, markets, and government offices more



challenging for hundreds of residents, including students and farmers, leading to reduced efficiency and financial strain.

Farmers from the affected villages also face increased transportation costs when bringing their produce to markets in Madilahat and Khayerbari Hat, cutting into their profits.

Shamsher Ali, a resident of Harhariapara village, said, "Vehicles can't pass through the bridge, and it's only a matter of time before it collapses."

Abdul Aziz Master said approximately Tk 15 lakh had already been spent on constructing the pillars and estimated that an

additional Tk 10 lakh would be needed to complete the bridge.

He said despite repeated attempts to secure funding from the upazila parishad, political indifference has hindered progress. He also alleged that local Awami League leaders were unwilling to support the project as they would not receive political credit for it.

Contacted, Upazila Engineer Shafiqul Islam said he will visit the site soon to witness the situation firsthand.

Upazila Nirbahi Officer Mir Md Al Kamah Tamal said appropriate measures will be taken to alleviate the villagers' suffering.

## JUDGES' APPOINTMENT Ordinance flawed, discriminatory Says SCBA president

The recently formulated Supreme Court Judge Appointment Ordinance is flawed and discriminatory, said SCBA President AM Mahbub Uddin Khokon yesterday.

"There is no provision in the law for keeping representative from lawyers in the Supreme Judicial Appointment Council, who will select candidates for the posts of Supreme Court judges and recommend them to the president. The law is defective and discriminatory. I demand amendment of the law," he said while talking to reporters at the SC premises.

The interim government has issued an ordinance for recruitment of competent judges in the two SC divisions through a seven-member Supreme Judicial Appointment Council led by the chief justice.

Even though the constitution mandates formulating a law for appointments of judges, none of the previous governments did it.

## Toddler dies in freak accident

A three-and-a-half-year-old girl was killed after she got entangled in the blades of a paddy-threshing machine at her house in Dinajpur's Birganj upazila yesterday afternoon.

The deceased is Jannatul, daughter of Md Ziaurul Islam.

The incident happened around 3:00pm in the courtyard of her home.

According to locals, the family was using a thresher in their courtyard. Jannatul wandered out of the house and became entangled in the machine's blades and sustained severe injuries.

She died on the way to a hospital.

Officer-in-Charge of Birganj Police Station Md Abdul Gafur said they are looking into the incident.

## Ex-whip Iqbalur among 692 AL men sued

Former Jatiya Sangsad whip Iqbalur Rahim, also former Awami League lawmaker from Dinajpur-3, and 691 other AL men have been sued for allegedly attacking a procession brought out by BNP men in the district on July 21 last year.

Local BNP leader Mostafa Mahmud Rinku, a resident of Balubari in Dinajpur, filed the case against the named 192 AL leaders and activists and some 500 unidentified people yesterday, said Motiur Rahman, officer-in-charge of Dinajpur Sadar Kotwali Police Station.

According to the case statement, on July 21, 2024, leaders and activists of AL and its affiliated organisations attacked BNP supporters near the main gate of Hajee Mohammad Danesh Science and Technology University (HSTU) when they brought out a protest procession.

Former AL MP Iqbalur instructed them to carry out the attack, Rinku said in the case.

The attackers used firearms, rods, sticks, machetes, petrol bombs, and crude bombs to carry out the attack. They also allegedly vandalised the vehicles carrying them.

## Man held over rape of 7-year-old boy

Police yesterday arrested a man in Gazipur's Kapasia upazila on the charge of raping a seven-year-old boy.

The arrestee is Joy Chandra Das, 23, a Nasimom driver.

The child's father filed the case with Kapasia Police Station, said Sub-inspector Moslem Uddin.

The child was initially taken to Kapasia Upazila Health Complex and later referred to Gazipur Shaheed Tajuddin Ahmad Medical College Hospital for better treatment, said Mamunur Rahman, health and family planning officer of Kapasia Upazila Health Complex.

Quoting the child's father, the SI said the victim was playing near his home when the accused took the child to a nearby area under the pretext of showing him a bird's nest and raped him.

Hearing his scream, locals later rescued him.

## 2 held for hoarding OMS rice

Authorities on Wednesday night seized 600 sacks of government subsidised rice from a warehouse named "Majumdar Bhandar" in Karamat Ali Market.


In a joint operation by Fakirhat police and the Food Department, they also arrested two persons involved in its illegal storage and intended sale.

The arrestees are Ashatit Majumdar, 21, a co-owner of the warehouse, and an employee, Abdur Rasul, 45.

Each sack contained 30 kilogrammes of rice, as part of the Open Market Sale (OMS) programme, and the total amount seized was worth Tk 9.34 lakh, said Fakirhat Model Police Station's Officer-in-Charge Alamgir Kabir.

He said the two were arrested for embezzling government subsidised rice and planning to deceive consumers.


A case has been filed against them.
