

Govt officer suspended for assaulting driver

The Ministry of Social Welfare has suspended Md Jahid Hasan, the upazila social services officer of Pabna, Rajshahi, following allegations of assaulting an auto rickshaw driver, said an official order issued on Monday.

The suspension follows a viral video showing Jahid severely beating the driver -- first with his shoe and then with a stick. Several national and local newspapers reported the incident on February 28, 2025.

Although the assault took place on February 2, it gained attention after the video surfaced online on February 28.

In its order, the ministry said Jahid's actions were inappropriate, violated professional discipline, and severely damaged the reputation of both the Department of Social Services and the Ministry of Social Welfare.

Loose soybean oil fixed at Tk 160 a litre in Ctg

The district administration yesterday fixed retail price of loose soybean oil at Tk 160 per litre across Chattogram district.

The decision came at a meeting organised by Chattogram District Administration at Chattogram Circuit House and made effective from the same day. It will remain effective till April 10.

Chattogram City Corporation Mayor Shahadat Hossain was present as chief guest in the meeting, chaired by Farida Khanam, deputy commissioner of Chattogram.

Senior officials from businesses

including TK and City Group, importers of edible oil, trader leaders from Khatunganj wholesale market, and representatives of consumer organisations were also present.

"From today [Tuesday], loose soybean oil will be sold retail at Tk 160 per litre. Action will be taken if complaints are received against anyone selling at a higher price," Shahadat said.

On Monday, the CCC mayor and Chattogram DC visited Khatunganj, the country's largest wholesale market of daily essentials, amid the ongoing supply crisis of bottled soybean oil.




