Fare hikes are primarily attributed to inflation, extortion, employee Eid bonuses, and owners' profit motives.
Besides, the absence of passenger representatives in monitoring teams has made oversight ineffective.
Jatri Kalyan Samity also presented figures for how much would be extorted from passengers using each mode of transportation, with long distance buses and minibuses taking Tk 90 crore extra from 30 lakh passengers and city buses taking Tk 12 crore from 40 lakh trips.
The Samity emphasised that the fare hikes are exacerbating the cost

of living, encouraging corruption, and increasing road accidents.
To curb these issues, it urged authorities to introduce digital fare collection, ban cash transactions, use CCTV for fare monitoring, and improve transport governance.
Present at the press conference were newly elected Chairman Mohammad Zakaria, former election commission secretary Syed Ahmad, former Dhaka Transport Coordination Authority executive director Mahmudul Hasan Russell, and Mohammad Alauddin Masud.

linked to conflicts involving criminal networks.
According to Rab, Sayed and another individual named Mehedi had been extorting money in the Gulshan and Badda areas for several years. After the fall of the Awami League government on August 5 last year, Mehedi fled

but continued collecting extortion money through Sayed.
However, Sumon later began extorting money in the same area on behalf of another group, known as the Robin group, leading to a conflict between the two factions.
Rab said Sayed planned Sumon's murder on Mehedi's orders. He, along with Belal and four to five other members of their group, began monitoring Sumon daily.
On the evening of March 20, Sayed and others met at his house, armed themselves, and went to Gulshan in search of Sumon.
Around 9:00pm, they spotted Sumon sitting in front of Police Plaza and shot him. When Sumon attempted to flee, he was shot multiple times before the attackers escaped.
A case was filed with Gulshan Police Station against unidentified individuals following the incident.

government, she said. "There are conventional challenges that every government encounters. A process has now begun to build consensus on various reforms, and this must be carried forward through proper procedures with collective efforts."
"Another key task is to ensure credible elections and meet public expectations," she added.
Asked about the possibility of achieving political consensus, the adviser said, "Our expectation is that we will rise above personal and party interests for the sake of national interest."
"However, different people perceive issues differently, and we need to bridge these differences. It will take time and must go through a process," he added.
She expressed hope that experienced political leaders would prioritise national interests.

Pay our due wages, bonuses right away

The event, titled "We Want Freedom for Fish, Meat, Rice, and Wages," was organised by the Ganatantrik Adhikar Committee, which urged the interim government to ensure payment of all outstanding wages and bonuses to workers across the country.
Speaking at the rally, researcher Maha Mirza said, "Workers have gone unpaid for three months while factory owners continue to deceive them. When they protest, police attack them. Under the Awami League government, workers faced repression, and the situation remains unchanged. Instead of being sympathetic, we are becoming even more inhumane."
She demanded that all pending wages and

allowances be cleared before Eid.
Raju Ahmed, general secretary of the Garments-Textile Sramik Federation, said, "We had to protest for our wages even under Awami League's rule. If we still have to fight for our rightful dues, then what has changed?"
Workers said factory owners had repeatedly assured them of payment but failed to deliver, leaving them in financial distress ahead of Eid.
They demanded wages for January and February, food allowances, Eid bonuses, and the current month's salary. Protesters vowed to continue until their dues were settled.
Since March 23, workers from several garment factories, including TNZ

Apparels Limited and Apparels Plus Eco Limited, have been staging sit-ins in front of the Shrom Bhaban.
On Monday afternoon, at least five police personnel and several workers were injured as

protesters marched toward the Secretariat.
Meanwhile, the National Citizen Party's labour wing also held a demonstration in front of Shrom Bhaban expressing solidarity with the protesting workers.

North District BNP President Golam Akbar Khandaker was appointed convener, while Nurul Amin, also known as Kala Amin, was named member secretary.
However, another faction led by Nurul Amin, also known as Chairman Amin, opposed the decision and began demonstrations.
According to locals, tensions had been simmering since Monday night, with multiple incidents of chase-and-counter-chase between rival groups.
Mirsarai Upazila Nirbahi Officer (UNO) Mahfuza Jerin said, "Intelligence reports indicated a possible clash ahead of the March 26 programme, prompting the imposition of Section 144."
Additional police and army personnel had been deployed to restore order, she added.
