

## No place for AL in NCP

Says Akhtar Hossain

If any member of Awami League attempts to infiltrate the National Citizen Party, they will be resisted and handed over to the law, said the party's Member Secretary Akhtar Hossain.

"If anyone from Awami League dares to associate themselves with the NCP, they will face consequences. We will take firm action to protect our movement and ideals," Akhtar said.

Anyone who has imposed fascism on Bangladesh has no moral right to participate in the country's politics, he also said.

He made the remarks on Friday night while talking to journalists following a discussion meeting with NCP organisers at the Rangpur Chamber Building.

Akhtar also said the party will never accept any attempt to rehabilitate Awami League, accusing the party of committing genocide and crimes against humanity.

In response to a question about the NCP's relationship with

# River land grabbed for farming

Locals have allegedly been encroaching on the Rabnabad river in Patuakhali's Galachipa upazila to cultivate watermelon.

During a recent visit to the area near the Galachipa launch terminal, this correspondent observed that a vast stretch of the riverbank had been elevated using soil extracted from the riverbed and riverbank areas to grab the river's land.

Watermelon cultivation has already begun on parts of the occupied land.

Some residents alleged that the illegal grabbing is being carried out without any obstruction from the upazila administration. Sources claimed that some officials of the upazila land office are facilitating the occupation in exchange for bribes.

Saeed Talukdar, a local farmer cultivating watermelon on a portion of the grabbed land, said his wife, Tasmin Akhter Jhumur -- an elected member of Golkhali Union Parishad -- had received a temporary lease of three acres from the upazila administration.

He admitted to elevating the

riverbank to protect the crops from tidal water but could not provide any document or details regarding the lease.

Another farmer said they had to pay the land office to cultivate watermelon on the riverbank area but declined to

mention the amount paid as bribe.

Although some areas were reclaimed at the time, illegal occupation resumed in recent

In 2009, after a report titled "Markets being built on grabbed river land in Galachipa" was published in a national daily, the then shipping minister directed the ministry secretary to take action against illegal occupation of the Rabnabad river's land. A subsequent

years, this time under the guise of temporary leases.

Harun-or-Rashid, surveyor of Galachipa upazila land office, claimed they were unaware of the soil extraction or elevation of the riverbank.

He said the lease permissions for plots in Badarpur mouza, granted to Abbas Hawladar, Dipankar, Sohel Shah Kamal

## Devotees take part in Ashtami Snan ritual

Thousands of Hindu devotees yesterday performed Ashtami Snan, a ritual of bathing in the holy waters of the Brahmaputra river in different districts, including Narayanganj, Kurigram, and Mymensingh.

According to Hindu mythology, taking a dip in the Brahmaputra during a specific lunar period purifies sins and earns religious merit.

The Ashtami Snan is celebrated on the eighth day of the lunar month, which falls in the Bangla month of Chaitra. This year's bathing time began on Saturday at 2:08am and ended at 12:45am on Sunday, according to the Hindu Tithi.

In Langalbandh of Narayanganj, devotees from all over Bangladesh, as well as from countries like India, Nepal, and Bhutan, joined the religious event, seeking absolution from sin.

The organisers said bathing arrangements were made at twenty ghats stretching over a three-kilometre area across Bandar and Sonargaon upazilas.

This year, an estimated one million people attended the event, said Joy K Roy Chowdhury, an adviser of the Langalband Bathing Festival Celebration Committee.

Visitors brought with them ritual ingredients such as flowers, grasses, fruits, Tulsi leaves, and mango leaves, as they bathed in the Brahmaputra throughout the day.

## 2 SSC examinees die after Eid day crash

The two SSC examinees, who were injured in a road accident on the Eid day in Pabna, died yesterday.

The victims are Nayon Hossain, 17 and Md Hriday Hossain, 17.

They were students of Dorga Bazar High School, said headteacher Rafiqul Islam.

This year's SSC examination is scheduled to begin on April 10.

The two were traveling on a motorcycle on the Eid day. At one point, they lost control over the bike and hit a tree beside Sarabaria Road at Atghoria upazila, said Shafikuzzaman Sarkar, officer-in-charge of Atghoria Police Station.

Nayon was taken to Dhaka Medical College Hospital while Hriday was admitted to Rajshahi Medical College Hospital.

Nayon succumbed to his injury around 12:30am and Hriday around 2:00am, said the OC, quoting family members.

## Two found dead

Police recovered two bodies in Tangail yesterday.

In Sakhipur upazila, a man was murdered allegedly by his wife over a family dispute.

Jewel, 38, was reportedly struck with a piece of wood by his wife Tania, 35, during an argument over his extramarital affair. He died on the spot.

Police recovered the body and arrested Tania from their house. Jakir Hossain, officer-in-charge of Sakhipur Police Station, said Jewel's father filed a murder case in this connection.

In Kalihati upazila, police recovered the body of a woman from a farm land in Majhipara village.

Foyjul Nechoha, 70, went missing since morning. Later, locals spotted her body in the crop field. Kalihati Police Station OC Abul Kalam Bhuiyan said the body has been sent for an autopsy.

## KULAURA HEALTH COMPLEX

# Only two doctors for 5 lakh people

Kulaura upazila, the largest in Moulvibazar district, is grappling with a shortage of medical professionals at its upazila health complex, the only reliable healthcare facility for its population of five lakh.

Despite the overwhelming demand, the hospital operates with just two doctors.

The shortage has led to chaotic and insufficient healthcare delivery, with patients waiting in long lines for basic treatments.

The lone paediatric specialist, Dr Abu Bakar Naser Rashu, visits only twice a week. In his stead, Upazila Health and Family Planning Officer Dr Md Zakir Hossain has been attending to paediatric cases.

The situation is further exacerbated by the lack of medical officers, with only a few on duty to attend to patients in just two rooms of the hospital.

Only three of the ten specialist doctors are currently working at the hospital. The lack of a full-time gynaecologist,



anaesthesiologist, and cardiologist, among others, has left patients without crucial medical guidance.

Many are forced to travel to distant hospitals for more advanced care, resulting in significant financial burdens for families.

During a recent visit, this correspondent saw a crowd of women gathered in front of the outpatient department. They were trying to see who would enter the doctor's chamber first.

The waiting women said they had been waiting since morning to see a doctor for

gynaecological problems. Since there was no gynaecologist, a female medical officer was seeing the patients.

Rupali Begum from Sharifpur said she had been waiting since 8:00am. The doctor came around 10:00am and started seeing patients. Lata Begum, Morjina Khatun and many others, who had come from far away like her, had been waiting in front of the room since morning for treatment.

Dr Md Zakir Hossain, the upazila health officer, said despite the challenges, they

## Schoolboy beaten to death

A schoolboy was beaten to death allegedly by a man and his son at Old Ferry Ghat Balu Point of Hossainpur in Sirajganj town on Friday afternoon.

The deceased was identified as Md Ashiq Hossain, 15, a 10th-grade student and son of Dulal Hossain of the Hossainpur.

Sirajganj Sadar Police Station OC Md Humayun Kabir said Ashiq went to bathe at a water pump owned by Al-Amin around 4:00pm on Friday.

Al-Amin and his son Rifat, 15, of Hossainpur Bou Bazar area, reportedly forbade him from doing so, triggering an altercation.

Ashiq was struck in the neck with a bamboo stick. He died on the spot.

Following this, Al Amin and his son fled the area.

Upon receiving information, police recovered Ashiq's body from the scene in the evening and sent it to Shaheed M Monsur Ali Medical College Hospital morgue for autopsy.

The body was handed over to the family after a post-mortem yesterday morning. The process of filing a case over the incident is underway, the OC added.
