



## Dhaka seeks 3-month pause on new tariffs

Yunus writes to Trump; govt offers zero tariff facility for another 100 US products

Chief Adviser Professor Muhammad Yunus has requested US President Donald Trump to postpone the imposition of 37 percent reciprocal tariff on Bangladeshi exports by three months.

In a letter sent to Trump yesterday, Yunus made the appeal to allow the interim government time to implement its plan to significantly increase imports from the US, the chief adviser's office said in a statement.

This additional time is necessary for the smooth implementation of this initiative in consultation with US officials, according to the statement.

- Yunus outlines plan to cut trade gap by increasing imports from US
- Planned steps also include removal of tariff, non-tariff barriers
- Govt working on 50% reduction of tariff on US turbines, semiconductors, medical equipment

In another letter to the US Trade Representative (USTR), Commerce Adviser Sk Bashir Uddin said Bangladesh was considering an option to extend the zero tariff facility to 100 US products on top of the 190 already enjoying it.

In his letter to Trump, Yunus outlined a series of steps the government is taking to reduce the trade imbalance between Bangladesh and the US, including the removal of both tariff and non-tariff barriers.

"We are working on 50 percent reduction of tariff on top US export items such as gas turbines, semiconductors and medical equipment," Yunus wrote. "We are also removing an array of non-tariff barriers to US exports."

He added, "We are eliminating certain testing

## Nation rallies against Gaza atrocities

Across Bangladesh, people take to streets in solidarity with Palestinians

Protests swept across the country yesterday as students, teachers, professionals, and activists from all walks of life took to the streets in a nationwide show of solidarity with the people of Gaza, condemning Israel's ongoing military onslaught in Palestine and calling it a genocide.

From the capital to the hills, demonstrators formed human chains, staged sit-ins, and held processions demanding the international community take steps to put an immediate end to the bloodshed in the besieged territory.

The wave of protests followed a global call for strikes under the banner "The World Stops for Gaza," urging educational institutions, offices, and businesses to suspend operations as a sign of protest.

## Govt issues stern warning to vandals

The government yesterday issued a stern warning to individuals involved in acts of vandalism and looting at various business outlets, including restaurants and shoe stores, during the nationwide protest against Israeli aggression in Gaza.

It also ordered the police to arrest those responsible for the vandalism in multiple districts, including Sylhet, Chattogram, Cox's Bazar, Khulna, Gazipur, and Bogura.

## Govt goes big to woo global investors

Four-day investment summit kicks off in Dhaka

The four-day Bangladesh Investment Summit 2025 kicked off yesterday with the view to shining a spotlight on the country's evolving investment landscape to global investors.

As part of the summit, a 60-member delegation from 25 countries was shown the Korean Export Processing Zone (KEPZ) and National Special Economic Zone to showcase the manufacturing facilities in the country.

Kihak Sung, chairman of Youngone Corporation, which manages KEPZ, said that as a private organisation, it can move very quickly.

"We are accountable only to our management, not constrained by multiple layers of bureaucracy. This makes our operations more efficient," he said.

**Bangladesh can outperform regional competitors in attracting and retaining foreign investment, says Kihak Sung, chairman of Youngone Corporation, which manages KEPZ.**

He also cited a successful partnership with a global storage company, where Youngone built facilities at its own cost to accommodate the investor, in an example of proactive investment facilitation that built long-term business ties.

Looking ahead, Sung emphasised the need for joint efforts between the government, financial institutions, and private enterprises to expand value-added exports, especially in the apparel sector.

He expressed confidence that Bangladesh could outperform regional competitors in attracting and retaining foreign investment.

After visiting the EPZs in Chattogram, Yasser Amit, chairman and chief executive officer of Evison Group and ImatrixUSA Inc, expressed strong interest in investing in renewable energy and semiconductors in Bangladesh.

## Bangladeshi banks among most exposed in Asia-Pacific

Moody's blames the country's heavy dependence on RMG exports

Bangladesh's banks are among the most vulnerable in Asia-Pacific to a sweeping hike in US import tariffs, Moody's Ratings said, warning that the country's heavy dependence on garment exports and fragile financial buffers have left its banking sector exposed to rising credit stress.

In a report released yesterday, Moody's said banks in Bangladesh, Vietnam and Thailand will be hit the hardest in the region.

"The higher tariffs are more negative, on a relative basis, for banks in Vietnam (Ba2 stable), Thailand (Baa1 stable) and Bangladesh (B2 negative) because of their economies' higher reliance on exports to the US compared with other economies in the region," Moody's said.

"In these three countries, a moderation in exports to the US will

hurt economic growth, straining loan growth for banks and hurting loan quality," the agency said.

For Bangladesh, the tariff shock comes amid a slowdown in economic growth and persistent weaknesses in the banking system, including poor asset quality and low capital buffers. "US tariffs are now very high for

exports from Vietnam, Thailand and Bangladesh and the first two are more dependent on exports to the US in terms of domestic value added in gross exports. Much higher US tariffs will lower their economic growth, with the resulting strain trickling down to banks," Moody's said.

"For Bangladesh, higher US tariffs will depress the already weak operating environment for banks amid a slowdown in the country's economic growth."

The US has raised average tariffs on Bangladeshi goods to 37 percent, more than tripling the previous rate of 11 percent. The blow will fall squarely on the country's garment sector, which accounts for over 85 percent of total exports and is already grappling with supply chain disruptions and labour issues following last year's political and social unrest.

## Bangladesh's relief team treats 619 in Myanmar

The rescue, medical, and humanitarian relief operations led by the Bangladesh Armed Forces in Myanmar after the devastating earthquake have entered their second week.



The special team, deployed under the directive of the Bangladesh government, remains actively engaged in supporting the quake-affected population.

The Inter-Service Public Relations (ISPR) Directorate disclosed the updates in separate press releases yesterday.

At the request of Myanmar's deputy prime minister, the Bangladeshi rescue team launched operations at the collapsed building of the

requirements, rationalising packaging, labelling and certification requirements and undertaking trade facilitation measures such as simplifying customs procedures and standards.”

These measures, Yunus emphasised, are aimed at creating a more open and predictable trade environment that supports increased US exports to Bangladesh.

The letter did not explain the reason behind choosing a three-month timeframe for the deferral request. Different international media outlets reported that Vietnam has also sought a three-month deferral of the reciprocal tariff on Vietnamese goods.

Trump has remained defiant since unleashing the blitz of levies on stunned countries around the world on April 2, insisting that his policies “will never change” even as markets went into a tailspin.

But his staggered deadlines have left space for some countries to negotiate, even as he insisted he would stand firm and his administration warned against any retaliation, the AFP reported.

In a post on Truth Social yesterday, Trump threatened to terminate talks with China concerning their requested meetings with the US if China did not withdraw its retaliatory tariffs.

He, however, added that negotiations with other countries, which have also requested meetings, will “begin taking place immediately”.

More than 50 countries have sought

talks with Trump to negotiate relief from the punitive tariffs on exports to the US, the White House said Sunday, as trade partners braced for fallout, the AFP said.

Yunus, in his letter to Trump, said that Bangladesh was the first to take “such a proactive initiative”, mentioning the visit of his High Representative Khalilur Rahman to Washington, DC, in February, which indicates Bangladesh’s intent to substantially increase imports from the US.

The chief adviser also said his government executed the necessary steps to launch Starlink, a US-based satellite internet provider owned by billionaire Elon Musk, in Bangladesh.

“This momentum ushers a new era for US businesses in Bangladesh across a number of advanced tech sectors including civil aviation and defence. We will complete the ongoing and planned actions within the next quarter.”

The chief adviser said that Bangladesh, having the lowest tariff on most US exports in South Asia, commits to a zero tariff on American agricultural commodities, as well as on scrap metals.

A key focus of the government’s action on the tariff issue is to significantly increase imports of US farm products, including cotton, wheat, corn and soybean, Yunus said.

The government was also finalising a dedicated bonded warehousing facility in Bangladesh where US cotton

will have duty-free access, he added.

Yunus also said Bangladesh is the first country to enter into a multi-year agreement to import liquefied natural gas (LNG) from the US, and has been exploring further collaboration since Trump lifted the freeze on LNG export permits.

Commerce Adviser Bashir Uddin, in his letter to the USTR, said the US government was planning a long-term LNG deal with the US.

He mentioned that Bangladesh has a 6.10 percent weighted average tariff on US products, where raw cotton and steel scrap face 0 percent and 1 percent tariff, respectively.

He said the government had already held meetings with the trade wing of the US Embassy in Bangladesh to identify trade barriers and “agreed a number of measures to resolve”.

The government also initiated reforms to enhance mutually beneficial trade, he said. The reform initiative includes import policy order, simplification of customs procedure, enforcement of intellectual property rights, and protection of trademarks and patent rights.

The government will encourage US private equity access to healthcare and other service sectors of Bangladesh, he said.

Commerce Secretary Mahbubur Rahman said the government will also accept the US’s reciprocal certification on import of different American food items.

“We are exploring solar and power projects in several economic zones. We also see great potential in developing the semiconductor industry here provided there is robust infrastructure and supportive policy,” said Amit, a New York-based non-resident Bangladeshi.

Kaniz, director of marketing development at China State Construction, expressed interest in Bangladesh’s progress, citing the success of existing foreign ventures.

She plans to report back to her headquarters but acknowledged that final investment decisions would take time. She also flagged the need for more clarity on utility and infrastructure services.

The low labour costs are an attractive proposition, said Kevin Wu of Mega Rich Industries (HK).

Jack He, managing director of MYSKY, praised Bangladesh’s affordable labour market, but he remained undecided due to limited knowledge about long-term business prospects and foreign investment regulations.

Addressing the delegation, Abdulla Al Faruque, project director of the National Special Economic Zone (NSEZ), outlined the benefits offered by the Bangladesh Economic Zones Authority, including land allocation, tax holidays and full profit repatriation.

He highlighted the NSEZ’s strategic location across Mirsarai, Sitakunda and Sonagazi, covering 33,800 acres with strong road, port, and air connectivity.

BEZA’s one-stop service centre currently offers 60 online services to ease the process of setting up and operating businesses, Faruque said, adding that the zone is targeting industries such as garments, steel, leather, electronics and agro-processing.

Over at Intercontinental Dhaka, there were three sessions to highlight the country’s start-up ecosystem in a programme titled “Bangladesh Startup Connect”. About 1,500 delegates attended the sessions.

The government is creating an ecosystem to make business operations in Bangladesh much easier, said Chowdhury Ashik Mahmud Bin Harun, executive chairman of the Bangladesh Investment Development Authority (BIDA).

“What we need to probably continue to focus on as an investment promotion agency of the government is how we create that bridge between the assets we have in the country and the potential liquidity that is available globally,” he said at the opening session.

Not just cheap and trainable labourers, Bangladesh’s utility services are cheaper than in Vietnam, Cambodia, Thailand and Indonesia, he

said.

BIDA is not expecting investments straight away since the summit has been organised to build confidence among investors.

“Sometimes investors express interest, but until the investment is delivered, there is no bridge between the government and the investors, resulting in low confidence among them,” Ashik said.

“We will keep track of all of them individually,” he added.

There were three start-up investment announcements on the first day, said Faiz Ahmad Taiyab, special assistant to the chief adviser for the ICT Division.

The first announcement was made by Incepta, which will invest \$1 million through youth summits and universities as either equity finance, grants or loans.

Besides, the Bangladesh Bank has announced two funds of Tk 800 crore and Tk 400 crore for start-ups, he said, adding that the central bank has been adopting a policy that will remove the obstacles for accessing funds by start-ups.

In addition, there was a positive note on mobilising funds from the budgetary support of JICA as a fund of funds – an investment vehicle that holds shares in other funds rather than in individual securities or private assets.

potentially higher problem loans,” Moody’s said.

Banks in Vietnam and Thailand, while also highly exposed, have slightly more diversified economic bases or stronger credit loss absorbing capacity. Thai banks in particular have longstanding challenges with SME loans but benefit from more robust provisioning.

In contrast, the impact of the tariffs on larger Asia-Pacific economies like China, India, Japan and South Korea is expected to be moderate. These countries either export less to the US relative to GDP or have more diversified industrial bases.

For example, China’s US-bound exports made up less than 3 percent of GDP in 2024. Additionally, Taiwanese chipmakers – some of the

region’s largest exporters – have been exempted from new tariffs.

Australia, New Zealand, Singapore and the Philippines face the lowest additional tariff rates and are expected to see limited financial spillovers.

Across the region, Moody’s expects central banks to respond with interest rate cuts or regulatory relief to cushion borrowers in export-facing industries. But for countries like Bangladesh, the credit rating agency said such moves may not be enough without broader structural reforms.

“The asset quality for RMG and related sectors will deteriorate,” Moody’s said, underscoring the need for policy support and longer-term export diversification to protect financial stability.

## Nation rallies against Gaza atrocities

In different parts of the capital, protesters—many waving Palestinian flags—chanted slogans such as “Free, Free Palestine” and “Stop Genocide in Gaza.” Some carried effigies of Israeli Prime Minister Benjamin Netanyahu and placards criticising the silence of world leaders, particularly those from the Muslim world.

In Dhaka, hundreds gathered near the US Embassy in Gulshan from the morning. A group of students gathered around 1:45pm at the footbridge opposite the embassy and chanted slogans like “Trump-er dui gaaley, juta maaro taley taley” and “Who are we? Who are you? Palestine, Palestine.”

Earlier in the day, a youth-led procession halted traffic in front of the embassy. Police and armed forces personnel were heavily deployed in the area, with officers forming human barricades and checking passers-by.

Around 4:00pm, hundreds of protesters, including students, professionals, and other citizens, gathered on Manik Mia Avenue in the capital. They held Palestinian flags, photo cards, and banners, calling for an end to the destruction of Gaza.

The protest began with a one-hour gathering in front of the parliament building, followed by a march through the avenue. Protesters chanted slogans such as “To stand with Palestine, one must be human” and “Free Palestine”.

Meanwhile, the National Citizen Party’s metropolitan unit held a programme at Shahbagh around 4:00pm.

Member Secretary Akhter Hossen said, “As long as Palestine is not recognised as an independent state and its people do not attain freedom, our oath of independence will not allow any friendship with Israel.”

He called on the United Nations to take steps to stop the war immediately, stating that Netanyahu must be punished for committing crimes against humanity.

“The common people of every country in the world are protesting against the atrocities in Gaza, while the world’s Muslim leaders are still silent. Some of the world’s superpowers are still defending Israel.”

### SCHOOLS SHUT

As part of the movement, academic and administration activities were suspended at several universities. Dhaka University halted classes and closed offices between 9:00am and 11:00am. Students and members of the public, including children, gathered in front of TSC, carrying Palestinian flags and chanting slogans against Israel’s military offensive.

Speaking to reporters, a protester at TSC said, “We are on the streets because the world has forgotten the people of Palestine. We demand freedom for Palestine and the trial of Israeli leaders for war crimes.”

BUET students and faculty formed a human chain on campus. BRAC University students also staged a demonstration in front of their university, holding banners and placards.

Students of Eden Women’s College held a protest march on the college campus in the capital. They chanted slogans like “Free Palestine,” “Stop Brutal Genocide in Gaza,” and “Justice for Palestinians,” while holding placards.

At the University of Asia Pacific, students formed a human chain, while students from private universities across the capital—especially in Bashundhara and Bhatara—participated in protest marches.

Students from Dhaka Medical College, North South University, East West University, and many other institutions joined the movement. Many demonstrators avoided institutional banners, instead waving Palestinian flags and wearing keffiyehs, a symbol of Palestinian nationalism.

Jahangirnagar University suspended all academic and

administrative activities for two hours from 10:00am. It also postponed all classes and exams scheduled for the day. Confirming the suspension, Public Relations Director Mohammad Mohiuddin said it was done in support of the global movement.

Teachers and students of Jagannath University formed human chains and held rallies on campus, calling for a boycott of Israeli products and urging Muslim-majority countries to unite against Israeli aggression.

Speakers at the rally also slammed international bodies for what they termed as “criminal silence” on the Gaza crisis.

### NATIONWIDE UPROAR

In Rajshahi, students, teachers, and staff of Rajshahi University staged a rally from Paris Road around 11:00am, carrying Palestinian flags and banners. They displayed images of US President Joe Biden and Israeli Prime Minister Benjamin Netanyahu, with messages condemning their role in the conflict.

In Chattogram, students from Chittagong Medical College brought out a procession at 11:00am, marching across the campus. Students from Chittagong College, Government Hazi Muhammad Mohsin College, Commerce College, and Hazera Tajul College also joined the movement.

In Narsingdi, thousands of school and college students blocked the Dhaka-Sylhet highway for about an hour, calling for a boycott of Israeli products and the punishment of Israeli leaders.

In Cumilla, students, residents, and political leaders formed human chains and marched through the Pubali Chattera Kandirpar area.

In Chandpur, students from several institutions, including Chandpur Government Medical College and Chandpur Nursing Institute, took to the streets in large numbers. A protest rally was also held at the 250-bed Chandpur Government General Hospital.

In Pabna, Bangladesh Jamaat-e-Islami organised a rally on Abdul Hamid Road in the town centre.

In Pataukhali, thousands gathered near the Circuit House in Jhaukola from 10:00am. The crowd included students, political party workers, professionals, and families.

In Narayanganj, around 10:00am, demonstrators began gathering at the Central Shaheed Minar in Chashara in small processions. They later took to the streets in protest.

In Bandarban, a protest rally took place at the central bus terminal, followed by a protest gathering in front of the Bandarban Press Club. Speakers at the rally called for strong international intervention to immediately stop the Gaza genocide.

The protest rally saw participation from students, members of civil society, social organizations, and people from various walks of life.

In Gazipur, a protest march was held in the Chandana Chowrastra area this afternoon. The march circled various roads in Gazipur.

In Cox’s Bazar, a protest march began around noon from Shaheed Daulat Maidan in front of Cox’s Bazar Public Library, proceeding through Holiday Intersection, Laboni, and ending at Kolatoli.

In Sylhet, thousands of people from all walks of life joined a protest at the Central Shaheed Minar area at 3:00pm.

In Tangail, students of Alokito Hriday School suspended classes and exams. They held a demonstration on the school premises from 9:20am to 1:00pm. Children displayed handmade banners and posters bearing messages such as “The World for Gaza,” “Stop War,” and “Stop Genocide.”

In Bogura, thousands of students and people staged a large protest rally from morning to afternoon, condemning the attacks on Palestinians and demanding a boycott of Israeli products.

The people of Kishoreganj and

Kushtia also organised similar programmes.

Jamaat-e-Islami’s Dhaka Metropolitan North Unit also held a rally and procession in the capital to protest Israel’s attacks and genocide in Gaza.

### VANDALISM MARS PROTEST

Rowdy elements from yesterday’s protests committed vandalism and carried out looting at various business outlets, including restaurants and shoe stores, in multiple districts, including Sylhet, Chattogram, Cox’s Bazar, Khulna, Gazipur, and Bogura.

They tore down billboards and banners, stormed inside, trashed the properties, and looted the products on display. They alleged that those establishments sell pro-Israel and pro-American products.

In Cox’s Bazar, at least five restaurants were attacked in the tourist zone.

Locals said the protest programme began around 12:00pm from the town’s Shaheed Daulat Maidan area and proceeded through Holiday Intersection, Laboni, and ended at Kolatoli.

At one point, a group of unruly protesters carried out vandalism on the pretext of boycotting Israeli products.

Several tourists were reported to have been injured during the vandalism.

Firoz Ahmed, manager of Kacha Lanka Restaurant, said, “There was a 7UP advertisement on our signboard, and they used that as an excuse to vandalise our restaurant.”

Confirming that matter, Cox’s Bazar Sadar Police Station OC Elias Khan said police were deployed during the protest programme and they could bring the situation under control immediately.

In Bogura, riotous elements from the protest vandalised a shoe outlet in the town’s Satmatha area around noon.

Witnesses said a group of people, who were chatting anti-Israel slogans, hurled bricks and stones targeting the store. Within moments, all the windows were smashed.

The incident triggered panic and other shoe outlets in the town were closed following the incident.

Contacted, Bogura Sadar Police Station’s OC SM Moinuddin confirmed the incident.

### GOVT CONDEMNS GAZA GENOCIDE

Besides the citizen protests, the interim government yesterday strongly condemned Israel’s ongoing military assault on Gaza, describing it as a gross violation of human rights. The Ministry of Foreign Affairs issued a statement condemning Israel’s indiscriminate aerial bombardment of civilian areas in Gaza and accusing Israel of attempting ethnic cleansing.

The statement called for an immediate halt to Israel’s military operations, urging the country to adhere to international humanitarian law. Bangladesh also appealed to the international community, especially the United Nations, to take immediate action towards an unconditional ceasefire and ensure the protection of civilians and the unimpeded flow of humanitarian aid to Gaza.

Furthermore, Bangladesh reiterated its support for Palestine’s right to self-determination and its call for the establishment of an independent Palestinian state based on pre-1967 borders, with East Jerusalem as its capital. The country also urged a return to peace talks for lasting stability in the Middle East.

Since October 7, 2023, Israel’s military campaign on the 365 square-kilometre Gaza Strip has left at least 50,695 Palestinians dead and 115,338 injured, according to figures from the Palestinian Wafa news agency.

The United Nations reports that 69 percent of Gaza’s infrastructure has been either destroyed or severely damaged, leading to a humanitarian catastrophe.

## ACC seeks work order details for Salman’s entities

The Anti-Corruption Commission has requested information from health authorities regarding any work orders issued over the past 16 years to entities owned by Salman F Rahman, a former adviser to the prime minister on private industry and investment.

It sought the information “for proper investigation” into various allegations against Salman, including misappropriation and money laundering, during the tenure of the Awami League government.

Although the ACC sent a letter to the health ministry on March 16 requesting the information by March 25, the Directorate General of Health Services – the principal agency under the ministry – only forwarded the request to its subordinate bodies yesterday.

DGHS instructed them to provide information within two days, according to a letter sent by Mohammad Nasir Uddin, its acting director (administration).

According to the complaint, a syndicate led by Salman, who is also the vice chairman of Beximco Group, misappropriated Tk 22,000 crore over vaccine procurement.

On March 19, Beximco Pharmaceuticals Ltd issued a rejoinder to various media outlets, including The Daily Star, rejecting the allegations as “misleading and baseless”.

Salman, a former AL lawmaker, was arrested following the fall of the Sheikh Hasina government amid a student-led uprising related to a murder case. He is currently in jail and facing multiple cases linked to the uprising.

On an average, 22 people were killed each day during the Eid-ul-Fitr vacation across the country, Road Safety Foundation (RSF) said in a report yesterday.

The nonprofit volunteer organisation, which analysed different media reports and also collected accident data from various sources, said 249 people including 41 women and 59 children were killed in 257 road accidents between March 26 and April 5.

## Woman dies as scarf gets entangled in motorbike wheel

A woman died in a road mishap in Dhaka’s Gulshan area early yesterday.

The deceased, Farzana Akter Mim, 30, was on her way home when her scarf got entangled in the rear wheel of a motorcycle she was riding, causing her to fall, said her sister, Fahima Akter.

The incident occurred around midnight near the Gulshan-2 roundabout.

She was rushed to Dhaka Medical College Hospital in an unconscious state around 4:30am, where doctors declared her dead, said Inspector Md Faruk, in-charge of DMCH police outpost.

Hailing from Monoharganj upazila of Cumilla, Farzana lived in a rented flat in Badda’s Natun Bazar area and worked at a beauty parlour in Gulshan.

Her body has been kept at the hospital morgue.

## TK 1.38CR GRAFT Seven ex-officials of Sonali Bank jailed

Eleven individuals, including seven former officials of Sonali Bank Limited, were sentenced to different terms of imprisonment in a case filed over the embezzlement of Tk 1.38 crore.

Of them, seven were sentenced to three years in jail while four were given 10 years’ imprisonment in the case.

Judge Mohammad Zakaria Hossain of the Special Judge’s Court-6 of Dhaka also fined them a total of Tk 1.38 crore, which they will have to pay proportionately.

The seven who were sentenced to three years in jail are Sonali Bank’s former managing director Humayun Kabir, former deputy managing director Mainul Haque, former general managers Noni Gopal Nath and Mir Mohidur Rahman, former deputy general manager Sofiz Uddin Ahmed, former assistant general managers Saiful Hassan and Kamrul Hussain Khan.

The four who were sentenced to 10 years in jail are Khanjahan Ali Sweaters’ Chairman Tazul Islam Molla, Md Abdul Jalil Sheikh and Directors Mir Mohammad Shawkat Ali and Rafiqul Islam.

According to the prosecution, the accused misappropriated Tk 1.38 crore of Sonali Bank’s then Hotel Sheraton branch through forgery.

Following the incident, ACC filed the case against the 11 with Ramna Police Station on January 1, 2013.

## Hilsa haul hits seven-year low

Experts point at climate change, overfishing and navigability issues

Hilsa production in the country fell to its lowest in seven years in the 2023-24 season, according to data from the Department of Fisheries.

Experts have attributed the decline to erratic weather conditions, overfishing, navigability issues, and the growing impacts of climate change.

According to the Barishal Divisional Fisheries Office, hilsa production stood at 5.29 lakh tonnes – around 42,000 tonnes less than the previous year.

In recent years, hilsa yields had shown a consistent upward trend: 5.71 lakh tonnes in 2022-23, 5.66 lakh tonnes in 2021-22, 5.65 lakh tonnes in 2020-21, 5.50 lakh tonnes in 2019-20, and 5.32 lakh tonnes in 2018-19.

Dr Mohammad Abu Kawsar Didar, a scientific officer at the riverine station of the Bangladesh Fisheries Research Institute in Chandpur, said adverse weather last year prevented many fishermen from going out to sea or rivers, resulting in a reduced overall catch.

He also pointed to a navigability crisis along major hilsa migration routes such as the Meghna-Tetulia, Payra-Bishkhali, and Sundarbans regions.

“Hilsa typically prefer water with a depth of over five metres,

but in many of these routes, depth has fallen to two or three metres, obstructing the natural migratory flow,” he said.

Dr Didar said overfishing along these routes has worsened the situation. “There’s a limit to how much hilsa can be harvested sustainably – and we’ve crossed that threshold,” he noted.

Narendranath Biswas, deputy director of the Barishal divisional fisheries office, acknowledged the decline in production, saying fewer hilsa are arriving through the main migratory routes, directly affecting overall yields.

He, however, expressed hope for better catches during the

## One killed in fire at furniture shop

A man was killed and 17 others, including women and children, suffered injuries or fell ill as a fire broke out at a furniture shop on Nazimuddin Road in Dhaka’s Bangshal area early yesterday.

The deceased was identified as Amin Uddin, 65, said police.

Md Faruk, in-charge of the DMCH police outpost, confirmed that Amin Uddin died while undergoing treatment at Dhaka Medical College Hospital.

The fire originated in the shop on the ground floor of the five-storey building at around 4:10am. On information, seven firefighting units rushed to the spot and managed to douse the blaze after an hour’s effort, said Md Shahjahan, duty officer at control room of Fire Service and Civil Defence.

The firefighters rescued 18 people from the building, of whom 12 were provided first aid on the spot, while six others were sent to DMCH and the National Institute of Burn and Plastic Surgery, he added.


The cause of the fire could not be known immediately.

In a letter sent to the secretary of the health services division on March 16, the ACC mentioned that a three-member team is investigating complaints involving Salman.  
The allegations against him include stock market fraud, manipulation of placement shares, embezzlement of thousands of crores of taka from shareholders through deception, securing loans amounting to approximately Tk 36,000 crore from various banks using undue influence, and misappropriating these funds, as well as laundering thousands of crores of taka abroad.  
To facilitate a proper investigation into these allegations, the ACC sought records and documents showing whether any work orders were issued to any

entity owned by Salman between 2008 and 2024, according to the document.  
The DGHS yesterday issued a letter to all of its subordinate bodies, including the Central Medical Stores Depot, the National Institute of Preventive and Social Medicine, the Institute of Epidemiology, Disease Control and Research, the Centre for Medical Education, all specialised hospitals, and all medical college hospitals.  
The same letter was sent to its directors and line directors.  
When asked why the letter was sent yesterday, the DGHS director said they received it from the health ministry on Sunday. "After receiving the letter, we issued the instruction today [Monday], asking for all relevant information within two days," he added.

since we netted more than two maunds in a single trip. With river catch dwindling, we're now forced to go deeper into the sea—facing greater risks and more accidents," said Alauddin Mia, a fisherman from Bhola Sadar upazila.  
Ibrahim Majhi, a fisherman from Kuakata, said, "Sometimes, we return empty-handed. Spending over Tk 2 lakh per trip has pushed us deep into debt."  
Fishermen have called for stricter enforcement against illegal nets and intensified monitoring to protect jatka and ensure sustainable hilsa yields.  
Meanwhile, prices of hilsa in Barishal markets have soared, driven by dwindling supply and increased demand ahead of Pahela Baishakh.  
At Port Road Market — one of the largest hilsa trading hubs in the south — sellers said prices have risen sharply as wholesale traders hoard fish in anticipation of festival demand.  
"Demand has spiked as hotels and restaurants in major cities like Dhaka and Chattogram have sent agents to secure hilsa for their Baishakhi menus. Whatever little we get isn't even enough to meet local demand. As supply shrinks, prices are shooting up," said Zahir Sikder, a fish trader at the market.  
Hilsas weighing around 500 grammes are now selling for around Tk 1,100 per kg, while larger ones

over 1kg are going for over Tk 3,000 per kg — more than double the rate a couple of weeks ago. Prices of smaller hilsa (200–300g) have also jumped by at least 50 percent compared to just before Eid-ul-Fitr.  
Barishal District Fisheries Officer Ripon Kanti Ghosh said fishing is currently banned in key spawning grounds in Hizla, Mehendiganj, and Bhola until April 30.  
"This, along with jatka conservation drives, significantly reduced market supply, causing the recent price hike," he added.

Prof Riaz said the commission aims to complete its mandate by mid-July.  
So far, 29 political parties have submitted their opinions on reform recommendations, with dialogues commencing before Independence Day.  
Talks were held with four parties prior to Eid-ul-Fitr.  
"We hope to complete the first round of discussions by the first week of May. The second phase is expected to begin in the second week of May," he said.  
"We expect to identify areas of agreement, while in some areas there might still be differences or need for clarification. But we will continue discussions within that timeframe," he said.  
The commission's work builds on proposals drawn from five earlier reform bodies: the Constitution Reform Commission, Public Administration Reform Commission, Electoral System Reform Commission, Judiciary Reform Commission, and the Anti-Corruption Commission.

To gather feedback, the NCC had earlier sent a spreadsheet of 166 proposals to 38 political parties, requesting responses by March 13. Among those, the AB Party submitted detailed feedback, agreeing with 108 proposals, partially agreeing with 26, and disagreeing with 32.  
AB Party Chairman Mujibur Rahman Manju said, "We appreciate the proposals of the Consensus Commission. Even on issues where there are partial agreements or disagreements, today's discussion helped clarify positions."  
Responding to criticism that the NCC's questionnaire resembled a multiple-choice format, Manju said, "We didn't find it to be MCQ-style. There was enough space to express all kinds of opinions. Therefore, it shouldn't be underestimated."  
He emphasised the importance of both formal and informal dialogue. "We are not rigid in holding onto our views — we welcome any discussion based on logic and reasoning," he said.  
Commission members Safar Raj Hossain, Justice Emdadul Haque, Iftekharuzzaman, and Chief Advisor's Special Assistant Monir Haider were also present at the meeting.  
The AB Party delegation was led by Manju and included 13 members.

the 15-day Eid-ul-Fitr vacation last year, 367 people were killed, averaging 24 fatalities per day, while 20 casualties per day were recorded over the 14 days of vacation in 2023.  
RSF noted that, according to media reports, 553 individuals were injured in road accidents this year; however, the actual number of injuries could exceed 2,000, with 571 injured people admitted to the National Institute of Traumatology and Orthopaedic Rehabilitation (NITOR) in just two days during Eid.  
The report said the highest number of fatalities involved motorbike drivers or pillion, with 106 killed in 114 accidents.

Besides, 49 were three-wheeler passengers, 39 pedestrians, 18 private car or microbus passengers, 14 bus passengers, 10 locally-made vehicle passengers, nine truck or pick-up van or tractor or trolley passengers, and four bicycle riders.  
It said 32 of the deceased were either drivers or their assistants of various vehicles.  
During the vacation, 13 people died and 15 others were injured in six waterway accidents. Besides, 12 people died and eight were injured in 17 railway accidents.  
The report outlined that out of the total accidents, 68 were head-on collisions, 113 were due to drivers losing control, 41 involved running over pedestrians, and 11 involved collisions with other vehicles from behind.  
Accidents occurred on various roads, with 87 on national highways, 98 on regional highways, 43 on rural roads, and 29 on urban roads. A total of 408 vehicles were involved in accidents, including 119 motorbikes, 88 three-wheelers, 78 buses, 29 trucks, and 21 locally made vehicles.  
The report found that the highest percentage of

accidents, 26.84 percent, occurred in the afternoon, followed by 23.34 percent in the morning, 21 percent at noon, 17.5 percent at night, 8.17 percent in the evening, and 3.11 percent around dawn.  
Dhaka division saw the highest number of fatalities, with 62 deaths in 74 accidents, while Sylhet division recorded the lowest, with six deaths in seven accidents. District-wise, Chattogram saw the highest fatalities, with 31 people killed in 18 accidents. In the capital,

seven people were killed, and 48 were injured in 31 accidents.  
The report identified reckless motorbike driving by teenagers and young adults as a major contributing factor to the accidents, noting that 57 percent of motorbike accident victims were aged between 14 and 20.  
Other contributing factors included faulty vehicles, speeding, unspecified wages and working hours, drivers' lack of skills, physical and mental illness, the

presence of slow-moving vehicles on highways, violations and lack of knowledge of traffic rules, poor traffic management, the Bangladesh Road Transport Authority's lack of capacity, and extortion in the transport sector.  
In its recommendations, RSF suggested creating more skilled drivers, establishing fixed working hours and wages for drivers, increasing the capacity of the BRTA, strictly enforcing traffic rules, and eliminating extortion in the transport sector.

# 3 years on, 4 key bridges remain incomplete

Despite the passage of official deadlines, construction of four key bridges on the Kalihati-Borachona and Dhalapara roads in Tangail remains incomplete, leaving thousands of residents to suffer daily.

The unfinished infrastructures -- meant to improve road connectivity and ease local transportation woes -- have instead become symbols of neglect and mismanagement.

Locals, commuters, and transport workers are blaming both the contractors and the authorities for the delays, expressing frustration over what they see as a lack of accountability and poor quality control.

In the 2021-2022 fiscal year, four separate contracts were awarded to build bridges at a combined cost of nearly Tk 25 crore. The projects were located in Kalihati's Betdoba (Tk 8.6 crore), Haripur (Tk 9.24 crore), and Rajafair (Tk 2.68 crore), as well as Ghatail's Khakuriya (Tk 4.21 crore).

The most glaring delay is seen in the Khakuriya Bridge in Ghatail's Deopara area, which remains incomplete nearly three years after the initial deadline.

Local residents from over 40 villages have been forced to rely on a deteriorated diversion road, enduring daily hardship.

The Local Government Engineering Department (LGED) awarded the contract to Dhaka-based SE Sadia & Samia (JV) in September 2021, with the project supposed to be completed by March 2022.

Locals allege the firm subcontracted the work to a local contractor, who

only worked for a few months before abandoning the site.

"The contractor hasn't visited in months. People and vehicles are suffering as they struggle to use the damaged diversion road," said Liton Miah, a local resident.

Drivers of CNG auto-rickshaws, battery-run three-wheelers, and small trucks echoed similar frustrations.

Ghatail Upazila Engineer Fazlur Rahman admitted the delay was due to the contractor's negligence but said

efforts are underway to resume and complete the project soon.

Meanwhile, a concrete bridge over the Jhenai river in Kalihati's Betdoba area -- meant to replace a partially damaged bailey bridge -- also remains unfinished. The 90.06-metre-long PSC girder bridge was funded by the World Bank and the government with a Tk 8.06 crore budget. Construction was expected to be completed by February 2023.

"Thousands of people are suffering

# 1 dead, 44 hurt in Bagerhat building fire

A woman died and 44 others were injured as a fire broke out in the five-storey Maisha Plaza in Bagerhat's Chitalmari upazila yesterday.

The deceased, Anita Roy, 40, a house help, died from smoke inhalation. The body has been kept at a hospital, said Shahadat Hossain, officer-in-charge of Chitalmari Police Station.

The fire started on the ground floor around 8:30am and spread rapidly.

Md Abu Bakkar Zaman, assistant director of fire service in Khulna, said eight firefighting units from Chitalmari, Bagerhat, Gopalganj, and Khulna brought the fire under control around noon.

The fire likely originated from an electric short circuit in a showroom on the ground floor, he added.

Of the injured, four were in critical condition and transferred to Khulna Medical College Hospital, while the rest received treatment at Chitalmari Upazila Health Complex, said Dr Mukti Biswas, resident medical officer of the health complex.

The building, owned by a Brunei expatriate, housed showrooms on ground and first floors, branches of several banks and an insurance company on second floor, a clinic on third, and residential flats on upper floors.

Ahmed Kamrul Hasan, deputy commissioner of Bagerhat, visited the spot.

# Woman found dead in Faridpur, husband held

Police recovered the body of a woman from her home in Dhormohati Dakshinpara village under Boalmari upazila in Faridpur on Sunday.

The deceased was Riya Begum, 24, wife of Mahfuzur Rahman of the village.

Police arrested Mahfuzur, 30, in this connection.

According to police and family sources, the couple had been living in Narayanganj for the past six months, where Mahfuzur works for a pharmaceutical company.

They returned to their village home to celebrate Eid. At the end of the Eid holidays, Mahfuzur informed Riya that he would return to Narayanganj alone and leave her at the village home. This led to a quarrel on Sunday afternoon.

Later that day, Riya's body was found hanging from a ceiling beam in their house.

Md Hasan, Riya's maternal uncle, claimed that her death was not a suicide.

Mahmudul Hasan, officer-in-charge of Boalmari Police Station, said the body was sent to Faridpur Medical College Hospital morgue for autopsy yesterday.

"Based on a complaint lodged by the victim's father, her husband has been arrested and sent to jail through court," the OC added.

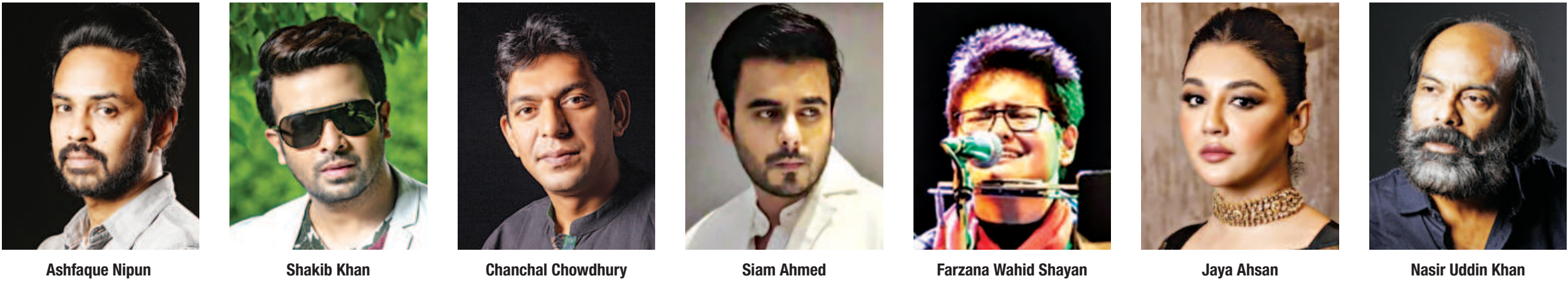

Can any of us escape responsibility for the ruins of Palestine? ...Right after Eid, they were plunged into hell—will the world not take responsibility for that? Chanchal Chowdhury shared two pictures—one of a child sitting alone in the rubble of destroyed homes, and another showing people burning in the continuous bombardment and explosions in Gaza. He wrote, "Endangered civilisation... Endangered humanity."

Actor Abdun Noor Shajal wrote, "Where is humanity? Can these really be the actions of human beings? Please support Gaza."

Shahnaz Khushi wrote, "In the name of acquiring knowledge for civilisation, humanity has caused the most harm to itself! Ah, life!"

Noted director Ashfaq Nipun wrote: "Two videos. In one, a child in Gaza is crying out, comforting another child. In the other, a child sits amidst the rubble in Gaza, tears in their eyes, eating something while crying again. May the

curse of these two children's suffering bring an end to the wrongdoers! May the final consequences of oppression be witnessed by these two children, along with millions of other oppressed people of Palestine."

Asked about the changes, the official said he could not provide details without the draft being approved first.

However, he mentioned that the use of posters by candidates campaigning in the next national election would be banned.

He said the decision was in line with the Election Reform Commission's proposal.

"We have incorporated almost all the proposals of the Election Reform Commission into the draft."

Asked whether political parties were engaged while preparing the draft, the EC said, "We will sit with stakeholders on a later date. The situation will guide us on what needs to be done."

Currently, there is a code of conduct for political parties and candidates. However, the EC has taken the initiative to revise it and formulate a new code of conduct.

Ministry of Foreign Affairs in Naypyidaw. Over the last two days, they have recovered crucial official documents and other valuable items from the debris.

The rescue team comprises members from the Bangladesh Army's Corps of Engineers, along with personnel from the navy, air force, and Fire Service and Civil Defence. Initial assessments by the engineering team confirmed that the building sustained severe structural damage due to the 7.7 magnitude earthquake, causing parts of it to collapse entirely.

Meanwhile, the Bangladesh Medical Assistance Team continued providing healthcare services in Naypyidaw. On Sunday, medical teams operated in three hospitals — the 50-bed Zabuthiri Township Hospital, the 100-bed Hospital, and the 1,000-bed General Hospital.

So far, Bangladeshi medical teams have treated 619 patients, including 162 yesterday, four of whom underwent complex surgeries.

The humanitarian mission will continue in coordination with Myanmar's local administration and relevant authorities, the ISPR said.

While responding to a query about holding the election by December, the EC said, "Yes, we do have a plan for when and what we will do. These meetings we are holding — this is also part of the planning."

About the use of social media in the days leading up to the election, he said, "We have proposed measures to keep rumours under control during the election period."

Regarding the April 20 deadline for parties to apply for registration, the EC said, "There has not been any decision to extend the deadline. However, we are prepared to facilitate parties seeking registration. So far one party has applied, while others are in the process of doing so."

the death toll from the earthquake at nearly 3,500, while 4,850 people were injured and another 220 are missing. The disaster caused severe flood, water, shelter, and healthcare shortages across multiple regions.

The Bangladesh government, under the direction of Chief Adviser Muhammad Yunus, promptly launched a humanitarian relief effort after the powerful earthquake struck Myanmar on March 28, the ISPR said.

On March 30, two transport aircraft from the Bangladesh Army and Bangladesh Air Force carried 16.5 tonnes of emergency relief to Yangon, including dry rations, clean water, oral saline, tents, hygiene products, and other essential supplies.

A second batch of assistance was sent to Naypyidaw on April 1. This included 15 more tonnes of relief supplies, a medical team equipped with emergency medicines, and a specialised rescue team with advanced equipment, according to the ISPR.

The 55-member support team, led by Colonel Md Shamim Iftikhar of the Bangladesh Army, includes 34 rescue personnel (from the Army, Navy, Air Force, and Fire Service) and a 21-member medical team, comprising military doctors and civilian medical specialists.

## Proper steps needed to handle US tariffs

Bold diplomacy, united efforts can help avert the crisis

We welcome the government's initiative to send two letters to the US administration—one to President Donald Trump and another to the US government's lead trade negotiation office—in response to its new "reciprocal" tariff regime imposed on all its trading partners. According to a report by this daily, the letters will outline policy measures to reduce bilateral trade imbalances that triggered the levying of a 37 percent tariff on imports from Bangladesh. This comes amid fears that the new policy, effective from April 9, may strike a blow to our export-based economy, particularly the garments sector, for which the US is the single largest market. As the world rushes to the negotiating table to deal with this economic setback, we must do the same to protect our industries and retain our competitiveness.

While talking to *The Daily Star* following a high-level meeting at the finance ministry, government officials and industry leaders appeared optimistic that if proper measures are taken, Bangladesh may not only weather this storm but also turn the challenge into an opportunity to diversify exports, streamline trade practices, and strengthen its position in the US market. This confidence comes partly from the fact that most regional trade rivals of Bangladesh face a heavier blow. In 2024, Bangladesh shipped \$7.4 billion worth of garments to the US, making it the third-largest apparel supplier after China and Vietnam. Now, under the new US policy, China's total apparel tariff could reach 65.5 percent, while Vietnam's may rise to 57.5 percent. However, there remains doubt about whether the 37 percent tariff imposed on Bangladesh will replace existing duties or be added on top of them. If it is an additional tariff, the total duty on our garments could rise to 48.56 percent—up from the current average of 11.56 percent. We, therefore, must prepare for the worst-case scenario, although we will not know for sure until April 9.

Our response must be swift, strategic, and with the broader interests of the nation, including workers, in mind. One strategy that could prove effective is requesting a delay in the implementation of the new tariffs. Vietnam has reportedly already sought at least 45 days of relief from the US to allow room for negotiation and adjustment, even offering to reduce all tariffs on US imports to zero. Bangladesh should not shy away from making similar moves to adjust trade balances. While the commerce adviser has said that a deferral is unlikely at this stage, persistence may lead to rewards. Even a limited extension could give our exporters time to reorganise and adjust pricing strategies.

In this regard, we may also consider engaging experienced US-based lobbyists to support our case. Experts have also stressed the importance of expanding US imports of goods and services, broadening our export base beyond RMG, expanding exports to other markets beyond the US, and removing all tariff and non-tariff barriers to encourage greater bilateral trade.

## Endless loss of lives on the roads

Govt must make greater efforts to ensure road safety

We are deeply saddened by the tragic loss of lives in road crashes during the Eid-ul-Fitr holidays. According to data from the Bangladesh Road Transport Authority (BRTA), during the eight-day vacation from March 28 to April 4, a total of 132 people lost their lives and 208 were injured in road accidents across the country. Unfortunately, such crashes and fatalities during Eid vacations have become a recurring feature over the years.

While the government deserves some appreciation for its efforts to make Eid journeys smooth and hassle-free for home-bound people this year, clearly, not enough was done to prevent road crashes. While ad-hoc measures cannot fully prevent road crashes during mass movements, we believe some steps could have been taken to secure accident-prone areas on the highways. For instance, the Chunati Jangalia area on the Chattogram-Cox's Bazar highway—reportedly the most accident-prone spot along this route—witnessed three major crashes, which could have been averted had preemptive measures been taken. Similarly, there are numerous known spots on our highways where road accidents frequently occur. Implementing safety measures in these areas during Eid could have helped save precious lives.

It is heartbreaking to think of the family that was traveling to Cox's Bazar to celebrate Eid but tragically lost their lives—all five of them—in a devastating accident on the Chattogram-Cox's Bazar highway. Or think of the family of the police constable who was on his way to visit his pregnant wife but never made it. Such tragedies must not be normalised. The authorities and transport leaders must take effective measures to prevent this annual scenario.

Previously, we saw how the Awami League regime consistently neglected the issue of road safety and bowed down to pressure from transport owners and workers. While numerous infrastructural development projects were undertaken during its tenure to enhance road connectivity nationwide, road safety was regrettably sidelined. Thus, over the past 15 years, public transport became one of the most corrupt and unregulated sectors, with the anarchy on our roads increasing significantly.

We hope the interim government will take decisive steps to regulate this sector and enforce the RTA-2018 without succumbing to any external pressures. Establishing a dedicated commission to implement much-needed reforms in the sector should be a priority. Without a comprehensive overhaul of the entire system, achieving road safety will remain an unattainable goal.

# The golden rule in recovering stolen assets

In 1972, when Bob Woodward was investigating the Watergate scandal, he was not getting any leads. He got a breakthrough from a secret informant with the pseudonym "Deep Throat," saying "Follow the money." In 2005, the identity of "Deep Throat" was revealed—it was Mark Felt, an FBI special agent. Mark passed away in 2008, but his advice to Bob Woodward became a golden rule in uncovering major crimes involving huge amounts of money.

Mark Felt's rule is still relevant to the question of laundered money from Bangladesh and its recovery. In this respect, "time is of the essence"—because the more time passes, the more difficult it becomes to "follow the money." Any laundered money travels very fast, particularly in this digital age. It moves to various destinations and takes different forms—both tangible and intangible. So, after a while, the colour of the money gradually fades, and it simply becomes very difficult to track and identify laundered money.

One critical question is: how big is the amount of money laundered from Bangladesh? Estimates vary. However, the White Paper on the state of the Bangladesh economy indicates that Tk 28 lakh crore was laundered between 2009 and 2023—equivalent to \$234 billion. This is just an indicative figure, based on various sources and assumptions. The ultimate point is that the sheer scale of laundered money from Bangladesh is simply huge. After it left the country, the money was used to buy homes or other tangible assets in Dubai, UAE, UK, Malaysia, and so on.

The million-dollar question is: how can Bangladesh recover the laundered money that has crossed its borders? Let us make it clear at the very outset that the recovery process is both complex and time-consuming. The complexity arises on both financial and legal fronts. The process often starts with identifying unusual and suspicious transactions, which can be done through anti-money laundering protocols. Authorities trace the funds through financial records, such as bank accounts, wire transfers, and export-import invoices, which requires

forensic financial investigation to uncover how money was laundered. The detection and investigation of laundered money require both bilateral and international cooperation. For example, governments use Mutual Legal Assistance Treaties to request assistance from foreign governments in gathering evidence, freezing accounts, or tracing assets. With cooperation from foreign countries, the laundered money can be temporarily frozen to prevent further movement. International anti-crime organisations like Interpol can be involved in the investigation. International investigation firms

are sometimes engaged in evidence gathering and investigations.

Next comes the legal action. Legal action is initiated against those involved in money laundering, both in the country of origin and the country of destination. The legal action involves charges of money laundering, fraud, or other related crimes. Along with criminal charges, civil lawsuits may also be initiated. But two issues are critical in this respect. First, three basic points need to be established: one, in the country of origin, wealth was accumulated illicitly; two, wealth was taken out of the country illegally; and three, the wealth entered the country of destination illegally. Second, before

For example, the destination country may only be interested in whether the money has entered its borders legally, irrespective of where and how it was accumulated and how it left the originating country. This reflects that the destination country might be more interested in incoming resources. This may impede the recovery process.

Additionally, if the funds were settled in tax havens or offshore banking, the recovery process becomes more complex. Similarly, complexities may arise if the laundered money is turned into tangible assets such as houses. It has been found on many occasions that legal firms engaged by money-laundering victim countries to

detect, trace, and recover laundered money have been bribed or paid large sums by those engaged in money laundering.

Questions are often asked if laundered money from different countries have ever been recovered. Two observations should be put forward before answering this question. One, there are positive examples where certain countries were able to recover laundered money. But there are also negative examples. Second, till now, no country has been able to recover the full amount of laundered money, so the success story is only partial.

Angola is often cited as a positive example, where \$5 billion was recovered through various means. It represents part of the billions of dollars laundered by the son of a past president of the country, Jose Eduardo dos Santos. In fact, about \$3 billion of the \$5 billion was willingly returned by a friend of the president's son. In Nigeria, during the rule of Sani Abacha, an estimated \$5 billion was looted and laundered abroad. After extensive legal proceedings and cooperation between Swiss authorities, the World Bank, and the Nigerian government, \$500 million was recovered in 2004. In 2020, a further \$300 million was agreed to be repatriated from the US. Other recoveries were made in various countries, including the UK and Liechtenstein, bringing the total recovered to \$1.3 billion. In Malaysia, Malaysia Development Berhad was involved in laundering \$4.5 billion through complex schemes. In 2020, the US Department of Justice reached a settlement with Goldman Sachs, which agreed to pay \$2.5 billion directly to Malaysia for its role in the scandal. US authorities also recovered over \$1 billion in assets tied to Malaysia Development Berhad.

Money laundering is a sensitive issue. Recovery is neither costless nor easy. It will take time. People should surely be informed about the progress as well as the problems of the recovery process, but they should not be given any false notions about the timing or the extent of the recovery. Whatever success Bangladesh has in recovering the laundered money, the issue needs to be pursued, irrespective of time and cost, because it has a moral dimension. When the culprits are brought to justice, it will send a strong signal to everyone that nobody can get away with looting national wealth.

# The draft Renewable Energy Policy 2025 needs revision

The long-awaited draft of the new Renewable Energy Policy (REP) 2025 was published in February, inviting suggestions and advice for refinement. It promises generation of 20 percent (6,145 MW) of electricity from renewables by 2030 and 30 percent (17,470 MW) by 2041. However, this estimation is based on the overstated electricity demand forecast from the Integrated Energy and Power Master Plan (IEPMP). As per a demand projection by the Centre for Policy Dialogue (CPD), 20 percent renewable electricity in 2030 is 5,600 MW and 30 percent is 10,500 MW. Thus, the target of the draft policy is ambitious on the surface.

In 2008, Bangladesh set a modest target: 10 percent electricity from renewable sources by 2020. That deadline came and went. Even in 2025, the country barely achieved around five percent of renewable capacity. Now, the draft policy expects us to believe that in just six years, we will quadruple that share. China, a global leader in renewables, has set a target of achieving 25 percent non-fossil fuel by 2030. This raises the

question: does Bangladesh—without the same resources, infrastructure, or investment as China—truly believe it can aim for a similar target?

The glaring flaw of the draft policy is the omission of a fossil fuel phasing-out strategy. The UK agreed on a coal phase-out by 2024. In Germany, a law schedules a coal phase-out by 2038 at the latest. On the other hand, Bangladesh government continues to promote conventional fossil fuel sources, and without a phase-out strategy, the renewable energy target seems like a mere political statement.

The draft policy lacks synchronisation. While its goals are set based on the estimations from the IEPMP, it should be noted that IEPMP emphasised natural gas, LNG, and nuclear power rather than renewable sources. Besides, the draft policy talks about increasing the "green energy" share in the energy mix but promotes many renewable sources that are not green. The policy assigns the Sustainable Renewable Energy Development Authority (SREDA) the responsibilities for overseeing, developing and implementing renewable programmes, but it provides the Bangladesh Energy Regulatory Commission the licensing authority, thus creating a bureaucratic maze.

The policy is deficient in adequate financing mechanisms. It speaks of a Sustainable Energy Development Fund, yet only in whispers, using wordings such as "may" be established, "may" be implemented. These words suggest a language of hesitation, not commitment. It also mentions Bangladesh Bank and Infrastructure

Development Company Limited. However, financing from banks and non-bank financial institutions is not mentioned. Nothing is mentioned about incentives for foreign investors either. The truth is that the policy did not lay out any real financial schemes to generate the billions of dollars necessary for this shift. Where will that money come from in a country where too many power subsidies are already

weighing the economy down?

There are several other areas where the policy requires improvements. In Bangladesh, industries are ascribed for the majority of electricity demand. Although the draft policy has encouraged rooftop utility-scale solar projects, it does not provide any measures for solar adoption for heavy manufacturing industries. Besides,

the policy uses indecisive language with regard to several incentives. For instance, "the government *may* consider waivers for EVs," "stamp duty *may* be exempted," and "production-linked incentives *may* be provided." This lack of clarity creates uncertainty for stakeholders and could hinder investment and industry participation.

If Bangladesh wants to transition to a sustainable energy future, REP 2025 must undergo critical revisions. First, it must re-evaluate and set targets based on proper estimations. Secondly, strong and well-thought financing mechanisms and incentives for foreign direct investments must be introduced. Besides, it should include a phase-out strategy. Additionally, to accelerate the industrial renewable energy integration, it should also create financial incentives for off-grid solar adoption in manufacturing zones. To improve coordination, it is recommended SREDA be assigned full licensing authority over renewable energy projects. In terms of providing incentives, it must remove ambiguous wording and use more definitive language, such as "shall" or "will" to clearly establish the government's commitments. It has to actively and judiciously promote grid modernisation and improvement of renewable energy storage capacity.

The draft REP 2025 does not have enough necessary structural support, financial backing, and clear implementation strategies to attain the envisioned targets. Without critical revisions, the draft policy risks being another well-intentioned but ineffective document.



# How to avoid a summer of political discontent

Bangladeshis have just observed the first Eid after the despot Sheikh Hasina fled the country. She had left behind a blood-soaked nation where all institutions and organs of the state were systematically ravaged. The chief adviser has rightly compared the state of affairs in August 2024 to a war zone.

From that beginning, the people of Bangladesh have worked hard to restore stability. From New York to Beijing, Professor Yunus has received felicitations and enthusiasm, not accorded to any Bangladeshi leader in years, if not decades. Meanwhile, for the first time in living memory, this has been a Ramadan where many staples have been affordable for most people.

This has been a happy Eid-ul-Fitr for the people of free Bangladesh. However, the Eid revelry has been followed by a return to grim reality.

First came the news report in *The New York Times* about the risk of extremism against the backdrop of the country's political vacuum. There is nothing factually wrong with the report. Indeed, there is a political vacuum. And there are people who cherish the opportunity to peddle their extremism in this vacuum. Furthermore, the potential for instability, misinformation and disinformation remains, pitting the interim government, pro-democracy political parties, and armed forces against each other in the current political interregnum. There is only one way out of this morass: a concrete timetable on elections.

The bad news printed in New York was followed by worse news from Washington, DC, in the form of the shock caused by the tariffs

imposed by the Trump administration. While it is too soon to fathom, let alone analyse the full ramifications of these announcements, the uncertainty is already weighing in on the major economies of the US and China. Against this oncoming global economic headwind, domestic political certainty can be a major cushion. If nothing else, a government that has the qualifier “interim” before it is not conducive to investment. Again, this calls for an expedient democratic transition.

Of course, before we can have elections, we need to reach a political consensus on how we can avoid the rise of another despot, or at the least, make another despot a less likely possibility. This is the rationale for the reform process that was initiated in October 2024.

Sheikh Hasina was a tyrant. Without absolving her manifold misdeeds in any way whatsoever, it is important to stress that the political system we had between 1991 (when the 12th amendment to the constitution was adopted) and 2011 (when the 15th amendment came into effect) was extremely vulnerable to despotism. In this system, all powers were concentrated in the person, and indeed the persona, of the prime minister. With Hasina, we saw absolute power bringing absolute irresponsibility.

This extreme concentration of power made losing an election an extremely costly exercise. Meanwhile, our first-past-the-post electoral system made it quite likely (in the sense that it had happened twice in four elections) for the winning party or coalition to amass two-thirds majority with less than half the vote and amend the constitution. That is precisely what allowed Hasina to amend the

constitution in 2011, paving the way for three rigged elections.

It would be a gross dereliction of duty by our political leaders if they fail to reach a consensus on a reform package that could reduce the risks of another would-be Hasina.

Fortunately, such a reform package is within the realm of possibility, centred around an upper house of the parliament. All

41 percent of votes in the election and 207 seats (their record in 1979). The government is formed on the basis of the lower house numbers, and since BNP enjoys an absolute majority, it can run a strong government to implement its policies and programmes, and pass budgets and most legislations. It can also pass a constitutional amendment bill in the lower house through its two-thirds majority.

Historically, BNP has been the party of democratisation, through the fifth amendment restoring multi-party democracy, the 12th amendment restoring parliamentary system, and the 13th amendment codifying the caretaker system. To the extent that BNP has no track record of imposing one-party rule, it has no reason to seek a power that has been abused repeatedly by political parties that are less democratic. Rather, agreeing to a “proportionally represented upper house” will be very much consistent with the party's reformist, democratising credentials.

One can further discuss whether such an upper house could have vetting powers over appointments to the judiciary or constitutional bodies. Indeed, that is precisely the kind of discussion that is needed between the senior leaders of all major democratic parties.

However, if BNP agrees in principle to a “proportionally represented upper house,” there is no reason to delay the election beyond the end of the year. Professor Yunus has repeatedly said that no reform will be imposed on anyone. Therefore, election is the appropriate mechanism to decide on various other recommendations by Prof Riaz and members of other commissions where disagreement exists. Meanwhile, recommendations such as those on the judiciary, which major parties agree upon, can be implemented through ordinance or regulation.

Some political parties want local government elections held under the interim government, but justifiably, BNP has expressed reservations lest it delays the national election. But even this can be resolved by holding parliamentary, city council, municipality and upazila elections simultaneously (perhaps over several days).

There is no reason to drag the reform process into the monsoon of 2025. Rather, election dates could be announced within weeks if our leaders show sufficient maturity. An election campaign is the best way to celebrate the first anniversary of the Monsoon Revolution.

The alternative may be one long, torrid summer of discontent.

major political parties agree with the concept, but they differ on how the upper house members would be elected. The largest party, the Bangladesh Nationalist Party (BNP), wants the upper house numbers to be proportional to the seats won in the lower house, though they have also said that they are open to discussing the matter. Professor Ali Riaz and his team proposed that the upper house members would be elected proportionate to the votes received by the parties in the lower house.

To put that in concrete terms, suppose in a future election the BNP were to win

Suppose passing the constitutional amendment in the upper house also requires a two-thirds majority; in that case, under BNP's preferred method, they would have 69 of 100 upper house seats, whereas under the alternative, they would have 41. This difference is crucial—the first method will leave us at the mercy of a future would-be despot, whereas the second one can significantly reduce the risks of brute majoritarian despotism.

The point here is *not* that a future BNP government *will* amend the constitution and usher in despotism. In fact, quite the opposite.

# Bangladeshi youth's solidarity with Palestine will be remembered

Everywhere in the world, excited children gathered for Eid and so did the children of Gaza. But the latter, unlike anyone, had to celebrate with bombs raining down on them. At least 85 people were killed on Eid in Gaza, marking one of the deadliest days since Israel began their massacre again. Speaking to the Middle East Eye, Ahmad-al-Qahwafi who lost his relatives on Eid to Israeli airstrikes, said, “Instead of taking the children to celebrate Eid, we took them to the hospital's morgue - some of them were brought in as pieces.” What did Gazans do to deserve such devastation during Eid-ul-Fitr?

Two holy months of Ramadan in Gaza—last year and this year—have now passed amidst genocide. Still people fasted, and still, people were excited. They mourn and they celebrate at the same time. Gazans have accepted life with indescribable grief. But Gaza will remain a witness to the failure of humanity to rise up against the gravest injustice we have ever seen in recent history. After seven decades of oppression and occupation, Gazans are being wiped out systematically and brutally for a year and a half.

In despair, we ask: how will Palestinians ever heal from the wound that the Israeli government has instilled in our soul, watching their children being peppered with shrapnel? And how will children losing their families in front of their eyes ever recover from the trauma? And most importantly, how will humanity recover from this period of freefalling morality? The world has watched the flesh and open wounds of Gazans on smartphones, while Israeli extremist ministers have openly said, “A good Palestinian is a dead Palestinian.”

On Eid, sadness envelops Gaza—its streets, the remains of its ruins and memories, and the rest of its men,

women, children and the elderly, whose misery was the companion of the decades of its long journey from Nakba to Nakba without catching her breath. Life for Gazans is just intermittent breaks between the bullets and the bombs. It is a collective death sentence by all means. As I write this, the death sentences of thousands more innocent people are being manufactured in American ammunition factories. This continuous military aid, along with unwavering political support from the US, has allowed the gruelling war against Gaza to persist.

After a brief respite of ceasefire, Israel's Netanyahu resumed his murderous campaign, realising his extremist coalition will collapse if the bloodshed truly ends. What's particularly disturbing is that Netanyahu's own view about Palestinians is just one among many extremist Zionists who truly believe that human beings deserve to be killed in the most vicious ways possible—their bodies broken into pieces.

The Trump administration's so-called mediation efforts, rather than curbing the war, provided Israel's Prime Minister Netanyahu with extended political cover. The Biden administration prioritised the optics of solidarity with Palestinians, and duplicitously used every veto power they had to ensure Israel could go on. The new Republican administration inherited a volatile situation. However, rather than recalibrating US foreign policy to meet their electoral promise of “ending wars,” Trump pursued a more aggressive stance, discarding any pretence of mediation. The new administration has made it clear that Gaza's future will be dictated by the demands of Netanyahu, and his far-right coalition, including figures like Itamar Ben-Gvir, and Bezazel Smotrich, who represent extreme

Zionism that embraces violence and justifies mass murder.

But now, with Donald Trump's declaration of economic war, many wonder if the superpower would be isolated and eventually, the world order would change. But the optimism for Gaza—that any change in the near future will lead to a cessation of suffering—remains slim. The people

of Gaza live life, waiting for the next worse action by Israel. In this context, though, students across the world, in the US and in Bangladesh, have protested, reflecting true, genuine support for the people of Palestine.


On April 7, 2025, students from various universities in Bangladesh marched in response to a global strike, “The World Stops For Gaza.” The same day, Israeli airstrikes continued killing dozens of people and targeting a tent in Khan Younis that was being used by several journalists. Footage showed a journalist being engulfed by flames, and burned alive. Such horror happens regularly and the outrage towards it has been treated with repeated repression and censorship from the powers that be.

We appreciate students and people's remarkable and sustained solidarity with Palestine, when many have started turning the other way. Protesting against powerful occupation forces, shows the

genuinity of the Palestinian cause to achieve freedom to live life with human decency. And Bangladeshi students have shown that genuinity with their bravery. We must mention Umama Fatema, spokesperson for Students Against Discriminations (SAD), who rejected the US State Department's “International Women of Courage” award for the July

uprising, stating, “The collective recognition of women activists is highly honourable for us. However, this award has been used to directly endorse Israel's brutal attack on Palestine in October 2023. By refusing acknowledgement of the Palestinian war for independence, the award has justified Israel's assault in a way that questions its neutrality. While

the Palestinian people continue to be deprived of their fundamental human rights, including land rights, I am personally rejecting this award as a mark of respect for the Palestinian struggle for freedom.” The world must not lose momentum and such acts of solidarity that the youth continue to demonstrate will be written on the right side of this dark history.

# The ultimate guide to acing business competitions

**This is the foundation of any business competition. Many teams make the mistake of jumping straight into solutions without fully diagnosing the issue. A structured approach works best—reading the problem statement carefully, identifying the key challenge, and breaking it down using frameworks like SWOT analysis, Porter’s Five Forces, or PESTEL analysis.**

Business competitions are among the most rewarding experiences a BBA student can have. Participating in these competitions provides exposure to real corporate problems often presented by leading companies. These cases are based on actual business challenges, which means that participants must apply theories in practical, high-pressure scenarios. They teach you how to analyse business problems, develop viable solutions, and present ideas persuasively—all within a tight deadline.

Beyond skills, these competitions also help you build a good network. Some of my closest professional relationships started in competition rooms, with mentors, and even competitors. The exposure to industry leaders, who often serve as judges, is a golden opportunity to make an impression that could lead to internships or job offers. More importantly, business competitions give you the confidence to navigate high-stakes situations. Whether it is pitching an idea to a CEO, debating financial feasibility, or handling unexpected questions, the experiences from these competitions prepare you for the intensity of corporate boardrooms.

Having won BizMaestros and HSBC Business Case Competition, along with several local competitions, I have firsthand experience in how these competitions can shape one’s approach to business challenges and accelerate professional growth. This guide explores how to ace business cases as a BBA student.

**Choosing the right team**

The skills developed through business competitions go beyond technical knowledge. They help improve teamwork, communication, and leadership—qualities that are crucial in any professional setting. Since most competitions require team participation, selecting the right team is one of the most important decisions. The ideal team consists of a balance of skills—someone with strong analytical skills, someone who excels in storytelling and presentation, and someone who is highly organised and manages time effectively. A well-rounded team ensures that all aspects of the competition, from research to execution, are handled efficiently. A common mistake is forming teams based purely on friendships, but in high-stakes competitions,

complementing skill sets matter more than personal relationships.

**Understanding the problem**

This is the foundation of any business competition. Many teams make the mistake of jumping straight into solutions without fully diagnosing the issue. A structured approach works best—reading the problem statement carefully, identifying the key challenge, and breaking it down using frameworks like SWOT analysis, Porter’s Five Forces, or PESTEL analysis. This ensures that the solution is aligned with the actual business need rather than being generic or superficial. The best solutions are always those that are not only innovative but also feasible in terms of execution and impact. Judges appreciate ideas that are well-researched, realistic, and backed by data rather than vague or overly ambitious suggestions.

**Formulating a strategy**

Once the problem is clearly defined, the next step is crafting a structured and compelling strategy. A winning presentation typically follows a logical sequence: introduction, problem analysis, proposed solution, implementation plan, financial justification, and expected impact. The introduction should set the stage with a strong hook—either a powerful statistic, a thought-provoking question, or an engaging story. The problem analysis should clearly define the issue using data and business insights, avoiding unnecessary jargon. The proposed solution should be actionable, innovative, and backed by solid reasoning. The implementation plan should cover how the solution will be executed, including key steps, timeline, and resource allocation. Many teams overlook financial justification, but including a cost-benefit analysis strengthens the case. The conclusion should tie everything together and emphasise the long-term impact of the proposed solution.

**Mastering presentation skills**

Even the best strategy can fall flat if it is not presented effectively. Presentation skills play a critical role in determining the outcome of the competition. Judges do not just evaluate the content but also how confidently and persuasively it is delivered. A professional, engaging, and visually appealing presentation can set a team apart from competitors who

may have equally strong ideas but fail to communicate them effectively. The key to a strong presentation is simplicity—slides should be clean, with minimal text and impactful visuals that enhance rather than distract. Cluttered slides with too much information can overwhelm the audience. Effective presenters maintain eye contact, use confident body language, and modulate their voice to emphasise key points rather than reading directly from slides. Rehearsing multiple times before the final presentation is crucial, ensuring that the team is well-coordinated, transitions smoothly between speakers, and maintains consistent energy.

**Navigating Q&A**

One of the most unpredictable yet crucial segments of any business competition is the Q&A round. A well-handled Q&A session can reinforce the strength of a presentation, while a poorly handled one can weaken an otherwise strong case. Judges use this session to test the depth of understanding and the feasibility of the proposed solution. The best way to prepare for Q&A is to anticipate possible questions and develop structured responses in advance. Teams should critically analyse their own proposal, identify its potential weaknesses, and prepare counterarguments. If a judge challenges an aspect of the solution, it is important to respond confidently with supporting evidence rather than becoming defensive. If a team does not know the answer to a specific question, acknowledging it honestly while redirecting the conversation to related insights is a smarter approach than attempting to bluff through it.

**Managing time effectively**

Time management is often one of the biggest challenges in business competitions, especially when cases have short preparation windows. Teams that fail to allocate time effectively often find themselves rushing to complete slides at the last minute, leading to poorly structured presentations. The most successful teams break down their work into specific phases—time for brainstorming, research, slide preparation, and rehearsals—ensuring that each stage receives adequate attention. Strict internal deadlines help prevent last-minute panic. It is also crucial to avoid overcomplicating solutions. Many teams fall into the trap of trying to do too much, proposing overly complex solutions that lack focus. Simple, clear, and impactful solutions tend to be more persuasive than complicated strategies that are difficult to execute.

**Thinking outside the box**

Finally, what truly differentiates winning teams is their ability to think outside the box. Judges are often exposed to similar ideas across multiple teams, so the challenge is not just to provide a viable solution but to present it in a way that is memorable and unique. Creativity in problem-solving, storytelling, and presentation design can make a significant difference. Some of the most successful teams use innovative storytelling techniques, turning their business case into a compelling narrative rather than a dry, data-heavy presentation. Others differentiate themselves by using interactive elements, such as live demos or audience engagement techniques, to make their presentation more dynamic.

Winning business competitions takes strategic preparation, teamwork, and proper execution. The teams that succeed are those that approach the competition with a winning mindset—staying confident but not overconfident, learning from feedback and failures, and constantly improving their approach. For me, these competitions were never just about taking home trophies. They provided invaluable lessons that extended far beyond the competition room. Every competition, win or lose, was an opportunity to grow, refine skills, and build a network that became instrumental in future career opportunities.

# 10 biggest tech acquisitions of the decade

The tech world has seen some jaw-dropping deals over the past decade, with companies shelling out billions to dominate markets, expand their ecosystems, and stay ahead of the competition. The latest headline-grabber? Alphabet’s potential \$32 billion acquisition of cybersecurity firm Wiz marks Google’s parent company’s biggest deal ever. But that’s just the tip of the iceberg.

Here’s a look at the ten largest tech deals that have reshaped the industry in the last decade.

**1. Walt Disney snags Twenty-First Century Fox for \$71 billion (March 2019)**

In a move that shook the entertainment industry, Disney acquired Twenty-First Century Fox, gaining control of iconic franchises like X-Men and Avatar. The deal also bolstered Disney’s streaming service, Disney+, as it took on Netflix.

Dell’s acquisition of EMC Corp created a tech powerhouse, combining Dell’s hardware expertise with EMC’s data storage solutions. The deal remains one of the largest in tech history.

**5. Elon Musk’s \$44 billion Twitter takeover (October 2022)**

Elon Musk’s purchase of Twitter (now X) was as controversial as it was expensive. The deal sparked debates about free speech, platform moderation, and the future of social media. X remains a popular platform - for more reasons than one.

**6. Broadcom’s \$37 billion Avago Technologies merger (February 2016)**

Broadcom’s merger with semiconductor supplier

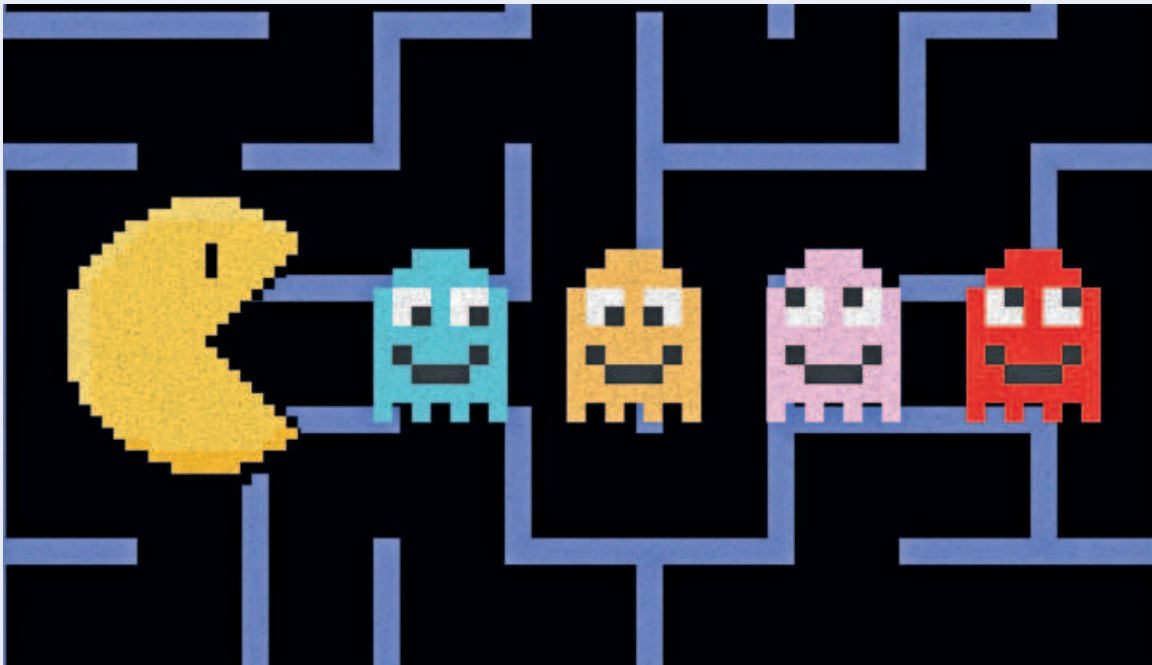

market. The deal highlighted IBM’s shift from legacy hardware to cloud-based solutions.

**8. Cisco’s \$28 billion Splunk deal (March 2024)**

Cisco’s acquisition of Splunk, a data analytics and cybersecurity firm, aimed to enhance its capabilities in AI-driven security

and observability.

**9. Salesforce’s \$27.7 billion Slack buy (July 2021)**

Salesforce’s purchase of communication platform Slack was a bid to compete with Microsoft Teams in the workplace collaboration space. The deal integrated Slack into

Salesforce’s customer relationship management ecosystem.

**10. Microsoft buying LinkedIn for \$26.2 billion (December 2016)**

Microsoft’s acquisition of LinkedIn transformed the professional networking platform into a hub for enterprise tools and services.

These mega-deals reflect the tech industry’s relentless pursuit of innovation and market dominance. From cloud computing and cybersecurity to entertainment and gaming, companies are betting big on the future. Alphabet’s Wiz acquisition could be the latest example of how tech giants are willing to spend billions to stay ahead.

As the tech landscape continues to evolve, one thing is clear: the race for supremacy is far from over, and the price tags are only getting bigger.



# Tanzid hammers hundred, Nasir settles in after ban

Just a day after admitting the need to show more responsibility in converting starts into bigger scores, Bangladesh opener Tanzid Hasan Tamim lived up to his words.

The left-hander smashed a blistering 59-ball 103 -- his first List A century in two years -- to power Legends of Rupganj to a thumping ten-wicket victory over Partex Sporting at BKSP Ground 3 in Savar yesterday.

Tanzid's exploits helped his side chase down Partex's 129 all out in just 18.3 overs in the 50-over fixture.

The 24-year-old -- who had not found that elusive three-figure mark in List A in 46 innings, but found starts in international cricket, most recently in the Champions Trophy -- struck a boundary off Md Rakib to bring up his ton and the winning runs.

Rupganj bowlers had set the game up for Tanzid's carnage.



Pacers Shoriful Islam and Rejaur Rahman bagged two each, while Mahedi Hasan picked four for 34. The outcome meant they are fifth in the standings, still in line for qualifying for the Super Six with five wins.

Meanwhile, at BKSP Ground 4, Agrani Bank stunned Brothers Union with a four-wicket win, courtesy of Taibur Rahman's four-

fer and 35 with the bat.

Asked to bat, Brothers batters managed starts. Mizanur Rahman managed 44, while Aich Mollah notched 33 before veteran Alok Kapali's 57-ball 58 helped them to 238 for nine.

Agrani's chase had a similar look to Brothers' innings, but Taibur and Shuvagata Hom (45 not out off 35) helped avert a

collapse after three quick wickets, ensuring they remain fourth in the standings.

Elsewhere, in Mirpur, the focus was very much on Nasir Hossain, who returned to domestic action a day after his two-year ban for breaching ICC's Anti-Corruption Code was lifted.

Nasir appeared for Rupganj Tigers in their fixture against Gazi Group and helped his side upset the third-placed team with an eight-wicket victory, with 16.3 overs to spare.

Electing to bowl, Rupganj operated with Nasir from the start, and the 33-year-old off-spinner conceded 31 runs in the 10-over spell, returning with a wicket, while five others chipped in with wickets to bundle Gazi out for 159 in 42.1 overs.

In reply, Rupganj openers Abdul Majid and Amit Majumder both struck fifties to lay the platform for a smooth chase, before Nasir fell for nine after coming to the middle in the 30th over.

## Kohli second-fastest to reach 13k mark in T20

Virat Kohli etched his name in the history books once again as he became the second-fastest batter to reach 13,000 runs in T20 cricket during Royal Challengers Bengaluru's IPL 2025 clash against Mumbai Indians at the Wankhede Stadium yesterday.

The 36-year-old reached the milestone when he scored his 17th run in the match -- becoming the first Indian and only the fifth player overall to cross the 13,000-run mark in T20s -- before reaching fifty off 29 balls with a six off Vignesh Puthur.

Kohli achieved the feat in his 386th innings, placing him second on the all-time list behind West Indies great Chris Gayle, who reached the milestone in 381 innings. Kohli surpassed England's Alex Hales by a staggering 90 innings to clinch the second spot.

Since his T20 debut in 2007 for Delhi, Kohli has been a force in the format. Over 8,000 of his T20 runs have come in the IPL, where he also leads among Indians in centuries, with nine to his name -- eight of them in the IPL alone.

With this latest landmark, Kohli further cements his legacy as one of the greatest batters in the shortest format of the game.



## Brook named new England white-ball captain

England batter Harry Brook has been appointed the country's white-ball captain after Jos Buttler stepped down after their group stage exit from the ICC Champions Trophy, the England and Wales Cricket Board said on Monday.

The 34-year-old Buttler had overseen 22 losses in 34 One-Day Internationals since succeeding the retired Eoin Morgan in June 2022 and led England to their second Twenty20 World Cup title that same year. However, the performances have dipped since then with the side failing to retain their T20 and ODI crowns.

Brook, 26, captained England in the ODI series against Australia in September and was vice-captain at the Champions Trophy.

"It's a real honour to be named England's white-ball captain," Brook said in a statement.

"Ever since I was a kid playing cricket at Burley in Wharfedale, I dreamed of representing Yorkshire, playing for England, and maybe one day leading the team.

"I want to thank my family and coaches who've supported me every step of the way. Their belief in me has made all the difference and I wouldn't be in this position without them," Broom said. "There's so much talent in this country, and I'm looking forward to getting started, moving us forward, and working towards winning series, World Cups and major events."

Real Wednesday's high-voltage Champions League quarterfinals lineup will feature defending champions Real Madrid taking on Arsenal at the Emirates Stadium. In the other fixture, Bayern Munich will host Inter Milan. The Arsenal-Real contest pits together two sides who are second in their respective domestic league. At the same time, it is a clash of league-leaders as Bundesliga toppers Bayern will brace for the arrival of Serie A leaders Inter in the other fixture.

➔ Arsenal won their only previous tie with Real Madrid, back in 2006 -- a goalless draw at Highbury following a 1-0 win in Spain in the last 16 of the competition.

➔ The Gunners last progressed into the semifinals of the competition in 2009, while Real have been crowned kings of Europe six times since then.

➔ Real Madrid have won 11 of their previous 22 knockout games against English opposition in the UEFA Champions League.

➔ Real haven't lost the first leg in any of their last eight knockout-stage ties in the Champions League, winning five of them. They are unbeaten in four when on the road for the opening game of a tie, with only two defeats in their previous 13 such matches.

➔ Los Blancos have beaten 111 different teams in the European Cup/Champions League, but Arsenal are not yet one of them.

➔ Inter have kept a clean sheet in

eight of their 10 matches in the UEFA Champions League this season and have conceded only two goals in that period in the competition.

➔ Bayern are unbeaten across their last 22 home matches in the Champions League (W17 D5). The last time they lost was when they faced PSG in the quarters in April 2021.

➔ Bayern have won five of the nine encounters between these two sides in European competition, with three wins for Inter and one draw.

## Abahani aim to derail Kings

Domestic football returns with a bang today following a seven-week break, as defending champions Bashundhara Kings face off against traditional powerhouses Abahani in the Federation Cup's Qualifier-1 fixture at Shaheed Dhirendranath Datta Stadium in Cumilla.

In Mymensingh, spirited Brothers Union will also take on giant-killers Rahmatganj MFS in the competition's elimination match at Rofiq Uddin Bhuiyan Stadium. Both matches will kick off at 2:45pm.

Under the new format of the Federation Cup, the winners of Qualifier-1 will move to the final, while the losing side will face the winners of the elimination match to have a second shot at the final.

Since the emergence of Kings in top-flight football, they have knocked down all heavyweights, including Abahani, who have managed to conquer Kings only twice in the last six seasons.

However, this season brought a twist. Abahani, fielding a squad without foreign players, secured their first-ever Bangladesh Premier League win over the Kings.

Local coach AKM Maruful Haque was behind Abahani's triumph. The club have now strengthened their squad with the inclusion of two proven foreign campaigners -- Raphael Augusto and Emeka Ogbugh -- and are determined to secure a place in the final after one season.

"Amid tight schedule, we don't want to wait for another match to confirm the final berth; rather, we want to ensure the Federation Cup final

by beating our opponents tomorrow [Tuesday]," Abahani head coach AKM Maruful Haque told The Daily Star from Cumilla yesterday.

Abahani had kept up their training during Ramadan, and the two new foreign recruits also had three weeks to adjust to the local squad. Coach Maruful is optimistic about the inclusion of midfielder Raphael and attacker Emeka.

"We had previously lacked control of the game from midfield and, as a result, failed to create goal-scoring chances. But the inclusion of Raphael and Emeka has mostly resolved those issues," said Maruful, who, however, downplays his significant role in shaping the Abahani squad.

Kings, meanwhile, used the break to bolster their ranks with four foreign players. Three are likely to feature today alongside proven Brazilian Jonathan Fernandes.

However, they face injury setbacks. Miguel Ferreira and Tariq Raihan Kazi will miss the tie due to unavailability and injury, while defender Tapu Barman and new Argentine forward Juan Eduardo Lescano are also nursing knocks.

Despite the injury concerns, Kings are determined to reverse their fortunes in the season's second meeting with Abahani and make it to the final for a second straight year.

"Although Bashundhara Kings are ahead of Abahani in terms of the head-to-head record over the last six to seven years, [tomorrow] the team who takes their chances will come out successful," Kings assistant coach Mahbub Hossain Roxy told The Daily Star over the phone from Cumilla.

# Some US RMG buyers want price cuts

## Many put work orders on hold

Some of the US clothing and footwear retailers and brands are demanding a big discount from Bangladeshi suppliers, and are putting the work orders on hold to adjust the new reciprocal tariff measures, exporters said.

In some cases, the buyers are demanding a 10 percent discount from local suppliers on the ready-to-ship goods and are asking the local manufacturers to delay the process of making garments.

The local suppliers are now trying to negotiate prices of garments under the new tariff regime. However, not all the US buyers are demanding the price cuts as many are trying to wait and see.

The suppliers and the brands are doing their homework. For instance, a US buyer in Bangladesh has sought a 10 percent discount on the ready-to-ship goods and suggested bearing 3.3 percent discounts by suppliers, 3.3 percent by fabric suppliers, and 3.3 percent by retailers, said an exporter, wishing not to be named.

It is true that some of the US buyers are demanding discounts from the local suppliers, said Rubana Huq, former president of Bangladesh Garment Manufacturers and Exporters Association (BGMEA). She, however, declined to mention the names of retailers and brands.

# Polls code of conduct almost finalised: EC

If the proposed law for demarcating parliamentary constituencies is not approved, the national election will proceed under the existing framework, said Election Commissioner Md Anwarul Islam Sarkar.

"There was a printing mistake in the proposed law. The commission has sent amendments to the law ministry. Once we get the approval, we can carry out the delimitation work. If it is not approved, the election will be held based on the existing constituency arrangement."

The Election Commissioner made the remarks at a press briefing at the EC headquarters in the capital's Agargaon yesterday morning.

The briefing followed a meeting of the commission formed on six election-related issues, including the delimitation of parliamentary constituencies and the registration of political parties.

EC Anwarul told reporters that the draft of the electoral code of conduct for the next national election is nearly complete.

"Once the draft is finalised, we will place it before the commission. If the commission approves, it will be published."

# Back down or face 50% added tariffs

## Trump threatens China

US President Donald Trump yesterday threatened to impose an additional 50% tariffs on US imports from China, ratcheting up a trade war even as a dramatic selloff in global markets gathered pace.

Trump upended the world economy last week with sweeping tariffs that have raised fears of an international recession and triggered criticism even from within his own Republican Party.

In response to Trump's tariffs, Beijing -- Washington's major economic rival -- unveiled its own 34 percent duties on US goods to come into effect on Thursday.

The US president yesterday chastised China for not heeding "my warning for abusing countries not to retaliate."

He said on social media that if China did not immediately back down, "the United States will impose ADDITIONAL Tariffs on China of 50 percent, effective April 9th."

With the incoming 34 percent rate and new 50 percent threat, the total additional tariffs this year could hit 104 percent, the White House told AFP.

Stock markets and oil prices collapsed further as trading floors across the world were overcome by waves of selling after last week's sharp losses.

Wall Street was wracked by volatility, bouncing into positive territory on hopes of a 90-day pause in tariffs, only to sink lower when those were dashed by the White House.

Hong Kong collapsed by 13.2 percent Monday, its worst day in nearly three decades.

Trillions of dollars have been wiped off combined stock market valuations in recent sessions.

# Tureen Afroz arrested at her Uttara home

Police late last night arrested Barrister Tureen Afroz, former senior prosecutor of the International Crimes Tribunal (ICT).

Dhaka Metropolitan Police (Uttara Division) DC Mohidul Islam confirmed this to The Daily Star.

"She was arrested around midnight from her home in Uttara Sector-3," he said.

Tureen Afroz was arrested in connection to a case filed over the attempting murder of Md Jabbar, 21, who sustained bullet wounds in the Uttara West area on August 4, last year.

The case was filed on March 27 this year.

Tureen Afroz was removed from the ICT after allegedly meeting accused war criminal Mohammad Wahidul Haque.

She prosecuted cases against executed war criminals Ali Ahsan Mohammad Mojaheed, Muhammad Kamaruzzaman, Motiur Rahman Nizami, Salauddin Quader Chowdhury, and Ghulam Azam, who died in jail.

# 37 more Gazans killed in Israeli strikes

**Journalist among the dead; France opposes any displacement, annexation in Gaza, West Bank**

At least 37 people, including a journalist, were killed by Israeli strikes on Gaza yesterday as French President Emmanuel Macron said that he strongly opposes any displacement of Palestinians or annexation in Gaza and the Israeli-occupied West Bank.

Twenty-two of those killed were in the central and southern regions of the Strip, the sources said. At least 44 Palestinians were killed on Sunday.

In Khan Yunis, an Israeli air strike hit a tent used by local media, killing two, including a Palestinian journalist, and wounding nine others.

Footage showed people trying to douse flames in the tent inside the compound of the Nasser Hospital during the early hours of yesterday.

Images appearing to show a journalist in flames and another person trying to rescue him were widely shared.

The Israeli military said in a statement it struck Hassan Aslih, whom they described as a "terrorist, who operates under the guise of a journalist" and a member of Hamas' Khan Younis Brigade.

Aslih, a well-known Palestinian journalist in Gaza, with hundreds of thousands of followers on social media platforms, was critically wounded in the strike, medics said.

Ismail al-Thawabta, director of the Hamas-run Gaza government media office, said Israel's accusations against Aslih were "false", adding that Aslih had no political affiliation.

A second Palestinian was also killed in the attack, Gaza medics said.

Faqawi's death raised the number of journalists killed by Israel's campaign in Gaza to more than 210 since October 2023, according to the Palestinian Journalists Syndicate.

In the occupied West Bank, Israeli forces yesterday shot and killed a Palestinian-American boy.

An Israeli strike on southern Lebanon killed one person yesterday, according to the health ministry, with Israel's military saying it had "eliminated" a Hezbollah commander in the latest raid despite a truce.

The Lebanese health ministry said in a statement that an "Israeli enemy" strike on the town of Taybeh, near the border, "led to the death of one citizen".

Lebanon's official National News Agency (NNA) said the strike hit "in front of a motorcycle repair shop" in the town, in south Lebanon's Marjayoun district.

# 130 pro-AL lawyers sued sans specific charges

A pro-BNP lawyer sued 144 pro-Awami League lawyers for illegally gathering, trespassing, theft, causing bodily harm, attempted murder, vandalism and exploding crude bombs.

Only 12 were sued on specific charges and the complainant did not mention any specific charges against 130, according to the case statement.

The 12 lawyers include Khandakar Golam Kibria Jobayer, Mohamad Anwar Shahadat Shawn, Hasibur Rahman Didar, Kazi Shahanara Yeasmin, Nazrul Islam Shamim, Salma Hai Tuny, Sanzida Khanam, Abu Sayeed Siddiqui Tipu, Matiar Rahman Bhuiyan, Fahim Sharif, AKM Salah Uddin and Ramjan Ali Sarder Rana.

Kazi Md Nazib Ullah Hiru, the AL law affairs secretary, and Sheikh Fazle Noor Taposh, former mayor of Dhaka South City Corporation, have been named as masterminds in the case.

The complainant, Mohammad Ali Babu, also sued 200 to 300 unnamed persons in the case filed with the court on February 6.

Kotwali police registered the case the following day as a first information report as per the court's order.

Among the 144 lawyers, 24 are female, 11 are former presidents of the Dhaka Bar Association (DBA) and five are its former

# Robbers loot valuables in 4 Mugda flats

A group of masked robbers looted valuables from four flats in a building at Green Model Town Society in the capital's Mugda area early yesterday.

The gang also hurt four residents.

The robbery took place between 3:00am and 4:00am at a building on Road 3 in D-block, said Sajedur Rahman, officer-in-charge of Mugda Police Station.

"Around 15 to 17 armed robbers entered the building, kept residents hostage in four flats, and robbed around Tk 1 lakh and nine bhoris of gold ornaments," he said.

The injured were flat owner Humayun and his wife Shahinur Akter, and their neighbours Abdul Mannan and his son Hasan. All were admitted to Mugda Medical College Hospital, and Humayun was stabbed.

Humayun and Mannan live on the fourth floor of the eight-storey building. According to the police, the flat owners -- all bank employees -- jointly bought the land and constructed the building.

OC Sajedur said the building is in a secluded place. The robbers likely entered the second-floor balcony through a gap before breaking into lower flats and letting
