



Step up diplomacy as US tariff clock ticks away

At a roundtable organised by *Star*, exporters and an economist urge a swift rethink of trade strategy

Bangladesh must intensify trade diplomacy to protect garment exports from steep US tariffs as the clock runs down on a three-month reprieve, business leaders warned yesterday.

The call came at a roundtable discussion titled "Impact of US Tariffs on Bangladesh's Garment Industry: Challenges and Opportunities", organised by The Daily Star in Dhaka.

Currently, Bangladesh is the third-largest garment exporter to the US after China and Vietnam, commanding 9.3 percent of the \$90 billion American apparel market annually. In 2024, Bangladesh shipped \$7.34 billion worth of garment products to the US, marking a 35.95 percent year-on-year growth.

However, the country's foothold in its largest export market is now under severe threat, as President Donald Trump's administration imposes a 37 percent reciprocal tariff on top of the existing 16 percent duties. The broader implication is starker still: Bangladesh's global standing as the second-largest garment exporter after China is at risk.

"From the Korean side, there is growing concern regarding the future stability of Bangladesh's garment exports to the US," said Kihak Sung, chairman of Youngone Corporation. Sung warned that Vietnam was "very close" to overtaking Bangladesh and stressed the need for immediate, proactive measures.

Around 15 percent of Bangladesh's total exports, roughly \$8 billion, go to the US. Reducing overreliance on a single market through diversification must be part of the strategy, he said.

Sung further pointed out that labour rights had become a prime agenda item under the Trump administration, calling for Bangladesh to define and address US demands methodically. He urged the mobilisation

AID PASSAGE TO RAKHINE 'Govt can't decide unilaterally'

Political parties worried

BNP and several other parties have voiced concern over reported developments regarding a UN-backed humanitarian corridor into Myanmar's war-torn Rakhine State, calling it a potential threat to national sovereignty and regional security.

The BNP has expressed strong resentment over no visible steps from the government to engage the political parties in discussions over the issue.

Leftist and Islamist parties and platforms also opposed the move to establish a corridor, questioning the West's interests in the Rohingya refugee issue. Such a corridor may become a threat to national security, they warned.

Modi meets top security brass; Pak FM fears 'imminent incursion'; UN calls for calm

Indian Prime Minister Narendra Modi has given the country's military "operational freedom" to respond to a deadly attack in Kashmir last week, a senior government source told AFP yesterday, after New Delhi blamed it on arch-rival Pakistan.

A week after the deadliest attack on civilians in the contested region in years, Modi yesterday held a closed-door meeting with army and security chiefs, during which he told the armed forces that they had the "complete operational freedom to decide on the mode, targets and timing of our response to the terror attack", said the government source, who was not authorised to speak to the media.

Dhaka’s Signal Economy

Unveiling trade at traffic stoplights

Often, on my way to the office from Dhanmondi to Mohakhali, I pass through at least three or four major traffic signals – the stubborn standstill at Dhanmondi 27, the long, impatient pause at Khamarbari, and the inevitable gridlock at Farmgate. However, it does not end there. The legendary bottleneck at Bijoy Sarani awaits, followed by the guarded patience required at Jahangir Gate. And if luck chooses to mock me, as it often does, the Mohakhali Railgate signal delivers the final blow.

So yes, wedged between the relentless chorus of horns and the glow-stick rave of brake lights, I have cultivated an oddly fascinating pastime – calculating the city’s “invisible” GDP – the minutes we waste subtracted from the minutes gained by the signal vendors who spring into action the moment the signal bleeds red!

Within those few minutes, or sometimes hours, of a red light or VIP signal, you can buy roses, sunglasses, tea towels, phone chargers, balloons, peanuts, cold water, “original” Ray-Bans, and occasionally, moral guilt.

Welcome to what I call the Signal Economy!

Here, while most of us lose precious time, a few cleverly turn those lost minutes into opportunity and profit. I am sure all of us have encountered



them. Some, to me, are true lifesavers – selling cold water or juice on a sweltering summer day, they appear like angels out of nowhere. And then, of course, there are others – those who feel more like a nuisance, testing the limits of our already diminishing patience.

“It’s my office,” says Manik with a grin on his face while balancing a mountain of tissue packets in his hands near Dhanmondi 27. The teenager adds, “The longer the signal, the better the business.”

In Dhaka, the signal is not a stop. It is a stage. And the performers are these sellers – of all ages! This is a setup that I am sure no marketing team could ever dream of. The products are seasonal, tactical, and as adaptive as Dhaka’s

weather. During summer, they sell sunglasses and water bottles. During the monsoon, umbrellas and plastic shoe covers emerge like magic!

And sometimes, no matter the season, if you are packed inside a sweaty, overburdened bus, brace yourself. Sooner or later, a vendor will weave through the crowd, waving a tiny miracle – a 10-taka tablet that claims to cure everything from migraines to heartbreaks, putting even the best doctors to shame!

If you listen long enough, you will be half-convinced that it might fix your headaches, your heartbreaks, and maybe – just maybe – your stubborn bachelorhood too.

“We sell what the eyes want,” says Liton, a man offering “designer” mobile

covers near Farmgate. “If your face says you are tired, I will show you a stress ball. If you look romantic... a flower for you!” he winks. Clearly, a man who has mastered microeconomics in its rawest form.

There’s a certain choreography to it too – a glide between cars, a delicate tap on the window, a quick smile, a flash of the product, and a retreat if the driver scowls. This is salesmanship under pressure, with a moving, impatient audience and a ticking clock.

Then, of course, Dhaka being Dhaka, the gig economy is not always “legal” nor “organised”. But it is efficient. Sellers need patience, agility, and a sharp sense of who might roll down a window and who will look away. Authorities sometimes crack down, clearing intersections, but like every underground market, the sellers return – new faces, new tricks, same survival story.

At a certain level, it’s hard not to admire the sheer hustle. No one taught these entrepreneurs about pricing, supply chains, or customer retention. Yet, here they are, running a parallel economy under the nose of an impatient city, turning every red light into a flash sale.

So, the next time you are stuck at a traffic stoplight, maybe, just maybe, buy a packet of tissues or a flower. It’s not charity. It’s the small price of admission into Dhaka’s liveliest street theatre.

of organisations such as the International Labour Organization (ILO) and the World Bank to advocate on Bangladesh’s behalf.

Speed to market should be another priority. “Timely deliveries and high-end, high-quality production are crucial,” Sung said. He also called for a permanent trade negotiation team based in the US. “On-and-off discussions will not yield lasting results,” he said.

Bangladesh must position itself diligently, Sung added, as the US administration actively pursues trade agreements with Korea, Australia, Japan, India and the UK.

To address US trade imbalance concerns, Sung proposed increasing imports from the US by at least \$1 billion annually over the next three years. He stressed the need for a detailed and quantifiable plan rather than empty promises.

Sung also emphasised the importance of working closely with the US Embassy in Dhaka. “The embassy can play a pivotal role in advocating for Bangladesh,” he said.

AK Azad, chairman and managing director of Ha-Meem Group, described the situation as “very critical.”

“After the imposition of tariffs, customers are asking us to share the burden. Some customers are being illogical, asking us to absorb a portion of the tariffs, which is unethical,” said Azad, whose company exports \$800 million worth of goods annually, 90 percent of it to the US.

While the US government has suspended the new tariffs for three months, Azad said buyers are demanding discounts for at least one season. He called for the immediate appointment of lobbyists and the formation of a high-level committee, headed by a government

adviser, with private sector representatives.

Reflecting on past cooperation during the export quota phase-out, Azad criticised the current government for failing to consult exporters properly. Citing talks with US officials, he said Bangladesh must propose specific measures to reduce the trade gap.

A n w a r - U l - A l a m Chowdhury (Parvez), chairman of Evince Group, said the government’s approach remained half-hearted. “Some officials still doubt the need for lobbyists,” he said.

He said Bangladesh was trying to import more US goods such as raw cotton, LNG, soybeans, and medical instruments, but warned that “this will take time.”

NEGOTIATION MUST BE STRATEGIC

Abdur Razzaque, chairman of Research and Policy Integration for Development (RAPID), warned that “doing nothing is not an option.”

Engagement with the US administration is important, but Bangladesh must be cautious, he said, because many experts believe the tariffs are unsustainable and might eventually be reversed.

Bangladesh must find its bargaining chips, Razzaque said, as larger economies like India have stronger leverage.

Although Bangladesh exports about \$8 billion worth of goods to the US, only 40-50 percent of that value is actually created domestically, after accounting for imported inputs like fabrics and accessories.

This means, Razzaque said, the net value-added exports are closer to \$3.6 billion. At the same time, Bangladesh imports around \$2.6 billion worth of goods from the US, such as cotton, LNG and agricultural products.

As a result, Bangladesh’s

true trade surplus with the US is only about \$1 billion – much smaller than the headline figures suggest, he said.

Negotiations must begin without making premature commitments, he advised. Otherwise, Bangladesh could be disadvantaged if the US policy shifts later.

Razzaque also pointed to opportunities if US imports shrink. “Chinese container traffic to the US is down 45 percent, and ship arrivals at US ports are down 33 percent,” he said. “Shelves will soon start emptying.”

He recommended maintaining export incentives even beyond LDC graduation under WTO flexibilities and suggested reviewing some supplementary duties to signal openness.

Md Fazlul Hoque, managing director of Plummy Fashions Ltd, said that with just two months remaining before a final US announcement on tariffs, large structural adjustments such as a full FTA negotiation were unrealistic.

“Even starting discussions might take more than two months,” he said. Realistic goals should include full engagement with the US administration and signalling willingness, without making definitive commitments.

Hoque believes the tariffs are unsustainable and that Bangladesh is not the main target of the US measures. After Trump temporarily reduced tariffs, he became more confident that a reversal is possible, Hoque said.

NEED FOR NATIONAL DIALOGUE

Syed Sultan Uddin Ahmed, chairman of the Labour Reform Commission, argued that organisations like the ILO or the World Bank cannot speak on Bangladesh’s behalf.

He proposed the creation

of a National Social Dialogue Forum, bringing together the government, private sector, labour groups, international organisations, embassies, and trade partners for regular discussions.

Currently, he said, Bangladesh’s approach is fragmented, with different groups working separately.

Faruque Hassan, managing director of Giant Group and former BGMEA president, said the Trump tariffs were not about reciprocity but about the US trade deficit.

He argued that Bangladesh could frame its response by highlighting imports of American goods such as cotton, soybean oil, LNG, fire safety equipment, and hardware – the products already being purchased, often through regional hubs.

“We have to explain to the US that we are importing more agricultural products – all at zero tariff,” Hassan said.

Humayun Rashid, chairman of Energypac Fashions Ltd, dubbed the crisis the “3T issue” – the Terrible Tariff of Trump.

He advocated a “watch and see” approach, noting that shortages on US shelves could shift the political scenario within months. Bangladesh, meanwhile, should focus on expanding into Asian and South American markets.

Drawing lessons from China’s earlier experience with high US duties, Rashid urged the BGMEA to set up dedicated desks monitoring market trends across different regions.

B a n g l a d e s h i ambassadors, he added, must be judged by economic results, not just political reporting.

Mahfuz Anam, editor and publisher of The Daily Star, delivered the opening remarks, while Arun Devnath, deputy editor, moderated the discussion.

The BNP standing committee met at its chairperson’s Gulshan office on Monday night. Party’s acting chairman Tarique Rahman presided over the meeting virtually from London.

At the meeting, it was decided that all standing committee members would make specific recommendations on the issue, detailing their observations.

Each member has been tasked with thoroughly analysing the political, diplomatic, and security implications of the matter to ensure a comprehensive response, said meeting sources.

After gathering the documents, the BNP plans to hold a press conference to present its position to the public. It also decided to consult its allies on this issue.

Foreign Adviser Touhid Hossain on Sunday said that Dhaka agrees in principle with the UN proposal for a humanitarian corridor to Rakhine, but certain conditions must be met for its implementation.

BNP Secretary General

Mirza Fakhru Islam Alamgir on Monday slammed the interim government for making such a move without consulting the political parties.

Chief Adviser’s Press Secretary Shafiqul Alam yesterday said that the government has not held any discussions with the United Nations or any other entity regarding the creation of a “so-called humanitarian corridor” through Bangladesh to Myanmar’s Rakhine State.

BNP Standing Committee member Iqbal Hasan Mahmud Tuku said, “The foreign affairs adviser spoke on a matter that is directly linked to the country’s sovereignty. After his statement, various political parties expressed their positions. But suddenly, the press secretary claimed that no such discussion had taken place.”

“It appears as though the government is playing a childish game. A country cannot be governed in this manner.”

In a statement issued yesterday, the Communist Party of Bangladesh said the “so-called humanitarian gesture” could have serious

consequences.

“An interim government has no authority to make such a policy decision,” reads the statement from CPB President Mohammad Shah Alam and General Secretary Ruhin Hossain Prince.

It said the move violated the constitution and could jeopardise the country’s independence.

The CPB warned that allowing the corridor would leave Bangladesh’s borders exposed.

“The Myanmar junta could exploit the corridor under various pretexts, creating new threats to our security,” the statement added.

The CPB also questioned the motivation of Western countries, suggesting their sudden interest in the Rohingya issue was “part of a broader imperialist conspiracy.”

“The UN and its allies could have opted for alternatives like Sittoung Port or other coastal routes into Myanmar instead of involving Bangladesh,” it said.

Bangladesher Samajtantrik Dal General Secretary Bazul Rashid Firoz condemned the government’s “unilateral

in the police force.”

Starting from the field level, the law enforcement agencies at all levels will have to work to gain the trust of the people, he said.

He said the interim government has taken initiatives to reform the police, and urgent measures have been taken in several matters for the welfare of police members working at the grassroots level.

When the interim government took office last August, Yunus said the law and order situation in this country was fragile and there was a distance between the police and the people.

“The government has taken all necessary measures to improve the situation. Necessary measures have been taken to eliminate chaos and public suffering on roads and highways, conduct special operations, strengthen police’s communication with stakeholders, and increase the morale of police members,” he said.

“You are trying your best to take immediate action against all the crimes that are happening in the country. With the joint efforts of the police and other forces, the law and order situation in the country has now been brought under control to a great extent.”

On the eve of the Liberation War in 1971, on the night of March 25, police members first staged armed resistance at Rajarbagh Police Lines, Yunus said.

“This is an important chapter in the glorious history of the Bangladesh Police Force,” he said, paying his deepest respects to the police members who were martyred during the Liberation War.

During the 15 years of the dictatorial regime, Yunus said all kinds of measures were taken to turn the country’s police force into a party force.

While carrying out the illegal and unjust orders of the dictatorship, the police force faced widespread public anger, Yunus said, adding that many honest police members also had to pay the price for this.

decision-making” on such a sensitive national issue.

In a statement, he described the corridor as “aligned with the US agenda in the region”, warning that it would compromise Bangladesh’s sovereignty.

Meanwhile, Islami Andolan Bangladesh’s Ameer Syed Muhammad Rezaul Karim said the government must build a national consensus before taking such a decision.

“This is not merely a humanitarian matter, it is a national security issue,” he said, adding, “Such decisions are inappropriate without broad understanding and agreement between all political quarters.”

H e f a z a t - e - I s l a m Bangladesh’s Joint Secretary General Mamunul Haque strongly opposed the move.

“Imperialist powers are trying to implement their agenda by using Bangladesh. As a patriotic force, Hefazat-e-Islam does not support this in any way,” he said at a press conference yesterday.

He also warned that such decisions could drag Bangladesh into unwanted geopolitical entanglements.

SC stays HC bail of 15 pro-AL lawyers

EXPATRIATE VOTING METHOD EC seeks party suggestions by May 15

The Election Commission (EC) has asked political parties to submit their recommendations by May 15 on a proposed hybrid voting system for expatriate Bangladeshis, combining postal ballots, online voting, and proxy voting.

At a seminar organised by the EC on this issue, leaders of several political parties said more in-depth discussions are needed before finalising any method.

The event, held at the EC office in Agargaon, was attended by representatives from over 20 political parties, university teachers, and media professionals.

Chief Election Commissioner (CEC) AMM Nasir Uddin said, "One size doesn't fit all," stressing that any final decision must consider the country's socio-economic and political context, along with the general level of education.

He assured that stakeholder input would be considered and emphasised the importance of political leaders' support, without which, he said, the initiative would be futile.

BNP Standing Committee Member Nazrul Islam Khan noted that no voting system is perfect and called for a system that is accessible, efficient, and widely accepted.

Communist Party of Bangladesh (CPB) Presidium Member Kazi Sajjad Zahir Chandon pointed out that expatriates make up about 10 percent of voters. He said the EC must earn political parties' trust and consult with them before making a decision.

Nagarik Oikya Organising Secretary Shakib Anwar suggested the EC hold more interactive sessions with

A hospital without doctors

The Kuakata 20-bed Hospital exists only in name, as it currently has no doctors, severely disrupting healthcare services for both residents and tourists.

Although the hospital is supposed to have six doctors, including four junior consultants, a residential medical officer, and a medical officer, all the posts are vacant.

The last serving doctor left the facility on April 17 to attend a two-month-long course, leaving the hospital without medical staff since then.

According to hospital sources, out of 17

areas, as well as visiting tourists, of necessary healthcare.

"Since the hospital was inaugurated, it has never had full staffing. As a result, we have long been deprived of proper medical services," said Ashraf Ali, a resident of the hospital's adjoining area.

Ruman Imtiaz Tushar, president of Kuakata Press Club, said, "Considering Kuakata's importance as a tourism hub, it is essential to appoint sufficient doctors and fully operationalise the hospital immediately."

Though the hospital was formally inaugurated on February 25, 2012, it has never operated with its full



approved staff positions, 12 remain vacant. The facility currently has five senior staff nurses; and one each of ward staff, lab attendant, ward assistant, office assistant, cook, and cleaner on paper. However, the ward staff has been temporarily transferred to the Kalapara Upazila Health Complex, and the lab attendant is serving at the Patuakhali Civil Surgeon's office, further crippling operations.

As a result, the hospital has been non-functional, depriving hundreds of thousands of residents in Mahipur, Latachapl, and Kuakata municipality

workforce. Often, it ran with just one or two doctors, rendering healthcare services ineffective, he said.

Contacted, Dr JH Khan Lelin, health and family planning officer of Kalapara upazila, said they had already requested higher authorities to post doctors to Kuakata and other healthcare facilities under his jurisdiction.

"Meanwhile, we have deployed a sub-assistant medical officer to keep emergency and outpatient services at the Kuakata hospital somewhat functional," he added.

'Consensus possible by June if NCC shows wisdom'

Says Biplobi Workers Party at a dialogue with the commission

Political consensus can be achieved by June if the National Consensus Commission (NCC) demonstrates wisdom and foresight, said Saiful Haque, general secretary of Biplobi Workers Party, yesterday.

He made the remarks during a dialogue with the commission held at the LD Hall at the Jatiya Sangsad Complex.

A 10-member delegation from his party, led by Saiful, took part in the discussion.

"Since political parties are committed to the public sphere and have made promises to the people, an understanding among them could be reached by June if the consensus commission demonstrates wisdom and foresight. This would lead to consensus on the question of minimum national unity," he said.

He also said, "We do not want to go back to a system that turns a party into an autocracy and its leadership into a fascist regime."

"The mandate of this uprising is to move beyond that era and begin a democratic journey that will ensure the people's voting rights and democratic freedoms," he added.

Referring to the July uprising and what he termed a 16-year struggle against fascism, Saiful added, "People have been waiting for a real election. If reforms and elections are addressed together, Bangladesh will move forward."

He also called for a constitution that guarantees equal rights for all citizens regardless of political, religious, social, or ideological beliefs.

"Every citizen's constitutional and civil rights must be guaranteed by the state," he said.

The party leader also urged the creation of a system of governance rooted in accountability.

"No individual or party should feel entitled to wield

Confiscate Saima Wazed's Gulshan flat

Court orders ACC

A Dhaka court yesterday ordered the Anti-Corruption Commission to confiscate a flat in Dhaka's Gulshan owned by Saima Wazed Putul, daughter of ousted prime minister Sheikh Hasina, in connection with corruption allegations brought against her.

The court also approved a request to appoint a receiver to oversee the flat.

Judge Md Zakir Hossain of the Dhaka Metropolitan Senior Special Judge's Court passed the order following an application filed by ACC Deputy Director Md Monirul Islam, who is leading the inquiry, said Md Aktarul Islam, public relations officer of the ACC.

ACC Public Prosecutor Md Rezaul Islam moved the application on behalf of the anti-graft body.

On April 27, the same court ordered authorities to initiate steps to secure an Interpol arrest warrant against Putul in connection with alleged irregularities in plot allocations in Purbachal New Town.

ACC Assistant Director Anan Jannat Keya submitted the charge sheet on March 25, listing all 18 accused as fugitives and seeking arrest warrants against them.

Polytechnic students shut down campuses

Students of polytechnic institutes across the country yesterday announced that all campuses would remain shut until a proper roadmap for implementing their six-point demand is formulated.

“Administrative and academic buildings will be locked, and all campus activities will remain suspended,” said Mashfik Islam Dewan, a leader of Karigori Chhatra Andolon (Technical Students’ Movement), while speaking at Dhaka Polytechnic Institute. Afterwards, students locked the campus entrances around 11:30am.

Shutdown programmes were also enforced at institutes in Sirajganj, Chapainawabganj, Kushtia, Jhenaidah, Lakshimpur, Rajshahi, Chattogram, and other districts under the same platform.

Protesters said the move came in response to the slow progress of the committee formed by the Technical and Madrasah Education Division. The committee has only held one meeting so far, with no significant updates on the roadmap’s preparation.

“We are not seeing any tangible progress. The committee is not working with the urgency the situation requires,” said Mashfik.

He warned that the shutdown would continue until the authorities officially publish a detailed roadmap outlining the implementation timeline of their six-point charter.

Earlier, on April 22, the

Country failing to protect children from violence

Experts call for cultural shift, stricter enforcement of laws

A 16-year-old madrasa student in Jhenaidah was hospitalised last month after being beaten by an assistant teacher – reportedly for eating two slices of leftover orange after iftar, with the madrasa superintendent’s permission.

Unaware of the approval, the teacher allegedly beat the boy so severely that seven sticks were broken during the assault.

Despite longstanding legal prohibitions, the presence of corporal punishment remains a major barrier to ending violence against children, say

Today, as Bangladesh joins the global observance of the International Day to End Corporal Punishment of Children – celebrated on April 30 every year – child rights advocates are renewing calls for stricter enforcement of laws, greater public awareness, and a shift in cultural attitudes.

Not forming edn reform commission a ‘national failure’

Says Centre for Policy Dialogue

The government’s failure to form an education reform commission, despite setting up 11 other reform bodies, is a form of national failure, said Debapriya Bhattacharya, distinguished fellow of the Centre for Policy Dialogue (CPD), yesterday.

Debapriya, who also serves as the convener of the Citizen’s Platform for SDGs, Bangladesh, made the remarks at a media briefing titled “Technical and Vocational Education in Bangladesh: Current Situation and Reform Thinking,” held at the CPD office in the capital’s Dhanmondi.

“The most sensitive question is why the government did not set up an education reform commission,” he said.

“Education is not just a technical matter. It includes values, worldviews, and perspectives on humanity, the world, and the nation. It also carries historical awareness. These issues have become especially

Migrants stranded as ‘Ami Probashi’ app goes offline

Abdul (not his real name) paid for his Bureau of Manpower, Employment and Training (BMET) clearance through the Ami Probashi app, completed all the necessary steps online, and was ready to board his flight to Saudi Arabia.

But when the app abruptly became inactive following the government’s decision not to renew its contract, his dreams were grounded—literally.

“The ticket was bought, and bags were packed,” he said.

“Then, just because the app was blocked and no one had any answers, I had to stay behind. I don’t even know if I’ll get another visa.”

He is one of more than 2,100 migrant workers left in limbo after the Ami Probashi app—once widely used to apply for BMET clearance—ceased functioning on April 19 when its agreement expired.

Over 20 workers have already missed their flights, while at least 50 are on the verge of losing their visas.

“My visa will expire in a few days. I completed everything through the Ami Probashi app and was just waiting for clearance. Now I don’t know what will happen,” said another affected worker.

Launched in May 2021, Ami Probashi was a privately developed

app that partnered with the Ministry of Expatriates’ Welfare to digitise services including BMET registration, emigration clearance, and Pre-Departure Orientation (PDO) bookings.

Though optional, the app became immensely popular—particularly among

Though optional, the app became immensely popular as a transparent and agent-free method to complete formalities. Over four million people used the platform, often bypassing middlemen and associated costs.

tech-savvy migrants—as a transparent and agent-free method to complete formalities. More than four million people used the platform, often bypassing middlemen and associated costs.

Now, with operations suspended, thousands are struggling. Over 10,000 workers trying to book daily PDO sessions cannot secure slots. Another 5,000 are

government does not want to implement, he said, citing the liberalisation of the exchange rate as the bone of contention.

"We fought with them, we argued with them. We gave them examples and told them we won't tread that path. There is macroeconomic stability in Bangladesh now and the situation is much better than in December, and they also agreed with this."

He said the price of dollar hit Rs 280 in Pakistan and LKR 400 in Sri Lanka after they launched the market-based floating system.

"We told the IMF if we open the market now, the dollar exchange rate would hit that level. So, we deferred."

The foreign exchange market and foreign reserves level are both stable without the IMF tranches, he said.

The exchange rate is hovering around the Tk 120-122 mark under a crawling peg mechanism introduced on the IMF's prescription.

Under the mechanism, the exchange rate fluctuates within a certain range.

"They told us to remove the band under the crawling peg," Salehuddin said.

If the band is removed, he fears the dollar would appreciate unsustainably.

"So we asked for a \$1 billion stabilisation fund if we removed the band, and they agreed for a \$500 million fund. Still, we are considering."

If the taka is allowed to float freely, there would be "peaks and troughs" of the exchange rate and the volatility would send a wrong signal to investors, the adviser said.

He believes non-disbursement of the two IMF instalments would affect the chances of getting budget support from the WB and other multilateral lenders, but it would not affect getting loans from them for projects.

"We don't want to take loans with hard conditions. Pakistan took \$7 billion and Argentina took \$20 billion. We don't want to increase our debt burden. If we take \$3 billion and for that, we have to make the exchange rate flexible, we would need around \$5 billion to repay that amount," Salehuddin added.

At another event, National Board of Revenue Chairman Abdur Rahman Khan said the IMF board would take a decision on whether to approve the two tranches for Bangladesh on May 5.

"We are optimistic that a positive outcome will be reached."

a press release issued by the information ministry quoted him as saying.

The channel's parent company, Kazi Media Ltd, also served a termination letter to senior journalist Md Mizanur Rahman, stating he was dismissed with immediate effect.

A senior newsroom member at Deepto TV, requesting anonymity, told this newspaper the journalist was sacked due to the incident at the previous day's press conference.

Md Fazle Rabby, a special correspondent of ATN Bangla Ltd, was also terminated yesterday on grounds of "unprofessional conduct during reporting".

A termination letter, signed by the channel's Chairperson Mahfuzur Rahman, read, "You are being terminated for failing to do your professional duty during reporting."

Speaking to The Daily Star, Fazle Rabby said he was neither asked for an explanation nor served with a show-cause notice prior to his dismissal.

"I wasn't questioned, and the office didn't discuss it with me. After clips from the press conference went viral on social media, there was considerable backlash, with groups threatening to march to the television station. As a result, I was mentally prepared for this outcome."

He claimed he was dismissed for "doing journalism".

Channel i's senior reporter Rafiqul Bashar was also suspended. The channel's online platform posted a notice on social media saying, "Channel i has suspended and commenced an internal investigation against the journalist accused of not exhibiting professionalism during the question-and-answer session of the cultural adviser's press conference."

Bashar told this correspondent he had not been given a reason for his suspension. "I was told by the office that my job is gone, but no reason was provided. I don't think I said anything at the press conference that went against the spirit of the July movement."

Meanwhile, Bangladesh Journalists in International Media in a statement last night said, "We call on the authorities to ensure the journalists' safety and protect them from potential offline harm, and urge the respective media outlets to stand by their journalists, ensure their protection, and refrain from punishing them for fulfilling their professional duties."

FAROOKI'S STATEMENT

Around 11:30pm last night, Cultural Adviser Mostofa Sarwar Farooki on his verified Facebook page claimed that the remarks made by the three journalists, who have now been terminated or suspended, at the press meet appeared to reflect a "subtle attempt at mass murder denial".

"The words spoken yesterday could hurt anyone who witnessed July... For a mother who lost her child just eight months ago, for someone wounded by a killer's bullet, for a brother or sister who narrowly escaped death – those comments struck like shrapnel."

He noted that justice for the killings has yet to be served. "Even in the West, Holocaust denial continues to hurt people despite judicial closure. Here, we are only eight months since the tragedy, and when someone questions whether a killer can be called a killer, it's seen as an attempt to erase the memory of July."

The adviser added, "This evening [last evening], I learned that the journalists have been dismissed by their respective channels. Every media house has its own editorial policy, and decisions are made based on that."

Responding to claims circulating online that the journalists lost their jobs because they questioned him directly, Farooki called such assertions "ridiculous."

"This is not about me – it's about July, and the policies of the institutions involved. Those trying to connect me to their dismissal are missing the point entirely," he said, adding, "For the record, I want to make it clear that we had no direct or indirect involvement in their employment status. Anyone who has doubts can contact those channels to know the truth. It's better not to reach conclusions based on speculation."

has been spreading rumours and fabricated information involving Asiatic 3sixty and its affiliated companies through media and social platforms.

On the allegation of supplying fake gold medals to various global figures in recognition of their support for Bangladesh's Liberation War, Asiatic 3sixty said that they were supplied by a different company, and clarified that Asiatic's involvement in that initiative was "to act as an event management company".

The statement also denied past or present connections between CRI (Centre for Research and Information), and Asiatic 3sixty's Managing Director Iresh Zaker or any of its affiliated companies.

Regarding the 50th anniversary of independence and Mujib Borsho celebrations, the statement said, "Asiatic was responsible for event management, logistics supply, and event-related technical support only, which was also done by maintaining strict standards, processes, and transparency. All aspects of this engagement followed due process and were transparent at every step."

The group also denied allegations of monopolising the advertising market, saying it has a competitive bidding process for all private and corporate clients, and that it has always participated in competitive pitches and tenders, meeting the necessary criteria.

"Asiatic responds to requests for proposals, competes based on merit, and, upon selection, executes contracts with professionalism, efficiency, and clarity. In this regard, the highest integrity and transparency are always maintained," said the statement.

Asiatic 3sixty operates within a healthy and competitive market, where the company earned its position alongside many other reputed agencies, the statement added.

In the statement, the group also denied involvement in any Joy Bangla concerts held in previous years, saying two other leading agencies organised them. It added, "While Asiatic was involved in organising some events for various ministries during the tenure of the past government, the company was never associated with managing or promoting any political party's campaign or event."

The statement also clarified Asiatic 3sixty's position on the freezing of bank accounts belonging to 17 companies under Asiatic 3sixty, along with those of 6 board members and 2 employees.

"No prior notice or official warning was issued to Asiatic in this matter," the statement read, adding that due to the lack of specific allegation in media reporting or communication from the banks, the legal team of Asiatic has reached out to the relevant authorities to better understand the issue.

Asiatic 3sixty highlighted that it employs over 700 permanent staff and nearly 4,000 contractual employees nationwide, and over 500 vendors are associated with the group's operations.

"The sudden freezing of the bank accounts of Asiatic 3sixty has placed the livelihoods of its employees, their families, and these extended partners at serious risk and raised concerns with deep empathy," the statement read.

The statement also highlighted the group's position in the marketing communications sector of the country, saying, "Asiatic remains the only agency group in Bangladesh that works exclusively in marketing communications and related services. We are not involved in any other business. Over the last five years alone, Asiatic has contributed more than Tk 750 crore to the national exchequer in the form of VAT, taxes, and various government fees."

Israel ‘live-streamed Gaza genocide’

Amnesty says ‘states watched on as if powerless’

AFP, Paris

Amnesty International yesterday accused Israel of committing a “live-streamed genocide” against Palestinians in Gaza by forcibly displacing most of the population and deliberately creating a humanitarian catastrophe.

In its annual report, Amnesty charged that Israel had acted with “specific intent to destroy Palestinians in Gaza, thus committing genocide”.

Since Israel launched its offensive in Gaza on October 7, 2023, at least 52,243 Palestinians, mostly women and children, have been killed there.

“Since 7 October 2023, when Hamas perpetrated horrific crimes against Israeli citizens and others and captured more than 250 hostages, the world has been made an audience to a live-streamed genocide,” Amnesty’s secretary general Agnes Callamard said in the introduction to the report.

“States watched on as if powerless, as Israel killed thousands upon thousands of Palestinians, wiping out entire

multigenerational families, destroying homes, livelihoods, hospitals and schools,” she added.

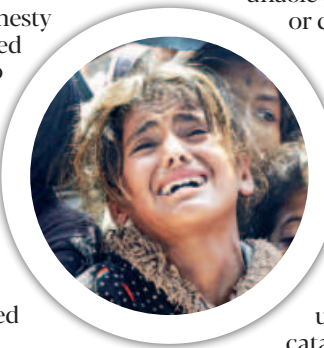
Amnesty’s report said the Israeli campaign had left most of the Palestinians of Gaza “displaced, homeless, hungry, at risk of life-threatening diseases and unable to access medical care, power or clean water”.

Amnesty said that throughout 2024 it had “documented multiple war crimes by Israel”.

It said Israel’s actions forcibly displaced 1.9 million Palestinians, around 90 percent of Gaza’s population, and “deliberately engineered an unprecedented humanitarian catastrophe”.

Even as protesters hit the streets in Western capitals, “the world’s governments individually and multilaterally failed repeatedly to take meaningful action to end the atrocities and were slow even in calling for a ceasefire”.

Meanwhile, Amnesty also sounded alarm over Israeli actions in the occupied Palestinian territory of the West Bank, and repeated an accusation that Israel was employing a system of “apartheid”.

Zelensky slams Putin's truce call

Ukraine's President Volodymyr Zelensky has branded a three-day truce announced by his Russian counterpart Vladimir Putin as an “attempt at manipulation”.

“Now there's a new attempt at manipulation: for some reason, everyone has to wait until May 8,” Zelensky said in his daily address.

Putin on Monday ordered the ceasefire on May 8-10, which coincides with Moscow's World War II commemorations, drawing ire from Kyiv, which demanded Moscow pause hostilities immediately.

Ukraine said that it wanted an immediate truce with Russia for “at least 30 days”.

“If Russia truly wants peace, it must cease fire immediately. Why wait until May 8th?” Ukrainian Foreign Minister Andriy Sybiga wrote on X.

The Kremlin yesterday said that Ukraine had not responded to many offers by Russia President Vladimir Putin to start direct peace negotiations, and that it was unclear whether it would join a three-day ceasefire he has announced for next month.

100 DAYS OF TRUMP 2.0

President's ‘fun’ fails to uplift American spirit

After 100 days of political chaos and economic shock that have sent his approval ratings tumbling, Donald Trump hopes to regain the unqualified adulation of his supporters Tuesday at one of his bread-and-butter events: a public rally.

To mark the symbolic milestone in his second term, the Republican US president is visiting the site of one of his last campaign events, in Michigan, a battleground state that swung his way in November's election.

“The first time, I had two things to do – run the country and survive; I had all these crooked guys,” he said in an interview with The Atlantic magazine, referring to advisors and cabinet members whom he considered incompetent or disloyal lieutenants in his first term.

“And the second time, I run the country and the world,” he crowed, adding “I’m having a lot of fun.”

Many of the former real estate tycoon's voters remain behind Trump.

“He knows what he's doing,” Karen Miner, a 57-year-old wine store owner in Reno, Nevada, told AFP.

“So far, I'm very satisfied with the job he's doing,” said Frank Tuoti, a 72-year-old retired machinist from New Hampshire.

But he concedes that the tariff instability has made him “a little concerned about the economy.”

Now surrounded exclusively by loyalists, Trump since January 20 has unleashed in terms of tariffs, foreign policy -- and political revenge.



In the grand entrance hallway of the White House, he has moved a portrait of Barack Obama, America's first Black president, to make way for a painting of himself surviving an assassination attempt.

And in the Oval Office, pushing the limits of presidential power, the Republican has already signed over 140 executive orders.

In the process, he has called birthright citizenship into question, attacked universities and law firms, rolled back environmental policies, entrusted his mega-billionaire ally Elon Musk with dismantling large parts of the federal bureaucracy, and launched a protectionist trade offensive against much of the world -- before partially retracting it.

Many of his executive orders have been blocked by judges, with whom the executive branch has engaged in an unprecedented bout of arm wrestling.

Trump, whose political career was built on deepening divisions, cannot claim the high approval ratings that generally accompany

the first 100 days of a US president.

Opinion polls have been unanimous in noting a particularly sharp slide in his approval ratings, fueled by concern about tariffs and his attacks on the institutional order. According to a poll published Sunday by the Washington Post and ABC News, only 39 percent of Americans approve of how Trump is conducting his presidency.

With the exception of Bill Clinton and now Trump, US presidents dating back to Ronald Reagan have had an approval rating topping 50 percent after their first 100 days in office, according to the Pew Research Center.

Trump called the polls “Fake News” in a Truth Social post on Monday. “We are doing GREAT, better than ever before.”

At least 64 percent of respondents said Trump is “going too far” in his efforts to expand presidential powers.

It is impossible to know how long Trump, who at 78 is the oldest US president ever elected, will maintain his frenetic pace.

Restaurant fire in China kills 22

A restaurant fire in northeastern China killed 22 people and injured three yesterday, Beijing's state media said, with footage posted online showing fierce flames engulfing the building.

The blaze erupted at lunchtime in Liaoyang City, about 580 kilometres northeast of the capital Beijing, according to state broadcaster CCTV.

“The incident has resulted in 22 deaths and three injuries,” it added.

President Xi Jinping said that the blaze had caused “significant casualties” and that the lessons from it were “profoundly serious”, CCTV said.

Xi called for “every effort to treat the injured, properly handle the aftermath for the deceased and provide support to their families, swiftly determine the cause of the fire, and pursue accountability in accordance with the law,” the report added.

Footage shared online and verified by AFP showed the inferno engulfing the two-storey restaurant and smoke billowing skyward.

Deadly fires are relatively common in China due to lax building codes and an often slipshod approach to workplace safety.

The country has seen a spate of such deadly incidents in recent months.

This month, 20 people died in a fire at a nursing home in northern China's Hebei province.

‘Diplomacy, not confrontation’ Says BRICS amid tensions

Brazil, which chairs the 11-nation BRICS grouping that also includes Russia and China, called for closer cooperation as the world deals with conflicts in Ukraine and Gaza and trade wars under US President Donald Trump.

“We advocate diplomacy instead of confrontation, and cooperation instead of unilateralism,” Brazil's Foreign Minister Mauro Vieira told the BRICS foreign ministers in Rio.

“The conflict in Ukraine continues to have a severe humanitarian impact, highlighting the urgent need for a diplomatic solution,” he added.

Ministers from the bloc -- which also includes Egypt, Ethiopia, India, Indonesia, Iran, Saudi Arabia, South Africa and the United Arab Emirates -- met to hone their agenda ahead of a leaders' summit on July 6 and 7.

Vieira on Monday also called for a “complete withdrawal” of Israeli forces from Gaza.

“The resumption of Israeli bombings and the continuous obstruction of humanitarian aid are unacceptable,” he said.

The ministers were expected to issue a final joint statement yesterday in which they will call for respect for multilateralism and international market rules.

BRICS has expanded significantly since its 2009 inception as a group of four powers -- Brazil, Russia, India and China -- seeking an alternative platform to Western-led international organisations such as the G7.

It now makes up nearly half of the world's population, 39 percent of global GDP and weighs in on issues from Ukraine to Gaza to global trade.

A BRICS challenge to the hegemony of the dollar was expected to feature high on the agenda being prepared for July.



India gives forces ‘operational freedom’

The development came after Pakistan's defence minister said a military incursion by neighbouring India was imminent.

“We have reinforced our forces because it is something which is imminent now. So in that situation, some strategic decisions have to be taken, so those decisions have been

taken,” Defence Minister Khawaja Muhammad Asif told Reuters in an interview at his office in Islamabad on Monday.

Yesterday, New Delhi released video images of a stern-faced Modi meeting with army chiefs, as well as Defence Minister Rajnath Singh and National Security Adviser Ajit Doval.

Sources said a meeting of the Cabinet Committee on Security and Political and Economic Affairs will be held, possibly today.

After the terror attack, Modi vowed to pursue the terrorists behind the attack and their patrons to the “ends of the earth” and inflict the harshest punishment on them.

Relations between the nuclear-armed neighbours have plummeted after India accused Pakistan of backing an attack in Indian-administered Kashmir on April 22 in which 26 men were killed.

Islamabad has denied any role and called for a neutral investigation. Both countries have since exchanged gunfire in Kashmir, diplomatic barbs, expelled citizens and ordered the border shut.

Yesterday, the Indian army said that both sides exchanged fire for a fifth straight night along the Line of Control (LoC), a heavily fortified zone of high-altitude Himalayan outposts.

There was no immediate confirmation from Pakistan on the exchange of fire, but state broadcaster Radio Pakistan reported that the

military had shot down an Indian “quadcopter”, calling it a violation of its airspace.

The unmanned Indian aircraft had attempted to conduct surveillance along the LoC in the Manawar Sector of the Bhimber area, the Radio Pakistan report said.

It did not say when the incident happened. There was no comment from New Delhi.

Analysts say they fear bellicose statements will escalate into possible military action.

During his interview with Reuters, Asif said India's rhetoric was ramping up and that Pakistan's military had briefed the government on the possibility of an Indian attack. He did not go into further details on his reasons for thinking an incursion was imminent.

He said, although Pakistan was on high alert, it would only use its nuclear weapons if “there is a direct threat to our existence”.

Meanwhile, Aqeel Malik, Pakistan's minister of state for law and justice, said Islamabad is preparing international legal action over India's suspension of the Indus water-sharing treaty.

He told Reuters late on

Monday that Islamabad was working on plans for at least three different legal options, including raising the issue at the World Bank, the treaty's facilitator.

It was also considering taking action at the Permanent Court of Arbitration or at the International Court of Justice in the Hague where it could allege that India has violated the 1960 Vienna Convention on the Law of Treaties, he said.

UN Secretary-General Antonio Guterres yesterday held calls with Pakistan's prime minister and India's foreign minister to express “deep concern at rising tensions”, his spokesman said.

The United Nations chief “underscored the need to avoid a confrontation that could result in tragic consequences. He offered his Good Offices to support de-escalation efforts,” spokesman Stephane Dujarric said.

During the call, Pakistan's Prime Minister Shehbaz Sharif urged the UN chief to “counsel India” to exercise restraint, his office said.

Iran has already offered to mediate, and Saudi Arabia has said Riyadh was trying to “prevent an escalation”.

Stop the trend of filing malicious cases

Authorities must protect citizens from this legal assault

We are concerned about the trend of filing dubious cases against individuals with alleged ties to the Awami League, which persists even nearly nine months after the August 5, 2024 political changeover. Journalists have been frequent targets of this legal assault. According to a report, at least 137 journalists have been implicated in 32 criminal cases filed in Dhaka, Chattogram, Bogura, and Rajshahi over the July-August events—the latest of them registered at the Mirpur police station on April 20, accusing Sheikh Hasina and 407 others, including 24 journalists, of involvement in the killing of BNP activist Mahfuz Alam Shraban. In addition to murder and attempted murder, journalists have also been charged with unlawful assembly, rioting, abduction, vandalism, extortion, assault, and even genocide and crimes against humanity.

According to a Supreme Court lawyer, even in places where no student movement took place or no one died, journalists have been falsely implicated. Referring to the case of a journalist couple who were sued for murder, he noted that while journalists may have committed other offences for which they could be booked, a murder charge “sounds vague.” The argument that those who aided, committed or enabled July atrocities and those who extended moral support to the regime—through talk shows or speeches, for example—belong in the same bracket is not only legally tenuous; it also opens the door to abuse and invites question marks over any outcome of the ongoing trials. The implication of media personality Iresh Zaker in the Shraban murder case, alongside journalists, doctors, businesspeople, and lawyers, further illustrates that anyone is fair game in such a climate.

The Shraban case exemplifies how the right to file cases is being abused. Three individuals named as witnesses in the case have said they were unaware of being listed. The case statement lists eight in total, including the plaintiff, and provides the phone numbers of four. This newspaper spoke to all four; three of them denied any knowledge of their inclusion. The manner in which the whole case came into being—about nine months after the uprising, at the behest of “an administrative office in Paltan,” using false witnesses, and implicating hundreds merely for their “support” of Hasina—reeks of both personal vendetta and a broader campaign against those even loosely associated with the previous regime. Unfortunately, the current process for filing cases does not require police officers to verify claims at the outset, allowing anyone to lodge dubious complaints. This is why the government’s instruction to police not to harass or arrest anyone wrongly implicated offers little hope or protection.

For journalists, this trend marks a new chapter in a country where they already routinely face threats, harassment, and intimidation. But it must be countered for the sake of everyone. It is crucial to address the underlying loopholes in the case-filing process—by strengthening initial verification mechanisms and, if necessary, disallowing mass accusations—and to ensure accountability for any misuse of legal provisions. The government alone cannot address this problem. Political parties, too, must come forward to stop this alarming trend.

Save migrants from forced war role

News of young men trafficked to Russia to serve as soldiers raises alarm

Bangladeshi migrants continue to be exploited in many ways. But the revelation that a number of aspiring migrants from Bangladesh have been trafficked to Russia and forced to fight in the war against Ukraine is quite shocking. According to media reports, some travel agencies are luring young men with the promise of high-paying jobs in Russian factories and restaurants. However, instead of the promised jobs, they are then forced to join the Russian military as “contract fighters” and sent to the frontlines with little or no training.

According to a report in this daily, the Human Trafficking Cell of the Criminal Investigation Department (CID) recently busted one such travel agency, which allegedly trafficked around 20 Bangladeshis to Russia over the past two years. Among them, at least three have been killed in the war and another has been critically injured. Some remain missing, with their families having lost all contact since they were sent to the battlefield.

With the Russia-Ukraine war dragging into its fourth year, it is believed that Russia, despite being the world’s second-largest military power, is struggling to recruit enough soldiers locally. As a result, it has increasingly turned to the Global South—including India, Nepal, Cuba, and Sri Lanka—for recruits, according to international media reports. Central Asian migrants already in Russia have also reportedly faced coercion or intimidation into joining the war. Recent reports from the Bangladeshi media confirm that our citizens, too, are now falling victim to traffickers who are essentially selling foot soldiers to the Russian military.

One key reason why traffickers have found a market in Bangladesh is the widespread poverty and unemployment among young men. One can only imagine the level of desperation it takes for someone to be enticed by offers of factory work in a country known for its brutal winters and volatile situation. The aspiring migrants reportedly paid between Tk 9 to Tk 12 lakh each for the promised jobs. That they would take such risks reflects a lack of faith in the opportunities available at home, pushing them into the arms of human traffickers.

We urge the authorities to raise awareness—especially in rural areas—about the dangers of war trafficking, and also to create more viable economic opportunities for youth in the country. Law enforcement drives against trafficking networks must be strengthened. Furthermore, the government must use its diplomatic channels to obtain the list of Bangladeshi nationals recruited by the Russian military, and initiate efforts to bring them back safely.

The promises and pressures of Bangladesh’s pharma industry

The pharmaceutical sector in Bangladesh, now valued at more than \$3.5 billion (as of 2023), stands as one of the most compelling narratives of progress in the country’s economic landscape. From meeting 98 percent of domestic medicine needs to reaching over 150 countries with exports, this industry has evolved into a cornerstone of both national health and economic resilience. Our pharmaceutical companies are not only providing affordable healthcare across the country, but they are also gradually earning recognition on the global stage. As we approach the country’s graduation from the Least Developed Country (LDC) status in November 2026, there is a growing need for the industry to adapt to new global norms and challenges.

This transformation has not happened overnight. Decades ago, Bangladesh was heavily reliant on imported medicines. Today, it produces nearly all essential drugs domestically, including life-saving ones such as antibiotics, insulin, and cancer treatments. With a population exceeding 170 million, the demand for accessible and cost-effective healthcare continues to grow. The local pharmaceutical sector has stepped up in response, resulting in improved health outcomes and a strengthened national supply chain. Alongside this domestic impact, the country has extended its pharmaceutical reach to international markets. In FY2023-24, pharmaceutical exports were valued at \$205.48 million, registering a 17.14 percent growth. Bangladeshi medicines reached regions in Africa, Southeast Asia, and even entered regulated markets like the United States and Europe. A key contributor to this success has been the industry’s commitment to upgrading its technological capabilities and investing in more advanced manufacturing practices, including the production of biosimilars and complex generics.

Underlying this growth has been a strategic use of policy flexibility under the World Trade Organization’s (WTO) Trade-Related Aspects of Intellectual Property Rights (TRIPS) agreement. Bangladesh currently benefits from a waiver that allows the production of generic versions of patented drugs without the need for costly licensing. This policy has provided a significant competitive edge in global markets. However, this advantage will come to

an end after November 2026. Once the waiver expires, companies will be required to obtain a licence to produce patented medications. This shift is likely to increase production costs, potentially affecting the affordability of life-saving drugs. At the same time, global pharmaceutical giants may reclaim market space that Bangladeshi firms have started to occupy.

The expiration of the TRIPS waiver is just one aspect of a broader set of challenges that the industry will need to address. One of the most pressing issues is the overwhelming dependency on imported raw materials, specifically active pharmaceutical ingredients

manufacturing, especially in fields like biologics and hormone-based treatments, requires specialised training and a strong foundation in both research and engineering. Although progress has been made, there is still a long road ahead in terms of workforce development. Infrastructure development has not kept pace either. Projects like the long-awaited API Industrial Park have faced repeated delays, often tied to policy inconsistencies and administrative bottlenecks. As Bangladesh graduates from the LDC status, it is also set to lose various trade privileges, including duty-free access to several export markets. This shift may erode the cost competitiveness that has so far helped our pharmaceutical products find a foothold abroad.

Still, despite these hurdles, there is reason to be optimistic. While highly regulated markets have always attracted the most attention, there are numerous unregulated and semi-regulated markets in regions like Africa, Latin America, and parts of Asia that

Government incentives, policy support, and funding for research facilities, when combined with private sector efficiency and ambition, can create a powerful engine for long-term growth. As part of this preparation, the government can also explore negotiating an extension to the TRIPS transition period to allow more time for adaptation. Building frameworks for patent access, including participation in global patent pools or voluntary licensing agreements, can help maintain the affordability and availability of newer medicines. Additionally, streamlining regulatory approval processes, simplifying land acquisition, and providing tax incentives for research activities would send a strong signal to investors and innovators alike.

There is no doubt that Bangladesh’s pharmaceutical industry has shown remarkable potential. But in order to sustain this momentum, we will need forward-looking policies, strong coordination across stakeholders, and a willingness to confront the industry’s structural weaknesses. This is a moment

(API). More than 95 percent of these are sourced from countries like India and China, which makes the entire production chain vulnerable to disruptions and external price fluctuations. Beyond sourcing materials, the path to entering highly regulated export markets is filled with obstacles. Certifications for compliance with international standards can be expensive and time-consuming, often delayed further by bureaucratic inefficiencies at home. Building new manufacturing facilities or upgrading existing ones also tends to move slowly under the current administrative frameworks.

Another critical concern lies in the gap between the industry’s technical demands and the available talent pool. Modern pharmaceutical

offer immediate opportunities. These areas typically have fewer entry barriers and a strong demand for affordable, quality medicines. Accelerating the establishment of the API Industrial Park and supporting local production capabilities can significantly reduce dependency on imported raw materials, making the industry more resilient and cost-effective in the long run. With global demographics shifting and an ageing population driving the need for drugs targeting chronic illnesses and cancer, Bangladesh has a timely opportunity to develop its expertise in biosimilars and niche therapeutic areas through targeted investment in research and development.

Collaboration between the public and private sectors will be key in unlocking the next phase of innovation.

Laws exist, but silence does not

Noise pollution in Bangladesh has escalated to alarming levels, posing significant threats to public health and the environment. The increasing prevalence of loud music at social events, excessive honking in traffic, relentless mechanical noise from construction sites, and industrial operations have made high-decibel sounds a regular aspect of urban life. The problem is particularly acute in cities such as Dhaka, Chattogram, and Rajshahi, where noise levels far exceed safe limits.

According to a 2022 United Nations Environment Programme (UNEP) report, Dhaka ranked as the world’s noisiest city with average noise levels of 119 decibels, followed by Rajshahi at 103 decibels. These figures far surpass the World Health Organization’s (WHO) recommended limits—55 decibels for residential areas and 70 decibels for commercial spaces during the day. WHO’s 2018 guidelines reduced the safe limit to 53 decibels, mirrored by the Bangladesh Environment Conservation Act and the Noise Pollution (Control) Rules. Main noise sources include chaotic traffic, hydraulic horns,

outdated engines, construction work, and loudspeakers at public events. Airports and railway stations further amplify this constant high-decibel environment.

The WHO estimates that over five percent of the global population suffers from noise-related issues. The safe noise is now considered to be 55 decibels. Levels above 65 decibels may cause heart problems; over 90 can lead to ulcers, hearing loss, and nervous disorders. At 120 decibels, noise can cause pain and permanent hearing damage. Prolonged exposure contributes to stress, anxiety, sleep disorders, high blood pressure, and heart disease. Children are particularly vulnerable. Noise impairs their concentration and development. Older adults exposed to noise may experience cognitive decline, worsening conditions like dementia. Noise pollution also harms wildlife. Animals rely on sound for survival; excess noise forces them to change habitats and disrupts breeding. In aquatic environments, industrial and ship noise interferes with marine life like dolphins and whales that use echolocation for navigation and hunting.

Bangladesh introduced the Noise Pollution (Control) Rules, 2006, to address this crisis. These rules categorise five zones: silent, residential, mixed, commercial, and industrial. According to the law, authorities are required to mark these areas with signals or signs. Each zone has specific noise limits for day and night. Silent zones include hospitals, schools, offices, and the surrounding 100 metres

where the limit is 50 decibels during the day and 40 at night, and horn use is strictly prohibited. For residential zones, the day limit is 55 decibels and 45 at night. The rules allow exceptions for social, cultural, and political events such as weddings, concerts, fairs, and sports, provided permission is sought in advance. Such events can exceed limits for five hours a day, up to 10 pm. Violating these limits is a punishable offence.

Despite these detailed regulations, enforcement is weak, and violations are rampant. Government and law enforcement activities and programmes by faith-based groups are exempt from these rules, allowing sirens, horns, and loudspeakers to operate unchecked, often disturbing daily life. During the 2025 New Year celebrations, over 1,000 noise-related complaints were made to the emergency helpline 999, yet only a few prompted action, highlighting the gap between regulation and implementation. Penalties include up to one month in jail and/or a Tk 5,000 fine, with repeat offenders facing up to six months’ imprisonment and/or a Tk 10,000 fine. However, these penalties are too lenient to deter transport operators and event organisers. Additionally, residential power generators, a significant noise source, remain unregulated.

Public awareness is also a major hurdle. Most people are unaware of the rules, permitted noise limits, complaint processes, and permission procedures. The law is rarely discussed, and no large-scale public campaigns exist. As a result, the law is ineffective not

only due to lax enforcement but also because of public ignorance. Awareness campaigns, media involvement, and education programmes are crucial. When people understand the risks and legal boundaries, they are more likely to report violations and support action. Additionally, stricter enforcement is essential. Authorities must increase penalties, implement real-time noise monitoring, and regulate horn use and loudspeakers more strictly. Other countries strictly control honking and penalise loud residential music—Bangladesh must follow suit. Technology can also help. Installing noise barriers, encouraging quieter vehicles, and maintaining silent zones around schools and hospitals are important. Urban planning should include noise-reducing designs, such as better road layouts and soundproof buildings. Public celebrations should promote quieter practices, and fireworks and event sound systems must be strictly regulated.

Noise pollution is a growing crisis in Bangladesh, severely affecting public health, wildlife, and quality of life. Although laws exist, weak enforcement and a lack of awareness allow violations to continue unchecked. The problem is not solely the public’s fault—government negligence and lack of transparency also play a role. Solving this issue demands a collective effort from government, law enforcement, planners, and the public. Strengthened laws, increased awareness, technological interventions, and better planning are the keys to creating a quieter, healthier Bangladesh for all.

Why are young men becoming so violent?

The senseless killing of Jahidul Islam Parvez, a 24-year-old student of Primeasia University, over a trivial matter encapsulates a frightening trend in our society: violence is seen as the only means of resolution to a conflict. What is scarier is the appeal of violence and brutality among young people, especially young men.

The three main suspects of the murder, who have been arrested after identification through CCTV footage, and the others also in the case are in their 20s. It all happened when Parvez and his friends were chatting and having snacks at a tea stall near the university campus. According to media reports, two female students of another private university were also there and they felt insulted because they thought Parvez and his friends were laughing at them. The young women seemed to have complained to their friends, as soon after, a group of young men, possibly students, came and

they launched their attack on Parvez and his friend Tarikul using sharp weapons. Parvez was stabbed in the chest and died of his wounds, while his friend was critically injured.

Thus, a young life was cut short just because he might have been laughing at two female students. Parvez's assailants were so hungry for blood that they didn't even care that they were committing murder in public, that they would have to bear the consequences of their brutal act. How can they be so cruel and callous about the loss of a life over such a trivial matter?

The violent attacks and deaths of teenagers by "kishor gangs" (teenage gangs) over the last few years are a symptom of a society that is losing its moral compass and has failed its youth. There is a staggering lack of empathy, respect, and compassion in our society, which has seeped into many of our young people. The regular news of college students violently clashing with each other

weapons and making loud noises with their motorbikes, left residents and visitors petrified. CCTV footage of violent crimes taking place that flood social media often show that many of the perpetrators are young men, in their teens or twenties.

So what is happening to our youth? Well, to be honest, given the environment in which they grow up,

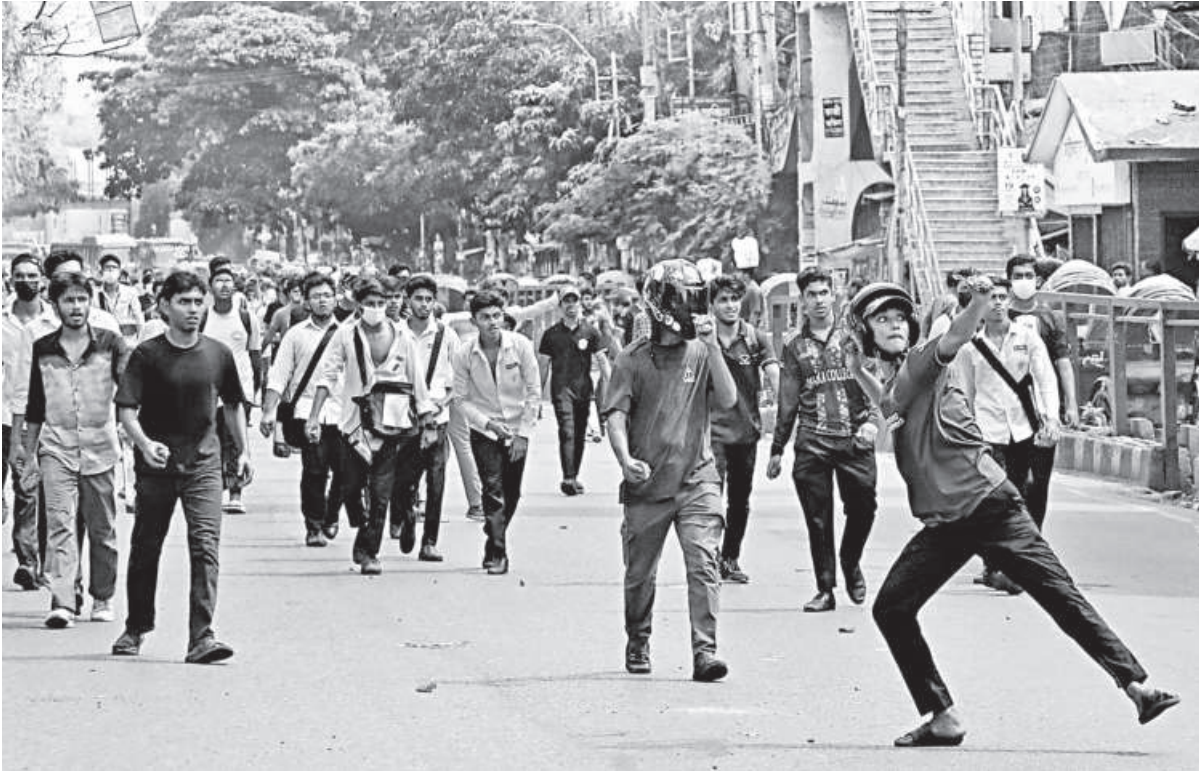

advantages of having a young population (almost 25 percent of the total population is in the 15-29 age group, according to the Bangladesh Bureau of Statistics) we often choose to ignore the fact that a huge proportion of our young people are deprived of basic prerequisites of a wholesome life. This includes access to quality education, skills training, health, nutritious food, and decent jobs. Many don't get the guidance and love that are essential for children to grow up with good values. School curriculums are uninspiring, classrooms are overcrowded, and teachers don't have the time to give personal attention to each student. There are not enough playgrounds or recreational facilities for young people. Entertainment has become confined to mobile devices with internet connection, exposing them to violent content and pornography that serve to glamorise sexual violence.

The truth is, our governments and society have grossly overlooked the nation's most valuable asset: its young people. They have been seen merely as cheap labour that will keep the wheels of the economy running, that will bring in huge remittances. But little has been done at the policy or ground levels regarding development of youth that will be impactful.

The July uprising showed the strength and power of young people when they united and led the way to uprooting tyranny. Their courage and sacrifice moved people to join them in their fight for justice. Now is the time for society to harness this strength and spirit. The interim government and political parties must prioritise young people and plan how to empower them with quality education, skills training, and opportunities to earn, as well as make them feel part of nation-building. But most of all, society as a whole must teach young people to be empathetic, peace-loving human beings. It is the only way our nation can survive.

Bangladesh must explore sending skilled nurses abroad

Chief Adviser Prof Muhammad Yunus, while speaking at an event back in February this year, emphasised two issues that are hindering Bangladesh's progress: the widespread use of forged documents by migrant workers, and the lack of certified nurses despite demand from around the world. He called for a serious re-evaluation of our current strategy and ascribed both issues to systemic faults, excessive bureaucracy, and opposition to reform.

It is important to have a comprehensive understanding of the global need for nurses and midwives before we make any observations or policy recommendations regarding the nursing profession in Bangladesh. Approximately 2.9 crore nurses and 22 lakh midwives are now providing healthcare worldwide. By 2030, there might be a shortage of roughly 45 lakh nurses and 3.1 lakh midwives because of the growing number of ageing population, expanding healthcare demands, and population growth.

To meet this growing demand, many countries have already started looking for international nurses to recruit. For instance, the United States will require more than 12 lakh nurses by 2030, while Germany will require more than 500,000. Additionally, as 24 percent of the UK's National Health Service (NHS) nurses received their training abroad, these countries are hiring more foreign-trained nurses and expediting credentialing procedures to meet their nursing shortages.

The Philippines and India are the two countries that contribute the most to the nursing workforce worldwide. About 640,000 Indian nurses work overseas, with a sizable portion of them based in the Gulf countries. As the largest represented non-UK nationality in the NHS, Indian professionals make up 10.1 percent of all full-time equivalent nurses and health visitors in the UK. Meanwhile, 28,258 Filipino nursing graduates took the US licensure exam in 2024, and 54 percent of the first-

time test-takers passed the test while 36 percent of repeat takers succeeded. The Philippine economy benefits greatly from the remittances sent home by Filipinos employed abroad, particularly nurses, which amount to about \$8 billion a year.

Prof Yunus, in his speech, also emphasised that Bangladesh has the potential to produce globally qualified nurses, yet despite interest from countries like the UK and Japan, systemic obstacles prevent us from meeting this rising global demand.

The biggest obstacle to nursing education comes from within the medical community and administration. The vested interests that have historically controlled the health education sector fear that if nurses gain professional skills and confidence through an MSc or PhD degree, they would start participating in patient management,

education, and because of the scarcity of seats, many deserving candidates are turned away every year. The absence of globally recognised BSc and MSc programmes is one of the sector's main structural problems. This crisis is not just about seat limitations; it is also about deep-rooted professional interests, power-hungry mindsets, and the gatekeeping tendencies of policymakers. decision-making, and hospital leadership, which may potentially break down the traditional power structure in hospitals.

The Bangladesh Nursing and Midwifery Council (BNMC) exacerbates this structural crisis. The role of this body should be to ensure the quality of education and expand its scope. But in reality, it has restricted the entire sector to government control by not allowing private universities to offer nursing programmes. Private medical colleges are running MBBS programmes under public universities. Similar arrangements could have been made in nursing education.

Prof Yunus drew our attention to another deep crisis: the use of fake certificates to avail work opportunities abroad. It is important to stop such corruption. But at the same time, we need to think about the deeper structural issues that encourage workers to commit such crimes. This problem is not only a domestic failure

for Bangladesh. The international labour market is also riddled with inequalities, lack of accountability, and a lack of institutional recognition. When we send workers abroad, our agreements with those countries often lack clear terms. As a result, opportunists harass our workers under various pretexts.

In developed countries, there is a recognised system called "apprenticeship" or "on-the-job training," where workers are given a formal certificate based on their work experience. But this facility is largely absent for workers in Bangladesh. As a result, when a worker with informal work experience applies for a new job, they are considered "unskilled." This rejection puts them in a situation where they feel the need to produce and present fake certificates. If foreign employers and agreements made with them provided other ways for Bangladeshi workers to prove their skills, the workers wouldn't feel pressured to use fake certificates to get ahead. The lack of such a system contributes significantly to the problem.

Corruption is not only internal; international structure also adds to the problem and helps facilitate the corrupt practices. Why do we not consider these issues seriously while signing contracts to send workers abroad?

It is imperative to take immediate action to address the issues the chief adviser highlighted. If we can produce skilled nurses suitable for the global market through necessary interventions and adequate recognition of work skills, along with other structural reforms, there is immense potential for us in the foreign labour market. We should not lag in utilising these potentials.

students had suspended their protests after the education ministry announced the formation of the committee. However, they withdrew the suspension the following day, expressing dissatisfaction with the committee's inactivity.

As part of their ongoing movement, students staged protest rallies on Sunday and Monday across the country. They also submitted a memorandum to the Institution of Diploma Engineers, Bangladesh (IDEB), reiterating their demands.

The six-point charter includes demands such as abolishing the 30 percent promotion quota for craft instructors, standardising the diploma-in-engineering curriculum to four years, ensuring reserved quotas in technical Grade-10 posts, and other reforms aimed at improving the quality of technical education.

Campus activities at many institutes across the country remained suspended yesterday as students locked the entrances to administrative and academic buildings, with banners and placards reiterating their six demands.

Meanwhile, education ministry officials told this newspaper that discussions were ongoing, but drafting a comprehensive roadmap would require time and further consultation with various stakeholders.

The accused pro-AL lawyers cannot get released from jail following the orders, said Additional Attorney General Md Abdul Jabbar Bhuiyan and defence lawyer Md Azhar Ullah Bhuiyan.

The HC granted the bail to the accused lawyers considering that there were no specific allegations against them, said Advocate Azhar Ullah Bhuiyan.

The case was filed against 144 pro-AL lawyers over allegations of attacking members of the Dhaka Bar Association, vandalising lawyers' chambers, and attempted murder.

Subsequently, 115 lawyers secured eight weeks' anticipatory bail from the HC in the case.

Otherwise, like Awami League, BNP too will be thrown out by the people," he said.

He also cautioned against being misled by misinformation on social media. "There are countless lies on Facebook," he said. "YouTube videos are so misleading they could make you lose your mind. Don't fall for them."

At the event, Fakhru reasserted BNP's vision for the country. "We want to build a happy, prosperous, and loving Bangladesh. We don't want division, revenge, or vengeance," he said.

power. We want to ensure transparency, accountability, and legal and constitutional guarantees for those in power to face the public."

Prof Ali Riaz, vice-chairman of the consensus commission, also addressed the dialogue, saying Bangladesh now has a historic opportunity to rebuild the state collectively.

important during this transitional time and have sometimes become points of contention," said Debapriya.

He said although the government claims to fight inequality and was born out of student and youth movements, it has not initiated education sector reforms.

To address this, Debapriya said CPD had proposed forming a high-level reform committee to the education adviser in March, aiming to overhaul the technical education sector and align it with market demands.

"However, no such body has been formed yet," he added.

He said a skilled technical workforce could drive employment in Bangladesh. However, a disproportionate focus on general education, inadequate planning, and weak monitoring have hindered the potential of technical and vocational education.

Referring to the Sustainable Development Goals (SDGs), he said ensuring wider and fairer access to quality technical education by 2030 is a key target. However, Bangladesh is falling behind.

"If education commissions had been formed and functioned properly, the state of technical education would be much better today," he said.

He added that countries like South Korea, Japan, and India have transformed their economies through strong technical and vocational education systems — something Bangladesh has yet to replicate.

Debapriya said despite the number of technical graduates each year, many are not ready for the job market due to outdated training equipment and curriculum mismatches.

As a result, many local graduates remain unemployed while foreign workers secure jobs in Bangladesh, he added.

He also called for changing the negative perception of technical education, where technical graduates are often undervalued compared to those with general degrees like BBA.

Speaking at the event, CPD's distinguished fellow Prof Mustafizur Rahman said Bangladesh's socio-economic progress depends on a greater focus on applied and technical education.

Highlighting the need for skilled workers and mid-level professionals before the country's LDC graduation, he stressed the importance of strengthening public-private partnerships and aligning vocational training with actual job market needs.

"To progress in the 21st century, Bangladesh must address these challenges urgently and systematically," he said.

Other CPD officials also attended the event.

political parties after collecting their recommendations.

Meanwhile, the National Citizen Party (NCP) has expressed doubts about the proxy voting system, and Jamaat-e-Islami said this method carries a risk of possible fraud. The AB Party also called it risky.

Jamaat-e-Islami Publicity Secretary Matiur Rahman Akanda said his party supports voting rights for expatriates but warned that proxies could misuse their power by voting for a different symbol than the one assigned by the actual voter.

Khaled Saifullah, joint convener of NCP, noted that in some regions, expatriates make up more than 10 percent of the electorate, so this can become a major issue.

However, despite concerns, leaders from BNP, Jamaat, CPB, and NCP said they would submit their recommendations within the deadline.

EC PREFERS PROXY SYSTEM

While the EC discussed three voting methods, officials indicated a preference for proxy voting for expatriate Bangladeshis.

They explained that online voting would require extensive and time-consuming trials, while the postal ballot system has proven ineffective, as expatriates have shown little interest in using it during past elections.

At the event, Election Commissioner Masud presented a draft amendment to include the proxy voting method in the Representation of the People's Order 1972.

in queue for one-stop clearance.

A government-backed digital alternative, developed in collaboration with Buet at the cost of several crore taka, has so far failed to operate smoothly, according to sources.

In the absence of a functioning online system, manual processing has returned—bringing with it allegations of corruption. Several workers have alleged that BMET officials are nudging them towards manual submissions, where unofficial payments are being demanded.

Those who previously completed the entire process independently are now turning to recruiting agents, often paying large sums for services they could once access themselves for free.


Tarique Ekramul Haque, managing director and founder of Ami Probashi, said the app was always focused on empowering migrants.

"To help them, we are ready to cooperate with the government and any stakeholders in the sector," he said.

"Though not mandatory, our submission system offered a vital alternative—allowing migrants to apply for training and clearance from their mobile phones."

He added, "We have full faith that the government is doing its best to resolve the issue and assist the affected migrants."

The crisis comes at a time when overseas job markets are shrinking.

the Supreme Court outlawed corporal punishment in educational institutions in 2011, and the Children Act 2013 prohibits cruel or degrading treatment of children, implementation remains weak and is poorly monitored.

Corporal punishment — defined as the use of physical force intended to cause pain as a disciplinary measure — remains deeply embedded in Bangladeshi society.

A national study conducted under the Children's Worlds Report 2020, involving over 3,000 children in Barishal, Rajshahi and Moulvibazar, found corporal punishment to be widespread at both schools and homes.

According to the 2019 Multiple Indicator Cluster Survey (MICS), 88.8 percent of 70,027 children aged 1–14 experienced physical punishment or psychological aggression in a month, over 30 percent faced severe physical punishment, while only 6.4 percent were subjected to non-violent discipline.

Alarming, 35 percent of mothers or caregivers believed physical punishment was necessary — suggesting that nearly nine in ten children, amounting to over 45 million in Bangladesh, are exposed to violent discipline monthly.

Globally, Unicef reports that 400 million children under five are regularly subjected to physical or psychological punishment at home, with around 330 million facing physical discipline.

Dr Helal Uddin Ahmed, professor of Child, Adolescent and Family Psychiatry at the National Institute of Mental Health, warned of the serious psychological impact.

"Corporal punishment in children leads to both immediate and long-term psychological and behavioural consequences," he said.

"Immediate effects may include stress, fear, aversion to authority figures, withdrawal from education, sleep disturbances, and regressive behaviours such as bedwetting," he also said.

Long-term impacts, he added, may include chronic depression, PTSD, difficulties in relationships, personality disorders, and an increased risk of becoming abusers themselves.

A 2021 report by the Global Partnership to End Violence Against Children, analysing over 300 studies, found no evidence of benefits to corporal punishment. Instead, it linked the practice to self-harm, anxiety, addiction, and intergenerational cycles of violence.

The World Health Organization, in its 2021 fact sheet "Corporal Punishment and Health," highlighted additional risks including chronic illness, school dropout, and increased aggression.

Child rights activist Laila Khondkar, convener of Shishurui Shob, said, "To truly protect children, Bangladesh must enact a comprehensive law banning corporal punishment in all settings — including the home. Existing policies, such as the Ministry of Education's circular, are important but must be properly monitored and implemented nationwide."

She added that both parents and teachers need training in non-violent discipline methods.

"Many parents are unaware that parenting itself is something that can and should be learned," she said. "Laws alone are not enough — mindsets must change."

Also at the meeting, Constable Samia Shorna from Dhaka district demanded a compensatory allowance equal to one month's basic salary.

In response, Chief Adviser Yunus assured the attendees that the issues raised would be further discussed.

Inspector General of Police Baharul Alam said Police Week aims to connect policymakers with frontline officers to modernise the force and boost their morale. Acknowledging past tensions with the public, particularly during the student protests, he said steps had been taken to rebuild trust.

Since the interim government assumed office in August 2024, restoring law and order has been a priority, he noted.

"Coordinated efforts have re-established command and lifted the morale."

The IGP thanked the chief adviser for initiatives, including lifting the cap on risk allowances, halting non-essential procurement, and facilitating motorcycle loans for officers.

"We aim to be a humane, transparent, and accountable force, committed to justice and human rights," he said.

Meanwhile, 62 officers

were awarded the Bangladesh Police Medal and President Police Medal for outstanding service.

WORKSHOP ON POLLS PREPAREDNESS
Senior officials also held a workshop with field-level officers at the Rajarbagh Police Lines yesterday, focusing on restoring public trust, improving the force's image, and maintaining law and order amid evolving national challenges.

Md Kamrul Ahsan, deputy inspector general of the PHQ, led the session, assigning field officers with six key tasks.

These included restoring a stable work environment, enforcing the law, countering propaganda and subversive activities, removing poor leadership influences, and rebuilding public confidence.

Officers were directed to act strictly by the law and resist all forms of pressure ahead of the national election. They were also instructed to combat misinformation and share accurate information with the public.

According to meeting sources, a presentation was given during the session, identifying five major threats to law and order. These included illegal and looted weapons posing risks to election security; shifting narratives between

interim and political governments; intra-party conflict; mob violence, and protests.

Other threats discussed were inmate escapes, terrorist bailouts, growing extremism in the southwest, and the Rohingya and Arakan crises destabilising the borders.

'RECRUIT UNMARRIED ASPs'
On the first day of Police Week-2025, high-ranking officers also met Home Adviser Lt Gen (retd) Jahangir Alam Chowdhury and placed several demands, including the recruitment of unmarried assistant superintendents of police.

Barrister Zillur Rahman, principal of the Police Academy, noted that around 70 percent of probationary ASPs are married, which creates challenges during training.

"Many leave their families behind but later request to reunite with them, disrupting the training process," a meeting source quoted the principal as saying.

Zillur added that most trainees later seek transfers to Dhaka.

He also raised concerns about physical standards, particularly height. "Although minimum height is required, it's often overlooked during medical

exams."

He recommended ensuring recruits meet height and weight standards and prioritising unmarried candidates.

Officials also proposed a special allowance for training academy staff and improved services at divisional police hospitals.

Addressing the high officials, the home adviser said, "You only focus on your own matters. That's not right. First, address how lower-level officials are living and performing. Fix those issues first."

He emphasised genuine concern for lower-ranking officers, especially regarding housing, duty schedules, workload, and overall well-being.

"Sincere attention should also be paid to their food and nutrition," Jahangir added.

He said the government is considering allowing junior officers to be posted within their home districts and, where possible, posting police spouses in the same district as well.

Trump threats help Liberals win

a wide lead in the polls that evaporated after Trump slapped tariffs on Canada and threatened to annex the country. Canadians are shunning U.S. goods and trips in response.

While Carney remains prime minister, his Liberals appeared to win only a minority of seats in the House of Commons, making the government more fragile and dependent on smaller parties to stay in power.

Australia holds an election on May 3, and the major parties have closely watched the polling surge towards Carney, Australian political strategists said. As in Canada, voter concern over the global fallout from Trump's policies has tilted support toward the center-left Labor Party.

Former Canadian diplomat Colin Robertson, who knew Carney when he worked at the Finance Ministry, said Carney is Canada's best-equipped prime minister since the 1960s, given his experience leading the Bank of England and Bank of Canada.

"He goes in extremely well-prepared, with a superb Rolodex, and people will take his call and look to him because their challenges are economic right now," he said.

Carney will likely start by expanding Canadian trade with Europe, Australia and Asian democracies such as Japan, Robertson said, blunting some of the economic damage from newly imposed U.S. tariffs on cars, steel and aluminum.

Fortifying Canada's economy is expected to be Carney's immediate priority, including by advancing infrastructure projects to make Canada less dependent on the United States, which buys 90% of Canada's oil exports.

Leading the smallest G7 nation, Carney will then need to muster his global coalition "without waving a giant red flag in front of Donald Trump," said Roland Paris, a former adviser to ex-Prime Minister Justin Trudeau and now professor of international affairs at University of Ottawa.

"It will be a difficult tightrope or balancing act for him," Paris said. "He and Canada have an interest in coordinating with other like-minded countries, but without necessarily setting up Canada as the organizer of an opposition. Why turn Canada into that kind of target?"

Paris said Carney's calm demeanor and financial experience may elicit a more constructive response from Trump than the president directed at Trudeau, whom he belittled as "governor."

Robertson, a senior adviser at the Canadian Global Affairs Institute think tank, expects Carney to try to work collaboratively with Trump, possibly as early as the June G7 Leaders' Summit in Alberta, where he predicted Carney may arrange a trade meeting with Trump and Mexican President Claudia Sheinbaum.

ensure trial of the actual perpetrators.

"It is essential to ensure justice in the killing of Sharban, and at the same time, necessary and appropriate measures must be taken to ensure that those responsible don't go unpunished. Besides, the government is being urged to take effective steps to prevent anyone from being harassed through cases lodged with malicious intent," HRFB said.

Implicating a large number of people in the cases will hinder both the investigation and the judicial process and delay the investigation reports, it added.

"In this context, it becomes evident that such cases are being filed with the intent to harass, which could have far-reaching consequences," it said, while urging utmost caution in accepting such cases.

The HRFB demanded withdrawal of cases, including the one filed against Zaker along with other professionals, non-

political individuals, and ordinary people, following proper investigations.

It is also essential to conduct proper probes to identify those involved directly or indirectly in each killing, how they were involved, and under whose instructions these acts were done.

Filing serious charges like murder without any evidence is undoubtedly considered repressive.

"It is also unacceptable," the rights body said, adding that the situation is increasingly creating opportunities for both domestic and foreign actors to launch conspiratorial and misleading campaigns against the country's justice system.

The body demanded prompt investigations and trials of the killings of the July uprising as well as an inquiry and action against those who are misusing the law in this manner.

Meanwhile, ASK said the ordinary people have the right to file cases over the murders during the July uprising, but deliberately implicating persons with

the intent to harass is a violation of human rights.

The purpose of the law is to protect the rights of citizens. However, the use of law to harass innocent people through such politically motivated cases is unacceptable, it added.

Echoing similar concerns, BLAST said politically motivated cases and mass arrests are undermining justice and called for urgent reforms to ensure fair investigations based on credible evidence. It also urged swift justice for genocide and gross human rights violations during the July-August uprising.

Referring to the murder case of Shrabon where 408 individuals, including Zaker and several journalists, were accused, the rights body criticised the filing of such a first information report without credible evidence or specific links to the incident.

The rights body also warned that similar practices were seen during previous governments, where accountability was lacking, and called for an urgent reform of such procedures.

told The Daily Star yesterday, "We received a copy of the court's order today [yesterday]. Action is being taken accordingly."

Meanwhile, actor Siddiqur Rahman Siddique was assaulted yesterday afternoon on the capital's Bailey Road by a group of youths who alleged he had ties to the Awami League. The group later handed him over to police.

Siddique, who was in custody at Ramna Police Station, was seen with torn clothes and bruises in a video that went viral on social media. A voice in the video can be heard calling him "a supporter of the fascist regime".

In another video, an attacker was heard saying, "We are Habibullah Bahar [unit of] Chhatra Dal [the student wing of BNP]".

Siddique had earlier collected a nomination form from the AL to contest the Dhaka-17 by-election in 2023, following the death of actor and MP Akbar Hossain Pathan Farooque, but did not receive the party's nomination.

Talebur Rahman, deputy commissioner (media) of Dhaka Metropolitan Police, said Siddique was handed over to Gulshan Police Station, where a case had previously been filed against him. He was shown arrested in that case.

‘Miniscope 2’ returns to prove less is more

Dwip Gallery in Lalmatia opened its doors to the second exhibition of its kind, **Miniscope 2**, on April 26. Flaunting creative gateways for diverse artists from both Bangladesh and India, it is currently hosting miniature and endearing artworks.

Notably, during autumn last year, the Dwip gallery authorities issued a call for visual art submissions to both professional and non-professional artists, and the response was overwhelming. Eventually, 56 artists from Bangladesh and West Bengal were selected, and a collection of 116 artworks from them now adorn the gallery walls.

From ink work to acrylic, sculptures to photography, and watercolour to etching, Dwip is showcasing an array of imaginative artworks by said selected artists. The best aspect about **Miniscope 2** is that the artists were able to skillfully portray their thought process into a smaller volume specified by the gallery, which paved the way for a larger collection of art pieces to be accommodated within the gallery walls.

Upon entering the first room, Sumana Akter’s **Punojonmo** series caught my eye. The humanoid trees in white on green backdrops made me gape at them curiously. Some minimalist artworks in black and white,



including Farzana Ahmed Urmi’s **We Are Needed** series, gives weight to the legendary architect Mies Van der Rohe’s quote, “Less is more”. A Asan created dry pastel paintings, **Read the Dark**, with unique animal forms, which rather intrigued me.

The narrow corridor bore Anindita Datta Banti’s stunning and vibrant **Flower Composition** series, a set of acrylic paintings. Salma Zakia Bristy’s mixed-media abstract

paintings look unique with real, antique jewelry attached to them. They somehow reminded me of Bangla novels written during British rule. A set of black backdrops held golden coloured metal work by Rezaul Karim Rezon, conveying the essence of the ancient craftwork of this sub-continent. Shibananda Adhikary Biplab’s **Images of Innocence II** has an endearing white baby bird, which gave me a serotonin boost.

In the innermost room, on the dusk blue wall hung Ashang Mong’s **Endless Poetry**, reminding me scenes from seas and forests. Showrab Gosh’s **Intangible Sentiment** is a tiny yet powerfully thought-provoking piece, with delicate lines, strokes, and a bright red-orange background. Khurshid Jahan’s **Echoes of the Earth** in mixed media is a series that transported me to the world of fairy forests.

In short, the variety of artworks and their mediums, not to mention the proficiency of the artists, left me mesmerised. **Miniscope 2** is proof that small art pieces are just as capable of filling our souls as large-scale artwork is. Through this exhibition, Dwip has created a wonderful platform for rising artists while also creating networking opportunities for younger art enthusiasts.

Miniscope 2 will be run at Dwip Gallery till May 6.

Indian filmmaker Payal Kapadia joins Cannes jury

Rare opening stand undone by late collapse

Courtesy of Shadman Islam's second Test century, Bangladesh yesterday found themselves in a promising position on day two of the second and final Test against Zimbabwe. However, a flurry of wickets in the final session has cast doubt on their chances of securing a significant first-innings lead in Chattogram.

The Tigers closed the day on 291 for seven, leading by only 64 runs, having lost their grip on a match they once looked to be dominating.

Resuming the day's proceedings, after Taijul Islam wrapped up Zimbabwe's first innings by taking his sixth wicket off the very first ball of the day, the home side looked to mean business.

The new opening pair of Shadman and Anamul Haque Bijoy composed a much-needed 118-run opening stand – Bangladesh's first century opening stand in 16 Tests following Najmul Shanto and Zakir Hasan's 124-run partnership against India in Chattogram over two years ago.

Anamul eventually departed for 39, but Shadman found another able partner

in Mominul Haque. The duo added 76 runs for the second wicket without much trouble, further strengthening the hosts' position.

Shadman went on to reach his century, off 142 balls as he dispatched Richard Ngarva delivery with a classy cover drive for a boundary. His innings served as both a comeback from his poor outing in Sylhet and a notable team milestone

as well, giving Bangladesh their first Test hundred from an opener in 28 months.

However, a lapse in concentration at the stroke of Tea saw both batters depart in quick succession – first Mominul for 33, then Shadman on the very next ball after reaching career-high 120 runs.

The sudden double blow brought captain Shanto and a vastly experienced Mushfiqur Rahim to the crease, and while

they managed to regroup, the momentum shift was also a sign of things to come.

Mushfiqur and Shanto stitched together a 65-run stand for the fourth wicket, frustrating the visitors and reviving hopes of a commanding lead. But the final session proved costly. What seemed a solid foundation quickly crumbled as Bangladesh lost four wickets for just 20 runs.

Shanto's dismissal triggered the slide, gifting a simple catch to mid-wicket off debutant leg-spinner Vincent Masekesa, who soon grabbed his maiden Test wicket. Masekesa struck again to remove Jaker Ali, while Mushfiqur, looking steady on 40, was run out trying to sneak a needless single. Masekesa capped off the session by removing Nayeem Hasan, leaving the visitors firmly back in the game.

Reflecting on the day, Shadman admitted the collapse hurt their momentum, saying, "we were in a good position but suddenly we witnessed a collapse," while remaining hopeful with Mehedi Hasan Miraz at the crease and that "a good partnership" is still possible to regain control.

Ancelotti set to take over Brazil

Real Madrid coach Carlo Ancelotti has agreed to take over the Brazilian national team, several Spanish media outlets reported Monday.

The veteran Italian has one more year on his contract with the Spanish giants, but after quarterfinal Champions League elimination by Arsenal and Copa del Rey defeat by rivals Barcelona, he is poised to depart the Santiago Bernabeu.

Ancelotti has not hidden that a potential exit was on the cards and said his future was "a topic for the next weeks" after defeat by Barca on Saturday.

Spanish media reports Ancelotti would take over ahead of the 2026 World Cup qualifiers in June, leaving Madrid before the Club World Cup starts in the United States this summer.

Brazil sacked Dorival Junior after a 4-1 thrashing by Argentina in March and are fourth in the South American qualifying table for the tournament in the US, Mexico, and Canada.

Ancelotti led Real Madrid to a Champions League and LaLiga double last season, with Brazil stars Vinicius Junior and Rodrygo Goes vital parts of the team, and is one of the most successful coaches in the club's history.



Suryavanshi hailed as India's next superstar

Vaibhav Suryavanshi etched his name in history, becoming Indian cricket's newest sensation after a breathtaking century in just 35 balls during Rajasthan Royals' emphatic win over Gujarat Titans in Jaipur on Monday. At 14, the left-handed opener shattered records, becoming the youngest to score a T20 hundred.

Nicknamed "Boss Baby," Suryavanshi's fearless hitting drew instant comparisons with West Indies legend Chris Gayle. His debut had already hinted at greatness, smashing his first ball for six against seasoned pacer Shardul Thakur. But Monday night in Jaipur, he truly arrived, dismantling India's best bowlers – Siraj, Sharma, and Sundar – with 11 towering sixes and seven sizzling boundaries.

The cricketing world erupted. Sachin Tendulkar praised his "fearless approach" and "bat speed," while Suryakumar Yadav called it "absolute carnage." Coach Rahul Dravid, despite a broken leg, rose from his wheelchair to celebrate the landmark six that sealed Suryavanshi's century off Rashid Khan. India's 1983 World Cup-winning batsman Kris Srikkanth said: "Indian cricket's next superstar is here."



Inter brace for daunting Barca trip

Inter Milan head into the Champions League semifinals at risk of finishing the season empty-handed after a late-season slump killed their treble hopes and has left them wondering where the next win will come from.

Wednesday's daunting clash at Barcelona could hardly have come at a worst time for Inter who, since reaching the last four, have lost three games on the bounce without scoring a goal.

Those three defeats handed Napoli a three-point lead at the top of Serie A with four matches remaining and left Inter out of the Italian Cup after a dismal 3-0 derby defeat at the hands of AC Milan last week.

Simone Inzaghi's team look tired and bereft of ideas up front in Sunday's 1-0 home loss to Roma.

Barca are on a high after beating Real Madrid to win the Copa del Rey on Saturday as their old enemies had a petulant meltdown in a face of a third straight Clasico defeat. Unlike Inter, the Catalans are still in contention for a treble as they also lead LaLiga by four points.

"We're not scared, the best thing is to be in April and still have something to play for," said wing-back Carlos Augusto on Sunday.

"We have a chance to achieve something extraordinary and we're not afraid. This team has already won a lot and is always focused."

Inzaghi will be hoping striker Marcus Thuram will be available as his replacements have done nothing alongside Lautaro Martinez who has looked exhausted, and frustrated.

- Barcelona are unbeaten in their six home games against Inter in the Champions League.

Bashundhara remain Kings of Fed Cup

Bashundhara Kings broke their final curse against Abahani with a 5-3 win in penalty shootout in the eventful final of the Federation Cup at the Mymensingh District Stadium yesterday.

Even though Kings have a positive win record against Abahani, they had lost both finals against the Sky Blues – in the 2018 Federation Cup and the 2022 Independence Cup. Yesterday's win against the 12-time champions means Kings now have their second silverware of the season following the triumph in the season-opening Challenge Cup.

Goalkeeper Mehedi Hasan Srabon played a key role in the shootout following a 1-1 draw in regulation and extra time, thwarting Abahani's second shot from Nigerian forward Emeka Ogbugh.

A total of 17 players were booked and one saw red card in the high-voltage final, which was halted after 105 minutes due to heavy rain followed by bad light last Tuesday.

Kings' Romanian coach Valeriu Tita was happy to lead the side to the season's second trophy as he believes it wasn't the same Bashundhara side that played last season.

"I had no sleep in the last seven days. I had slept only for one hour before this final because it was not an easy task for us. All the people talked about Bashundhara but everyone must understand that this Bashundhara side is not the Bashundhara side of last season. This is another Bashundhara with no good condition of players and no money," Tita told reporters after the final.

No lack of fire in Abahani's 24th DPL triumph

Abahani completed a three-peat of the Dhaka Premier League with a commanding six-wicket victory over rivals Mohammedan at the Sher-e-Bangla National Stadium in Mirpur yesterday.

However, for the team that have now won the title six times since the tournament gained List A status from the 2013-14 edition and 24 times overall, this triumph came against a number of challenges.

A majority of the country's top cricketers had been featuring for Abahani, contributing to their firm grasp on the title in recent years. Even in the previous season, Abahani had national stars Liton Das, Taskin Ahmed, Afif Hossain,

Mohammad Naim, Tanzim Sakib, and Shoriful Islam in their ranks.

With the DPL being played under a reduced budget, Abahani, which also went through a number of changes following a change in the country's political landscape, lost a number of the high-profile players, with a few even joining Mohammedan this season.

A few players stayed, such as Mosaddek Hossain and national team skipper Najmul Hossain Shanto. Mosaddek ended up as the joint top-wicket taker, alongside teammate Rakibul Hasan, with 30 wickets. In a match-winning performance, the all rounder bagged

two wickets in the final to help restrict Mohammedan to 240 for seven before smashing an unbeaten 65-ball 78 to see Abahani cruise over the line.

"This is special, as many things have changed. There were many challenges in front of us, and becoming champions is a huge thing. Our first target was to avoid relegation, and when we started winning, our expectation increased," Mosaddek, who amassed 487 runs this tournament, said after lifting the trophy.

While teams like Mohammedan were struggling with injuries and players leaving for national duty, a young Abahani side managed things better.

It was not just players who had to adjust. Abahani head coach Hannan Sarkar, who took over a side in DPL for the first time, said his players had a fire within themselves that led to the outcome.

"Cricketers came here with some discontent. I won't name them, but some players were contracted with other clubs. But at the last moment, those teams rejected them. So there was some fire within them. As circumstances forced them to play for Abahani under reduced payments, they wanted to prove themselves,"

Hannan said.

Abahani's 22-year-old opener, Parvez Hossain Emon, became the second-highest run-getter with 798 runs, while the 20-year-old Jishan Alam, who smashed a fifty yesterday, managed 400 runs with an attacking flair. Also, experienced campaigner Mohammad Mithun was an assured presence in the middle order, finishing with an unbeaten 79-ball 66 in the final.

"There were some young players who wanted to prove themselves and play for the HP squad or the Bangladesh A team. Ultimately, apart from winning the title with Abahani, they were also trying to establish themselves. So there were players with more hunger," Hannan added.

More than the performances on the field, the tournament, however, came under the spotlight more for the wrong reasons – with Mohammedan skipper Towhid Hridoy's suspension saga that dragged on for days the main highlight.

It was perhaps inevitable that such a tournament also ended with chaos – this time due to Mohammedan veteran Mahmudullah Riyad, who hopped onto the stands to confront a fan who had reportedly criticised the team.



Govt may take a tough decision on IMF loan

Says Finance Adviser Salehuddin Ahmed

The government will decide whether to continue with the International Monetary Fund's \$4.7 billion loan programme if the fourth and fifth tranches are not released, said Finance Adviser Salehuddin Ahmed.

"We will take a tough decision," he told journalists after a meeting of the advisory committee on government purchase yesterday.

Disbursement of the two instalments remains uncertain after the government and the IMF failed to reach a consensus on the reform measures under the programme.

Salehuddin held several meetings with the IMF on the sidelines of the World Bank-IMF Spring Meetings in Washington, DC, over the release of the two instalments. The meetings ended without any agreement.

There are conditions for the IMF loan that the

'PRESS MEET FALLOUT' 2 journalists sacked, one suspended

Depto TV, a private television channel, suspended its news service for hours till late last night, while three journalists from three TV stations, including Deepto, were dismissed.

The development came a day after the three journalists, among others, asked Cultural Adviser Mostofa Sarwar Farooki a range of questions about the July uprising movement, including about the death toll.

Around yesterday afternoon, Deepto TV ran a scroll saying, "Due to unforeseen circumstances, all news services will be suspended until further notice." No reason was provided.

The news service, however, resumed at 11:00pm.

Meanwhile, Information Adviser Mahfuj Alam said the government had not instructed the suspension of Deepto TV's news service.

"This is Deepto TV's internal decision,"

JULY UPRISING Rights bodies worried over false cases

Human rights organisations yesterday expressed concern over implicating innocent persons in cases filed over the July uprising, saying that such actions, driven by malicious intent or harassment, amount to a violation of human rights.

In separate statements, Human Rights Forum Bangladesh (HRFB), a platform of several rights bodies, and Ain O Salish Kendra (ASK) demanded law enforcers drop the names of innocent persons, including actor Iresh Zaker, from the case filed recently over the killing of a person named Mahfuz Alam Shrabon during last year's mass uprising.

Meanwhile, the Bangladesh Legal Aid and Services Trust (BLAST) demanded that law enforcers stop harassing individuals through politically motivated and indiscriminately filed cases, and instead

Form an independent police commission

Top cops tell chief adviser it's necessary to ensure impartiality in law enforcement

Police officials have called for the formation of an independent commission to ensure the force operates impartially and free from political influence.

They raised the demand during a meeting with Chief Adviser Prof Muhammad Yunus at the Bangladesh Police Auditorium in Rajarbagh Police Lines yesterday, following the inauguration of Police Week-2025.

Two officers placed demands on behalf of the force at the closed-door meeting, according to a senior officer who was present.

Mohammad Al Asad, assistant superintendent of police at Police

Acknowledging past tensions with the public, particularly during the student protests, IGP Baharul Islam said steps had been taken to rebuild trust.

Headquarters (PHQ), said political pressure often compels officers to act in favour of parties, citing examples under the previous regime.

"As such, the Police Reform Commission has proposed forming an independent Police Commission. While the [reform] commission is working on the proposal, it said further discussion is necessary."

Asad also noted that the National Consensus Commission had yet to address the matter.

"To ensure police operate independently and without interference, an independent commission is essential."

17 actors sued for 'attempt to murder'

Another actor assaulted, handed over to police

Seventeen actors were sued yesterday in a case filed over the July uprising, while another actor was handed over to police after being assaulted by a group of youths.

The accused include Nusraat Faria, Apu Biswas, Nipun Akter, Ashna Habib Bhabna, Zayed Khan, Suborna Mustafa, Rokeya Prachy, Sohana Saba, Meher Afroz Shaon, Jyotika Jyoti, Symon Sadik and Azizul Hakim.

Filed in March with the Chief Metropolitan Magistrate's Court of Dhaka, the case accuses the actors, ousted prime minister Sheikh Hasina, and 265 others of attempted murder.

The complainant, one Enamul Haque, claimed he was injured during student protests in Bhatara last year. After recording his statement, the court directed the officer-in-charge of Bhatara Police Station to register the complaint as a First Information Report.

Sujan Haque, inspector (investigation) of the station,

Trump threats help Liberals win Canada polls

PM Carney aims for global leadership role against Trump as congratulations pour in

Canadian Prime Minister Mark Carney completed a comeback victory for the governing Liberals in Monday's election, positioning himself for a global role as a champion of multilateralism against US President Donald Trump's more protectionist policies.

The first person to lead two G7 central banks has the experience to earn immediate international credibility, experts say. Carney's tough words for Trump during the campaign have been closely watched in other parts of the world.



"Canada is ready to take a leadership role in building a coalition of like-minded countries who share our values," Carney said on April 3 in Ottawa. "We believe in international cooperation. We believe in the free and open exchange of goods, services and ideas. And if the United States no longer wants to lead, Canada will."

Carney's Liberals beat the Conservatives, led by Pierre Poilievre, whose slogan "Canada First" and sometimes acerbic style evoked comparisons with Trump that may have cost him the election. The Conservatives for months had held
