

Echoes of Tagore at Shahzadpur

3-day Rabindra Festival kicks off at Kacharibari

The Shahzadpur Kacharibari, a mansion within Rabindranath Tagore's ancestral estate in Sirajganj, continues to preserve the legacy of the Nobel Laureate poet.

During his stays in Shahzadpur, the poet found deep inspiration for his literary pursuits, as reflected in a letter he wrote to his niece Indira Devi. "Here (Shahzadpur) I get the inspiration of writing rather than



part of the play Bishorjon, as responsibility for the estate, well as poetry and short-story Rabindranath visited the area several times, with his last visit in 1901, said researcher Habibur Rahman Shwapan. Professor Dr Abdul Alim, a researcher and teacher of the Bangla department at Pabna University of Science and Technology, said, "Rabindranath the Shahzadpur estate from was close to the locals. Some of Zaminder Rani Bhabani of his famous works were inspired Natore in 1840. After assuming by those he met and the lives

he observed here, such as Postmaster Ratan from the short story Postmaster, and the poor farmer Upen from the poem Dui Bigha Jomi."

Md Habibur Rahman, custodian of Rabindra Kacharibari, said around 300 items once used by Tagore are preserved at the site. "With the passage of time, many important things connected to Tagore have been lost. We have kept those that remained at the Shahzadpur Kacharibari museum for visitors, including tables, chairs, a bed, and a palanquin used by the poet during his stays," he said.

Meanwhile, as in previous years, a three-day Rabindra Festival will begin today at the Kacharibari to mark the 164th birth anniversary of Tagore. Organised by the Sirajganj district administration, the festival will feature discussions, recitations, music, and dance performances.

Two wetlands declared wildlife sanctuaries

UNB, Rajshahi

The government has declared two ecologically vital wetlands in Rajshahi district as "Wetland Dependent Wildlife Sanctuaries" to ensure the conservation of their rich biodiversity, particularly avian species.

The announcement came through two separate gazette notifications issued yesterday by Forest Wing 2 of the Ministry of Environment, Forest and Climate Change under the Wildlife (Conservation and Security) Act, 2012.

The newly designated sanctuaries

include a 1.65-acre wetland in Biljowana Mouza of Tanore upazila and a 15.08-acre wetland in Bilbala Mouza under Godagari upazila.

These wetlands serve as crucial winter habitats for a diverse range of native and migratory bird species.

More than 100 bird species along with various amphibians, reptiles and mammals inhabit the wetlands.

The new designation is expected to provide a secure haven for wildlife and also promote ecological awareness, education, research and nature-based tourism.

2,500 tea workers agree to resume work

A total of 2,500 tea workers of four gardens under Burjan Tea Estate in Sylhet, who have been agitating to press home their demand for 20 weeks' arrears and rations, have agreed to return to work following assurances from the authorities.

Four killed in road crashes

Three people were killed and four others injured as a microbus hit a stationary dump truck in Gangni upazila of Meherpur on Tuesday.

The deceased are Shahin Hossain, 25; his aunt Akhter Banu, 45; and the microbus driver, Jamal Hossain, 40, said Bani Israel, officer-in-charge of Gangni Police Station.

The accident occurred around 11:30pm on Meherpur-Kushtia road in Shukurkandi area.

In Narsingdi, a head-on collision between a private car and a CNG-run auto-rickshaw in Monohardi upazila left the auto-rickshaw driver dead and two others injured on Tuesday.

The deceased is Md Shahin, 35, said SI Shahiduzzaman of Monohardi Police Station.

In another development, the bus driver, who continued driving at high speed on the Dhaka-Mawa Expressway despite the vehicle's roof being blown off, has been arrested by Rab.

Rab-10 Assistant Director (Media), ASP Shamim Hasan Sardar, in a press release yesterday said the driver, Shahidul Sheikh, 30, was arrested on Tuesday in South Keraniganj.

Mango harvest in Rajshahi starts May 15

The Rajshahi district administration has set this year's calendar for the mango harvest, prohibiting growers and traders from selling the fruit in markets before May 15.

The decision was made at a meeting with mango growers, traders and agriculturists at the deputy commissioner's office yesterday, chaired by Deputy Commissioner Aha Akter.

DC Afia said Gutti varieties of mangoes can be collected and marketed from May 15.

The dates for other varieties were also finalised: Gopalbhog, Ranipochondo (also known as Lakkhanbhog) on May 20; Himsagar and Khirsapat on May 25; Lengra on May 30; and Fazli on June 10.

AAUB excels in US aerospace contest

For the first time, Aviation and Aerospace University, Bangladesh (AAUB) took part in the Design/Build/Fly (DBF) competition held in Arizona, USA, from April 10-13, said a press release.

Competing against top universities worldwide, AAUB earned 18th place in the Design Report and 36th overall, gaining international recognition for both the university and Bangladesh.

A reception was later held on May 6 at the Dhaka campus, where Vice Chancellor Air Vice Marshal AKM Manirul Bahar praised the students' creativity and perseverance.

Their UAV, capable of precision landings and launching gliders mid-air, completed 21 missions before its final demonstration on February 25.

The drone holds promise for disaster management, agriculture, and surveillance.
