

2 SIs stabbed during anti-narcotics drive

Two policemen were stabbed allegedly by drug dealers during an anti-narcotics drive in the capital's Sayedabad rail line area on Friday night.

Faisal Ahmed, officer-in-charge of Wari Police Station, said a police team from the station conducted the drive around 9:45pm and detained one person.

He said as the team was escorting the detainee away, a group of suspected drug dealers attempted to snatch him and attacked the police, he said.

Kawsar Ahmed, 32, and Moniruzzaman, 30, were admitted to Rajarbagh Police Lines Hospital.

Police detained three people in this connection.

Woman dies after bike hits divider

A woman died after a motorcycle hit a road divider on the Dhaka-Mawa Expressway in Munshiganj's Sreenagar upazila yesterday.

The accident took place in the Hasara area, said Dewan Azad Hossain, station officer at the Sreenagar Fire Service.

The victim, Sakila Akter, who was riding pillion, suffered critical injuries in the crash, while her husband, Shakib Gazi, the rider, was also injured.

A fire service team rescued the couple and took them to Dhaka Medical College Hospital, where doctors declared Sakila dead, the official added.

GRAFT ALLEGATIONS Travel ban on Asif Mahmud's former APS Moazzem

A Dhaka court yesterday issued a travel ban on Md Moazzem Hossain, former assistant private secretary (APS) to IGRD and Youth and Sports Adviser Asif Mahmud Shojib Bhuyain over corruption allegations.

Judge Md Zakir Hossain of Dhaka Metropolitan Senior Special Judge's Court passed the order following an application from Anti-Corruption Commission Assistant Director Minu Akter Sumi.

According to the application, Moazzem allegedly amassed a large sum of money through extortion, tender manipulation, and irregularities in procurement and transfer-related activities.

"The ACC official came to know from a credible source that Moazzem was attempting to flee the country. If he flees, inquiry into the allegations brought against him might be hampered. So, an order is needed to prevent him from doing so," said the ACC in her application.

The court also directed the ACC to take steps to block Moazzem's national identity card and to send copies of the order to the Special Branch of police in Dhaka's Malibagh and EC Secretariat, Agargaon, for the next course of action.

Jamuna erosion takes serious turn in Shahzadpur

Ainul Haque, 70, a retired primary school teacher in Sayedpur village under Shahzadpur upazila of Sirajganj, lost his house to Jamuna river's erosion five times in last 30 years.

On last Wednesday, the river devoured his house yet again, for the sixth time.

"A crack appeared in the riverbank near the house all of a sudden on Wednesday noon, and by the evening, everything was gone. My family members and I only managed to save our lives, nothing else," Ainul added.

"At least five houses were devoured by Jamuna while some 10-15 houses were relocated from riverbank, including mine, in last couple of weeks," said Md Niam Uddin Bepari, a resident of the village.

"When I built my house four years ago, the river was at least 500 metres away. Now it has moved close to my doorstep," he added.

Not only Sayedpur village, but also at least 5-6 spots in neighbouring Kojuri Bazar, Haatpachil, Dhitpur and Kurshi villages in the upazila have become vulnerable to river erosion.



Sonaton union in the upazila has been the worst affected in the recent spell of Jamuna's erosion.

Md Kamruzzaman, Shahzadpur upazila nirbahi officer, said they would begin relief work if necessary.

Md Najmul Hossain, sub-divisional engineer of Bangladesh Water Development Board in Sirajganj, said a Tk 651 crore project to develop 8-km flood protection embankment and 6.5-km riverbank protection is undergoing from Enayetpur to Haatpachil area of Shahzadpur upazila to mitigate river erosion.

"Upon completion of the project, likely by 2026, entire Shahzadpur upazila will be protected from Jamuna's erosion," he added.

Contacted, Md Mokhlesur Rahman, executive engineer of BWDB in Sirajganj, said most of the erosion hit areas of Sonaton union are remote shoal lands that are located beyond the riverbank protection work.

"As the river is swelling up, riverbank areas along the shoals have been eroding, which is natural. However, there is no damage in the protected areas along the riverbank," he added.
