40 acres of WDB land grabbed in Ctg

Grabbers include former lawmaker, ex-CCC mayor; WDB to start eviction drive soon

An influential group has allegedly occupied around 40 acres of land belonging to the Water Development Board (WDB) in Chattogram’s Kattali and Halishahar areas, constructing various types of structures and disrupting the land’s intended use for forestation.

According to WDB documents obtained by The Daily Star, the occupied land now houses a stadium, truck terminals, garages, and tin shed structures.

The list of alleged encroachers includes former Chattogram City Corporation (CCC) mayor Mohammad Manjur Alam, his nephew and former member of parliament Didarul Alam, former CCC councillor Nisar Uddin Ahmed Manju, Abu Hashem, and several others.

During a recent visit to the area, this

correspondent observed that a mini stadium – formerly named Sheikh Russel Mini Stadium – was constructed in 2021 on WDB land acquired by the agency in 1970. Truck terminals and garages were also seen on adjacent land.



Jamal Uddin, a local garage owner, said the lands along the Patenga Outer Ring Road gradually turned into truck terminals and garages after the road opened in 2022, as port-centric traffic increased along the route.

As per the WDB list, former mayor Manjur Alam built a mini stadium, former Awami League lawmaker Didarul Alam allegedly occupied seven acres to establish a vehicle terminal, and former CCC councillor Nisar Uddin Ahmed



Manju reportedly constructed vehicle garages on about one acre of land.

Asked about the construction, Manjur Alam said, “I acquired it from the person who was occupying it and built a

PABNA MENTAL HOSPITAL Admission of patients resumes after nine days

After a nine-day suspension, Pabna Mental Hospital yesterday resumed patient admissions, following the resolution of a food supply tender dispute that had brought operations to a standstill.

The hospital had halted new admissions on July 3, citing uncertainty over food supply after a tender process failed to finalise approved bidders.

Shafkat Wahed, director of the hospital, said, “The crisis is now over. Two companies received work orders last week, and we resumed patient admission.” He said over 100 beds are currently vacant due to the halt.

The crisis originated after the hospital issued a tender on May 28 for recruiting food suppliers.

Eight companies took part in the bidding for three categories of food supplies on June 26, but the hospital authority could not immediately finalise the lowest bidders, as multiple suppliers submitted similar price quotes.

Ministry of Local Government. More troublingly, the original design was reportedly altered without following due process.

Following these revelations, the Ministry of Local Government halted funding in 2016. Since then, construction has come to a standstill, and critical project documents have mysteriously gone missing from the Dhaka Zilla Parishad office.

Rajuk’s Chief Town Planner Ashraf Islam said, “To my knowledge, this building does not have any approval. However, if they now follow the proper procedure and submit a fresh application, and if the building is deemed usable, then we can discuss the matter in a board meeting.”

When The Daily Star visited the site on July 1, security guards denied entry, saying prior permission was required. From outside, this

correspondent observed algae growing across sections of the neglected structure, with visible signs of decay due to lack of maintenance. Four security guards are currently stationed at the site.

According to the project brief, the ministry was to finance 30 percent of the construction, while the remaining 70 percent would be covered in advance payments. One floor was earmarked for the Zilla Parishad’s office, with

the remainder planned for shops, a community centre, and chambers for legal professionals.

However, ministry officials said the project never underwent a feasibility study, a mandatory requirement for large-scale constructions, especially in congested Old Dhaka. They also noted that no approval was sought from the Local Government Engineering Department (LGED), which is mandatory for projects exceeding Tk 50 lakh.

“There is no clarity on how the project’s budget was fixed at Tk 160 crore, and no proper justification was documented,” said one ministry official, requesting anonymity.

Sources said the Zilla Parishad had collected approximately Tk 60 crore in advanced payments from businesspeople who booked space in the building. These investors are now left in the lurch.

“I’ve lost money, and I don’t know if this building will ever be completed,” said one investor, also requesting anonymity due to fear of repercussions.

The construction firm,

Toma Construction Ltd, reportedly received Tk 60 crore in payments but is still owed around Tk 65 crore.

Meanwhile, the disappearance of original project files has raised serious concerns. Officials claimed a syndicate involving members of both the Zilla Parishad and the Local Government Ministry orchestrated the removal of documents. Those who served in key positions between 2010 and 2016 are believed to have knowledge of the incident.

Notably, Hasina Doula, then president of the Savar Upazila Awami League, served as administrator of the Dhaka Zilla Parishad during that period.

Chief Executive Officer of Dhaka Zilla Parishad Md Mamun Khandaker confirmed that project documents had indeed gone missing. However, no formal complaint or general diary was filed with the police.

“We’ve written to the ministry, urging measures to protect the building from encroachment. We’ve also retrieved a copy of the original design from LGED and requested the Anti-Corruption Commission to investigate the irregularities,” he told The Daily Star.

An LGED survey found the building structurally usable, though with some conditions, he added.

contacted the victim and asked him to visit the station to file a complaint.

The incident took place on Road 2 in Shyamoli around 6:00am.

“We are reviewing CCTV footage to identify and apprehend the culprits,” the OC said.

The video shows that around 6:00am, a man was walking with an umbrella when three individuals on a motorcycle approached him from behind. One of them got off the bike

Of the three, two were wearing helmets and one was shirtless.

Brandishing machetes and sharp weapons, the

two muggers then forcibly took everything the man was carrying, including cash. They also stripped him of his shirt and shoes before fleeing the scene on the motorcycle.
