

Three to die for rape of teen in Netrakona

A Netrakona court yesterday sentenced three men to death and 10 years' rigorous imprisonment on charges of raping a 15-year-old girl and provoking her to die by suicide.

Judge AKM Emdadul Haque of the Netrakona Women and Children Repression Prevention Tribunal delivered the verdict, court sources said. The convicts – Apu Chandra Sarker, 31, Mamun Akand, 34, and Sultan Mia, 31 – are from Thakurakona in Sadar upazila.

According to the prosecution, on September 3, 2017, Panna Akter, 15, from Thakurakona, went to a neighbour's house. From there, the three took her to a nearby fish enclosure at knife-point and raped her. The next morning, Panna hanged herself in a room at her home.

On September 10 that year, her mother filed a case with the Netrakona Model Police Station.

Four DIGs sent into forced retirement ‘in public interest’

The government yesterday sent four deputy inspectors general of police into forced retirement, citing “public interest”. The decision was made through four notifications signed by Nasimul Gani, senior secretary of the Public Security Division under the home ministry.

Dharla erosion leaves hundreds homeless

The erosion of the Dharla has left riverside families in disarray across Kurigram and Lalmonirhat districts.

Acres of farmland and homesteads are at risk of being devoured by the river. The worst-affected areas include Debnathpara, Kurul, Megharam, Chhaymatha, and Char Budaru in Lalmonirhat Sadar upazila; as well as Gorokmandol, Char Gorokmandol,



Haque Bazar in Phulbari upazila, Kurul, Megharam, Chhaymatha, and Char Budaru in Lalmonirhat Sadar upazila.

In Debnathpara village, 65-year-old farmer Abdar Hossain said,

“Just last week, I lost the last four bighas of my farmland to the Dharla. Earlier, the river took 12 bighas more. Only our homestead on eight decimals remains now. I don't know how our seven-member family will survive.”

Another resident, Bholanath Debnath, 60, said, “I lost five bighas of land last week, and the rest is under threat. We are on the verge of living by the roadside.”

Two more die of dengue, 394 get hospitalised

Two dengue patients died while 394 others were hospitalised in the last 24 hours until yesterday morning.

Among the deaths, one was from Barishal division, and another from Chattogram division, according to the Directorate General of Health Services (DGHS).

With the latest data, the total number of deaths and cases rose to 78 and 19,923 respectively.

Among the total cases, a total of 18,587 dengue patients were released, the DGHS said.

Currently, 1,258 dengue patients are undergoing treatment at different hospitals throughout Bangladesh, 910 of which are from outside Dhaka.

Rucusu polls on September 15

The election to the Rajshahi University Central Students Union (Rucusu) will be held on September 15, with voting and result declaration scheduled for the same day.

The announcement of the election schedule came during a press briefing held at the university's Senate Building yesterday.

Prof Md Enamul Haque declared the date on behalf of Chief Election Commissioner Prof Amzad Hossain.

Nomination forms will be distributed from August 17 to 19, while students will be able to submit their nomination papers on August 21, 24, and 25. Scrutiny of the papers will take place on August 27 and 28.

A preliminary list of candidates will be published on August 31, and the last date for withdrawal of nominations is September 2. The final list of candidates will be published on September 4.

FROM PAGE 3 expectations of primary school headteachers, it said, adding that the initiative will ensure their financial security and reinforce their social dignity.

Headteachers have long been demanding a pay upgrade from the 11th to the 10th grade. Due to inaction, 45 teachers filed a writ petition with the High Court, which ruled in their favour and directed the authorities to upgrade their salaries. Following the verdict, the finance ministry agreed to implement the ruling. On July 3, the Directorate of Primary Education issued an office order granting 10th-grade salaries to the 45 petitioners. The order also mentioned that the case of other headteachers was under active government review.

ASSISTANT TEACHERS DEMAND GRADE II Assistant teachers, now officially titled “teachers”, have also been demanding 11th-grade pay for years. However, a recent proposal by the consultation

committee recommended placing them in the 12th grade and introducing a new post “assistant headteacher”. Teachers rejected the proposal and have since staged several protests.

Earlier, on February 10, a government-appointed advisory committee to improve primary and non-

formal education suggested that new teachers start at Grade 12, be confirmed after two years, and be promoted to senior teacher at Grade II after two more years.

Headteachers should be placed in the Grade 10 pay scale and appointed through promotion, the committee recommended.
