Parties split over making July Charter legally binding

The National Consensus Commission has finalised the agreed-upon reform proposals for inclusion in the July Charter, but parties remain split over whether to make the document legally binding for ensuring its implementation.

Some parties are calling for the charter to be legally binding while others believe that the consensus it represents overrides legal formalities, making its implementation a moral and political obligation for any future government.

The BNP and its allies, including Jatiyatabadi Samamana Jote, the 12-Party Alliance, the National Democratic Movement (NDM), and the Labour Party, oppose giving the charter legal status.

Speaking to reporters, BNP Standing

Committee member Salahuddin Ahmed said, "We are committing to implement this charter based on the sovereign authority of the people. There is no greater national consensus than this. It is above the law."

He said that the charter includes a proposal to implement reforms within two years of forming a new government, a timeline the BNP supports.

"The charter will not only be signed by the commission but by all political parties. It reflects the people's will and may be added to the constitution's fourth schedule," he said.

"We will grant it constitutional and state recognition. If this isn't legally binding, what is?"

The Trump administration has lowered its reciprocal tariff on Bangladeshi goods to 20 percent from 35 percent, strengthening the country's competitive standing in the US market amid intensifying regional competition.

Effective from August 7, the revision is a major win for Bangladesh's garment industry, which has long struggled to stay competitive.

With this move, Bangladeshi exporters are now well placed

to increase their share of the US apparel market as they enjoy a clear advantage over regional peers in India, Vietnam, and China.

India faces a 25 percent rate and risks further penalties due to its energy and defence purchases from Russia.

Although Bangladesh's effective tariff will reach 36 percent after adding existing duties to the 20 percent benchmark, its core exports -- formal shirts, knitted polo shirts, trousers, underwear, and sweaters -- face below-average duties. These

Breathing room for exporters, but concerns persist

The 20 percent US tariff on Bangladesh's exports offers an opportunity for the country to diversify its export markets, said industry insiders yesterday.

They believe that the revised rate would enable them to compete with countries like Vietnam, a close rival in the American market.

Some exporters, however, have

voiced concern.

The reactions come as the US slashed its tariff rate on goods from Bangladesh from the previous 35 percent, after a final round of intense negotiations followed high-level discussions between Bangladeshi officials and the Office of the United States Trade Representative in Washington.
