

# 5 killed, 4 hurt in Jamalpur road accident

Five people were killed and four others injured in a head-on collision between a battery-run auto-rickshaw and a covered van in Digpait area of Sadar upazila in Jamalpur yesterday.

All the deceased were passengers of the auto-rickshaw, police said.

The victims were identified as Chan Mia, 65, and Jahangir Alam, 40, of Narayanpur village in Jamalpur Sadar upazila; Arifa Khatun Poli, 28, wife of Sharif Ahmed of Uchchagram village in Sarishabari upazila; Rashed Mia, 30, of Sanakur village in the same upazila, and Sumaiya Jaman Shithi, 24, of Tangail's Dhanbari upazila.

The injured – Shundha Begum, 50, wife of slain Chan Mia; Sadika Akter, 25; Farzana Begum, 22; and deceased Arifa's son, Arsh, 5 – were taken to Jamalpur General Hospital, said Nazmus Sakib, officer-in-charge of Jamalpur Sadar Police Station.

The OC said police recovered the bodies and sent those to Jamalpur Sadar Hospital morgue for autopsy.

The covered van was seized. Legal action will be taken once a complaint is filed, the OC added.

# METRO RAIL, FLYOVERS Writ seeks HC order to examine material quality

A writ petition was filed with the High Court yesterday seeking its order on the government to verify and ensure the bearing quality of the materials used in the construction of metro rail and flyover pillars in Dhaka, in order to safeguard public lives.

Advocate Abdullah Al Mamun, a Supreme Court lawyer, submitted the petition.

The petition also sought a court directive for the formation of a committee to investigate possible negligence in the maintenance of the Dhaka Metro Rail that may have led to the fall of a bearing pad, killing Abul Kalam Azad on October 26.

He also sought an order for the committee, formed to investigate the incident, to submit a report to the court.

The secretary of the Ministry of Road, Transport and Bridges, the managing director of Dhaka Mass Transit Company Ltd, the executive director of Dhaka Transport Coordination Authority, and the Italian-Thai Development Company Ltd have been named as respondents in the petition.

Abdullah Al Mamun said the death of Abul Kalam has made it evident that the respondents, being public authorities under constitutional and statutory obligations, have failed to discharge their duties to protect the lives and safety of citizens by not adopting appropriate preventive and regulatory measures to control.

# Salauddin, who lost sight

9:00pm, where doctors declared him dead at the emergency department, said his elder son, Amir Faisal Ratul.

Ratul said, "Apart from the eye, bullets had hit my father's face, neck, and hands. The splinters in his throat could not be removed. Doctors had advised him not to talk much. He had been coughing badly in recent days, and he would often cough blood."

"My father had also been seeing dimly through his other eye," he added.

Salauddin lived with his wife and two sons in Godnail area of Narayanganj Sadar upazila.

He was listed as number 132 among those critically injured during July movement, in the interim government's official gazette. Alongside government's financial support, the July Foundation also helped his family by providing goods to start a small grocery shop last month.

Due to his fragile condition, Salauddin could not manage the shop regularly -- his son Ratul often looked after it instead.

Family members recalled that during the anti-discrimination movement protests in Narayanganj last July, Salauddin had been working at a shop in Bhuigor area. When demonstrations erupted in the city, he joined the protesters. On July 19, he, along with others, was shot by police.

After initial treatment at Narayanganj 300 Bed Hospital, he was transferred to the National Institute of Ophthalmology, where he underwent surgery, but he never regained vision in one eye.

Salauddin's wife, Rani Begum, believes he might have survived if he had received advanced treatment.

Worried about their future, she said, "We have no savings. He worked whenever he could, and that is how we lived. I never imagined I'd lose him like this."

Salauddin's janaza was held yesterday at Godnail Bazar, followed by burial at a local graveyard, family members confirmed.

crime and law-and-order situation.

The home adviser said the police would play a key role in ensuring a free, fair, and neutral national election. He warned that no police member should take sides, seek or provide political favours, or act as political activists.

He said police have a list of "fascists" responsible for creating unrest in society and urged intensified drives against them.

"However, no innocent person should be harassed," he said.

The adviser also directed police to hold regular district-level core committee meetings, withdraw politically motivated cases, and expedite the disposal of false ones.

"Any attack on police will not be tolerated under any circumstances," he said, directing immediate legal action against those involved.

Highlighting the rise of cybercrimes, Jahangir urged young officers to take the lead in tackling digital threats.

IGP Baharul said the national election would be a major challenge but also an opportunity to restore public trust.

He instructed all units to recover illegal arms, improve intelligence gathering, and conduct election-related training with diligence.

The IGP also directed

officers to register complaints submitted to the Commission on Enforced Disappearances, speed up investigations into anti-discrimination movement cases, and ensure timely police clearance certificates without harassment.


