



Uncertainty lingers on as parties dig in

Amid a deepening impasse, major political parties yesterday hardened their stances on the timing of a referendum on the reforms, the implementation order for the July charter, and the fate of dissenting notes. With the seven-day deadline for the parties to reach a consensus having expired on Monday, the government said it would announce its decision on the issues on Thursday. As the clock ticks down, the nation watches – unsure whether a resolution or rupture lies ahead.

Govt to clarify July charter steps in 3-4 days

Says Adviser Nazrul

Implementation details of the July charter will be clarified within days, said Law Affairs Adviser Asif Nazrul yesterday.

"We had expected that political parties will provide us with a unified directive after internal consultations. However, we have not remained idle; we have continued

responsibility" for any decision made outside the charter, and the signatory parties will not be held accountable for it.

"We urge the government to take cautious and responsible steps in this regard," BNP Standing Committee member Khandaker Mosharraf Hossain said at a press briefing at the party chairperson's Gulshan office yesterday.

The briefing was held to convey the outcomes of the party's Standing Committee meeting, chaired by acting chairman Tarique Rahman on Monday night. The meeting discussed the legal framework for implementing the charter.

At the meeting, party leaders said that if the government took any decision in favour of Jamaat-e-Islami under pressure, the BNP would not accept it. The Daily Star has learnt from people involved in the proceedings.

On November 3, amid the ongoing dispute over the referendum and the July charter's implementation order, the interim

Top leaders of the eight parties issued the warning at a rally at Dhaka's Paltan intersection in the afternoon.

Later, they met at the central office of Islami Andolon Bangladesh to decide their next course of action.

According to a press release issued by Islami Andolon, the parties expressed concern over the government's failure to make a decision regarding the legal recognition of the July charter and the holding of a referendum before the election.

The meeting decided to seek an appointment with Chief Adviser Prof Muhammad Yunus today (Wednesday) to discuss the matter. If the government still does not come up with a decision after their meeting with Yunus, they will be forced to announce tougher programmes the same day, the press release added.

Earlier at the rally, some leaders said if the demands were not met, they would lay siege to the chief adviser's official residence Jamuna.

The government has rolled out extensive security measures to thwart any act of sabotage ahead of the Awami League's "Dhaka Lockdown" programme tomorrow, an event announced despite a ban on the party's activities.

Officials from the home ministry and law enforcement agencies said security forces have been placed on high alert and will show zero-tolerance against any attempt to create unrest

in or destabilise the capital.

Surveillance across Dhaka and its entry points was ramped up early yesterday. No gatherings or demonstrations will be allowed at the city's entrances tomorrow.

During visits last night, police patrols were visible at major entry points including Gabtoli, Jatrabari, Abdullahpur, and Tongi, where additional checkpoints have been set up to screen incoming vehicles.

Authorities have also tightened border

2 shooters held over gang hit

Detectives claimed to have detained the gunmen who on Monday, in full view of the public, shot dead top-listed criminal Tariq Saif Mamun, 55, in front of the Dhaka National Medical Institute Hospital.

Based on intelligence, a team from the Detective Branch (DB) of police conducted raids yesterday and apprehended five suspects, including the shooter duo believed to be directly involved with the killing, according to DB sources.

A senior DB official present during the raid said the shooter duo have been primarily identified as Faruk and Robin.

After the killing, the two gunmen first fled to Sylhet, then to Moulvibazar in an attempt to cross the border – but both efforts failed. Detectives later tracked them down and detained them in the region.

The two pistols used to

4 SENSATIONAL MURDERS Ctg police yet to make headway

A recent spate of shootings and murders has shaken the port city, yet there has been little visible action from the Chattogram Metropolitan Police.

In the majority of these cases, police have yet to apprehend any of the main gunmen or recover the murder weapons, confirm police sources.

As of yet, there has been no real headway in at least four major public shootings.

Several police officials, requesting anonymity, admitted that in two of these incidents, the victims were listed criminals themselves – leading to a lack of interest from law enforcement.

AKBAR MURDER CASE

On May 25, Md Akbar, alias "Dhakaiya Akbar", a known criminal from the port city's Bayezid area, was shot in broad daylight at Patenga in front of bystanders. He died a day later at Chattogram Medical College Hospital. Police said he had 10 cases against him, including murder, arms, and extortion charges.

Akbar reportedly had a long-standing feud with another notorious Bayezid-based criminal, Sazzad Hossain, alias "Chhoto Sazzad". Before his death, Akbar had posted several videos on Facebook from his account while criticising Sazzad Ali alias "Boro Sazzad" – a fugitive accused in the sensational "Eight-Murder Case" – and his

close accomplice, Chhoto Sazzad.

Police suspect the killing was a result of internal gang rivalry.

Akbar's family filed a case with Patenga Police Station against 11 individuals. Following the incident, Rab apprehended two relatives of Boro Sazzad – his nephew Alvin and his brother Osman Ali – and handed them over to the police. However, progress on the investigation appears to have since slowed.

Investigating Officer Amitabh Das, sub-inspector of Patenga Police Station, said, "Four accused have been arrested so far; two are currently out on bail. The weapon used has not been recovered."

Akbar was shot twice at close range with a pistol, the IO said, adding that the police believe the murder stemmed from a turf war.

When asked why the gunmen had not been identified, he replied, "There's no CCTV footage of the shooting. We've recorded eyewitness statements and are continuing efforts to catch the remaining accused."

SARWAR MURDER CASE

It has been almost a week, and yet the police are in the dark about the murder of high-profile gangster Sarwar Hossain, alias Babla, on November 5. He was shot dead in the city's Chalitatali area while accompanying BNP-nominated candidate Ershad Ullah during election campaigning for the Chattogram-8 constituency.

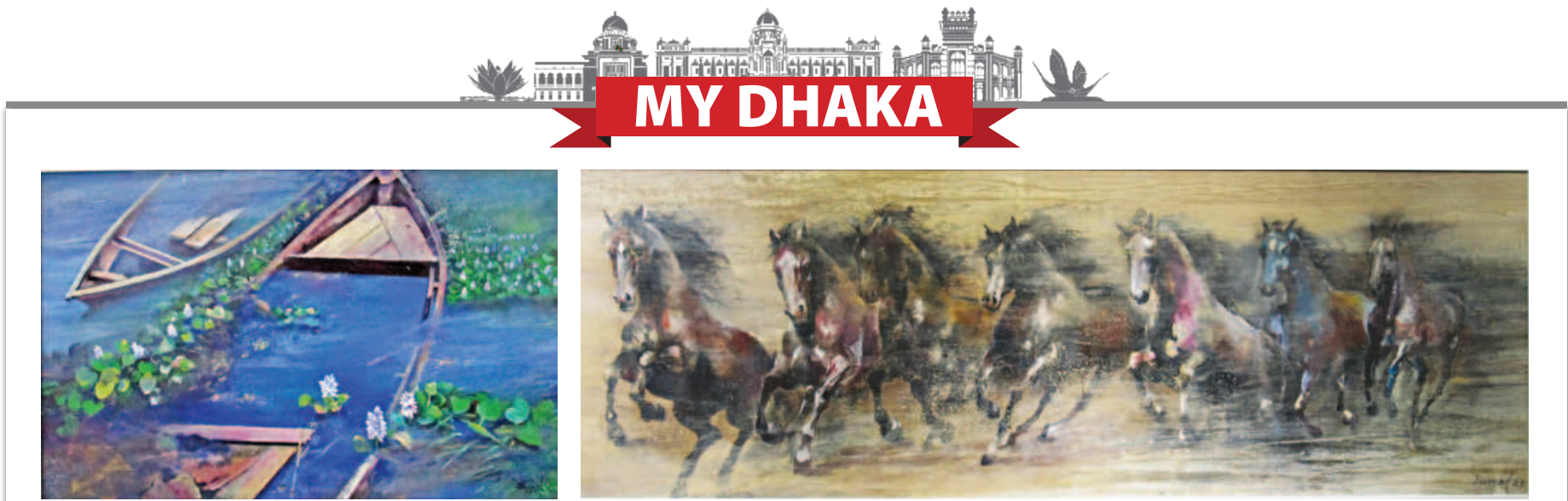
Investigators have yet to find any clue about who carried out the attack or how they escaped.

Sarwar's father, Abdul Kader, filed a case with Bayezid Bostami Police Station naming 22 people as accused. Police have arrested four of them so far, but the key suspects – including Mohammad Raihan and Mobarak Hossain – remain at large, and the weapon used has not been recovered.

The victim's brother, Alamgir, told The Daily Star "I saw my brother being shot right in front of my eyes. The attackers fired multiple rounds and fled openly without any resistance from law enforcement."

"There's no sense of security here. We're living in fear after losing him," said a visibly shaken Alamgir.

Celebrating Jamal Ahmed’s life and art at Galleri Kaya

Artist Jamal Uddin Ahmed's stylish confidence, tilting towards a definite hippie swagger, is what makes the art world of Dhaka love him. He dons a devil-may-care attitude, yet has the most amiable personality, making him a pleasant person to interact with.

His towering persona is accentuated by his trademark open shirt buttons, upturned collars, thick gold chains, and a nonchalant poise. The 70-year-old recently celebrated his birthday at Galleri Kaya, a contemporary art gallery in Uttara.

Dressed in an all-white ensemble, and his glasses on top of his forehead, the artist deliberately displayed a Tamil superstar vibe, looking mysteriously stylish.

The Ekushey Padak recipient of 2019, Ahmed is a professor at the Department of Drawing & Painting of the University of Dhaka, under the Faculty of Fine Arts.

His popularity surpasses that of any superstar, and because of his emotional intelligence, conscientiousness, and a friendly, easily approachable demeanour, the artist is sought after personality in Dhaka's art community. Ahmed is highly valued in his social and professional settings as well.

Galleri Kaya, with its strong commitment to professionalism and keeping the gallery purely on an intellectual and creative plateau, is holding an exclusive exhibition, "Celebrating Jamal Ahmed." Exhibits are from his most recent works.

His works reflect his non-conformist attitude, and a powerful philosophical



stance that is almost psychedelic. His bold strokes bring out the subtlety in the pose of his subject, be it a girl bathing or a pigeon in flight. He can capture the true essence of a fleeting expression to perfection, which draws us to his art.

His style does not stem from any artsy perspective of his surroundings; rather, it shows his skill in capturing the exact emotion of how any normal person would view a girl braiding her

hair, or the old lady contemplating life sitting on a chair on the porch.

"His strength lies in realism. He has mastered the art of capturing light and shadow. It is quite apparent that the artist possesses a profound comprehension of landscapes. Several of his figurative works express a significant feeling of joy. His drawings and sketches are vibrant and exhibit the appropriate level of restraint. He understands precisely when to cease,

which is a fundamental element of his artistic expression," says Goutam Chakraborty, director, Galleri Kaya.

Jamal's themes are almost kaleidoscopic; from the picturesque beauty of Bengal, its peaceful landscapes and riverine communities, to urban life, bauls, mendicants, and the working class. But it is his aesthetic portrayal of the alluring forms of young women, gypsy women, oarsmen, boatmen, and fishermen that are a smash hit with contemporary collectors of Dhaka. However, his most sought-after artworks feature his pigeons, horses, and raging bull.

For art enthusiasts, collectors, and regular people, Jamal's paintings bring about a profound sense of exhilaration.

The most striking canvas exhibited at Galleri Kaya is the 2025 acrylic work on canvas called Beauty in the river, 72x72 inches in size. Then there is Winter in the same medium on a canvas of 42x66 inches.

There is a total of 22 artworks of watercolour on paper, charcoal on paper, and mixed media on paper. These are works done between '24 and '25 and will be on exhibition at Galleri Kaya till November 21.

Galleri Kaya started its journey on 28 May, 2004, and has a successful portfolio of exhibitions, art trips, art camps, and art workshops both at home and abroad, gradually building a bond of trust with artists, art connoisseurs, and the media.

Celebrating Jamal Ahmed is a must-visit exhibition, because it fills you with cheerfulness and takes your mind off the chaos.

commit the murder have also been recovered, added the official, while speaking to this newspaper last night on condition of anonymity.

Monday's shooting took place just outside the hospital gate around 11:00am.

Two masked gunmen emerged from the crowd, raised their pistols, and opened fire on Mamun in front of hundreds of witnesses.

Mamun had gone to court that morning for a hearing in a 29-year-old murder case and was returning home to Aftabnagar when the attack occurred.

The gunmen opened fire from a short distance, killing him on the spot, before calmly walking away.

Witnesses described their movements as "brazen", saying they ensured the victim's death before leaving the scene.

While two men carried out the killing -- an operation lasting less than three minutes -- at least two backup teams were positioned nearby in case the plan faltered, a senior DMP official, who is involved with the investigation, told this newspaper.

"They were wearing masks and hats to conceal their identities, but we managed to identify them with the help of surveillance tools," said the senior official, requesting anonymity.

Meanwhile, a case is yet to be filed in connection with the killing, as police say the victim's family had gone to Lakshmipur for funeral rites.

Another official involved with the investigation said they suspect Sanjidul Hassan

Emon, a prominent figure in the criminal underworld, to be the mastermind behind the "contract hit".

The officer, requesting anonymity, said Mamun had a long criminal history and was once a close aide of Emon. The two had jointly controlled extortion and contract killings in the Hazaribagh, Dhanmondi, Mohammadpur, and Tejgaon areas under the banner of the "Emon-Mamun Group", said the officer.

The gang was linked to several high-profile killings, including those of film actor Sohel Chowdhury and Saeed Ahmed Tipu. Mamun served 24 years in jail before his release in 2023.

After his return, Mamun reportedly tried to reclaim control over his old territories, angering Emon, who is believed to be in Malaysia but remains active in the underworld.

Mamun had been using connections with some influential political figures in Lakshmipur to expand his activities and regain dominance in Old Dhaka's extortion rackets.

An investigator said Mamun was moving around in a rented car and no longer had gunmen or bodyguards, indicating his weakened position in the criminal hierarchy.

Family members also alleged that the killing was carried out by Emon's associates.

After the killing, Mamun's wife, Dipa, also said, "No one other than Emon could have done this. A few days ago, Emon had hired people to attack Mamun."

This was not the first murder attempt on Mamun.

working independently. Within the next three to four days, it will become clear what steps we have taken regarding the implementation of the charter," Nazrul told reporters.

He said the matter is being discussed at various levels of the Advisory Council. "We are coordinating with all parties' expectations to ensure that actions taken serve the country's and people's interests."

Meanwhile, Chief Adviser's Press Secretary Shafiqul Alam yesterday said the Awami League is trying to disrupt the upcoming

national election and is carrying out arson attacks across the country.

"The fascist AL is indulged in arson attacks across the country, aiming to thwart the election, but the national parliamentary election will be held in the first half of February and no domestic or foreign force will be able to foil it," he said.

Mentioning that there might be differences of opinions among political parties, the press secretary said everyone is preparing for the election. "Despite differences, all parties want a festive and participatory election," he said.

government urged political parties to resolve their differences and reach a unified decision within a week.

After the deadline passed, the BNP held a press conference to formally state its position.

Reading from a written statement, Mosharraf said some government advisers had recently made remarks about announcing certain decisions outside the framework of the July charter.

"Such statements are misleading and amount to ignoring the consensus-based decisions adopted earlier," he said.

Standing Committee member Salahuddin Ahmed said the charter was signed through a historic event and includes some notes of dissent from different

political parties on certain points.

"It was stated in the charter that if any party reflects its notes of dissent in its election manifesto and receives the people's mandate, it may implement those points accordingly. We are one hundred percent in agreement on this. We still stand by that position and have not deviated from the signed charter," he said.

He added that if any political party goes beyond the signed charter and launches movements over unreasonable or newly created issues in the name of implementing the July charter, "they may make statements on that."

On the president's order regarding the July charter, he said the BNP had not made any specific proposal on who should issue such an order.

He added that the country is now being run under the constitution and that the interim government has taken oath under it, so everything is proceeding according to law.

"According to the constitution, it is the president who has the power to issue any ordinance. But if any order is to be issued, there is currently no constitutional provision in Bangladesh that would give such an order legal validity," he said.

Asked whether there was any scope for talks on the referendum issue, he said if the government invited discussions, there could be an opportunity for dialogue.

Earlier, at a meeting in Thakurgaon, BNP Secretary General Mirza Fakhrul Islam Alamgir said the government would be entirely responsible if anything beyond the consensus on reforms was

imposed by force.

Meanwhile, on the same day, Jamaat and seven like-minded parties held a rally pressing their five-point demand, which includes giving a legal basis to the July charter and holding the next election under the proportional representation system.

A Standing Committee member, seeking anonymity, said: "Over the July charter, Jamaat has taken to the streets, which is not the right way. If the BNP wanted to, it could do the same, but we won't. We want a peaceful transition through discussions."

The party will hold talks with several parties and alliances, including Ganatantra Mancha, the 12-Party Alliance, the Jatiyatabadi Samomona Jote, and other like-minded parties over seat-sharing.

surveillance to prevent the movement of arms and suspects. Border Guard Bangladesh has been ordered to increase patrols along crossing points, particularly in the west and southeast.

Law enforcers have been instructed to take immediate action against anyone attempting to block roads or incite violence, officials said.

Several English-medium schools have switched to online classes over safety concerns, sources said.

The Civil Aviation Authority of Bangladesh has issued directives to restrict public movement around airports, and intensify searches, and patrols.

Over the last few days, Dhaka and some other parts of the country have witnessed a spate of flash processions, crude bomb and arson attacks.

In two days until the filing of this report at 1:00am today, at least 19 crude bombs went off, and 11 vehicles were set ablaze, leaving city residents on edge.

The last bomb blasts took place in front of the International Crimes Tribunal's (ICT) investigation agency office in Dhanmondi at 8:04pm, and in front of the Government Post Office (GPO) near Gulistan's Zero Point around 9:25pm.

The ICT is set to announce the date of a verdict in a case against ousted prime minister Sheikh Hasina on charges of crimes against humanity committed during the July uprising.

In both incidents of crude bomb blasts last night, two assailants on a motorcycle hurled the bombs and fled the scene, police said. No casualties or arrests were reported.

Two buses were also torched in Dhaka and Gazipur last night.

The fire broke out on a bus near Turag City on the Mirpur Beribadh road, an area under Shah Ali Police Station, around 10:00pm. Another

bus was set on fire in the Chakrabarti area of Gazipur's Kashimpur around 9:50pm.

Police said they did not have information on who started the fires. No casualties or arrests were reported in either incident.

Meanwhile, tragedy struck early yesterday when a bus driver was burnt to death and two passengers injured after unidentified assailants torched a parked bus in Mymensingh's Phulbaria upazila around 3:15am.

The victim, Julhas Mia, 35, a driver for Alam Asia Paribahan, was asleep inside the bus when three men arrived and set it ablaze, CCTV footage showed. The fire spread rapidly, burning him alive.

Passengers Sharmin Sultana Rumki, 40, and her

units of the police and Rapid Action Battalion (Rab) are closely monitoring online activity to identify those responsible.

Intelligence officials said the pattern of violence suggests a coordinated effort to destabilise Dhaka and challenge state authority ahead of the coming election season.

A senior officer involved in counter-sabotage operations told The Daily Star that several groups have been identified as working under the direction of exiled political figures.

"Their main target is to create a sense of fear among city residents before the so-called lockdown," the officer said, requesting anonymity.

To finalise security plans for November 13, the Advisory Council Committee on Law

"Security has been intensified around metro rail stations, courts, railway terminals, and tribunals. Additional forces have been deployed in potential trouble spots," he said, adding that law enforcement had been instructed to act immediately on any threat intelligence.

"The government will not allow anyone to create panic or disrupt normal life in the name of politics."

At a separate briefing, DMP Commissioner Sheikh Md Sajjat Ali said a banned political party and its affiliates were plotting subversive acts.

"In the past 24 hours, police filed 17 cases and detained 50 suspects; most of them brought into the capital from neighbouring districts with promises of payment," he said.

"These individuals were hired to join processions, detonate crude bombs, or torch vehicles before disappearing. We are identifying their handlers."

He urged Dhaka residents not to shelter strangers and advised hotel and mess owners to verify guests' identities before renting rooms.

"Motorcycle owners should avoid lending or renting out their vehicles to unknown persons. If you see any suspicious activity, inform the nearest police station or call 999," he said.

Police have also launched drives, checking guest records at hotels and messes to ensure no one with ill intent takes shelter in the capital.

Transport workers have also been told to remain alert if any bus carries unusually few passengers -- a tactic often used by arsonists to avoid detection.

"Dhaka is under tight security coverage. Every major route, terminal, and installation is being monitored," said a deputy commissioner of DMP.

"We are confident that any attempt to destabilise the city will be foiled."

Jamaat Ameer Shafiqur Rahman said, "Our demand is simple: the July uprising must be recognised. Those who don't accept July will not see an election in 2026. To hold that election, the uprising must first receive legal recognition. Without it, no polls can take place. The freedom-loving people of this country have one demand -- a referendum before the election."

The rally, which began around 2:05pm, was part of the eight-party alliance's ongoing demonstrations over its five-point demand. The demands include holding the next election under the proportional representation system and retaining the amended Representation of the People Order without further changes.

The rally was conducted by Jamaat assistant general secretaries Hamidur Rahman Azad and Rafiqul Islam Khan, the party's Dhaka South Secretary Shafiqul Islam Masud, Islami Andolon

Joint Secretary Ahmad Abdul Kaiyum, and Assistant Publicity Secretary KM Shariyatullah.

The Jamaat ameer said, "We speak politely, but on our demands, we are as firm as the Himalayas. People will not bow to fascism. The movement will continue until the people's demands are fulfilled. The government should understand this and hold the referendum before the election."

Also calling for the referendum to be held before the polls, Islami Andolon Bangladesh Ameer Syed Muhammad Rezaul Karim said, "If legal recognition [of the charter] is not given, the election will be illegal."

Addressing the government, he added, "If you don't act, we'll launch a movement strong enough to compel you to hold the referendum before the polls."

Hamidur Rahman Azad said, "The fascist regime amended the constitution to remove the provision for

a referendum. Those now claiming the constitution doesn't allow it are actually echoing Hasina's tone."

He added that if the constitution is to be followed, the election should be held in 2029 since the last one was in 2024. "By invoking the 1972 constitution, you're trying to build [a new era of] fascism."

Warning the government, Azad said, "We don't want to march from here to the Jamuna for a siege. Implement the July charter without delay and announce the referendum schedule."

He claimed that through the referendum and the election, "the patriotic and Islamic forces that triumphed in Ducusu, Cucsu, Jucusu, and Rucusu will show their strength again at the national level."

Bangladesh Khelafat Majlish Ameer Mamunul Haque said, "The July charter was written on national consensus. People don't want it to remain on paper only; they want it to

be the roadmap for a new Bangladesh. Those opposing the referendum want to revive fascism. We earned this country with blood, and we'll save it with blood."

Jamaat Secretary General Golam Porwar also said the election would be "invalid" if the charter and referendum were not implemented.

Khelafat Majlish Ameer Maulana Abdul Basit Azad said, "Our demand must be met. In future, we will not tolerate any rule that goes against the Holy Quran."

Jatiya Ganatantrik Party Spokesperson Rashed Pradhan said, "We won't let the uprising be questioned through a question base referendum on the day of the symbol-based election."

Bangladesh Khelafat Andolon Secretary General Habibullah Miazi, Bangladesh Nizame Islam Party Ameer Sarwar Kamal Azizi, and Bangladesh Development Party President Anwarul Islam Chan also addressed the rally.

son Shahid Islam Badsha, 20 were also inside. Shahid managed to escape, but his mother sustained serious burns and was later transferred to a private hospital in Dhaka.

Dhaka Metropolitan Police said that over the past six weeks, law enforcers have intercepted at least 14 flash processions and arrested 552 suspects allegedly involved in subversive acts.

Investigators believe some of these incidents were carried out by hired groups brought into the city from outside in exchange for money.

Officials warned that certain quarters are using social media to spread panic and incite violence ahead of the AL's programme. Cyber

Traffic slows in some spots amid eight-party rally

Traffic in Dhaka came to a standstill in some key places yesterday afternoon after a joint rally by eight like-minded parties, including Jamaat-e-Islami and Islami Andolan Bangladesh, commenced at Purana Paltan.

Activists began gathering at the venue from 1:00pm, blocking key intersections in the vicinity and causing a complete shutdown of traffic between the Kadam Foara and Dainik Bangla intersections.

Police set up barricades at both ends, while Jamaat activists were seen helping direct traffic alongside traffic police. The road closure led to gridlocks on adjacent routes, while metro rail stations in the area witnessed unusually large crowds.

Traffic Sergeant Minjis Alam Jibon, on duty at Kadam Foara, said police had placed barricades before 1:00pm.

"This stretch from Kadam Foara to Dainik Bangla is one of Dhaka's busiest roads. It already has heavy traffic, and today's closure has worsened congestion, stretching up to Matsya Bhaban and even Shahbagh," he said.

Many commuters faced long delays.

Sifat Habib, a passenger travelling from Farmgate to Kadam Foara, said, "I didn't expect so much traffic. It took more than an hour to reach here from Shahbagh – it usually takes 15 to 20 minutes."

He said he was heading to Baitul Mukarram Market but would now have to walk the rest of the way due to the closure.

Vehicles heading towards Dainik Bangla from Kadam Foara were diverted through Abdul Gani Road and Gulistan, resulting in heavy congestion on those alternative routes as well. The situation became normal in the evening after the rally ended, said traffic officials.

'Will maintain our funding for Rohingyas' Says Médecins Sans Frontières

With humanitarian funding declining for Rohingya communities in Cox's Bazar, Médecins Sans Frontières (MSF) yesterday said it would maintain its current level of funding in Bangladesh.

"We intend to maintain our level of funding," said Orla Murphy, MSF's country representative, at a Café de Press event held at a hotel in Dhaka.

The Bangladesh chapter of the international medical humanitarian organisation organised the event to share updates on its activities in the country.

A humanitarian crisis is unfolding in the Rohingya camps due to funding shortages and continued arrivals from Myanmar's conflict-hit Rakhine state,

EC bans posters, drones in campaigns

Issues code of conduct for national elections with guidelines for social media

The Election Commission has introduced a comprehensive code of conduct that bans the use of posters and sets clear guidelines for the use of social media during election campaigns.

The commission issued the code late Monday night ahead of the 13th national election, expected in the first half of February.

It outlines detailed dos and don'ts for candidates and political parties.

The new rules introduce stricter measures, including the possibility of disqualifying candidates for serious breaches of conduct.

The new code also bars members of the Advisory Council from participating in election campaign.

It further requires individuals serving or nominated as chairpersons or members of the governing bodies of educational

institutions to resign from those positions once their candidacy is finalised. It also prohibits campaigning at educational institutions.

Additional penalties have also been specified, and all parties and candidates must sign a written

pledge to comply with the code, according to the EC.

The draft makes it mandatory for political parties and candidates to formally commit to following the code.

Armed forces' magistracy extended till February 28

The government has once again extended the magistracy power of commissioned officers in the army, navy, and air force until February 28 next year, effective from today, according to a notification from the Ministry of Public Administration.

According to the notification, commissioned officers holding the rank of captain and above in the Bangladesh Armed Forces have been granted special executive magistrate powers across the country.

The government initially granted the magistracy power to commissioned army officers on September 17 last year for 60 days to improve law and order. It was subsequently extended on January 12, March 13, May 13, and July 13 this year.

'Jamaat will cease to exist after next polls' Says Fakhrul

BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday said Jamaat-e-Islami would "cease to exist" after next year's national election, urging people to remain cautious of their "hypocrisy".



"Jamaat says PR [proportional representation system] must be introduced or elections won't happen. Why are you so afraid of votes? Because you know you won't exist after the election," he said at a views-exchange meeting organised by BNP in Thakurgaon Sadar.

Mentioning that he does not understand PR, Fakhrul said people won't accept it. "We have always voted for candidates by their symbols – sheaf of paddy, boat, or scale. Now, they say we must vote for parties, and that the parties will decide who becomes an MP."

Fakhrul also dismissed NCP, saying, "They claim to be a party, but I don't see them anywhere. They won't get votes. Yet, they echo Jamaat, demanding PR and certificates before elections."

NOMINATION FORM NCP likely to extend deadline

Tasnim Jara collects form for Dhaka-9

The National Citizen Party has seen a sharp rise in the collection of nomination forms ahead of the upcoming national election, although most of its top leaders have yet to join the race.

The party is likely to extend the deadline for collecting nomination forms, which was initially set to end tomorrow (November 13).

According to the party's Election Monitoring Committee, nearly 300 nomination forms have been collected over the past five days through both online and offline channels.

As of 6:00 pm yesterday, no prominent central committee leader had collected a nomination form, except for Senior Joint Member Secretary Tasnim Jara.

Meanwhile, NCP's Chief Organiser (South), Hasnat Abdullah, said there is no possibility of forming alliances with parties that oppose reform initiatives.

"Our convener, Nahid Islam, has already made it clear that we may form alliances with political forces that stand for reforms, stand for Bangladesh, oppose Indian hegemony, and uphold communal harmony," Hasnat said.

Yesterday, Tasnim Jara collected nomination form for Dhaka-9, which includes the Sabujbagh, Khilgaon, Mugda, and Manda areas. "It's my home. I was born and brought up in Khilgaon, spending most of my life among its people," she told The Daily Star.

Denmark pledges \$3.7m to support rights, media

Denmark has announced its support of DKK 25 million (\$3.7 million) for advancing human rights, independent media, and access to rehabilitation for survivors of violence and torture in Bangladesh.

The fund will be provided to a consortium consisting of three Danish organisations -- DIGNITY, IMS, and the Danish Institute for Human Rights -- that will partner with Bangladeshi organisations to promote the causes, said the Danish embassy in a statement on Sunday.

Christian Brix Møller, Danish ambassador to Bangladesh, said Denmark strongly believes that the upcoming programme will contribute to revitalising the pursuit of justice and democratic reform for the people of Bangladesh.

"A strong civil society is crucial in advancing human rights and securing accountability and rehabilitation for survivors of torture and violence," said Rasmus Grue Christensen, CEO of DIGNITY.

Executive Director at the International Media Support (IMS) Jesper Højberg said working closely with local organisations, civil society, and government, they aim to strengthen the foundations of Bangladesh's media sector.

This year's funding requirement is \$934 million for 1.5 million people -- including 1.2 million Rohingya and 3,00,000 host community members -- but only 19 percent of that has been secured, said the report.

Orla Murphy said, "We are very lucky with our funding model. Ninety-eight percent of our global funding comes from private donations, so we are not reliant on donor funding. As others reduce their activities, we have to consider the additional support we can provide."

Rezwanaur Rahman Masum, deputy medical coordinator of MSF, said MSF operates five hospitals in Cox's Bazar, including one with 131 beds and another with 52 beds. On average, 2,270 people from camps and host communities received treatment from MSF every day this year.

Violence must be stopped immediately

Govt must maintain firmness in law enforcement

The rise of a new wave of political violence has raised fresh concerns among citizens. The latest incident saw the horrific death of Julhas Mia, a bus driver in Mymensingh, who was burnt alive in his vehicle early Tuesday. This despicable act appears to represent a shift from politically motivated property damage—too often the chosen method of anarchists—to fatal assaults on innocent civilians. The capital city has also been rocked by crude bomb blasts and arson attacks simultaneously. These coordinated acts of intimidation signal a deeply worrying trend ahead of the planned February election, which must be decisively and collectively addressed.

Tension is naturally building as the International Crimes Tribunal prepares to announce the date of its verdict in a case against former prime minister Sheikh Hasina on November 13. In anticipation, authorities have ordered an immediate security ramp-up. Police headquarters have directed all stations in Dhaka to increase patrols and surveillance, while key infrastructure and religious establishments across the country are under heightened protection. According to a statement from the Chief Adviser's Press Wing, a full-scale manhunt has been launched by the Dhaka Metropolitan Police and the Rapid Action Battalion to arrest those behind the attacks. Nevertheless, incidents of violence have persisted across several areas.

Despite a ban on its political activities, the Awami League's call for a "Dhaka Lockdown" is inflaming the situation. While political expression is a democratic right, it must never come at the cost of lives or public order. The party must resist resorting to violence and agitation, and allow the justice system to take its course.

For his part, Home Adviser Jahangir Alam Chowdhury on Tuesday reaffirmed that all security and intelligence agencies are now operating in synchronised coordination. Security patrols have been intensified at key locations, including the metro rail, railway stations, and most notably, the tribunal premises. This enhanced presence is intended to restore public confidence. Crucially, the adviser has directed law enforcement to act immediately on any credible intelligence about emerging threats. He also called for stricter judicial processes, urging the authorities not to grant easy bail to those accused of "terrorism." While this headline stance on bail may be effective in containing short-term threats, it raises concerns about the potential politicisation of the judiciary.

That said, the evolving security imperatives go beyond addressing immediate threats; it is part of a broader effort to safeguard a peaceful democratic transition through the upcoming election. The interim government is relying on a combination of visible force, tight intelligence coordination, and zero-tolerance stance on political unrest to navigate this volatile period. Bangladesh remains a nation in constant flux, and the recent surge in violence serves as a warning of the consequences if instability is allowed to escalate. In this critical moment, it is essential for all political stakeholders to exercise restraint, while the government must remain resolute in upholding law and order.

Fungal ‘superbug’ in NICUs alarming

Hospitals must take necessary measures to contain the threat

We are alarmed by the spread of the highly drug-resistant fungus *Candida auris* (C auris) in the neonatal intensive care units (NICUs) of hospitals, as revealed by a new icddr,b study. Between August 2021 and September 2022, researchers from the institution examined newborns admitted to the NICUs of two hospitals in Dhaka—one public and one private. Of the 374 infants studied, 32 were found to be colonised with C auris, and one developed a bloodstream infection. Given that C auris infections in low- and middle-income countries have an estimated mortality rate of around 70 percent, this is a public health emergency that requires urgent action.

Declared an urgent antimicrobial-resistant threat by the US Centers for Disease Control and Prevention (CDC), C auris can survive for weeks on hospital surfaces, spread rapidly among patients, and often resist multiple antifungal drugs. It is particularly dangerous for people with weakened immune systems, including preterm and critically ill infants, making NICU babies an extremely high-risk group. According to the icddr,b study, among the colonised patients, 44 percent were colonised at enrolment, while 56 percent became colonised after admission. Seven of the 32 colonised patients died. Alarminglly, 82 percent of the colonised patients were resistant to fluconazole, the first-line treatment for invasive fungal infections. Another crucial finding that warrants attention is that 81 percent of the colonised cases were delivered by Caesarean section and had longer hospital stays.

The heavy presence of C auris in hospitals serves as a stark warning about the broader threat of antimicrobial resistance (AMR) in the country. A recent WHO report has also revealed a worsening AMR situation, with some critical antibiotics showing resistance rates ranging from 79 to 97 percent. Health experts have previously warned that around 70 percent of deaths in our ICUs are linked to AMR infections. Bangladesh has made significant progress in combating communicable diseases over the past decades, but the rise of multidrug-resistant pathogens risks undermining those achievements. As the head of the AMR Research Unit at the Infectious Diseases Division of icddr,b has noted, this study is a necessary first step towards preventive action.

It is now up to the health authorities to act swiftly on its findings. To limit the spread of C auris within NICUs and other hospital settings, regular disinfection with chlorine-based cleaning agents, strict hand hygiene among healthcare workers, and immediate isolation of infected or colonised patients should be made mandatory. Equally important are continuous monitoring and data-sharing between hospitals and public health authorities to detect outbreaks early and prevent further transmission. Moreover, the misuse of antibiotics across the country must be urgently addressed through proper regulations and strict enforcement.

Can COP30 deliver on climate promises?

Global attention has currently turned to Belém, one of the gateways to the Brazilian Amazon, where the climate community has gathered for the 30th Conference of the Parties (COP 30) under the United Nations Framework Convention on Climate Change (UNFCCC). Marking a decade since the adoption of the Paris Agreement in 2015, this conference carries heightened global expectations for real implementation, accountability, and delivery of promises, rather than simply negotiating new ambitions. Being held against the background of a tense geopolitical scenario and devastating climate events in vulnerable countries, the issues that dominate the 12-day-long COP30 agenda carry far-reaching implications for the people and the planet.

First, countries will negotiate on adaptation-related outcomes at COP30, including a set of indicators to assess progress towards the Global Goal on Adaptation (GGA), which was anchored in the Paris Agreement. The GGA was designed to guide the transition from the countries' National Adaptation Plans (NAPs) to concrete actions by enhancing the adaptive capacity and strengthening resilience to climate change. The progress on the GGA is to be tracked through 100 indicators.

However, the indicator framework and operational details of GGA remain unfinished as reliable data and knowledge gaps prevail in vulnerable countries, which require time to build up their statistical capacity. COP30 is expected to finalise the GGA progress tracking architecture.

The second issue is new national climate plans, such as Nationally Determined Contributions (NDCs) under the Paris Agreement, which every country is required to submit every five years. Each new plan should show updated and stronger action than before, reflecting what the countries can do. NDCs for 2025 need to explain the countries' plan to tackle climate change up to 2035. Between November 2024 and November 10, 2025, 109 countries have submitted a 2035 NDC target, which will draw attention in Belém. To note, the Emissions Gap Report 2025 of the United Nations Environment Programme (UNEP), published just before COP30, warns that the world is still not doing enough to minimise climate change risk. Based on the current pledges from countries, global temperatures could rise by 2.3 to 2.5 degrees Celsius by the end of this century. This means the Earth's temperature will go past

the safe limit of 1.5 degrees Celsius above pre-industrial levels within the next ten years, worsening heatwaves, floods, and storms, according to scientists. The most important goal now is to bring the temperature back down as soon as possible. Failure at COP30 to ramp up ambition or agree on credible implementation will make it increasingly implausible to keep the temperature within the safe limit.

The third issue is the scaling up of climate finance for developing and low-income countries. Mobilising and delivering adequate funding for mitigation, adaptation, and loss and

them adapt to climate change.

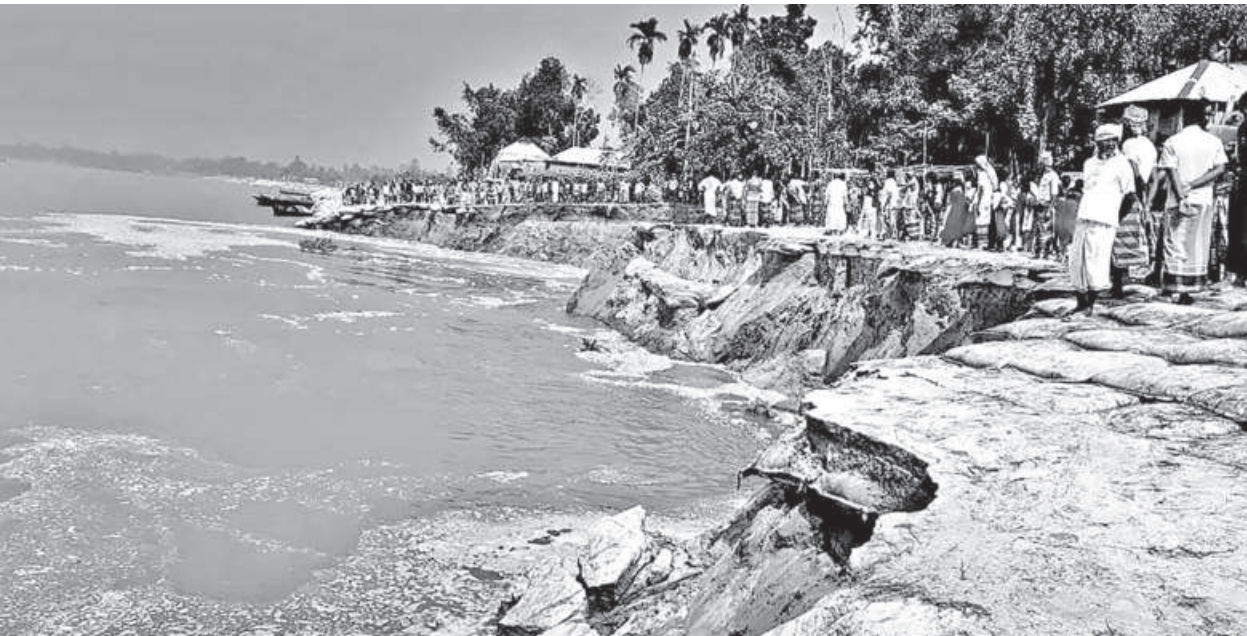
Fourth, it is expected that forests, biodiversity and tropical conservation, central to climate survival, will be at the focus at Belém. Hosting COP30 gives a symbolic boost to forest and nature conservation, since the Amazon rainforest holds about 60 percent of the world's largest tropical forest. Mechanisms like the Tropical Forest Forever Facility (TFFF), a proposed blended-finance fund to incentivise countries to protect tropical forests, are expected to be a flagship outcome, providing predictable long-term funds to conserve and restore tropical forests.

Fifth, countries are expected to decide a new plan called the Belém Action Mechanism for a Global Just Transition (BAM) at COP30. Such a plan should aim for a shift to a green economy in a fair way where people come first, so that climate action creates new jobs, provides training for workers, and helps communities adapt their economies as industries change. The just transition pathway is critically important for climate-vulnerable countries like

various commitments. Bangladesh is on the frontline of sea-level rise, cyclones, river-erosion and climate-driven displacement. Therefore, obtaining clarity on adaptation finance and the GGA indicators is crucial. Implementation of global commitments on funding, technology transfer, capacity building and institutional strengthening is imperative for Bangladesh.

Moreover, the forest and nature agenda has implications for Bangladesh. Although Bangladesh does not have a vast forest cover like the host Brazil, the global forest agenda—which includes carbon credits, nature-based solutions and preserving critical ecosystems—affects the global carbon markets, international cooperation and South-South partnerships in which Bangladesh might engage.

Moreover, COP30 is being framed not only as a negotiation among states but as a session demanding all-of-society engagement, which includes governments, the private sector, indigenous peoples, civil society, and

damage, especially for vulnerable countries, is a critical task. The new collective quantified goal (NCQG), adopted at COP29 in Baku, Azerbaijan, urged scaling up finance for developing countries to at least \$1.3 trillion by 2035, with a mobilisation target of at least \$300 billion annually. The task at Belém is to turn that collective ambition into concrete financial support. According to UNEP's Adaptation Gap Report 2025, the annual global requirement for adaptation to climate change-induced events such as sea level rise, extreme heat waves and storms will be about \$310 billion. However, in 2023, developing countries received about \$26 billion—two billion less than the amount they received in 2022 and 12 to 14 times less than what they currently need—in international funding to help

Bangladesh. The transition towards green growth, including renewables, sustainable agriculture, coastal defences and blue-economy solutions in these countries, depends on access to finance, appropriate technology and just transition frameworks. The COP30 outcome should be based on country contexts, to ensure climate plans and investments protect the planet, while supporting workers and building stronger, more inclusive societies. Agriculture and food systems is also one of the COP30 action agendas, since agriculture and land use are a major source of greenhouse gas emissions (GHG).

For developing and low-income countries, including highly climate-vulnerable ones like Bangladesh, COP30 is a strategic opportunity to expedite the implementation of

youth. This broader mobilisation is essential to scaling action and ensuring that agreements are not just signed but implemented with transparency.

If COP30 ends with weak commitments or compromised implementation pathways, the risks are profound, especially for climate-vulnerable countries like Bangladesh and for the broader global climate regime. It is not just about new promises; it is about cementing credible paths for the fulfilment of promises and ensuring vulnerable countries get a fair share of the burden and the benefits. A meaningful outcome from COP30 can unlock resources, technologies and partnerships essential for climate-resilient development in vulnerable countries. Conversely, the failure to make any progress will be a climate calamity.

Caring for caregivers: The missing link in disability support

The most profound acts of love often unfold in homes where a family member lives with a disability. In these homes, a woman—usually the mother, wife, or sister—becomes the entire infrastructure of care; a 24-hour lifeline that holds the household together. Yet, such relentless labour has huge implications on the physical, mental and economic well-being of the caregiver.

We often speak, and rightly so, about empowering persons with disabilities and ensuring their access to healthcare, education, and livelihood. Yet, in focusing so intently on the person with disability, we often ignore those who sustain their daily life. We are failing the caregiver and by doing so, we are also failing the person she serves.

During an interview for a BRAC Institute of Governance and Development (BIGD) study, a

grandmother in her sixties explained that the physical strain of caregiving for her granddaughter with disability can be overwhelming. She is expected to shift from a position of gentle authority to that of a hands-on therapist, implementing complex and often painful exercise routines that are essential for mobility. Furthermore, the task of taking her to a hospital, which is quite a distance from their home, leaves her drained. She also cannot attend to household chores on those days.

Yet the physical toll is only part of the story. The psychological costs run even deeper. Caregiving demands constant vigilance. For a child or adult with an intellectual or physical disability, the caregiver becomes a sleepless sentinel, forever alert to danger. She cannot afford to let her guard down. This endless watchfulness ensures safety and dignity for her loved one, but it strips

away her own rest, privacy, and peace of mind. Over time, this unending anxiety corrodes her spirit.

BIGD's fieldwork with households that combine disability support with livelihood activities revealed a painful truth. Many caregivers, especially older women, reach a point of profound fatigue and scepticism. Findings from an ongoing BIGD study suggest that separate counselling sessions, focused solely on the mental health of caregivers, can help with their emotional wounds. When caregivers were given space to express exhaustion, manage stress, and rebuild motivation, the entire family's progress in caring for the person with disability improved. Without this emotional repair, every intervention risked collapse.

The burden of caregiving is also deeply economic. In ultra-poor households, the caregiver often manages both care and income. She runs a small business, tends livestock, or manages a poultry farm while maintaining a demanding rehabilitation schedule. She is expected to be an entrepreneur, nurse, therapist, and homemaker all at once. Her life sits at the cruel intersection of poverty, disability, and gender inequality. This impossible balancing act comes at a cost. If she focuses on the family business, caregiving suffers.

If she focuses on caregiving, the family income declines. The constant tension between economic survival and emotional duty keeps her trapped in a cycle of anxiety and exhaustion.

As a society, we must stop viewing caregivers merely as instruments of care and begin recognising them as individuals with their own rights to health, rest, and dignity. This crisis cannot be solved by sympathy alone. It requires systemic reform. We need to create community-based support networks that provide scheduled respite. Even two hours of rest a week for an elderly mother, taking care of child with disability, would help. Every disability or poverty programme should include psychosocial care for caregivers as a mandatory component. Government safety nets must be streamlined to ensure that caregivers receive adequate economic support.

The silent suffering of caregivers is one of the clearest indicators of our collective neglect. Their strength is extraordinary, but it is not infinite. If we truly want to secure dignity and opportunity for persons with disabilities, we must begin by protecting the health of those who hold their world together. It is time to lift this invisible burden before the strain becomes too heavy to bear, and the caregivers are lost to exhaustion.

Why we need self-reliant local governments

Every year, hundreds of municipalities across Bangladesh wait for approval from Dhaka before they can repair roads, install streetlights, or expand markets. These local government bodies remain caught in a cycle of dependency on central budget and oversight. Without a proper resource mobilisation strategy to generate and manage their own revenue, they are often unable to plan or deliver according to local priorities.

At present, holding tax and trade licence fees constitute the major sources of own revenue for most municipalities. While there are a few other local sources of revenue depending on individual municipalities, their overall income still depends heavily on central government grants and development allocations. Most of these, however, often remain underutilised because of poor assessment and collection, limited staff capacity, and weak systems for digital record-keeping. In many places, there is no reliable data on the number of houses or businesses in operation, which makes revenue collection uncertain and prone to leakage.

Enhancing local revenue generation is not merely about money; it is about proper governance and accountability. When citizens see their taxes and fees being used for visible improvements—better roads, clean drainage, functioning streetlights, etc—they are more likely to continue to pay. This trust creates a virtuous cycle: locally sourced revenue finances better services, which in

turn increase compliance and participation. Strengthened local revenue also reduces the political vulnerability of municipalities that often depend on central allocations influenced by political alignment rather than need.

Equally, when local businesses see fair taxation and transparent use of funds, they are more inclined to formalise operations and invest locally. Strengthening municipal finances can improve fiscal autonomy and build transparency by linking taxes to service delivery. It can also ensure that local taxation data is immutably documented through digital systems, preventing manipulation and preserving the integrity of public records.

Simple but systematically employed tools can make a difference in this regard. For instance, municipalities can conduct periodic household surveys to identify unregistered holdings and assess the actual tax base within their jurisdictions. Similarly, economic surveys of local businesses can determine appropriate trade licence fees and reduce the scope for discretionary decision-making. For example, mapping and verifying properties through community engagement and basic digital tools can immediately expand the number of taxpayers. Once the data is updated, municipalities can introduce mobile payment systems such as bKash or Nagad, making it easier for citizens to pay dues without having to physically visit the office. This is not a costly transformation; it

requires planning, transparency, and training rather than heavy technology investments.

The “local economic development” model provides a framework for aligning revenue generation with local growth. It encourages local governments, businesses, and communities to work together to stimulate the economy and create jobs suited to local realities. Instead of waiting for centrally financed projects, municipalities can design

mobilise their own resources, they gain the autonomy to plan development according to local needs, not central directives. With accurate data and efficient collection systems, local governments can increase their revenue. By reinvesting these funds into local services such as solid waste management, street repair, and public lighting, municipalities can reduce wasteful spending, encourage innovation, and strengthen accountability to

research partners, can introduce cloud-based revenue management platforms that are easy to use. Capacity-building initiatives for tax assessors and municipal officers, combined with citizen awareness campaigns, can also transform the culture of local revenue management.

Currently, Bangladesh’s political culture continues to treat Members of Parliament (MPs) as the main patrons of local development, even though mayors and upazila/union chairmen are the ones directly accountable to citizens. As a result, national elections receive far more attention and resources than local ones. Strengthening the fiscal independence of local government bodies can change this dynamic by giving real power where accountability lies.

Empowered municipalities can play a vital role in addressing issues such as rural-to-urban migration by creating employment opportunities closer to home. While disaster-prone or poorer areas will continue to inspire internal migration, people in general are less likely to migrate when they can earn a living in their own towns. This vision of self-reliant local government also aligns with our broader agenda of decentralisation and inclusive growth. This is not about replacing central support but about using and supporting it strategically to build sustainable return systems. Local governments should be encouraged to innovate, experiment with digital tools, and link taxation with tangible public benefits.

When a mayor can finance a community centre or market renovation through locally collected revenue, it is not just administrative efficiency; it is democracy in action. Strengthening municipal revenue generation is therefore not only a financial necessity but also a political reform. It restores balance between the centre and the local, between authority and accountability, and ultimately between promise and performance in Bangladesh’s development journey.

initiatives around their own comparative advantages. Partnerships with chambers of commerce, traders’ associations, and industry bodies can also help update local business registries and improve compliance. Engaging sectoral associations—such as those in footwear, furniture, light engineering, agro-processing, and aquaculture—can ensure that revenue reforms align with actual business dynamics and do not discourage enterprise.

It is, therefore, not an isolated economic agenda; it is a pathway towards decentralisation. When towns and cities

Despite the potential, however, entrenched barriers continue to thwart progress. Many municipalities lack trained staff for assessment and collection. Corruption and informal payments remain common in trade licence renewals. There is also limited understanding of how to design fair, transparent, and citizen-friendly systems. Gaza ceasefire: The politics behind a fragile truce

When Donald Trump unveiled his latest peace proposal, arriving in Sharm el Sheikh to mark the ceasefire between the Hamas and Israel, he declared it to be “the first real peace in the Middle East in 3,000 years,” even hinting that a Nobel Peace Prize might be in the offing. Yet, the ground reality emerging just days into the truce suggests that this moment of hope may already be slipping into the realm of illusion.

The ceasefire formally took effect on October 10 this year, following two years since the deadly October 7 attack in 2023. Israel committed to a phased withdrawal, while Hamas agreed to release hostages in exchange for thousands of Palestinian prisoners.

Yet, within days, the truce came under strain. Israel resumed air strikes and halted humanitarian aid convoys, citing alleged violations by Hamas. According to Al Jazeera, Israeli attacks in Gaza since the ceasefire, killing at least 236 Palestinians and wounding another 600, suggest that Israel is pursuing a policy of “Lebanonising” Gaza—officially ending the war but maintaining the right to conduct attacks whenever it chooses,

indefinitely. This uneasy calm now unfolds against the backdrop of a new proposal from Washington.

Donald Trump announced that a US-coordinated international stabilisation force would be deployed in Gaza “very soon,” amidst a fragile truce and a worsening humanitarian crisis caused by continued Israeli bombardment. His declaration coincides with UN Security Council plans to establish a stabilisation force of 20,000 troops in Gaza, with participation from several Arab countries—Egypt, Qatar, the United Arab Emirates, Saudi Arabia, and Türkiye—authorising them to “use all necessary measures” to implement the mandate. This force, according to the draft plan, would be tasked with protecting civilians, securing border areas, and training Palestinian police. As reported by Al Jazeera, UN Secretary-General António Guterres emphasised that any stabilisation force must have “full international legitimacy.”

However, significant challenges remain for this mission to be effective. Hamas has yet to declare whether it will disarm—a central

clause of Trump’s 20-point plan—and Israel appears to have its own narrative. Tel Aviv remains adamant about excluding Türkiye from the force and insists on retaining full control of Gaza’s security apparatus.

During a joint press conference with Trump in September 2025, Israeli Prime Minister Benjamin Netanyahu told reporters, “Israel will retain security responsibility, including a security perimeter, for the foreseeable future” in Gaza. Washington has clarified that it will not deploy US troops, while Guterres reiterated that any deployment must possess international legitimacy and be genuinely aimed at supporting Palestinians in Gaza.

The notion of a “stabilisation force,” while promising on paper, risks becoming another layer of geopolitical management—neither true peacekeeping nor state-building, but rather a mechanism for perpetuating external control under the veneer of international cooperation.

Politics disguised as peace

Behind the signing photo-op lies a stark truth: this deal appears tailored more for political expediency than for genuine reconciliation. Netanyahu, historically sceptical of Palestinian statehood, accepted the agreement under heavy US pressure and growing domestic disquiet. The structure of the deal reflects his priorities: retain control, delay statehood, placate hostages’ families, and stall elections.

Meanwhile, Palestinians once again find themselves offered promises of “future sovereignty” without any immediate path to real political power. The terms favour

Israel’s strategic interests—continued settler expansion in the West Bank, maintenance of military dominance, and the relegation of Gaza to a subordinate status.

At the heart of the conflict—the two-state solution—remains entirely sidestepped. Netanyahu has publicly opposed Palestinian statehood, while Israeli settlers continue expanding their presence in the West Bank under army protection. These realities speak louder than any diplomatic rhetoric.

In Gaza, the practical outcome is a territory still dependent, fractured, and dominated by external forces rather than governed by its own people. As Israel presses ahead with its military-first doctrine, it is losing legitimacy abroad and among younger US demographics. Polls show weakening US support for Israel, especially among Generation Z, progressives, and even some evangelical voters. According to scholar Shibley Telhami, “For Israel, the war for American public opinion is existential.” The battlefield may yield tactical victories, but the global narrative is steadily slipping away.

Gaza today lies in ruins—a humanitarian catastrophe of staggering proportions. Over 92 percent of buildings are damaged, and more than 60 million tonnes of debris await clearance. A joint assessment by the World Bank, United Nations, and the European Union estimates reconstruction needs at \$53.2 billion over the next decade.

Yet under the terms of the ceasefire, Israel has restricted aid flows and refused to reopen the key Rafah crossing until hostages’ remains are handed over—a stalling tactic with severe humanitarian consequences. Meanwhile, Gulf states such as the UAE and Saudi Arabia

remain willing to fund reconstruction but with political strings attached. International efforts to rebuild Gaza without genuine Palestinian governance risk becoming yet another mechanism of external control.

Despite the destruction and betrayal, the human spirit in Gaza endures. Displaced families return to charred homes; children go back to shattered schools; and amidst the rubble, life continues. They have lost almost everything—yet their will to begin again remains. This resilience is not merely admirable—it is a statement of defiance: a refusal to accept defeat or submit to permanent subjugation.

Today, the ceasefire is both a lifeline and a trap. Israel holds the arrangement hostage to its political agenda; Palestinians cling to the fading promise of self-determination. Recent reports indicate that Israeli forces now control more than half of Gaza under the so-called “yellow line,” shrinking the territory into enclaves and cutting off exits to the outside world.

Seen in this light, the truce resembles less a genuine pathway to peace and more a strategic pause—a breathing space for Israel to reconfigure control and for Palestinians to await a salvation that may never come.

Now the question arises: will the international community insist on accountability, inclusive governance, and a genuine political horizon? Or will the theatrics of peace continue to mask the permanence of occupation?

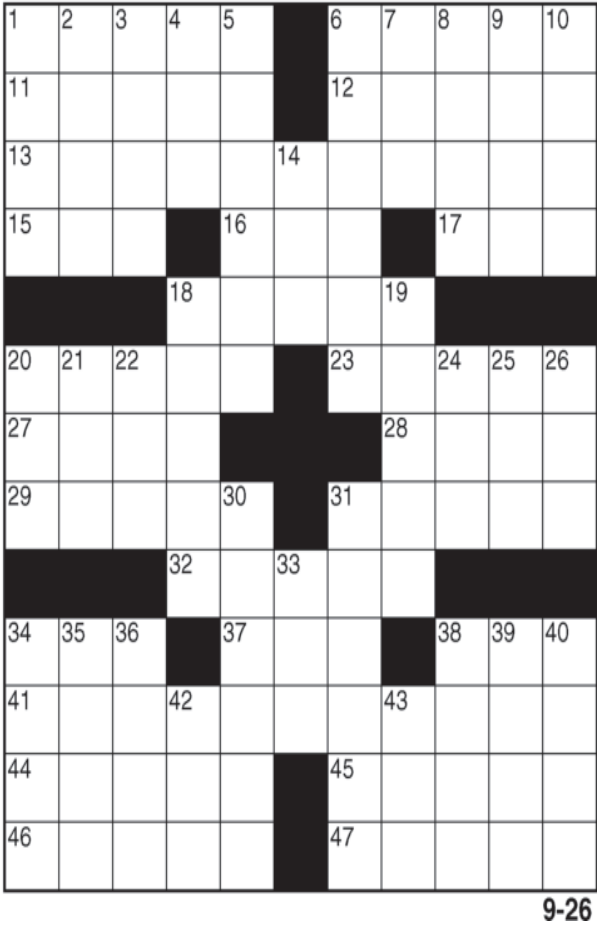
The question is no longer whether peace is possible, but whether we still believe it is worth pursuing.

I would never disrespect a woman: Irfan Sajjad

A new series titled *Eta Amaderi Golpo*, featuring Irfan Sajjad, has recently begun airing. Directed by Mohammad Mostafa Kamal Raz, the project also stars Khairul Basar, Sunerah Binte Kamal, and Keya Payel.

"I've mentioned before that I'm focusing more on films and being selective about television work. However, the way this series has been designed is very rich—it carries the production values of OTT content. I can confidently say no television series in Bangladesh has been made with such arrangements."

The series premiered on November 5 on Cinemawala's YouTube channel, with Channel i as its television partner.

Irfan also revealed that he will soon begin work on an OTT project directed by Sumon Dhar for iScreen. "After quite some time, I've taken up a web project," he said.

At this stage of his career, Irfan wants to focus on exclusive and festive projects. "I'm being very selective now, as I'm preparing myself for the silver screen and avoiding average work," he added.

In a short span, two of Irfan's films—*Vhoyal* (November 2024) and *Ali* (July 2025)—were released, both directed by Biplob Hayder. Reflecting on the audience's response, Irfan noted, "Both films were made by new production houses. I believe the response could have been stronger with broader marketing and promotions. Large-scale campaigns help projects reach their

audience—something these films lacked, no matter how good the project is."

Currently in talks with several production houses, Irfan hopes to collaborate with established directors and major banners in the near future.

Last week, an incident on social media left actor Irfan Sajjad deeply disturbed. Speaking to The Daily Star, he shared his side of the story.

"My colleagues, friends, and followers know that I often post about cricket—and most of my posts are sarcastic," Irfan said. "After Rubaba Dowla ma'am was appointed as a director of the Bangladesh Cricket Board (BCB), I made a sarcastic post saying that now, at least if the boys don't perform well, there's no hope. It was meant humorously and positively, not in a negative or sexist way. What I meant was that for us, the boys, Rubaba ma'am is a diva—someone beautiful, brilliant, and admirable. Unfortunately, some radical feminists took it offensively. When I saw the situation escalating and hatred spreading, I chose not to argue and preferred peace over drama."

Despite his clarification, Irfan said a section of people continued to spread negativity online, leaving him traumatised.

"I will be extremely careful about what I post on social media from now on," he stated. "My wife is a news presenter, and I believe that

if I, as a man, can contribute to creating a safer environment in the media, she too will be safer—it's all connected. I would never intentionally disrespect any woman in my life."

Michael Jackson has set a new Billboard milestone as *Thriller* returned to the Hot 100 at No 10 after the 2025 Halloween season. The jump from No 32 makes him the first artiste to score top 10 hits in six different decades.

people have been martyred and around 27 are wounded."

An AFP journalist saw paramilitary troops cordoning off the area where the minister said the assailant detonated the explosives near a police vehicle.

"We are trying to identify who he (the attacker) is and where he came from," Naqvi said. Pakistani Taliban militant group claimed responsibility, saying in a statement they had targeted judicial officials.

"Our fighter attacked the judicial commission in Islamabad. Judges, lawyers and officials who carried out rulings under Pakistan's un-Islamic laws were targeted," the group said in a statement, threatening to carry out more attacks "until Islamic Sharia law is implemented" in the Muslim-majority country.

Earlier, Prime Minister Shehbaz Sharif pinned the blame on "terrorist proxies backed by India", Pakistan's longtime foe, without providing evidence.

Sharif accused the Pakistani Taliban militant group and separatists from the country's Balochistan region, both of whom have carried out attacks mostly targeting the security forces.

In Islamabad, lawyer Mohammed Shahzad Butt said there was a "massive blast".

"Everyone started running inside out of panic. I have seen at least five dead bodies lying at the front gate," he told AFP.

Rustam Malik, another lawyer, told AFP he "heard a loud bang at the gate" as he was entering the complex.

"It was complete chaos, lawyers and people were running inside the complex. I saw two dead bodies lying on the gate and several cars were on fire," said Malik.

Islamabad has largely been spared major militant violence in recent years, with the last suicide attack occurring in December 2022.

The bombing came as Pakistani security forces battled militants who had holed up in a school in northwest Khyber Pakhtunkhwa's Wana district.

"There was an attack in Wana as well last night," Naqvi said. "Three people died in that attack. The attacker involved in that attack is an Afghan. Afghanistan is directly involved in that attack."

that COP30 must find effective ways to close the global ambition gap," said David Eckstein, one of the authors of the report.

Global emissions must be cut immediately to avoid further human and economic losses.

"At the same time, adaptation must accelerate, with concrete loss and damage solutions and adequate climate finance," he added.

In 2024, drought, flood, heatwave, storms and wildfires were the main weather events.

Bangladesh, the Philippines and

India recorded the most people affected by extreme weather in 2024. Bangladesh experienced a severe heatwave with temperatures that reached 43.8 degree Celsius and that affected more than 33 million people.

"Heat waves and storms pose the greatest threat to human life when it comes to extreme weather events," said Laura Schäfer, another author of the report.

Storms also caused by far the greatest monetary damage, while floods were responsible for the highest number of people affected, she added.

London for so many years I also had a similar feeling about London," Szalay told BBC Radio.

treatment for the victim, and guarantee the safety of his family.

The report said that taking a detainee to police quarters while in custody and summoning his wife at night are both violations of legal procedure.

According to the report, Afsana told ASK investigators that Md Fazlul Karim, sub-inspector (SI) and the investigating officer of Netrakona Sadar Police Station, called her from her husband's phone on October 20 and asked her to bring food to the station. When she refused, her husband called again and said, "Why aren't you coming? The police are asking you to come."

Moments later, she heard her husband screaming over the phone, shouting, "My wife can't come here with a child. Kill me instead!"

Terrified, Afsana went to the police station around 9:00pm with her mother and two-year-old child. She said the investigating officer told her to go to the police quarters and warned, "Don't panic or cry when you see your husband."

Afsana said that when she entered the police quarters, she saw her husband blindfolded, hands and legs tied, hanging from an iron rod. When she asked why, the police replied, "He's on remand; should we let him sleep instead of questioning?"

She alleged that the police officer demanded money, saying, "You've done politics and made money for years; now face the consequences."

Apel is a former vice-president of the Netrakona district unit of banned student organisation Bangladesh Chhatra League.

He was beaten continuously for around two hours, his wife told ASK.

During a jail visit, ASK representatives spoke with Apel, who said that while he was on remand, SI Fazlul, constable Ashraf, and another officer wearing glasses hung him in the police quarters and beat him.

A day after Sarwar's murder, armed criminals shot and injured a CNG auto-rickshaw driver in the same area, heightening panic among residents.

Several CMP officials said that no precautionary or preventive measures were taken after these shootings. Two former police officials, who recently left CMP for another unit, said that in similar past incidents, large-scale block raids were immediately conducted, but no such response was seen this time. Such inaction risks further emboldening the attackers to operate with impunity.

BAKALIA DOUBLE MURDER

On March 29, two men were shot dead in a brazen attack on a private car in the city's Bakalia area. Police said that the now slain Sarwar was also inside the car during the attack but had then somehow managed to survive.

The victims, Bokhtiar Hossain, 30, and Md Abdullah, 32, were both identified as known followers of Sarwar. According to the murder case filed by the victims' families, the double murder was rooted in a feud between Sarwar and Chhoto Sazzad.

Feroza Begum, mother of one of the victims, filed a case with Bakalia Police Station, naming Chhoto Sazzad, his wife Tamanna Sharmin (as an instigator), and seven others as accused.

Two weeks before the double murder, Chhoto Sazzad was arrested in Dhaka. In response, his wife Tamanna posted a video on social media threatening reprisal against those she believed responsible for his arrest. She was later arrested in June in the Bakalia double murder case.

Investigating Officer Mozammel Haque, inspector (investigation) of Bakalia Police Station, said, "We've arrested 10 suspects, including four named in the FIR, and recovered a

MURDER OF JCD ACTIVIST

On October 27, Jatiyatabadi Chhatra Dal (JCD) activist Md Sazzad, 22, was shot dead in the city's Bakalia Bogar Beel area amid clashes over tearing down political banners.

At least 10 others were injured in the shooting incident. Party sources said the gunfight broke out between followers of Emdadul Haque Badsha, former organising secretary of Jubo Dal's Chattogram city unit, and Gazi Siraj Ullah, former president of the same unit.

Sazzad was reportedly a supporter of Emdadul. Police named Borhan Uddin, a follower of Siraj Ullah, and Nazrul Islam, a leader of the pro-Awami League organisation "Tanti League", as accused – but neither has been arrested yet.

Bakalia Police Station Inspector (Investigation) Mozammel Haque said, "We have arrested 11 suspects and recovered some weapons. Efforts are on to capture the remaining accused. The case is now being handled by the Detective Branch."

CMP CHIEF DENIES INACTION

When asked why the gunmen remain at large despite repeated shooting incidents, CMP Commissioner Hasib Aziz said, "Many of the main suspects are already in jail. Some are operating from abroad. One person has been arrested with weapons in the Bakalia double murder case. These criminals often hide in remote hilly areas outside the city and maintain links with hill-based armed groups."

"They use motorbikes to execute their targets and then flee quickly. We've conducted several raids but haven't caught them yet," he added

Referring to Sheikh Hasina, he said, “Those who burn vehicles and destroy property while sitting comfortably in Delhi should not be allowed to return.”

He also cautioned the interim government against imposing reforms beyond consensus. “For nine months, you discussed reforms with political parties and reached agreements. If you force anything outside of that, responsibility will be yours. The people will not accept it.”

He criticised the government for scrapping plans to recruit music and physical education teachers in primary schools, saying such education is vital for children’s development.

UN seeks joint effort to rescue Rohingyas at sea

The United Nations and rights bodies have urged regional countries to launch urgent search and rescue operations for Rohingya and other refugees stranded at sea following the capsizing of a boat off the coasts of Malaysia and Thailand.

According to the UN Refugee Agency, 13 people have been rescued by Malaysian authorities, while at least 21, including two teenage Rohingya girls, have been confirmed dead by Thai authorities. The rest of the passengers remain missing.

Rights group Fortify Rights said authorities believe three smaller boats originated from a larger vessel carrying at least 300 people, which reportedly departed from Buthidaung Township in Myanmar’s Rakhine State. Only one of the boats has been accounted for so far.

Fortify Rights also called on regional governments to meet their international legal obligations to ensure the safe disembarkation of migrants and refugees and provide humanitarian assistance.

The UN Refugee Agency (UNHCR) and the International Organization for Migration (IOM) said they were deeply saddened by the recent tragedy involving up to 70 people from Myanmar, including Rohingya.

They expressed concern over the potential loss of life, noting that at least one other boat carrying around 230 people is still at sea. Both agencies said they are ready to support local authorities in assisting survivors.


CARETAKER GOVT SC verdict on appeals, review November 20

The Supreme Court yesterday fixed November 20 for the delivery of its verdict on the appeals and review petitions against its 2011 judgement that scrapped the non-party caretaker government system.

A seven-member bench, headed by Chief Justice Syed Refaat Ahmed, set the date. The SC held hearings for 10 working days.

During the hearings, the lawyers for appellants, petitioners, and the state counsels prayed to the SC to overturn its 2011 verdict. The SC on August 27 allowed the BNP and five citizens to move two appeals before the court against its verdict that cancelled the 13th amendment to the constitution, which had introduced the caretaker government system in 1996.

Anwarul Islam Sarkar said the code will take effect once the election schedule is announced. Parties have been instructed to remove existing posters, he added.

Only digital billboards are allowed to use lighting for campaigns, while decorative lighting is strictly prohibited, according to the code. Also, no drones will be allowed for campaigning.

The code also requires all candidates to announce their election manifestos from a single stage.

GUIDELINES ON SOCIAL MEDIA CAMPAIGNS

The code strictly prohibits the use of AI for deceptive or manipulative purposes in election-related activities.

Candidates and their supporters are barred from using hate speech, personal attacks, or inflammatory language against rivals, women, minorities, or any other community.


The code forbids exploiting religious or ethnic sentiments for political or electoral gain.

Political parties, candidates, or their representatives are not allowed to create, publish, promote, or share any false, misleading, biased, hateful, obscene, vulgar, or defamatory content – whether in general form, edited, or AI generated – intended to mislead voters or damage anyone’s reputation.

When asked about the EC’s capacity to monitor social media and curb misinformation, Election Commissioner Anwarul Islam Sarkar said, “The Election Commission alone cannot manage everything – it needs collective cooperation.”

Meanwhile, any breach of the electoral code of conduct may lead to up to six months in jail, a fine of Tk 1.5 lakh for candidates, and Tk 1.5 lakh for the political party concerned. Previously, the highest fine was Tk 50,000 for both.

The first electoral code of conduct was introduced ahead of the June 1996 polls. It underwent major revisions before the 2008 election and minor changes in subsequent polls.

Butterfingers let visitors off the hook

Bangladesh spinner Hasan Murad provided the brightest moment yesterday with a gem of a delivery, drawing Ireland batter Curtis Campher forward before finding the edge as captain Najmul Hossain Shanto took the catch at slip. While it was an auspicious moment for the debutant, Shanto's reaction was telling as he proceeded to throw the ball into the ground in anger.

Shanto's frustration was understandable, given that he had earlier dropped one at slip to hand Lorcan Tucker a reprieve in the 49th over -- a missed opportunity that would have given Murad his first-ever wicket earlier in the innings on the opening day of the first Test in Sylhet.

Despite the spinners roaring back in the third session with four wickets, Bangladesh's day was defined by a string of missed chances, as the hosts allowed the visitors to wrest back the initiative.

The morning started brightly when Hasan Mahmud's in-dipper trapped Irish skipper Andy Balbirnie leg-before with just the fourth delivery of the day. Even as the stands were mostly empty, both Hasan and Nahid Rana were urged by the fans to go for the kill.

The movement of the new ball subsided soon after, but Rana, in particular, was able to generate some extra bounce from the surface. He soon induced Paul Stirling into poking one to second slip, only for Shadman Islam to spill it. The next over, Taijul Islam failed to hang on to another

regulation catch, as Irish debutant Cade Carmichael was given a reprieve. Rana's frustration deepened when Stirling was dropped again, this time by Mehidy Hasan Miraz at gully.

Within the first half-hour of the Test, the Tigers had already dropped three.

The Stirling-Carmichael duo made the most of the reprieves. Stirling hit a swashbuckling fifty off 61 deliveries, and Ireland seized the momentum completely in that first session, reaching 94 for one in 26 overs.

The pair put on 96 for the third wicket before Rana finally had his man, Shadman holding on to Stirling's catch after a 76-ball 60. Carmichael went on to score his maiden fifty, but Miraz's two wickets in the second session saw Ireland reach 184 for four at lunch. Tucker added 41 after being dropped on 11, adding to the Tigers' woes, while Mushfiqur Rahim later grassed a tough chance to allow Jordan Neill to survive.

Hasan Mahmud reflected on the day, saying catches are part of the game, though "it doesn't feel good when a catch is missed."

Eventually, the spinners staged a partial recovery. Miraz bagged three, Murad two, and Taijul Islam struck with the final delivery as Ireland closed on 270 for eight.

The Sylhet International Cricket Stadium has hosted four Tests, and in three, the side surpassing 200 in the first innings have won. After a butterfingers day, Bangladesh will have their work cut out to drive home the advantage.

Rakib aims to end the year on a high

Forward Rakib Hossain remains optimistic about delivering a victory for the nation when Bangladesh face India in their final match of the year. The striker believes the team's recent home performances give them confidence ahead of the clash.

The Bangladeshi international shared his thoughts yesterday at the Bashundhara Kings Arena training ground, as the team continued preparations for two upcoming international fixtures -- against Nepal on November 13 and India five days later at the National Stadium.

Bangladesh have already been eliminated from the race for the AFC Asian Cup, following two home defeats and two away draws. However, Rakib dismissed the notion that the team performs better on foreign soil.

"If you look back, we've played really well at home," said Rakib. "In our last home match against Hong Kong, we had a strong first half. We also scored four goals in two matches -- one against Singapore and three against Hong Kong."

Determined to finish the year on a positive note, he added, "We still have two matches left -- one at home and one away -- and we'll try to give the country's people a good result by winning against India in our last home match of the year."

The Bashundhara Kings forward also praised the growing excitement surrounding the national team since the inclusion of Hamza Choudhury and Shamit Shome, crediting their presence for lifting both the squad's spirit and public enthusiasm.

"You can see how football's popularity has grown -- tickets for home matches are selling out in just a few minutes," Rakib said. "The craze has definitely increased since Hamza and Shamit joined. We've improved a lot as a team, but sometimes the results just don't go our way -- that's our bad luck."



'Cherish the love I receive'

Leicester City midfielder Hamza Choudhury said representing Bangladesh remains a deeply personal chapter in his career, as he was unveiled as the new brand ambassador of private telecom operator Robi at their corporate office in Dhaka yesterday.

Currently in Bangladesh for the upcoming international fixtures against Nepal and India, Hamza attended the signing ceremony in the morning, where he spoke about his motivation for choosing Bangladesh and the emotions tied to that decision.

"It [debut for Bangladesh] still feels surreal, to be honest," Hamza said. "I just want to

be proud of being part of this country and to represent it in any way possible, especially for my parents. My father was born and raised here, so seeing that smile on their faces means everything to me. Every child wants to make their parents proud, and I feel blessed that I have the chance to make an entire nation proud."

Since his arrival, the midfielder has drawn large crowds wherever he has gone, from public appearances to training sessions. The reception, he said, has strengthened his bond with the country.

Contributing to that progress in whatever way I can is one of the main reasons I chose to play for Bangladesh. I have many childhood memories connected to this country, and I truly enjoy being here -- especially to inspire the younger generation to play football," Hamza added.

Tanvir, Soumya star in Barishal, Khulna wins

Skipper Tanvir Islam's nine-wicket match haul, including 4-52 in the second innings, guided Barishal Division to their first win of the National Cricket League longer version, defeating Rajshahi Division by 54 runs on Tuesday in Khulna.

Chasing 246, Rajshahi were 5-0 overnight and steadied with openers Sabbir Hossain (33) and Mizanur Rahman (25) adding 59. However, Barishal's bowlers stormed back, taking six middle-order wickets for just 28 runs. Tanvir's effort, supported by Yeasin Arafat Meshu (4-41) and Ruyel Miah (2-36), saw Rajshahi bundled out for 191.

In Chattogram, Soumya Sarkar backed up his first-innings 92 with 71 off 90 balls, while Shak Mahedi Hasan's unbeaten 50 off 49 guided Khulna Division to a two-wicket win over Chattogram. Khulna, resuming on 52-0, lost five quick wickets but a 57-run stand between Mahedi and Nahidul Islam (22) helped Khulna secure their second win in three matches and stay atop the points table.

Elsewhere, the other two matches in Cox's Bazar ended in draws. Rangpur Division reached 112-4 chasing 249 against Sylhet Division, while Sylhet opener Mubin Ahmed Dishan struck his maiden first-class century, 141 off 262 balls, as they declared on 294-9 at the Cox's Bazar International Stadium.

At the Academy Ground, newcomers Mymensingh Division, with Mahfijul Islam Robin (51 not out) and Mohammad Naim (44 not out), finished on 97-0 in their second innings after dismissing Dhaka Division for 388 to earn their third consecutive draw.



Starc wants spicy Perth pitch; Botham concerned

Australia paceman Mitchell Starc has urged curators to prepare bowler-friendly surfaces, cautioning against "flattening surfaces to maximise five-day revenue", while former England captain Ian Botham has voiced concern about the team's lean Ashes preparations.

Botham noted that the full England squad did not arrive in Perth until Sunday, playing only one internal match before the series opener on November 21, while most of Australia's players are gaining match fitness in domestic Sheffield Shield games.

"It's not the way I would prepare," Botham told reporters in Melbourne. Highlighting the traditional need for touring teams to acclimatize, he stressed the mental challenge: "You've got to remember there's 24 million people down here, not 11. And you have to take that on board."

Despite his concerns over preparation, Botham expects a better series for Ben Stokes's team than the 4-0 loss in 2021-22, provided they can avoid injuries, calling it "one of those big ifs."

Botham suggested England could "consider unleashing a four-prong pace attack," favouring an aggressive approach: "You want to be aggressive, come through and players, if they're not playing very well, don't like it in the ribs."



However, England assistant coach Marcus Trescothick countered the idea that Australian conditions would curb the 'Bazball' style, arguing that the pace and bounce will be welcomed.

"Playing on bouncy pitches, where the

ball comes onto the bat nicely, is something we always talk about trying to get back at home. It suits our style of play, which we're happy with," Trescothick said.

Trescothick also backed star batter Joe Root to finally score a Test century in Australia, noting that under the current regime, "His game has gone to the next level and hence the reason where he is in the rankings."

On the Australian side, paceman Mitchell Starc has weighed in on the pitch debate, urging curators to prepare bowler-friendly surfaces. Starc warned that docile wickets, like the one he recently played on in the Sheffield Shield, would play "right into the England batters' hands."

Starc, who is building his rhythm after a layoff, believes his bowling is coming good, saying, "I think I've sorted it out and now it's just getting the engine going again."



RONALDO confirms 2026 WC will be his last

Cristiano Ronaldo confirmed that the 2026 World Cup will mark the end of his legendary international journey. At 40, with over 950 career goals and 143 for Portugal, the five-time Ballon d'Or winner said the tournament in USA, Canada, and Mexico would be his "last dance." Now starring for Al Nassr in Saudi Arabia, Ronaldo admitted he plans to retire from football "in one or two years." Portugal, still fighting for qualification, hopes to give their captain one final shot at glory -- something that eluded him since the 2006 semifinal loss to France. Reflecting on his career, the world's first football billionaire said farewell won't be easy: "It will be very, very difficult. Probably, yes -- I will cry."



Suicide bomber kills 12 outside Islamabad court

27 hurt; Pakistani Taliban claims responsibility

Use SMG burst-fire to deal with armed criminals

CMP chief tells cops

After repeated shootings in the port city, Chattogram Metropolitan Police (CMP) Commissioner Habib Aziz has directed police officers to keep SMGs in "burst-fire mode" and use them to neutralise any armed terrorists encountered. In a verbal order issued to all CMP personnel yesterday, the commissioner instructed patrol units and operation units. At least five officers from CMP's four zones confirmed to The Daily Star that the wireless order came in several phases between 12:30pm and 1:00pm today, saying that the CMP commissioner has ordered that there should be no shotguns and no Chinese rifles. Now, SMGs will be kept in burst-fire mode, they cited the directive. 'Use firearms in self-defence' Patrol teams were instructed to carry, in addition to SMGs, a pellet-

Bangladesh 13th in Long-Term Climate Risk Index

Bangladesh has been ranked 13th in the Long-Term Climate Risk Index (CRI), reflecting its continued vulnerability to climate-related hazards such as floods, heatwaves, cyclones and storms. The CRI was prepared by the global disaster watchdog Germanwatch by analysing data on casualties and property damage caused by extreme weather events in 20 countries, including Bangladesh, over the last 30 years. The index documents over 9,700 extreme weather events from 1995 to 2024, which resulted in more than 830,000 deaths and caused over \$4.5 trillion in direct damages, adjusted for inflation. Germanwatch praised Bangladesh for bringing down the number of deaths by effective risk management in CRI 2026, which was released at COP30 in Belém. Owing to effective risk prevention and adaptation, cyclone-related mortality in Bangladesh has fallen more than 100-fold in the last 40 years, from half a million deaths in 1970 to 4,234 in 2007, the report said. Bangladesh's neighbours, India and Myanmar, are both ranked within the top 10 in the index. Dominica, Myanmar and Honduras are listed as the three most affected countries over the 30-year period. The other countries in the top 10 are: Libya (4th), Haiti (5th), Grenada (6th), the Philippines (7th), Nicaragua (8th), The Bahamas (10th) and China (11th). None of the eleven is among the world's wealthy industrialised nations. However, industrialised nations such as France (12th), Italy (16th) and the US (18th) are among the top 30. The CRI findings underscore that countries in the Global South are especially vulnerable to the climate crisis and need greater support from wealthier nations. Still, even industrialised countries are increasingly affected. "The results of the CRI 2026 clearly demonstrate

COP30 focuses on countries' need for climate resilience

With typhoons tearing across Southeast Asia this week while areas of Jamaica and Brazil are still clearing debris from damaging storms, delegates at Brazil's COP30 summit began grappling with how best to help the vulnerable withstand worsening weather and other climate extremes. The topic of "adaptation" has grown more important as countries fail to rein in climate-warming emissions enough to prevent extreme warming linked to increasingly frequent weather disasters across the planet. A UN report last month said developing countries alone would need up to \$310 billion every year by 2035 to prepare. Where that money will come from is unclear. Ten of the world's development banks, under pressure to free more cash for climate action, said on Monday they would continue to support the need. "Lives, well being and jobs cannot be sustained where homes, schools, farms and businesses are under threat from flooding, drought, or other climate extremes," the banks said in a statement. Last year, they channelled more than \$26 billion to low- and middle-income economies for adaptation.



Separately, the director of a multi-partner UN fund told Reuters it would soon announce a new impact bond aimed at raising \$200 million by the end of 2026. "The whole bond idea started exactly one year ago at the previous COP in Baku," said Markus Repnik, who leads the Systematic Observations Financing Facility backed by the World Meteorological Organization, UN Development Programme and UN Environment Fund. "We were getting the sense that things are going to change significantly from an international perspective." The fund, which also works to plug gaps in weather data for developing countries, hopes for country donations this week during COP30. On Monday, Germany and Spain pledged \$100 million to a different effort, the multilateral Climate Investment Funds (CIF), which is financing projects to boost climate resilience in developing countries. The organisation's chief praised Brazil for featuring the issue as a COP30 focus, after years of seeing the issue slide down UN climate summit agendas. "We're really thrilled that, for the first time, adaptation is Day 1 and Day 2 of the COP," CIF Chief Executive Tariye Gbadegesin told Reuters.

Touhid rejects Indian media claims of LeT-Bangladesh link

Foreign Adviser Touhid Hossain yesterday said there is no reason to believe the Indian media's claim that Pakistan-based terrorists are plotting to attack India "using Bangladesh as a launchpad". "The [Indian] media will try to put the blame on us for any incidents. There is no reason to believe it. No sensible person can believe this," he told reporters at the foreign ministry. Various Indian media outlets, including the Times of India, referring to a video, reported that Lashkar-e-Taiba (LeT) commander Saifullah Saif has claimed that

Typhoon reveals ancient shipwreck in Vietnam

Severe coastal erosion caused by Typhoon Kalmaegi exposed a centuries-old shipwreck in Vietnam, providing a narrow window to salvage what experts say could be a historically significant find. Initially discovered in 2023 off the coast of Hoi An, the at least 17.4-metre (57-foot) vessel – whose heavy wood-ribbed hull survived hundreds of years of rough seas almost perfectly intact – was resubmerged before authorities could reclaim it. Experts have not yet dated the wreck, but preliminary findings suggest it was built between the 14th and 16th centuries – when Unesco-listed Hoi An was at the centre of a thriving regional trade in silk, ceramics and spices. "We are currently preparing to apply for an emergency excavation (permit)," Pham Phu Ngoc, director of the Hoi An Center for the Preservation of World Cultural Heritage, told AFP on Monday after the wreck resurfaced following the passage of Typhoon Kalmaegi last week. "The discovery of this ancient ship is clear evidence of Hoi An's significant historical role in regional trade," he said, adding more of the ship had been exposed this time "which could provide us with more information".



ASK probe finds evidence of police torture in Netrakona

The Ain o Salish Kendra has found preliminary evidence of human rights violations in an incident of alleged torture in police custody in Netrakona. In a report published yesterday, ASK said it conducted an investigation on November 5 and 6 and found evidence that an accused, Apel Mahmud, 35, was tied up and tortured while in police remand. It also claimed that the victim's wife, Afsana Mimi, was summoned at night to the police station at Borogara under Sadar upazila, where she was subjected to intimidation and harassment. On the evening of October 14, police arrested Apel, and the following day sought a seven-day remand; the court granted one-day remand. ASK urged authorities to take disciplinary action against those responsible, file a case under the Torture and Custodial Death (Prevention) Act, ensure medical

BOOKER PRIZE Szalay's 'Flesh' wins 2025 fiction award

David Szalay won the 2025 Booker Prize for his novel 'Flesh' on Monday, becoming the first Hungarian-British author to win one of top awards in the English-speaking world. Written in spare prose – characterised by brevity and a lack of unnecessary detail – the book follows a man caught in a series of events beyond his control over decades. It charts his rise from a housing estate in Hungary to the mansions of London's super-rich. "A meditation on class, power, intimacy, migration and masculinity, Flesh is a compelling portrait of one man, and the formative experiences that can reverberate across a lifetime," organisers of the award ceremony in London said in a statement. In addition to the 50,000-pound (\$67,000) prize for the winner, as well as a 2,500-pound awards to each of the shortlisted authors and translators, the writers also gain a boost in popularity and benefit from increased book sales. "Even though my father is Hungarian, I never felt entirely at home in Hungary. I suppose, I'm always a bit of an outsider there and living away from the UK and
