**Order on Petition for Confiscation: arising out of Permission Petition-200/2025**

Motijhel Police Station Case No. 27 dated 26.04.2023: Under Sections 4(2)/4(4) of the Money Laundering Prevention Act, 2012 (as amended in 2015)

ORDER No. 04. Dated:-19 January 2026.

This order arises out of an application filed by the Sub-Inspector of Police, Financial Crime Unit, CID, Dhaka, seeking an order under section 17(2) of the Money Laundering Prevention Act, 2012 (as amended in 2015) read with Rule 50(3) of the Money Laundering rules, 2019, praying for Confiscation in favour of the State of the movable and immovable properties mentioned against accused persons serial no. Ka to Kha, and for publication of such attachment by notification in the Government Gazette and in two widely circulated daily newspapers.

Heard the learned Public Prosecutor and perused the application along with the relevant case records and materials placed before the Court.

It appears that the case involves allegations of money laundering offences as defined and punishable under the Money Laundering Prevention Act, 2012 (as amended in 2015). During investigation, certain movable and immovable properties standing in the names of accused persons serial no. Ka to Kha, have been identified and attached, which are prima facie suspected to be proceeds of crime derived from money laundering activities.

The investigating officer has stated that there exists a reasonable apprehension that, if the properties are not formally attached in favour of the State and publicly notified, the accused persons may attempt to transfer, alienate, conceal, or otherwise deal with the said properties, thereby frustrating the object of the law. Section 17(2) of the Money Laundering Prevention Act, 2012 (as amended in 2015) empowers the Court to pass appropriate orders for attachment of proceeds of crime, while Rule 50(3) of the Money Laundering rule, 2019 provides for publication of such attachment through the Government Gazette and newspapers to ensure public notice and prevent unlawful dealings.

Upon careful consideration of the facts, circumstances, and the materials on record, this Court is satisfied that a prima facie case has been made out and that the prayer sought is reasonable, lawful, and necessary for safeguarding the proceeds of crime and for ensuring effective administration of justice.

Accordingly, the application is allowed.

- The movable and immovable properties described in the schedule of the application, standing in the names of accused persons serial no. Ka to Kha, are hereby Confiscation in favour of the State, in accordance with section 17(2) of the Money Laundering Prevention Act, 2012 (as amended in 2015).
- The investigating authority is directed to take immediate steps to publish this Confiscation order:
  - in the Government Gazette, and
  - by way of public notice in two widely circulated daily newspapers, in compliance with section 17(2) of the Money Laundering Prevention Act, 2012 (as amended in 2015).
- All concerned registering, maintaining, and financial authorities are directed not to permit any transfer, registration, mutation, encumbrance, or withdrawal of the Confiscation properties and monetary assets until further orders of this Court.
- This order will be implemented by Deputy Commissioner which the property is located Rule 50(5) of the Money Laundering rule, 2019.
- The investigating officer shall submit a compliance report before this Court within the time prescribed by law.
